On behalf of Sispar Ltd, with a registered company address at Wilton Works, Naas Road, Clondalkin, Dublin 22, we wish to apply to An Board Pleanala for an alteration to ABP Ref. 27.JA0029 under a section 146B application of the Planning and Development Act 2000, as amended.
