Linutes of previous Feetings were unanimously adopted.

Read letter 7th December, 1942, addressed to the County Manager from J.J. Robinson, Architect, to Sisters of Mercy, Convent of Mercy, Atklow, and referred by the County Manager to the Council, for their views thereon. The letter suggested that the cost of a proposed wall which the Convent proposed erecting should be borne by the Local Authority, as the necessity for it would not have arisen but for the Housing Scheme.

It was unanimously decided that the Council had no responsibility in the matter.

Read letter 10th December, 1942, from Chairman, Irish Tourist Board, in reply to the Council's letter requesting particulars of the Board's proposals in relation to development of Council's North Beach property, pointing out the difficulties in the matter, and stating that as soon as possible the Board would inform the Council a s to what their decided Scheme envisaged.

The following Resolution, forwarded by Tullamore U.D.C., was unanimously approved on the proposition of Cllr. Cleary, seconded

"That, in the opinion of the Tullamore Urban District Council, legislation should be enacted without delay to compel Ground landlords to sell their interests to leaseholders at a fair purchase by Cllr. Birthistle*price."

"That the Resolution moved by Cllr. O'Cleirigh be amended by the insertion of the figure £10 per annum instead of £20 per annum."

Cllr. McEmbron moved a further amendment to the effect that a decision be postponed in order to afford an opportunity to the Clergy and local residents of expressing their views in the matter of a proposed Greyhound Racing Track for Arklow.

Cllr. Weadick stated that the property had been acquired by the Council as a public amenity, and should not be sold, as it had been the intention to reserve it as an open space.

The Town Clork informed the lecting that he had received intimation from the Chairman of the Irish Tourist Board to the effect that the disposal of any portion of the property to the local Company would interfere with their interestin the purchase from the Council of the entire holding and its future development.

The Chairman ruled Clir. McElheron's amendment out of order.

Ellr. Kavanagh's amendment was first put to the Leeting, and declared lost by six votes against to two for.

Resolution 2 - "That the Dundalk Urban District Council request the Minister for Local Government and Public Health to amond existing legislation concerning the housing of the Working Classes, particularly the provisions governing payment of the full 663% subsidy, so that many people at present debarred from this relief, though in dire need of it, may be brought within its scope; that the restrictions on letting of houses generally may be relaxed so as to enable the public authority to let houses to any genuinely deserving cases; that the law be amended so that families unavoidably occupying rooms in Council houses of which they are not tenants may be eligible for subsidised houses; that in view of the urgent need of many of these people, such amending legislation be immediate; and that copies of this resolution be transmitted to the Association of Municipal Authorities and all municipal Authorities in Eire."

He suggested that the question of location for a new Industry might be left to the Council's Town Planning Consultant.

The County Lanager referred the Council to the historical background which he had already given them in regard to the North Beach property, and also explained the position in regard to Town Planning, including that of Town Planning Consultant. He also drew attention to the statutory requirements in regard to the disposal by sale or leasing of property which the Council had acquired.

It was proposed by Cllr. McCarthy, seconded by Cllr.
Birthistle, "That we decide to lease to Messrs. McMicholl, Avoca,
the sites at our North Beach property - about two acres - as
outlined in the Town Surveyor's letter of 4th December, 1944,
required by them for the establishment of a factory, at an
annual rent of 215, the lease to be phe of 999 years' duration."

Chir. J.J. Kawanagh proposed, and Clir. Keogh seconded, the following amendment:- "That we decide to sell to Lessrs. McNicholl, Avoca, the sites at our North Quay property as outlined in the Town Surveyor's letter of 4th December last, required by them for the establishment of a factory, for a sum of £400, or, alternatively, that the property sought be leased at a rent of £15 per year for a period of 999 years with the inclusion in the Lease of the revertionary clause that the sites revert to the Council in the event of Messrs. McNicholl failing to continue to use the property for the purpose for which it is proposed to lease it."

Clir. Kawanagh's amendment, on being put to the Meering, was declared lost by three votes for to four against, viz. For - Clirs. Kawanagh, Keogh and McElheron; Against - Clirs. Weadick,

Birthistle, McCarthy and McDonagh.

Cllr. McCarthy's Resolution was then put and declared carried by four votes for to three against., viz. For - Cllrs. McCarthy, Weadick, Birthistle and McDonagh; Against - Cllrs. Kavanagh, Keogh and McElheron.

The Monthly Meeting of the Council's Tourist Development Committee was held on the above date at 8 p.m.

Minutes of Leeting 3rd January, 1945, were confirmed. Apologies for non-attendance were received from Lessrs. W.I. Briggs, T.E. Earl, J.W. Barrett, H. Fleckney, and Miss J. Callanan.

The Secretary explained to the Meeting that the Orders made at previous meeting had not yet been carried out by him, due to his absence through illness.

The following recommendations were made to the Urban Council:-1. Approach Postal authorities to have an all-night telephone service provided in the town. 2. Local Fire Brigade officer's residence to be connected by 'phone. 3. Representations to be made to the C.I.E. Company with a view to securing, when conditions permit, Bus services on the following routes: (a) Carlow-Arklow; (b) Wicklow-Arklow;

(c) Fuller service on Dublin-Arklow route.

It was unanimously decided to invite lr. REPORT OF TOURIST COMMITTEE MEETING WEDNESDAY, 2nd MAY, 1945.

The May Monthly Meeting of the Council's Tourist Committee was held on above date at 8 p.m.

Minutes of previous Meetings were confirmed.

It was unanimously agreed to permit Mrs. Brennan and Mr. Annesley plant roundabouts in housing schemes, and to defer granting of permission of roundabout at Seaview Avenue.

In connection with proposed Flower Garden competition, it was unanimously decided that Secretary call at offices of "Evening Herald" with a view to securing particulars of a similar scheme sponsored by them some years ago. The Secretary was also instructed to draft suitable Entry Forms for those desiring to take part in the competition, and have them distributed by Rent Collectors to tenants of Council cottages.

On the suggestion of Mr. G.A. O'Toole, it was unanimously decided to seek the advice and co-operation of Mr. Dawson, County Horticultural Instructor, in the proposed competition, and also to secure his views on the possibilities of running a Horticultural Show in the Urban Area.

A Sub-Committee consisting of Councillor McElheron, Messrs. Hickey and Tyrrell, and the Secretary, was appointed to examine and approve proposed new I.T.A. Folder (Draft), and Secretary was instructed to request I.T.A. expedite preparation of Draft.

Mrs. Brennan intimated that the firm of A.W. Brennan, Ltd. were agreeable to undertake at their shop "Cigar Box" distribution of Tourist literature etc. and to supply information to callers re 'Buses and Trains. The Secretary was, accordingly, instructed to inform the I.T.A. in the matter and request a supply of I.T.A. Literature and Time-tables.

It was unanimously decided to insert in new Guide-Folder a reference to the desirability of tourists lodging their complaints at U.D.C. offices for transmission to I.T.B.

It was decided to bring to the notice of the I.T.B. that a number of guest-houses were permitted by that Board to increase their charges for the present season because of their not having disclosed the fact that the rates submitted for approval were an increase of those of last season, while other guest-houses, who had disclosed that the present season's rates would be an increase on those of last year, did not receive approval to the increase.

It was mnanimously decided to register the Committee's protest at the delay of the Department of Local Government in according sanction to the plans of the U.D.C. for laying of intercepting sewer along south side of Avoca river.

The County Manager was requested to instruct S.S.O. investigate dumping of rubble near sewer outlet atvCoomic Lane.

It was unanimously decided to recommend the County Manager to accede to the U.D.C's. request to take over control and maintenance of public right-of way connecting 'Bus Stop with St. Mary's Road, as it is at present in an insanitary state.

Read Town Planning Consultant's Report 19th April, 1945, recommending granting of lease of 42 acres of land at U.D.C. property, North Beach, to local G.A.A. Club for use as playing pitch.

Read Town Planning Consultant's Report on application from Mossrs. McNicholl for industrial site on North Beach property, stating that, on the information submitted, he could not recommend approval.

Read letter 19th April, 1945, from Mr. P. McDowell, Solicitor for Messrs. McNicholl, intimating with withdrawal of his clients from negotiations for the purchase of the property, in view of delay in matter.

Read copy letter 3rd February, 1945, addressed to Mr. Ml. Cavanagh, Hon. Secretary, old Arklow Tourist Association, informing him that it was understood that his Committee held in trust funds collected for local development purposes, and enquiring if it would be possible to have the money placed at the U.D.C's. disposal for the purpose of assisting in the provision of local amenities for tourists.

The May Monthly Meeting of the Council was held in the Boardroom, Courthouse, Arklow, on the above date at 7 p.m.

Read letter 19th April, 1945, from Mr. P. LeDowell, Solicitor for Messrs. McNicholl, intimating the withdrawal of his clients from the negotiations for the purchase of portion of U.D.C's. property at North quay.

Read letter 19th April, 1945, from Mr. N. O'Dwyer, B.E., Town Planning Consultant, reporting on applications received for interim permissions under Town Planning Acts, stating (1) Re application from Messrs. McNicholl for permission to erect a factory at North Quay, that on information submitted he could

(2) Re application by Brook Pottery Ltd. for permission to erect a not recommend approval: Pottery Works at Wexford Road, stating that generally the location is not one in which a Pottery should be allowed, being in a residential area, and every effort should be made to have the proposed Pottery transferred to the area of the existing Pottery

(3) Re application from Mr. R. T. Kearon, stating that he saw no Works. objection in principle to the proposal, and recommended approval, subject to complete plans being submitted to and approved by the

subject to certain safeguards. (6) Re proposed housing development at Bridge Street, he thought it unwise to go on selecting housing sites piecemeal, and the problem of dealing with the entire housing needs should be

(7) Re plan for Mr. Keogh's house at Wexford Road - He saw no objection to the plan submitted, provided that a site plan showing an adequate setback from the street frontage is lodged with the Town Surveyor.

Read Manager's Orders Nos. 1536 re Brook Pottery; 1537 re McNicholl proposal, and 1538 re Messrs. Brennan and J. Keogh's proposals, by request of the Heeting.

Road Manager's Order No. 1476 - 23rd February, 1945, granting permission to the Brook Pottery, Ltd. to erect a factory in

concurrence with the wishes of the U.D.C.

The Town Clerk informed the Meeting that, on the direction of the County Manager, the terms of this Order were not communicated to the applicants, as, subsequent to his making it, the appointment of a Town Planner had been approved, and he deemed it necessary to secure his Report on the proposal.

It was unanimously decided to request the County Manager to give an early decision on the lines suggested by the Town Planning Consultant on G.A.A. application.

Submitted letters 14th March, 1945, from Messrs. A. B. Brennan Ltd. and 12th March, 1945, from Mr. R. T. Kearon, making applications reported on in Town Planning Consultant's letter.

Town Clerk was instructed to bring to the notice of the County Manager the insanitary state of ditch-right-of-way, and the need for its early extinguishment both on these grounds and in regard to necessity for extra garden space for houses abutting thereon.

The attention of the County Manager was also/to be drawn to the urgent necessity of fencing off No. 60 Connolly Street garden to prevent trespass on adjoining gardens from that point.

It was proposed by Cllr. CCarthy, seconded by Cllr. Weadick, and passed unanimously: - Resolved - "That we hereby request the Department of Local Government and Public Health to issue without further delay the findings of local Inquiry held in Soptember, 1943, into proposed extinguishment of Ditch right-of-

way." Prior to putting of Resolution, the Clerk stated that the County Manager desired it to be understood that the delay in this matter was due to the doubtful ownership of the right-of-way, and he was at present negotiating in the matter with the Sisters of Mersy, who were alleged at the Inquiry to own portion of the right-of-way.

It was unanimously decided, on the suggestion of Cllr. McElheron, to bring to the appropriate authority's notice the apparant inconsistency in closing down schools while at the same time permitting running of children's matinees during the present whooping-cough epidemic.

It was unanimously decided to again represent to the County Manager the desirability of changing public lamp at Beresford

Terrace to polo convenient to public fountain.

It was proposed by Cllr. McCarthy, seconded by Cllr. McElhoron and passed unanimously: - Resolved - "That this Council takes exception to the treatment of the E.S.B. in failing to implement their undertaking re provision of public lighting services at 124 new houses scheme, while they are at present tendering for the carrying out of similar work in other areas, and we hereby instruct the Town Clerk to bring to their notice the number of accidents which have occurred as a result of the absence of public lighting."

The County Manager was requested to have coping stones dumped some years ago removed from river bed, as they were collecting sewage matter.

County Manager was requested not to delay in formulating plans for erecting of a public abbatoir.

The attention of the S.S.O. was directed to the dumping of sleughtorhouse offal and stale eggs at Green, and dumping of Amsanitary matter at Tinahask Lower (vicinity Charter-school).
