- Letter dated 27/9/1939 (No.S.27153/39) from Min.Loc.Govt. notifying that it has been decided by the Minister for Finance that save where the terms of an existing Mortgage Deed or Charging Order preclude it, interest on every issue made out of the Local Loans Fund on and after 12th September, 1939, shall be charged at the rate of 5% per annum, irrespective of the purpose of the Loan and of whether it was authorised by him before or on or after that date. Read. Town Clerk to be instructed to appeal to the Minister to maintain the programme of building and public works by supplying necessary monies and that there should be no decision to restrict grants or Loans.
- Circ. C.P.10/39 dated 23/9/39 from Min.Loc.Govt. intimating that in view of delay in obtaining supplies from official contractors, and in some cases to the inability to obtain supplies at the official contract prices, it will be necessary to vary in some respects the terms of the official contracts entered into for the present year by orders under the Emergency Powers Act,1939. The Minister invited the co-operation of local authorities in restrict -ing orders for supplies from contractors to bare minimum require -ments, etc.

- Report of Surveyor re Swimming Pools at Bray Head stating that to make these pools satisfactory further considerable expenditure is necessary, the principal defect being that of filling the pools, and no matter how effective penstocks may be conditions occur periodically throughout the summer when it is impossible to renew the water in the pools and have them full. He pointed out that he considered the only remedy for this to be the installation of suit. able pumps and had obtained tenders for the pumps and the amount of two horizontal centrifugal pumps to deal with 4,200 gallons per minute, driven by two 36 H.P. slip-ring inducation motors, together with enclosed starters, all necessary sluice valves, bolts &c. would be £770., and estimating the cost of fixing and housing of these pumps would be £150., making in all a total of £920. He estimated the cost of flooring the pools @ £450. and the fixing of concrete on the remainder of the mens' side and on the Ladies' side @ £300., making in all a total of £1,670. Surveyor, in his report, drew attention to the fact that the pumps are in duplicate but it would be satisfactory, at least for a couple of years, to rely on one pump only which would reduce the all-in total by approximately £350., bringing the total down to £1,320. Read. Referred to next Finance Committee.
- Report from Mr. Magee re Council-V-B.H. Knoxmstating that in view of Mr. kyan's opinion there would appear to be every possibility of obtaining a Decree against Mr. Knox for arrears of annuity and arrears of rent in respect of No.6,0'Byrne Road. A Meeting of the Air Raid Precautions Committee was held in the Town Hall, Bray, on Thursday, 26th October, 1939, at 8 o'clock p.m.

Present: - Councillors P. Ledwidge, (in Chair), Geo. Byrne, Hipwell, Sexton and Dunne.

- 14 Letter dated 23/10/39 from Secretary, Department of Defence, Air Raid Precautions Branch, referring to telegram sent on 7/9/39 relative to the partial restoration of public lighting and enclosing copy of an Order entitled "Emergency Powers (Control of Lights) Order, 1939" made by the Minister for the Co-ordination of Defensive Measures on the 16th October, 1939, and which comes into effect on 18th November, 1939. Agtention was drawn to Se Article 4 (a) of the Order that street lighting may be permitted provided lamps are of a power not exceeding the existing power or such other power as the Minister may direct; that the lamps are screened and that the lighting system is capable of being instantly extinguished on receipt of an air raid warning. It was further pointed out in letter that the Parliamentary Secretary has been in consultation with the Electricity Supply Board with a view to arriving at the best means by which effect could be given to the above conditions and with regard to expenditure involved, and, in this connection a schedule of the various districts in the Council's functional area in which public street lighting is operated by the E.S.B., with a provisional estimate of the cost of screening and centrally controlling the lights in each case amounting to £233-6-0d, enclosed. Read and noted.
- Letter from Mr.F. Algar, Consumers' Department, Public Lighting Section, E. S. B., dated 24/10/39, referring to provisions of "The Emergency Powers (Control of Lights) Order, 1939" and stating that the Board is prepared to carry out the work necessary to make the lighting systems already contracted for conform to the Minister's requirements, on receipt of an instruction to do so, and an undertaking to pay the costs involved from the Local Authority concerned - payment of costs to be made on completion of the work.
