The Statutory Monthly Meeting of the Bray Urban District Council was held in the Town Hall, Bray, on Tuesday, 6th May, 1941, at 7.30 o'clock p.m.

Present:-Councillors Ledwidge (in Chair), Dunne, E. Byrne, Cooney, Hipwell, Martin and Byrne.

- 2797 Minutes of Meeting of 1/4/1941 and Special Meeting of 22/4/1941. Read and signed. Acknowledgments of votes of condolence from Mr. P. O'Brien, Mr. J. Lynch, Mrs. M. Harney and Mrs. Hoctor. Noted. Votes of sympathy were passed on deaths of Miss M. O'Brien and Mrs. Kavanagh.
- 2798 Councillor E. Byrne proposed and Cllr. P. Martin seconded the adoption of Report of G.P. Committee of 15/4/1941. Passed unanimously. Letter from Mr. J. O'Farrell, Chief Engineer, Consumers' Department, E.S.B., re reductions in Public Lighting pointing out that 40/500 watt, 105/200w, and 15/100 watt lamps normally lighting to 12.30 a.m. each morning were disconnected on 25th and 29th April and that if these lamps remain out of operation for the balance of the current financial year ending on 31/3/1942 an allowance of £367.14.11d will be made to Council. 2/500w, 16/200w and 1/100 w Pilot lamps normally lighting All Night have now been changed back to Midnight lighting and will result in a further allowance of £13.8.4d: the balance of lamps remaining in operation, i.e., 14/500w, 107/200w, 61/100w and 8/60watt lamps will be switched out each night at 12 midnight instead of 12.30 a.m. and the allowance to be made to Council under this heading will amount to £30.0.3d. Read and noted. Town Clerk to make the best possible arrangements.
- 2799 Councillor J. Dunne proposed and Cllr. E. Byrne seconded the adoption of Report of P.H. Committee of 15/4/1941. Passed unanimously. Awaiting Minister's sanction to acceptance of Tender of Lucan Dairies Ltd. for supply of New Milk under the National Free Milk Scheme @ 1/9d per gallon, for period ending 31/3/1942.
- 2800 Councillor G. Byrne proposed and Cllr. Cooney seconded adoption of Report of H.&E. Committee of 15/4/1941. Passed unanimously. Councillor G. Byrne drew attention to the fact that no communication had been received from Department of Local Government in connection with repairs to Sea-wall and the Town Clerk was instructed to write a strong letter to Department concerned.
- 2801 Cllr. Ed. Byrne proposed and Cllr. Dunne seconded adoption of Report of Special Meeting of Finance Committee of 22/4/1941. Passed unanimously. Cllr. Ed. Byrne proposed and Cllr. Dunne seconded adoption of Report of Finance Committee of 29/4/1941. Passed unanimously. Letter dated 3/5/41 (G.12114/41) from Min. Loc. Govt. re estimate of rates for 1941/42 stating that the estimate as prepared should be supplemented by figures showing against each sub-head the actual expenditure in 1940-41 for comparison with the estimated expenditure for the current year. He stated it was noted that Council propose to pursue the same policy this year and that whilst the estimate as prepared shows that a rate of 34/4d is required to meet liabilities the Council propose to make a purely arbitrary reduction amounting to almost 10/- in the £ by striking 24/6d. In view of the discussions that took place last year which did not influence the Council to make reasonable provision for their expenditure no purpose would be served by going over the same ground again. Read. Town Clerk to write Minister expressing disapproval of his attitude.
- Treasurer's advice note and financial statement books. Signed.
- 2802 Cllr. E. Byrne proposed and Cllr. Dunne seconded adoption of Report of Special Finance Committee of 29/4/1941. Passed unanimously.

- 2803 Letter dated 23/4/41 (RU/208/2) from Min. Loc. Govt. stating that a local contribution of £540 will require to be provided from rates in present financial year towards the cost of employment schemes to be undertaken in Bray by the aid of a grant from the Employment Schemes Vote, 1941/42. An immediate notification should be sent to Department of the particular schemes which the Council propose to submit together with an indication of (a) cost and (b) unskilled labour content. Read. Surveyor instructed to prepare schemes.
- 2804 Report dated 6/5/41 from Surveyor in connection with proposed scheme for the production of turf pointing out that before formulating a definite scheme it will be necessary to find out if petrol will be available for the transport of the material to Bray; whether it would be possible to use the unemployed labour at Bray at a rate equivalent to that being paid in the County; what finances will be available for the carrying out of the work. He suggested that the best arrangement at the moment would be that the Council should appoint a Committee of say three of its members to co-operate with him in investigating the bogs and the financial considerations involved in this scheme, etc. Read. Matter adjourned to Meeting on 13th instant. In the meantime, the Chairman, Cllr. P. Ledwidge, Cllr. E. Byrne, Town Clerk and Surveyor to meet County Surveyor during week to discuss the question of Turf Supply.
- 2805 Pursuant to advertisement inserted in press only one tender was received for renting of Tolls of Swimming Pools & Lavatories at Bray Head, from Mr. R. Tobin @ £40 for Season from 1st June to 31st October, 1941. Accepted, subject to the full amount of tender and arrears due from last year being paid in beforehand and subject to terms and conditions of contract to be completed by Mr. Robert Tobin and his sureties. No question of rebates will be considered. Letter from Mr. H. J. Byrne, Auctioneer, enclosing cheque for £88 nett result of letting of Kiosks &c. for current season and regretting that he has not been able to let No. 3 kiosk. Read. Considered satisfactory.

218 Letter dated 28/6/41 from Parl.Sec.,Min.for Defence, stating that the question of the establishment of Food and Rest Centres as part of Council's A.R.P. Scheme has been under consideration. It is considered that provision should be made in Council's A.R.P. Scheme for about 2 Food & Rest Centres, capable of catering approximately 400 persons. Lists of suggested equipment are enclosed. In connection with staffing of centres, it is proposed that there should be 1 supervisor, 1 deputy supervisor and 6 assistant supervisors in each centre. Immediately on the establishment of the centres, full time caretakers - one for each centre - would be engaged and when the centres would begin to function these would act as caterers and accountants under the direction of the supervisors. In addition, when the centres would begin to function, 2 nurses, 2 cooks, 2 asst. cooks, 2 indoor men to act as fire lighters etc., and 2 outdoor men to act as lavatory attendants, etc., would be appointed in each. All the staffs, would be paid wages at appropriate rates and a further communication regarding the method of their recruitment is forthcoming. Read. The following places were suggested:- Drummond Institute, Ravenswell Convent, St. Gerard's Old Connaught House - these to be sent forward to Department for selection and approval.
