ANNUAL COUNCIL MEETING

THE ANNUAL MEETING of Bray Urban District Council was held in the Town Hall, Bray, on Tuesday, 27th June, 1944, at 7.30 p.m.

229 Chairman stated he was prepared to accept nominations for the Election of Chairman:-
Councillor Martin proposed and Cllr. Temple seconded:-

"That Councillor George Byrne be elected Chairman of Council until next Annual Meeting or until his successor be appointed".
~~There being no further nominations~~

Councillor Dempsey proposed and Cllr. Stuart seconded:-

"That Councillor H.J.Byrne be elected Chairman of Council until next Annual Meeting or until his successor be appointed".

There being no further nominations a vote was taken and there voted FOR COUNCILLOR GEORGE BYRNE:- Cllrs. Martin, G.Byrne, Temple, Sayers, E.Byrne, P.Lodwidge-6; FOR H.J.BYRNE:- Cllrs. Bateman, Dempsey, Stuart, Craig, Doyle, H.J.Byrne-6.

The Town Clerk stated that, as there was an equality of votes, the question would have to be decided by lot. He read out the sub-section 1 (h) of Sec. 43 of the Local Government Act, 1941, which is as follows:- "If from an equality of votes given to two or more candidates any question arises under this sub-section as to which of such candidates is to be eliminated or as to which of such candidates is to be elected, such question will have to be decided by lot". He pointed out that it would be necessary for the meeting to decide whether the 1st name drawn would be eliminated or elected, and it was decided that the procedure the same as at last Annual Meeting be adopted, namely, the 1st name drawn to be eliminated.

On a draw taking place by lot Cllr. H.J.Byrne's name was first drawn and Cllr. Geo. Byrne's name remained and he was declared elected. Cllr. Geo. Byrne then took the Chair and signed the Statutory declaration.

230 Cllr. H.J.Byrne proposed and Cllr. Stuart seconded:-

"That Cllr. James Doyle be elected Vice-Chairman of Council until next Annual Meeting or until his successor be elected".

Cllr. Temple proposed and Cllr. E.Byrne seconded:-

The Supt. of the Gardai be also written to in regard to the matter". Passed unanimously.

Answers considered unsatisfactory and a copy of reply be sent to the Gardai Siochana for their comment on the matter and the Council's decision.

We support this application by pointing out that whilst the cost of lighting was in no way reduced by using these cowls the actual lighting enjoyed by our townspeople and visitors was reduced by about two-thirds".
