It was agreed to allocate No. 5 Wolfe Tone Square, West, to Mr. John Temple, and to allocate No. 72 Wolfe Tone Square, North, to Mrs. Reilly of No. 22 Volfe Tone Square, West.

(37) Extension to Haughton's Factory

Submitted Plans for proposed extensions to Messrs. Haughton's Factory at the Fair Green.

Order: - Recommend approval in accordance with the Plans and Specification submitted.

(38) Repairs to surface at corner of O'Byrne and Vevay Roads

The Town Clerk informed the Council that Mr. P. J. Toomey, Rathgar, Dublin, had requested the Council to carry out repairs to the surface at the corner of O'Byrne and Vevay Roads. The estimated cost of the concreting of the surface at this point was £43 los Od and a cheque for this amount had been sent to the Council by Mr. Toomey.

Councillor John Temple indicated that the I.T.G.W.U. had demanded that the workmen to be engaged on the conreting of the surface should be paid at the rate of 2/3d per hour which was the rate payable generally for road workers in the Urban area. He represented that the work proposed to be carried out could not be considered as the normal work of the Council. It was, in fact, a sub-Contract and, consequently, the I.T.G.W.U. would be compelled to insist that the rate of 2/3d per hour should be paid in respect of the work. The County Manager indicated that he was not prepared to agree that/rate of 2/d per hour should be the paid and pointed out that the Council had no obligation whatever to do the work for Mr. Toomey. Following discussion it was agreed to request the Minister for Local Government to approve of the payment of the sum of 2/3d per hour to workmen engaged by the Council in carrying out direct labour and repairs to footpaths, generally.

(39) Tool Shed at Rathmore Terrace - Submitted Plans by Mr. J. J. Cullen

Submitted Plans by Mr. J. J. Cullen for permission to erect a shed at Rathmore Terrace. The Town Clerk intimated that it was not quite clear whether the land upon which Mr. Cullen proposed to erect the Tool Shed was the property of Mr. Cullen or the Council. It was decided, consequently, to request Mr. Cullen to produce Title to the piece of ground.

(43) Wicklow Arts Limited - Factory at Harbour

Submitted Plans and Specification for proposed erection of a Factory at the Harbour for Wicklow Arts Limited.

Order:- Recommend approval in accordance with the Plans and Specification submitted.

The Town Clerk intimated that the Earl of Meath was owner of approximately one quarter of the piece of ground upon which the Factory would be erected. The Council already has entered into an Agreement with Wicklow Arts Limited for the payment of £20 per annum for the site. It was agreed, consequently, to pay an amual rent of £5 to the Meath Estate in respect of that part of the land which was their property.

(44) "Craglea" Newcourt Road, Bray.

The County Manager informed the Council concerning proposed proceedings to be instituted against the Council by Mr. J. J. Byrne, requesting specific performance of an Agreement to purchase the premises known as "Craglea" Newcourt Road. The County Manager intimated that Agreement had been signed by himself and the Chairman, that the Seal of the Council had not been affixed to the Agreement. The Manager explained the circumstances which had led up to the position whereby the Council had itself to re-purchase the premises at a total cost of approximately £570. There had, he said, been negligence on the part of former Officers of the Council which had led to the Registration of a Charge being mrde by Mr. McCambridge in respect of the premises.

An apology for inability to attend was received from Clr. J. Temple.

Officials present: - County Manager, Town Surveyor and Town Clerk.

(84) Housing allocation

Mr Downes, St. Kevin's Square, to whom a Council house had been allocated, appeared before the Council to answer allegations made against him that he had a house and shop in Dublin. He stated that the allegations were untrue and that he had resided at 4 Mespil Cottages, Dublin, as a tenant for some years, but had to have the premises. He was prepared to swear that the allegations were untrue. He had neither a shop nor a dwellinghouse in Dublin. The Council accepted his explanation and agreed that the house at Golf Links Site should be allegated to him.

(85) Draft Town Plan

The Council considered further the provisions of the Draft Town Plan as prepared by Mr. E. M. Murphy. The Minutes of the Council of the 17th January, 1949, were discussed. It was agreed that the island at Castle Street should be removed eventually and the site suitably laid out in shrubs, etc.. The site upon which Meade's Cottages are situated should be used eventually for the erection of a private dwelling house or houses. Consequently, the intention to have a road from the Housing Site at Dublin Road to connect with Old Connaught Avenue should be abandoned.

It was decided to amend the Draft Town Plan by the deletion therefrom of the proposed roads adjacent to the Dumping Ground and the Harbour.

Following discussion of the projected road from Killarney Road to Lower Dargle Road (as provided in Draft Town Plan) it was decided to defer the matter to a later date pending an inspection of the area traversed by the proposed Road and for examination of the contours and levels. In the opinion of the Council the projected road would not lead to any satisfactory development of the area. The Council considered that the 12" sewer referred to in Minutes of Meeting of the 17th January, 1949, running from O'Byrne Road via Boghall Road to the River Dargle would not serve the purpose indicated therein. It was decided, therefore, to defer consideration of the matter until a later date in conjunction with the consideration of the proposed road in the same area.

(86) Control of Advertisements

Mr. G. H. G. Stuart referred to a Neon Sign which had been erected at premises on Novara Road. The County Manager explained that the Council had no power at the present time to control the exhibition, etc. of advertisements of the nature complained of in this instance. The Advertisement Regulations Act, 1907, did not confer sufficient power upon Local Authorities to prohibit advertisements where they were less than 12 feet in height or were placed elsewhere than in a Public Park, Pleasure Ground or Esplanade.

It was proposed by Clr. E. O Beagain seconded by Clr. E. E. Byrne and resolved:-

"That in any proposed amendment to Local Government powers provision should be made to give Local Authorities powers given to Northern Six Counties to control advertisement signs with larger definitiin of Advertisement Signs"

(87) Submitted Letter from Mr. J Carr, Northview, Strand Road, regarding flooding at Putland Road and a wall which he states had been demolished some years ago at Strand Road.

The Surveyor intimated that the flooding of Putland Road was not the responsibility of the Council since the Gulley Trap (the cause of the flooding) inside the grounds of the Coast Guard Station, was not the property of the Council. There was no record available that the wall referred to had been demolished in connection with the Motor Car Races. It was decided to request Mr. Carr to submit a Plan showing the site of the wall and particulars indicating the date upon which it had been demolished.

(88) Proposed shop at No. 1 O'Byrne Road

Submitted Plan by Mr. Scully for proposed erection of a shop at the premises No. 1 O'Byrne Road. The Plan indicated that the structure was within the area of the site leased by the Council to Mr. Scully under the Tenant Purchase Agreement. The land upon which the structure is proposed to be erected is the property of the Council and is subject to a yearly perpetual rent.

The structure, if erected, would infringe the building line and would increase the building density in the area which is a residential one. Consequently, the Council could not grant permission for the structure under the Housing Acts or Town Planning Acts.

(89) Structure at rear of No. 16 Wolfe Tone Square, North

Submitted Plan for the proposed erection of a structure by Mr. J. Hayes at No. 16 Wolfe Tone Square, North.

It was agreed to convey approval to the structure providing it is erected at the rear of the house No. 16 Wolfe Tone Square, North, and complies with the requirements of the Town Surveyor.

(90) Fire Brigade Service

Submitted letter from the Department of Local Government regarding improvements, etc. to the Fire Brigade Service.

It was decided that the telephone Bell system (or Buzzer System) should be installed in the homes of the personnel of the Brigade in preference to the electric siren at the Town Hall recommended by the Department. It was agreed that the Fire Tender should be painted and that an advertisement be inserted in "The Wicklow People" for this purpose.

It was agreed that Mr. Toole the driver of the Fire Tender should be allocated a house at Vevay Road so that he can be readily available in the event of a Fire Call.

(91) Building on Derelict Sites

The Council approved of House Designs in respect of eighteen houses proposed to be erected by the Wicklow County Council's Direct Labour Organisation on various Derelict Sites within the Township. The rents proposed to be charged for the new houses are as follows:-

Plan A (floor area 690 square feet) 13/8d per week inclusive of wtes

Plan B (floor area 806 square feet) 15/ Od per "

House of the Plan A type and house of Plan B type will be erected. Plans to be submitted by the County Engineer in respect of two sites upon which two bungalows will be erected.

(92) Additions to Bray Head Hotel

Submitted Plan for proposed erection of a Lounge Conservatory and staff accommodation at the Bray Head Hotel.

Order: - Recommend approval in accordance with Plans and Specification.

(93) Wicklow Arts Limited

Submitted letter from Wicklow Arts Limited intimating that it was their intention to acquire an area of land surrounding the factory site at the Harbour which the Council had already leased to Wicklow Arts Limited for the factory premises. It was agreed to leave an additional tract of land measuring 15 feet depth from the eastwards boundary of the factory premises and to retain a right-of-way for dumping etc. by the Council between this boundary line and the sea.

The Chairman referred to the many benefits which the Earl of Meath had bestowed upon the Town and its people.

The Meeting adjourned as a mark of respect to the late Earl of Meath and resumed at 8 p.m.

140. Councillor G. Doyle.

The Council expressed their good wishes to Clr. G. Dovle upon his retirement and hoped he would enjoy his retirement for many years to come.

141. Employees of Solus Teoranta

A deputation was heard on behalf of a number of employees who had lost their employment in Solus Teoranta. Mr. O'Brien on behalf of the Deputation indicated that approximately 30 men had been discharged in November last on the grounds that the Plant required repairs. The Plant, however, was since in working order and the men had not been re-employed. It had been rumoured that the men would not be re-employed.

It was understood that the Company were importing bulbs with consequent reduction in employment and that some of the men concerned had had to emigrate as a result.

The Council decided that a Deputation should be appointed to interview the Directors of the Company to ascertain if anything could be done to alleviate the hardship imposed upon the employees and their families by reason of their dismissal. If the Directors of the Company refused to receive a Deputation in the matter it was agreed that the Minister for Industry & Commerce should be asked to intervene in the matter.

The following members were appointed to constitute the Deputation, viz., Clr. H. Byrne, P. Ledwidge, D. Sayers, and G. Doyle, together with the County Manager.

142, Publication of Council's Proceedings

Following the adoption by the Council at its Meeting on 14th Sept., 1948, of Part III of the Local Government (Superannu tion) Act, 1948, with effect from the 1st April, 1949, six employees, viz., T. Brien, C. Stalton, J. Sutton, T. Byrne, D. Pluck and J. Garvey, are eligible to retire as from that date.
