Pavilion at People's Park.

It has been submitted to the Council that Dressing accommodation at the People's Park, Lower Dargle Road, is very necessary for the football teams which use the Playing Pitch, and the Council agreed to give the matter further consideration when examining the Annual Estimates. The cost is estimated by the Surveyor at £250 and thus sum is included in the Estimates.

Band Performances

Last year the Council decided, after the adoption of the Estimates, to allocate a further sum of £50 for Band Performances. The Amusements Committee recently asked that the rate for this purpose be increased to 3d in the £. The same sum as allowed last year (£150) is shown in the Estimates.

School Meals.

The decision to withdraw State subsidies from bread and butter used in the School Meals provided by Local Authorities has resulted in an increase in £186 in the amount required from Rates for this service.

Printing, Stationery and Advertising.

Owing to recent increases in the charges for Printing, Stationery and Advertising this item shows an increase of £75 (£550 for 1951/52; £475 in 1950/51).

Civil Defence

The Council was instructed some time ago by the Department of Defence to undertake the preparation of a Civil Defence Scheme under the Aid Raid Precautions Act, and in the first instance, to arrange for the appointment of a Civil Defence Officer who would undergo a special Course of Training. The sum of £200 is intended to cover the Council's share of the cost of part of a year only; it is expected that 60% of the outlay will be recouped by the State. Next year, however, the expenditure on Civil Defence may show a marked increase, as special stores, equipment, etc. will have to be obtained.

When the former Scheme was in operation due provision was not made for the Council's contribution from Rates towards its cost. Fortunately, however, the increases in prices of materials and storing of supplies in 1946 to 1947 enabled the Council to dispose advantageously of ambulances, stocks of equipment etc. and thereby to liquidate a very large debit balance which had accumulated on the Acount for the Service. The efficiency of the Service was also impaired by the lack of an Officer with complete responsibility for the Service.

Harbour Store

The Town Surveyor has recommended repairs to this Store at a cost of £200.

Provision of New Stores.

Since the filling of the vacant position of Storekeeper efforts have been made to improve the keeping of Council's Stores and the storage accommodation. There is a lack, however, of sufficient storage facilities at the Town Hall and it is suggested that further storage accommodation might be found by constructing an addition to the new Fire Station which the County Council is arranging to erect on the site known as "The Pound" adjacent to the Town Hall. It should be mentioned that it essential to retain this plot for a Fire Stores, Stores Building, and for storage in the open of materials for Housing Schemes, Water Supplies, etc., and Consequently it is inadvisable to let any part of it to any outside organisation.

County Council Demand.

As already mentioned the County Council Demand shows an increase of £3,122 equivalent to 1/4d in the Rate levy. The Demand compares as follows with that for the present year :-

It will be noted that the major increases occur under the headings of Main Roads and Mental Hospitals. Owing to the increases in costs of materials and wages the County Council had to make additional provision for Main Roads and the Demand from Grangegorman Mental Hospital again showed an increase.

Unemployment Assistance Acts Levy

This is the product of a special rate of 9d in the £ which the Council is required to raise under the Unemployment Asst. Acts, 1933 and 1949. The money is paid to the Department of Social Welfare. The levy which is based on the gross valuation, excluding Council houses and a few minor items, bhows an increase of £60. Incidentally, the fact that this change and the County Council Demand are based on gross valuations, rather than valuations actually assessed to Rates, is a further proof of fallacy of the argument (and many more could be adduced) that the addition of new dwellings (which are only rated in part for the first seven years) is of unqualified benefit to an Urban community.

Comparison of Rates.

Reference already has been made to the comparative stability of the rate levy in the past 10 years. Prior to 1947 the Council levied two Rates, viz. a Poor Rate to meet the cost of the County Council Demand and the Unemployment Assistance Acts Assessment, and a Town Rate to meet the cost of Urban Services.

In the years 1937 to 1938; 1938 to 1939 and 1941 to 1942 the Town Rate was 14/- in the £. In the present year (1950/51) the expenditure on Municipal (Urban) Services for which provision was made in the Annual Estimates represented a rate of 14/- in the £. In the period between 1937/38 and 1950/51 prices of all commodities have increased to a marked extent and reference already has been made to the effect of wages and salary increases.

Moreover, in the past six years the Council has liquidated a substantial debit balance accrued in previous years and has been able to administer the Council's Services in the past three years without resort to Overdraft accommodation. It would probably be true to say that a Rate of 14/- in the £ in 1937/38 would represent between 30/- and 40/- in present day monetary values. It is to be regretted that, when the Town Rate was relatively high Schemes of progressive Works such as the relaying of Watermains and Reconstruction of Roads were not undertaken and that they have to be carried out nowadays at much higher cost and under difficult supply conditions.

Once again I desire to express sincere appreciation of the co-operation and assistance which has been received from the successive Chairmen of the Council and the Members in the past year. Local administration is each year making an increased demand on the time and ability of elected representatives as is evident from the increase in the number of problems on which decisions have to be taken and the number of Meetings to be attended. The satisfactory service given by all members of the Council's staff, both indoor and outdoor, must also be mentioned. The preparation of the Estimates and the review of your services was much facilitated by the thorough manner in which the Town Clerk (Mr. Fennell) kept the necessary records and supplied all relevant information, and valuable assistance was also given by the Acting Town Surveyor and Staff Officer.

209. Housing Allocations.

Councillor Ledwidge referred to Item No. 106 in the Minutes of 28th February regarding Housing Allocations and intimated that he pro posed to hand in a Notice of Motion to have the Minute, rescinded.

210. Housing Allocations

Clr. Temple referred to Item 204 in the Minutes of 29th March, regarding the allocation of a house at 5 Wolfe Tone Sq. South to Mrs. Kavanagh, 26 Wolfe Tone Sq., East. He stated that he was unaware that the matter had been considered by the Council. Although he was in fact in favour of the allocation of the house to Mrs. Kavanagh he represented that the Minute was not an accurate record of the decision of the Council in the matter of the Housing allocations.

211. Votes of Sympathy

The Chairman on behalf of the Council tendered a Vote of Sympathy to the relatives of the late Terence Byrne, 7 St. Kevin's Square, a former employ ee of the Council.

"That in view of the Minister for Local Government's statement that drains will be opened on rivers to prevent flooding, that a Grant should be sought to alter the bed of the River Dargle to prevent further flooding in Bray. The ex-Town Surveyor has already submitted a report on this matter."

217. Holding of Council Meetings in Public

Upon the request of the Council Clr. McLoughlin withdrew the following Notice of Motion which appeared in his name on the Agenda Paper viz.,

The Amendment having been declared carried was put as a substantive Motion and carried with the same.division.

220! Audit of Accounts of Council.

Submitted Report of Mr. R.M. Barragry, Local Government Auditor, upon his audit of the Accounts of the Urban Council, for the financial year ended 31st March, 1948.

The County Manager in reply to Cir. McLoughlin stated that the amount outstanding in respect of excess Water Charges was attributable to the fact that the sums referred to in the Auditor's Report represented a debt to the Council in respect of water to be used for building purposes which was recorded in the Accounts immediately upon the issue of approval Notices under the Building Byelaws. The sum would not be payable until work had commenced but were shown as being due in the Accounts, nothwithstanding the fact that frequently the works in respect of which the charge was made might not be proceeded with. "That we, the Members of the Urban District Council protest against the action of the British Government in introducing the Ireland Bill in the House of Commons."

(263) Religious Services on the Esplanade.

Clr. L. J. McKeown informed the Council that he had received letters from certain persons critising his statements regarding the holding of Religious Services on the Esplanade. He stated that he strongly resented such action.

(264) Housing Scheme.

St. Peter's Road. Mr. E. M. Murphy, B.E., submitted a Plan indicating his proposals regarding the erection of a wall along Old Connaught Avenue at the rear of the Housing Scheme. The total cost of the erection of the wall is estimated at £130. The plan provides for a "cut-off" at the junction of Dublin Road and Old Connaught Avenue. It was agreed to authorise an expenditure of approximately £130 for the erection of a wall. It was agreed that two additional houses be erected on this site in accordance with the Plan submitted, and that the footpath and roadway be completed at an estimated cost of £220.

Mr. Murphy was directed to report upon the wall around the premises of Messrs. Thomas Heiton, Fuel Merchants, Members of the Council represented that the wall might constitute a danger to existing property.

Hudson's Terrace. It was decided to obtain the opinion of the Council's Solicitors regarding the right-of-way to the back of the Housing site at Hudson's Terrace. Mr. Murphy was requested to ascertain the cost of erecting a wall between the School and the Housing Site.

Vevay Road. Mr. E. M. Murphy submitted a Plan indicating a proposed access road at the Vevay Road Housing Site. The estimated cost of the construction of the road, etc. is £120. It was agreed to authorise the expenditure of this sum for the purpose.

(265) Manager's Orders.

The County Manager's Orders No. 6392 to No. 6431, as circulated, were discussed.

(266) Landlord and Tenant- Rent Restrictions Act.

Submitted letter from Council's Solicitors advising in connection with appeals from persons requesting the Council to compel owners of premises to carry out repairs to the houses occupied by complainants. The County Manager intimated that the Council could issue a Certificate under the Rent Restrictions Act certifying that the premises occupied by the tenants were in an unsatiafactory condition, and such Certificate would be prima facia evidence and would assist the tenants in a claim for reduction of rent.

The Manager also intimated that he was of the opinion that the Council should not become involved in issues of this nature under the Rent Restrictions Act arising between Landlords and tenants.

Order:-

County Manager's action approved.

(267) Resolution from Athlone U.D.C.

Submitted Resolution from Athlone Urban District Council in connection with the amendment of the Local Government (Rates on Small Dwellings) Act, 1928.

Order:-

Adopt.

(268) Petition from residents of Galtrim Park.

Submitted petition from residents of Galtrim Park regarding the condition of the roadway. Messrs. White and Meares, Solicitors, on behalf of the owners of the property on which the road is constructed, intimated that their clients would be prepared to dedicate to public use the roadway known as Galtrim Park and the cul-de-sac abutting thereon. The Manager informed the Council that the cul-de-sac was in a bad state of repair and could not be taken over by the Council until it was put into a proper state of repair. It was agreed to take over the thoroughfare known as Galtrim Park Pending the completion of the Deed of Dedication, the Town Surveyor was directed to have some tar patching carried out on the roadway.

(269) "Exclusif" Photographers, Dublin - erection of Kiosk

Submitted letter from "Exclusif" Photographers, Dublin, requesting permission to take photographs on the Esplanade during the years 1950 to 1954 inclusive, and asking for authority to erect a Booking Office on the Esplanade.

It was agreed to grant an option of the Photographic Rights to "Exclusif" Photographers for the five years commencing from theyear 1950, at a rent of/£115, £125, £130 and £135 in respect of each/£100 of the years of the Licence. Permission was granted for the erection of a temporary structure on the Esplanade for the present year. It was agreed that the Council should erect a Kiosk on the Esplanade and let same to "Exclusif" Photographers at an annual rent representing 8% of the cost of the erection of the Kiosk.

(270) Bray C.I.E. Social Club - Application.

Submitted letter from Bray C.I.E. Social Club requesting permission to erect a Marquee on the Esplanade for dancing.

Order:-

Recommend that permission be granted at a nominal rent of £5 for the season. The decision can be reviewed if objections are made by residents in the vicinity.

(271) Bray Head Park Bye-Laws.

It was proposed by Clr. H. J. Byrne seconded by Clr. J. French and resolved:

"That the Rye-laws with respect to the Bray Head Park be amended by the making of the following additions:-

Bye-Law 13(a): A person shall not light any fire in any part of the Park or burn or do any act which might cause any timber, wood, brushwood, gorse, heather, furze, earth, fern, paper, rubbish or other substance to take fire or be burned in any part of the Park.

Bye-Law 13(b): A person shall not carelessly or negligently injure or destroy any timber, wood, brushwood, gorse, heather or furze in any part of the Park."

(272) Revision of Salaries of Officers of the Council.

An expenditure of approximately £270 was authorised to meet the costs arising out of the revision of Officers' salaries, as sanctioned by the Minister for Local Government. An increase not exceeding 7½% has been authorised by the Minister retroactively from the 1st November, 1948.

(273) Pollard's Terrace - Loan of £600.

Submitted Draft Mortgage in connection with Loan of £600 being borrowed from the Treasurer for the purchase of houses at Pollard's Terrace.

Order:- Approved.

(274) Sewage disposal at Harbour.

Petition from residents adjoining the Harbour requesting the Council to effect improvements in the sewage disposal at the Harbour.

Order:- Defer to next Statutory Meeting of the Council.

(275) Harbour Bridge.

It was decided to restrict the traffic on the Harbour Bridge to vehicles with gross weight not exceeding 3 tons.

(276) Kay's Hotel Novara Road - application for permission to erect Store Rooms

Submitted Plan for proposed erection of Store Rooms at Kay's Hotel, Novara Road.

Order:-

Recommend that permission be granted subject to agreement being reached between Mr. Kay and the owner of the adjoining premises.

(277) Structure at Vevay Road for Mr. J. Doyle.

Submitted Plan for the erection of a structure at Vevay Road for Mr. J. Doyle.

Order:- Recommend that permission be granted.

(276) Tenancies of Council's Houses.

Councillor Sayers moved the following Motion:-

"That I, or someone on my behalf, will move at the next Statutory Meeting of the Council that the decision of the Council regarding the letting of No. 5 St. Patrick's Square be rescinded in order that the letting may receive further consideration."

(279) It was agreed to allocate this house (5. St. Patrick's Square) to Mr. John Murray, 8 rear Prince of Wales Terrace, Bray, Clr. H. J. Byrne dissented.

The Council directed that proceedings be instituted against Mr. Boughton and Mr. Maloney who had taken up tenancy of the premises 5 St. Patrick's Square and 4 Bergin's Lane, respectively.

(286) Small Dwellings (Acq.) Acts - I I A Hogan

Upon the request of the Council Fig. C. C. A. Hogan, Moyleen, Putland Road, Bray, applicant for an advance under the Small Dwellings (Acq.) Acts, submitted the name of an Architect, viz. Mr. P. McMahon, 28 Adélaide Road, Dublin, who would supervise, on his behalf, the erection of a house at the New Road, off Newcourt Road, which Mr. Hogan proposes to acquire by means of a Loan under the Small Dwellings (Acq.) Acts.
