(356) Fire at Royal Marine Terrace.

The Town Clerk read a report from the Water Inspector and Station Officer to the Fire Brigade intimating that he had received a call on Sunday 26th June, 1949, at 3-35 p.m. to attend a fire at Royal Marine Terrace, Bray, and arrived at the scene of the fire immediately.

He noticed a large volume of smoke issuing from the central chimney stack of Nos. 2 and 3 Royal Marine Terrace. With the assistance of three members of the Brigade, whom he had contacted, he laid down a length of hose and erected a ladder to the roof of the houses. Mr. James Toole and others were engaged at a fire outbreak on Bray Head. He found it impossible, however, to fight the outbreak from roof in view of the heat of the slates which were red hot and which indicated that the fire had reached a serious stage underneath the roofing. Entering the building with some firemen he found the ceiling of the top floor of No. 2 Royal Marine Terrace ablaze. It fell in immediately whereupon he discovered that the whole roof was alight. In view of the serious nature of the outbreak he arranged for the attendance of the Dun Leoghaire Fire Brigade which arrived at 4 - 10 p.m..

It was decided, with the approval of the Officer in charge of Dun Laoghaire Brigade, to work off the high pressure main at Albert Avenue since the pressure of the hydrent was insufficient and in view of the fact that the tide was out. This necessitated the use of approx. 2,000 feet

The fire was brought under control at 9 p.m.. The Dun Laoghaire Brigade left at 11 p.m. and Council's Brigade was retained until 4-20 a.m. on the following morning.

The Water Inspector went on to state that he had received a verbal statement from a tenant of one of the premises to the effect that he (the tenant) noticed smoke issuing from No. 2 Marine Terrace at approximately 12 o'clock noon and believed that the chimney was on fire. Later, at 2-30 p.m., the tenant saw what he described as a "red glow" or "reflection" and heard a crackling noise. At 3-20 p.m. the Fire Brigade was summoned. The Report of the Water Inspector stated that the new Fire Tender was not brought to the scene of the fire because he was aware that there was insufficient pressure at Royal Marine Terrace to supply the Unit, and also in view of the fact that the tide was out,

Clr. J. French represented that the fire should never have assumed the proportions it did. It was a reflection on the Town of Bray that these houses should have been burned down. He stressed that the members of the Brigade were not blameworthy. It was lack of proper equipment which handicapped the men, He felt that the new Tender should have been used to fight the outbreak and maintained that the Township was large enough to operate a permanent full-time Fire Brigade Service.

Clr. G. H. G. Stuart agreed that the new Tender should have been brought to the scene of the fire, but at the same time expressed the view that, owing to lack of water pressure, it did not matter what equipment was used, it would have been useless in the circumstances. He advocated the appointment of a County Fire Brigade Officer.

Clr. P. McLoughlin stated that the members of the Council had done everything possible to improve the Fire Fighting Service, and he suggested that the officials should be responsible for implementing its re-organisation,

Clr. L. J. McKeown pointed out that criticism had been levelled unfairly at the members of the Council who had provided the money for new appliances etc. and felt that an explanation was necessary from the officials of the Council He said that in the matter of Sewers and Watermains the present Council was not responsible for their condition.

Clr. P. Ledwidge said he felt sorry for the three men he saw fighting the outbreak. They did their best under the circumstances. He could not understand why the staff sent to Dublin Fire Brigade Headquarters were not available. The Buzzer Telephones had not yet been installed in the houses of the personnel. The Council had done everything in the matter of the provision of necessary money for the Service and felt that an explanation should be forthcoming from the Officials of the Council,

Clr. J. Temple said he was of the opinion that some of the tenants of the houses were blameworthy in not reporting the fire for some considerable time. He believed that the Tara Street Fire Brigade would have been unable to control the fire. The members of the Council's Fire Brigade did their best in the circumstances.

Clr. D. Sayers intimated that he could not understand why there was delay in the re-organisation of the new Brigade and referred to occasions when he had raised the question at previous Meetings of the Council in the matter. He was then given to understand that the old Fire appliances would be used.

Clr. E. O Beagain said that from his experience the staff performed their duties as efficiently as elsewhere. They deserved credit on that account. There appeared, however, not to have been proper appreciation on the part of the property owners or on the part of the staff as to the determination of the action which should have been taken on the occasion,

The Chairman said that in his opinion no Fire Brigade could have saved the buildings at Royal Marine Terrace. It was, he stated, no fault of the Council and its staff that the Buzzer Telephones had not been installed. The criticism levelled by onlookers was irresponsible and they would not appreciate the difficulty facing the officers in the matter of the provision of watermains at Seapoint Road, which had been ordered many morths ago. So, too, have the Buzzer Telephones and the Syren. Both of these were on order for some time. Everything that could be done by the Officials was done to ensure that an efficient Brigade was available for fire fighting. Some of the personnel of the Brigade were simultaneously engaged in fighting a fire outbreak at Bray Head. In his opinion he said a certain amount of responsibility rested upon the occupants of the houses who failed to notify the Brigade within the proper time. If sufficient notification of the fire outbreak had been received an adequate supply of water would have been available as the tide was then in. He deplored the loss of the property which had arisen, but, at the same time, the responsibility rested upon the occupants of the houses who, it seemed, failed to notify the Brigade in sufficient time. Everything that could have been done by the Council's employees had, in fact, been done to prevent loss to the property upon the occasion.

The County Manager explained that the Brigade was a parttime one only and consequently it could not be expected that the service could compare with a full-time permanent one, If the Council thought that a full-time Brigade was essential, then the cost of same would amount to approximately £8,000 per annum, or, 4/- in the £1 in Rates,

The Brigade had fought nearly 40 fires within the past 12 months and there was no reason for complaint. All the fires had been extinguished because sufficient notice had been received. This was not the case in the present instance,

He said that lack of cable was responsible for the fact that the Buzzer system was not in operation. The Syren had been ordered for some time. The personnel of the Brigade had been trained in Dublin, so, too, had the driver. It was no fault of the Council or the officers that the water pressure was inadequate at Seapoint Road, etc.. The matter of the provision of new watermains was under consideration.

As the Water Inspector had stated, it was not possible to bring the new Tender to the scene in view of the lack of water.

The delay in notification of the fire was largely responsible for the damage caused to the buildings, and he agreed with the Report of the Officer of the Dun Laoghaire Fire Brigade that nothing could have been done at the time of receipt of the fire call to save the buildings from being damaged by fire.

The Town Surveyor expressed the viewpoint that the call had been received too late to allow the Brigade to cope with the fire. The men had done everything possible to prevent damage, and stated that the officer of Dun Laoghaire Brigade had intimated that the Bray Fire Brigade had acquitted themselves very well in their efforts to control the fire outbreak.

(357) Recruitment of Workman

It was decided to edent the recommendation of the County Manager regarding the appointment of six workmen. The names of the persons concerned are:-

The Chairman, on behalf of the Council, tendered a vote of sympathy to the relatives of the late Mrs. Kelly, 62 Wolfe Tone Sq., N. Mr. Mullen, 9 Carlton Tce., Mrs. O'Neill, Corke Abbey, Miss Hutchinson, Sidmonton Road, Miss Kirwan, 5 Gertrude Tce., and Mrs. Doyle, 65 O'Byrne Road.

442. Confirmation of Minutes

The Minutes of Meetings of 5th, 12th, 19th and 26th July, were read and signed.

Atising out of Minutes Clr. Ledwidge complained that in the past, information which he had specifically requested from Officials had been refused. He mentioned aspecific instance in the case of a request that details of money expended on the Park Lodge be furnished. The County Manager, Mr. Flannery, stated that he had no recollection of such a request having been made and that the request was not recorded in the Minutes. It was unanimously decided that this information be furnished for the next Meeting.

Arising out of the question of joint tenancies Mr. Ledwidge objected that a bed precedent had been created by the joint tenancy of Messrs McEvoy and Tobin, Wolfe Tone Square. It was pointed out to Clr. Ledwidge that this action was not a precedent as a similar position had arisen once before. Councilor Ledwidge contended that it was in fact no precedent and that no analogy existed between the previous case and the present one.

443. Manager's Orders

Arising out of Manager's Orders Councillor French suggested that investigations be made to ascertain whether prosecutions could be enforced for creating dirt on the seafront by spreading of litter. The County Manager was of the opinion that we could not prosecute for this offence. It was suggested that cars are being driven on to the seafront recently and that a notice Board should be erected at the entrance to the Municipal Baths. It was decided also, that the Caretaker be pressed to prosecute for various infringements of the Byelaws at the Esplanade, and that the Council's Law Agent be requested to attend the Court to emphasize our difficulties when prosecutions in respect of these misdemeanours were coming before the District Judge.

The Chairman then read a letter which he proposed to send to the Irish Press giving his observations on a letter published in the Irish Press, deploring the condition of the sea front. The Council endorsed the sentiments expressed.

444. Motice of Motion Clr. P. Ledwidge

Clr. Ledwidge expressed the opinion that too much money was being expended on Engineering Fees. Consulting Engineers were being appointed when unnecessary, with particular reference to the examination of the flooding position at Little Bray, and the commissioning of outside Engineers to submit reports upon the condition of houses at Wolfe Tone Square.

There was some discussion on the subject. Clrs. French, G.H.G.Stuart and J.Temple avering that the Surveyor's duty was a full one and that extraordinary works could not be placed on his shoulders.
