(491) Park Lodge - Expenditure on Repairs

AND WHEREAS the making, amending or revoking of a Bye-Law is a reserved function under the County Management Act, 1940.

NOW WE the Council of the said Urban District of Bray in Statutory Meeting duly assembled, acting in pursuance of the said recited powers and of every and any other powers in that behalf enabling us do hereby make the under-written Bye-Laws as additional Bye-Laws to the Bye-Laws of 1932, and the provisions of the Bye-Laws of 1932 as to penalties and otherwise shall apply to the underwritten Bye-Laws in the same manner as if these Bye-Laws were originally contained in the Bye-Laws of 1932."

Bye-Law No. 13. .

A person shall not light any fire in any part of the Park or burn or do any act which might cause any timber, wood, brushwood, gorse, heather, furze, fern, earth, paper, rubbish, or other substance to take fire or be burned in any part of the Park.

Bye-Law No. 13B.

A person shall not wilfully, carelessly, or negligently injure, spoil, or destroy any timber, wood, brushwood, gorse, heather, furze, fern or any shrub or flower in any part of the Park.

Made and adopted under the Common Seal of Bray Urban District Council on this 27th day of September, 1949.

Submitted Report of Mr. Desmond Fitzgerald, Consultant Architect, regarding proposals for the erection of houses at Old Connaught.

The Report indicated that the Scheme for the erection of houses consisted of two stages. Stage 1, in effect, would be an extension of the existing Housing Scheme at St. Peter's Road. The field proposed to be developed consisted of the field used by the Greyhound Racing Association, and that owned by Mr. Gorham and Mr. Fitzpatrick.

Approach may be obtained to the proposed Scheme through the existing Housing Scheme at the junction of Old Connaught and Dublin Road. The access road passes the rear of the Cemetery to a small open space which, it is understood, has been acquired as an addition to the existing Cemetery at Little Bray.

Access for pedestrians can be obtained through the existing laneway into the field used by the Greyhound Racing Association. The second stage of the Scheme provides for the development, later, of the land owned by the Cassell family and in respect of which the Council has already made a Compulsory Purchase Order.

Stage 1 of the Scheme provides for the erection of approx. 250 houses.

The Chairman stated that the population of the Town of Bray had increased by more than 30% since 1926, and consequently the housing problem in Bray was much more difficult than that facing other Local Authorities, with the possible exception of Dublin Corporation. The Urban Council were not dealing with a static situation. The population of Bray would continue to increase and every effort must be made, with the least possible delay, to prepare a programme for the erection of

sufficient houses to meet the present needs and estimated needs. He said that the 91 Houses Scheme just now completed was costing the Ratepayers a sum of 6d in the £1, and that the new Scheme would cost an additional 1/- in the £1.

It was proposed by Clr. J. Temple, seconded by Clr. G. Doyle and resolved:-

"That having considered the Report of Council's
Architect on sites for housing, we hereby approve
of the acquisition under the Housing of the Working
Classes Acts of lands measuring approximately 24
acres at Old Connaught, Bray, as shown on the Map
submitted by the Architect with his Report."

Healy and Child Welfare Centre, or at the Dispensary.

(625) County Manager's Orders

The County Manager's Orders (No. 6675 to 6702) as circulated were discussed.

(626) Right-of-way at Fr. Colahan Terrace

It was agreed to permit Mr. Kelly of Main Street to use the road at Council's Housing Scheme at Fr. Colahan Terrace to permit him to gain access to the rear of his premises, subject to the payment of a nominal sum of 1/- per annum and to the condition that the weight of the vehicles using the road should not exceed 2 tons.

(627) Housing Site at Boghall

Submitted letter from the Department of Local Government regarding the proposed Housing Scheme at Boghall. In this connection a Circular dated 29/11/1949 was read from the Department of Local Government intimating that Loans for the development of Housing Sites would be repayable on the annuity system over a period of 35 years at 3½% per annum. The Department's letter of the 8th November, 1949, approved of the raising of a Loan from the Local Loans I nd for the acquisition and development of the site at Boghall.

It was proposed by Clr. H. J. Byrne, seconded by Clr. J. French, and resolved:-

"That we hereby approve, subject to the sanction of the Minister, to the raising of a Loan of £6,000 from the Commissioners of Public Works, repayable in 35 years with Interest at 3½, for the purpose of defraying the cost of the acquisition of land at junction of Boghall Road and Bray - Greystones Road, and the development of such land for the purpose of Housing under the Housing of the Working Classes Acts."

The lay-out plan submitted by the Consultant Architect provided for the erection of 42 houses. Twenty-two are to be built by the Council and the remaining 20 sites to be let to persons desiring to build houses for their own occupation.

It was decided to insert an advertisement in the Wicklow People" inviting applications from persons desirous of building their own houses on the site, at a later date.

In the selection of tenants for houses to be let at economic rents the Council decided that tenants shall be selected having regard to their incomes and the number in their families. It was decided, in the allocation of houses to be let at economic rents, to exclude persons whose incomes would be considered sufficient to permit them to avail of Loans under the S.D. (Acq.) Acts, or from Building Societies.

Following lengthy discussion it was decided to appoint a deputation to meet the Minister for Local Government regarding the Boghall and Old Connaught Schemes. The Chairman, Clrs. D. Sayers, and G. Doyle were appointed to constitute the deputation.

(628) Old Connaught Housing Scheme

Submitted letter from Messrs. Montgomery and Figgis, Solicitors, on behalf of Mr. John Gornam, intimating that their client is prepared to sell to the Council approximately 4 acres 2 roods of land at Old Connaught and it was decided to offer for the purchase of the land from Mr. Gornam the sum of £300 per acre.
