appoint a deputation to meet Mr. Fitzpatrick to discuss the question of the acquisition of his land at Old Connaught. The following members were appointed to constitute the deputation: the Chairman, Clrs. G. Doyle D. Sayers, E. J. Little and J. Tample.

The Town Clerk said that an offer of £20 had already been made to the Jackson Estate, but a request had been made by the Jackson Estate that a sum of £75 should be paid by the Council in respect of compensation for the use of the property.

It was agreed to renew the offer of £20 and to indicate to the Jackson Estate that the offer of £20 represents a purchase price of £270 per annum which was very reasonable in view of the small area involved, the low-lying nature and shallow depth of the plot concerned

"That we have noted the Circular from the Local Government Department regarding the arrangement for the return of skilled workers from abroad for the housing programme, and submit to the Minister that the restrictions on entry into the Craft Unions requires to be investigated and that copy of this resolution be also sent to the Congress of Irish Unions and the Irish Trades Union Congress."

(18) Erection of additional houses by Direct Labour

Submitted layout plans by the Wicklow County Engineer providing for the erection of an additional 26 houses by Direct Labour. In this connection it was proposed to erect the houses on the following sites:-

10 houses at the Gair Green, Greenpark Road;

(61) Housing Scheme at Boghall

Submitted letter from Mr. Desmond Fitzgerald, Consultant Architect, intimating that, in connection with the erection of houses at Boghall, arrangements could be made to reserve part of the site for the construction of bungalow type houses.

It was decided to insert an advertisement in the "Wicklow People" on Friday 20th January, 1950, inviting applications from persons desirous of erecting houses for their own occupation. The latest date for receiving applications was fixed at February 6th, 1950.

(22)) Rathmore Terrace.

A deputation was received from the tenants of Council's tenant purchase houses at Rathmore Terrace. Mr. Hamilton, Mr. Whelar and Mr. Leggett represented that for a long number of years a right-of way had existed at the rear of the houses. The Council itself had constructed a concrete passageway. Approximately 8 years ago a wall was erected at one end of the Terrace by the resident of No. 15, Rathmore Terrace, or by the Council on her behalf.

The Deputation represented that numerous complaints had been made by the tenants to Officers of the Council, over a number of years, but their representations had been ignored. The only acknowledgment concerning the complaints made by the tenants was that issued by the present Town Clerk early in 1948.

Councillors P. Ledwidge and D. Sayers pointed out to the members of the Deputation that the question of a right-of-way at Rathmore Terrace had been raised by them at many Meetings of the Council. It was not correct to state that no action was being taken by the Council in the matter.

The Chairman exhibited the Conveyances under which the premises etc. were demised to the respective tenant purchasers. He indicated that the land shown coloured red on the Conveyances was the exclusive property of the tenant purchasers and it was obvious that it was never intended that a right-of-way should have existed at the rear of the premises. No matter how anxious the Council might be to facilitate the residents in the matter, the Council have no legal powers to provide a right-of-way for them. The provision of a right-of-way was a matter for agreement between all the tenants, and he

suggested that the members of the Deputation should approach the tenants of the two houses and request them to remove the structures which, at the moment, precluded the residents from gaining access to the rear of their houses.

The Town Clerk was directed to communicate with the tenant purchasers of the two end houses to ascertain whether some agreement might be reached whereby the tenants could gain access to the rear of their houses.

The Town Surveyor was directed to inspect and report upon the condition of the gullies. It had been alleged that flooding takes place at the rear of the houses owing to the fact that the wall has been erected which prevents the free flow of surplus water.

(24) Wicklow Arts Limited - lease of land at the North Beach

Submitted Report of the Town Clerk giving a precis of the covenants contained in Draft Lease under which the Council proposes to lease land at the Harbour to Wicklow Arts Limited.

Following discussion it was gareed to permit the Solici or for the Lesses to insert a Covenant that the Lesse should be termined in the event of the land demised thereunder being unusable owing to coastal erosion.

The Council could not agree to the deletion of the Covenan in the Draft Lease which provides that the Lessees shall not sub-let the premises without the prior consent of the Council.
