ERECTION OF 22 HOUSES AT BOGHALL.

395. The Council further considered the proposal to erect 22 houses at Boghall Road.

The County Manager intimated that the houses could be erected by Direct Labour at an all-in-cost of £1,310 per house, including Engineer's fees, administrative expenses and payment of bonuses to staff

A report of the Consultant Architect on the Tenders received for the erection of the houses also was considered. On a comparative basis the cost of the erection of the houses by contract will amount to £1,487 per house.

It was decided to erect the houses by Direct Labour and to request the Minister to receive a deputation with reference to payment of bonuses to staff and workmen, and regarding the availability of a grant of £275 per house, in accordance with the provisions of the Housing Act, 1950. The following members were appointed to constitute the deputation, viz., Clrs. H. J. Byrne, John Temple, G. Doyle and P. Ledwidge.

DEVELOPMENT AT BOGHALL.

396. It was proposed by Clr. G. Doyle, seconded by Clr. G. H. G. Stuart and resolved:—

"That we the Bray Urban District Council hereby make application to the Minister for Local Government for sanction to the raising of a loan from the Local Loans Fund, of the sum of £5,000, repayable over a period of 35 years, to defray expenditure to be incurred in connection with development work on the housing site at Boghall Road."
