Answer: The A.A. road signs at Sunnybank are erected on the thoroughfare which is in charge of Wicklow County Council and not the Urban District Council. Inquiries have been made from the County Engineer in the matter.

(3) Question : When will the No Cycling notices which the County Manager agreed to have re-erected at Albert Walk be put up?

The Chairman, on behalf of the Council extended Votes of sympathy to the relatives of the late Sergeant Callan and Mr. Charles Elliot.

396. Old Connaught Housing Scheme .

The following letter was read from the Department of Local Government in relation to the Old Connaught Housing Scheme:-

"With reference to your letter of the 3rd ultimo and previous correspondence regarding the proposed housing scheme at Old Connaught, Bray, I am directed by the Minister for Local Government to state that it is noted th t final arrangements have not yet been made for the acquisition of the plot adjoining the cemetery which is necessary for the provision of an access road to the Scheme. Pending the making of arrangements for the provision of the access road referred to any suggestions for the erection of houses on the land already acquired would be premature.

In regard to the house plans submitted I am to state that it is considered that plan G.33 is expensive to erect as is evidenced by tenders recently received for houses of that type in other areas. Plan A.3333 is not considered suitable and it is suggested that alternative designs should be prepared providing for the minimum room sizes recommended by this Department, i.e., living-room 160 to 180 sq. ft.; 1st bedroom 135 sq. ft; 3nd bedroom 110 sq. ft.; and 3rd bedroom 70 sq. ft. Several alternative designs providing the accommodation mentioned should be prepared in view of the magnitude and importance of the proposed scheme.

With regard to the proposed erection of Duplex type houses it is suggested that the part of the site on which it was intended to erect the Duplex houses would be more suitable for bungalow type dwellings.

House plan F. 44 is in order.

In regard to the acquisition of land from Mr. Gorham for the purpose of providing an access road to the scheme from the Upper Dargle Road it is noted that the all-in cost of the land in question as set out in your letter of the 23nd August, 1951, amounts to £5,430, which is considered excessive, particularly in view of the fact that the Council could not erect houses along the access road frontage. It is suggested that it might be possible to make more favourable arrangements with the Cassell family whereby land for the required access road could be acquired. The advantage of such arrangements would be that sites for the erection of houses by the Council would be available along that access road. Such an arrangement would mean that the Council would receive better value for the expenditure incurred.

It is noted that steps are being taken for the acquisition of the land occupied by the Greyhound Racing Track.

While the final detailed form of the lay-out for the pro-

004

posed scheme cannot be determined pending clarification of the position in regard to the land adjoining the parish cenetery which is required for the provision of the access road from the existing scheme at Old Connaught and the other lands referred to above and the submission of suitable house-designs, the general lines of the lay-out plan submitted to this Department are considered suitable. It is considered, however, that the backs of the houses shown on the north side of the acdess road from the existing scheme are too close to the boundary wall between the scheme and the balance of Mr. Fitzpatrick's land. It is suggested, therefore, that the lay-out should be revised to increase the distance between the backs of those houses and the boundary wall in order to provide larger back gardens to the houses.

I am to request the submission in due course of the Council's final proposals for the provision of the access road from the existing scheme at Old Connaught and the acquisition of the other lands required, together with revised lay-out plan and alternative house designs."

Following a lengthy discussion in which the Fembers expressed resentment that the pepartment had not indicated earlier that the House Designs were not considered suitable, the Consultant Architect represented that an error of £70 had been made by the firm of Building Contractors who submitted the Tender for the Type G.3 in another area.

The Town Clerk stated that the Trustees of the Cemetery were quite prepared to dedicate a site for the roadway through the Cemetery Field extension and that in this connection, the Title Deeds were being examined. Quite naturally the Trustees, however, could see no point in having the Deed of Dedication executed unless the Scheme as a whole were approved by the Department. It was agreed to request the Minister to receive a Deputation from the Council to expedite the commencement of the erection of the houses and to resolve the present difficulties which were delaying the progress of the Scheme.

The following were appointed to consitute the Deputation: Clr. E. Byrne (Chairman), Clrs. Dr. Donnelly, P. Ledwidge, H. B. Hipwell and J. Temple.

The Council recommended that houses to be let at economic rents should be erected on lands which are at present used as a Greyhound Racing Track and which the Council propose to acquire compulsorily.

Borrowing of Capital Monies: The Council approved of the terms of Draft Mortgages in respect of Loans of £8,000, £33,000 and £72,000, which it is proposed to borrow from the Commissioners of Public Works in connection with land acquisition; development work; and the erection of houses on Section 1 of the Scheme.

Submitted report from the Consultant Architect,

Mr. D. Fitzgerald, outlining his proposals for the development of the northern end of the Esplanade. Briefly, the recommendations are that (1) the area between the Municipal Baths and the proposed terminal cafe/casino be laid out as a lawn, flanked with shrubs on either side, (2) That the Car Park be converted into a Children's Play area with paddling Pool, Since the area has already been surfaced, it would entail relatively less expense than if the Paddling Pool etc., were provided elsewhere; (3) That a Shelter with kiosks be provided in the children's play area, and that the existing shelter lying between the Municipal baths and the harbour be moved to one side to open up the vista; (4) That the lawn which was No.2 on the Plan prepared by him and submitted to the Meeting be used for a putting Green

or for such other lawn sports as may prove popular from time to time; (5) That a cafe casino flanked by fountains be provided at the northern end.

Following discussion the Council adopted the report in principle, subject to the deletion of the recommendation for a cafe casino at the terminal point. As an alternative, the Council suggested the provision of a large shelter.

Plans submitted by Mr. Donnelly, for erection of structure at the rere of her premises at Parnell Road. The Town Engineer reported that the structure was considered unsightly and would not recommend that permission should be granted.

It was agreed to defer the matter to enable the Town Engineer to discuss it further with Mrs. Donnelly.

(4) Has the Town Clerk any more information re the Building of houses at Old Connaught? Will the work be in hand for Christmas? ANSWER :- The Council is aware that the whole position of proposed Old Connaught Housing Scheme was discussed at a Meeting on

the 27th ultimo, which was attended by the Consultant Architect. The erection of the houses will commence without delay when the site for the Access Road through the Cemetery Field has been dedicated for public use, providing the house designs are approved by the Dept.

(5) Due to unsatisfactory lighting of the Bray Urban Area, has the Engineer inspected the lighting arrangements lately, with a special reference to Parnell Road and Meath Road?

ANSWER :- The former Engineer made a survey of the Urban Area in February, last in connection with improved public lighting. Provision was made for additional lighting at the Estimates Meeting held in March, and orders were subsequently issued to the Electricity Supply Board for lighting of additional lamps. It is understood that difficulty in obtaining the necessary equipment has prevented the Board from complying with the requirements of the Council in this connection -

(6) When is it proposed to commence work on the resurfacing of Main Street and Quinsboro' Road?

ANSWER :- The Quinsboro' Road which is in charge of the Co. Council was resurfaced some five years ago. No provisior is made in the County Council's Road Programme for resurfacing of this road for the current year.

The Department of Local Government insisted that the Main Street should be resurfaced in tar macadam and suggested that, if the machinery were not available, that the resurfacing of the road should be performed by contract. The County Council had recently purchased the necessary machinery and it was hoped to commence work as soon as the machinery had been transferred to Bray.

(7) Has the Town Clerk received intimation as to when this Council will receive copies of Standing Orders?

ANSWER :- The Draft Standing Orders approved by the Council were submitted to the Department for approval some 18 months ago. but to date the consent of the Department to the adoption of Standing Orders has not been received.

### CLR. JAMES FRENCH.

(1) Will the Manager indicate what steps he proposes to take against Messrs. Boni and Cassoni, Strand Road, since they proceeded building after a Prohibition Notice was served upon them in relation to such building.

ANSWER-Mr. Boni: - As the Council will recollect, a Prohibition Order was made on 3rd July, 1951, in respect of a structure which

Mr. Cassoni: -- On the 20th November, 1950; the then Town Engineer stated that he had found a structure was being erected by Mr. V. Cassoni, at Strand Road, Bray, for which Plans had not been submitted under the Town Planning Acts. A Prohibition Order was made on the 21st idem declaring the further proceeding with the work to be prohibited. In February, 1951, Plans were submitted for the structure, but permission was refused as the structure was shown projecting in front of the building line. The Architect who submoded the Plans subsequently appealed to the Minister for Local Government and asked that the structure should be approved as a "Temporary Building" for a specific period under Section 27 of the Public Health Act, 1907, and that the building would be removed when so required by the Council. The Council declined to agree to the acceptance of an Agreement to this effect. On the 26th April, 1951, it was reported that work had again com-

menced on the structure and consequently the Council's Solicitors were requested to institute proceedings for contravention of the Prohibition Notice. Subsequently, correspondence took place between the Council and the Department of Local Government upon an appeal which Mr. Cassoni made to that Department. The Department requested the submission of various reports, Manager's Orders, etc. which were duly forwarded on 3rd August, 1951, and on 4th October, 1951; the Department intimated that, as no further communication had been received from Mr. Cassoni, or his Architect, it was assumed that the Appeal against refusal had been withdrawn. The matter is still in the hands of Council's Solicitors.

was being erected at 110 and 111 Strand Road without Plans having been submitted under the Town and Regional Planning Acts. A Prehibition Order was served declaring the further proceeding with the work unlawful. Subsequently, Plans were submitted, but permission way refused as it was considered that the area was already densely built-up, and that the structure would detract from the amenities of the neighbourhood.
