Pavilion at People's Park:

After the Estimates were adopted last year it was decided to make a contribution of £100 towards the cost of a Sports Pavilion in the People's Park, the remainder of cost to be subscribed by the football Clubs who would use it. A design for the Pavilion was prepared by the Town Engineer but as the Clubs did not proceed with the work last year, the Council's contribution is now included in the Estimates.

Band Performances:

Last year the amount for Band Performances was increased from £150 to £300 as in recent years there has been a rise in the charges for the hire of Bands. For the coming year, £300 is again included.

School Meals:

A00

The cost of food for meals for children attending National Schools shows a marked increase (£504). Last year the sum allowed was £972, which was £372 in excess of the provision made in 1950/51. The withdrawal, over a year ago, of State subsidies from bread and butter used in School Meals has resulted in increased costs and in addition, there has been an increase in the number of children partaking of the meals. The cost of serving the meals in the coming year will be £284 as compared with £205 provided last year; this is due mainly to the necessity for providing additional equipment. One-half the cost of food is met from State Grants so that the net increase under this heading is one-half of £504 or £252. The cost of serving meals however, has to be met in full by the Council, and the extra cost to Rates for the coming year consequently, will be £331.

Salaries:

The cost of salaries of existing staff shows no change but it has been represented that owing to the increase in the volume of clerical and accounting work, an additional clerical Officer (at cost of £220) would be necessary in the Council's office. There ismerit in the submission that work has expanded very much in recent years, and furthermore an examination of the position shows that numerically the staff is the same as it was twenty-five or twenty-six years ago, apart from the recruitment of an additional Shorthand-Typist three years ago. In 1926 the number of Council Houses was 185 and it is now 869; there were only four loans under the Small Dwellings Acts, whereas the number now is 137 (including 27 - 1939 loans). In the intervening years, new legislation has involved additional clerical work and the keeping of further administrative and accounting records, such as those arising in connection with Fuel Scheme, Town Planning, Housing lists, etc. Moreover, it should be mentioned that in the same period the population of the town has increased from 8,000 to over 12,000; such an increase in population is bound to result in an expansion in the Council's activities and commitments.

Office Expenses:

There is an increase of £70 - from £150 to £220. This is due altogether to postage expenses.

Fuel Scheme:

There is a rise in the cost of this item of £526, as there are now more families availing of the Scheme and the cost of fuel has risen. The additional cost however, is fully recouped and will not have to be met from Rates.

Office Safe:

A new Safe is found to be very necessary for the safe keeping of important records, such as Agreements, Leases and other legal documents. The cost is

Civil Defence:

For this purpose £100 is included, which is the same as the provision made last year.

Stores:

County Council Demand:

This Demand, as already mentioned, is up by £2,806, which represents 1s 3d in the Rate Levy. In the past two years it has increased by 2s 7d. The Demand compares as follows with that for the present year :-

Whilst there are variations in the costs under each heading, the increase in the Demand is really ascribable to the Health Services, the cost of which in the past few years, has shown a marked upward trend and is due to the expansion of these services and the rise in the costs of Hospital treatment.

Unemployment Assistance Acts Levy:

This is the product of a Special rate of 9d in the fl which the Council is required to raise under the Unemployment Assistance Acts, 1933 and 1940, and the money is paid to the Department of Social Welfare. The levy which is based on the gross valuation, excluding Council houses and a few minor items, shows an increase of £76. As stressed, when submitting the Estimates last year, the levy of this charge and the County Council Demand on the gross valuation of property in the Urban District shows clearly the lack of merit in any claim that the erection of new dwellings, which are only rated to one-third for the first seven years, is of immediate benefit to an Urban Authority.

Comparison of Rates:

Whilst the Estimates now presented for your consideration would involve an increase of 3s 5c over the rate for the present year, it will be evident from the details given that provision is included for many new works, and the Council may consider that some of these might be deferred. It is unfortunate however, that the increase in the County Council Demand, which cannot be pruned in any way, entails an automatic increase of 1s 3d.

Last year it was pointed out that in the years 1937 to 1942 the expenditure on Municipal Services under the control of the Council, was about 14s Od in the £1. In 1951/52 the rate for similar services was 13s 7d, notwithstanding the radical changes in prices, wages rates, and other costs which have occurred in the meantime. In recent years there have been insistent demands for improved services and new amenities, such as improvements at the Esplanade, better roads, improved water supply, more public lighting, etc., but it must be appreciated that these cannot possibly be provided without the incurring of additional costs which inevitably are reflected in the rates. In fact, it might be held that the achievement in a brief period of so many improvements, without a marked rise in the levy for municipal services (i.e. excluding the statutory demand services) has been no mean achievement on the part of the Council.

£84 is provided for a half-year's lown charge on the new Stores, which together with Fire Station, are being provided on site near Town Hall. The cost of Fire Station is being borne by County Council. The Town Engineer has reported that a new roof, at a cost of £220 is required for the Store at Harbour.

As you are well aware the condition of the roads maintained by Bray U.D.C. is very far from satisfactory.

Practically all the tarmacadam roads are in a very bad state of repair and are deteriorating at an alarming rate. Several of these roads are so rough and uneven that it is now essential that the surface should be scarified and levelled, and that a new surface of premixed tarmacadam should be provided.

A number of the tarmacadam roads which have not yet deteriorated to such a great extent need immediate attention in the form of levelling and tar-dressing. This latter treatment which is a comparatively cheap treatment, is essential if the present rapid deterioration is to be arrested. It is generally recognised that tar-macadam surfaces must be treated at regular intervals with a surface dressing of tar and chippings. The chippings are merely held by the tar and are intended to form the wearing coat of the road. In no case should the road be allowed to deteriorate to such an extent that the foundation of the road is forced to do the work of the wearing coat.

Normally a wearing coat or surface dressing has a life of only 4 to 6 years, depending on the volume of traffic, rate of spread of tar, quality of the chippings, etc.. This means that surface dressing at reasonable intervals is essential and it is only when this is provided that tarmacadam roads can be properly maintained.

Practically all the tarmacadam roads are now in immediate need of tardressing and those which have deteriorated beyond tar-dressing need new targrouted or tar-macadamed surfaces.

In view of the urgency of the matter and the fact that any further deterioration of the roads will increase enormously the capital sum which must eventually be expended to restore these roads, I strongly recommend that a substantial sum should be provided for in the coming financial year to carry out these urgently needed roadworks.

I attach a list of the roads which I consider should be given new tar-macadam surfaces and those which should be immediately tar-dressed, together with an estimate of the cost for each road.

The Town Engineer reported that in general the Saloons were weil

kept as regards cleanliness, light, state of decoration, and all provide comfortable seating accommodation. He stated that the principal difficulty appears to be lack of adequate sanitary accommodation. The County Fire Officer reported that no major alterations were

neccessary to make the buildings reasonably safe in the case of fire, but he recommended the installation of fire extinguishers in a number of the premises.

AMUSEMENT SITE AT BRAY HEAD.

203. The Council granted permission to Mr. Williams to use the Shelter at Bray Head in connection with the operation of the Amusements. It was decided to ask the Contractor to give the Council 50 per cent. of the proceeds received from the Amusement devices for one week which would include the 12th July, 1952, in lieu of the week to be given in June and September. in accordance with the terms of the Agreement.

BRAY COVE SWIMMING POOLS.

204. Submitted Report of the Town Engineer regarding the Briy Cove Swimming Pools intimating that the cpst of erection of a suitable hand rail would be approximately £80, and that repairs to the Diving Stage will amount to £50. No action was taken by the Council in the matter.

Permission was granted to the Club for the erection of a sign at Bray Head and Display Boards on the Esplanade-the Notice Boards to be removed after the holding of the last function for the season.

LIFE BOAT ASSOCIATION.

205. Permission was granted to the Life Boat Association to hold a Flag Box collection on the Esplanade and seawall on the 18th and 19th July, 1952.

206. It was agreed to grant permission to the Red Cross Society to hold Meetings in the Boardroom at the Town Hall on one afternoon in every quarter, free of charge.

CONTROL OF ERECTION OF STRUCTURES. 207. The Law Agent, Mr. McCarroll explained the powers of the Council in the control of erection of new structures and alterations and repairs to existing ones. Briefly, the Council's powers are obtained under the Public Health Acts, 1878, Public Health (Amendment) Act, 1907, Town Planning Acts and Towns Improvement Clauses Act, 1847. Bye-laws which have been made by the Council under the Public Health Acts provide for the control of erection of structures or additions to existing ones. The 1907 Act provides for the control of temporary structures. The Towns Improvement Clauses Act 1847, empowers a Local Authority to control the erection of such structures as sign post, show boards, etc., provided it can be proved that the erection of such structure would be an obstruction to the safe and convenient passage along any street. The Town Planning Acts empower a Local Authority to control erection of all structures but there is no power fat present to have a structure removed once it has been erected, until such time as the Town Planning Scheme comes into operation.
