The County Manager informed the Meeting that the Officials dealing with the matter had almost completed the Draft Town Planning, but there was one point on which he sought a decision of the Council. That was the method of dealing with Land under Bray Head and behind New Court Road. It was felt, he said, that no further building of houses should be allowed in this area-first of all. from the aesthetic point of view and that of preserving the amenities of a major Tourist Resort and, secondly, from the more practical viewpoint of the prevention of flooding in the already built-up area. #### Re :- Sewage Disposal at Bray.

Dear Sir,

At a recent Meeting of the Urban Council it was requested that a report should be submitted on alternative methods of sewage disposal other than the present system of discharging direct to the Harbour.

The volume of sewage is normally taken as equivalent to the water consumption of a town. In the case of Bray this would mean about 700,000 gallons of sewage per day. In a normal town sewage of this nature would contain about 1/10% of solids or impurities or a total of 700 gallons.

Since the surface water of Bray is also taken into the Council's sewers the sewage would be much greater in volume during wet woather, but i total volume of impurities present would not vary apart from the addition d a certain amount of grit and sand.

The need for sewage purification depends on the strength of the sewage (which is taken as the amount of oxygen absorbed to oxidise biochemcally all the organic material and ammonia present), and the effluent conditions required,

In normal practice it has been held that where a dilution of over 500 is available for the effluent no treatment works are necessary except possibly screening which eliminates floating matter and a grit chamber.

Where dilution is between 300 and 500 times, tank treatment works would be necessary. Where dilution is 150 - 300 times elaborate tank treatment and chemical tests on the effluent would be needed.

Bray would obviously be a case where dilution of over 500 times the effluent is available and consequently treatment works would appear necesser.

The only complication in the case of Bray is that Bathing takes place. in fairly close proximity to the Harbour, and the standards above and mainly concerned with the prevention of nuisance and the danger of river pollution. I am perfectly satisfied that there is no danger of river pollution or nuisance in the present system, and while there is no evidence of any ill-effects on bathers, it might be desirable to have the County Health Officer's view on this aspect of the matter.

At this stage there is little point in giving an estimate of cost since this would depend entirely on the type of treatment works required which in turn would be based on the standard of effluent required.

Mention has previously been made of the possibility of collecting the sludge and using it to manufacture fertilisers.

While the value of the sludge as a fertiliser is appreciated no satisfactory economic process has been devised to convert sludge to ferti ser. I might mention that in the case of Dublin a boat or barge is used to convey the sludge outside the twelve mile limit where it is dumped into t sea.

The sewage effluent from Bray Urban District discharges via an outfall pipe into the harbour. This outfall, unlike that of many seaside resorts, is below water level even at low springs, which means that at high tide and even at half tide it is several feet below water level. In the purification of sewage the concentration of oxygen is highly important. Winds may double oxygen absorption, waves may increase it tenfold and "white caps" a hundred fold. The specific gravity of sowage is lower than that of seawater, therefore it rises to the surface of the submerged outfall. The dilution as it rises through a cone of water is very important to the purification as such dilution, cn breaking the surface, is proportional to the square of the depth of the outfall. pipe below the surface. From this it will be seen how important it is that the outfall pipe should be below low water level. Failure to observe this principle has caused trouble to many seaside resorts.

The diluted sewage then leaves the harbour and enters the sea where further dilution and purification proceed continually. Additional factors influencing the increased dispersal, dilution and purification of the effluent are (1) the harbour opening faces E.N.E. or away from the town's beaches and (2) the set of the flowing tide is in a somewhat northerly direction, Apart from observation there is evidence of this in the relative high water times of Dublin and Bray. A further point is that the river enters the harbour beside the outfall and helps in dilution and purification both by its volume and by the agitation of the water which it causes (vide supra). From the Public Health aspect the physical processes concerned in the dissemination of sewage in bathing waters are important in establishing potential contact between the population and excretal pathogens. The specific risk of disease must also depend on the viability of such bacteria in sea-water. Under natural conditions coli bacteria from sewage die out fairly rapidly in sea water. There are a variety of reasons for this, among them being the brief survival of such organisms under natural conditions, rapid dilution and the colicidal action of marine flora and sunlight,

Let us now turn to the problem of the possible risk to health of bathing in sewage polluted waters. Apart from the rather nebulous requirements of "common decency" the assessment of permissable degrees of sewage pollution of bathing water should rest on firm knowledge of whether such bathing is assoe ciated with an increased incidence of strage-borne disease. Otherwise decisions on the costly provision of more elaborate sewage disposal systems must rest merely on a basis of expediency, and insuch arguments as the economic welfare of resorts. Much work has been done on the question of disease being conveyed by bathing in polutted waters. Most of this work has been undertaken in the United States, but a good dealhas aldo been done in Britain and the Continent and a voluminous literature on the subject has accumulated.

Investigations fall into various groups, namely Sanitary Survey, and Laboratory, these latter being divided into physical and chemical, and bacteriological. It is well at this juncture to distinguish between two categories of disease in relation to bathing. (1) What may be described as contagious diseases i.e., diseases spread in relatively small and badly managed pools where the chief danger is the direct spread of infection from one person to another, as Mainst the risk of bathing in water polluted by sewage. This contagious class includes conjunctivitis and respiratory and sinus infections.

#### BRAY SEWAGE IN RELATION TO PUBLIC

Beyond stating that more information is need as to whether these diseases are spread from one bather to another or indirectly by contamination of the water, or perhapschlorine irritation, it is not proposed to discuss them in further detail as they fall outside the scope of this paper.

With regard to sewage polluted waters there is evidence that typhoid can almost certainly be contracted by bathing in such waters or by falling into them accidentally. The risk however of contracting other diseases in this way appears to be minimal.

The earliest report on an outbreak of typhoid fever probably due to bathing was reported by Reece (1909) who investigated an outbreak in Walmer, Kent. Here there was gross pollution of the pool by the outfalls of 2 main sewers, the effluent being carried into the pool by the flowing tide. Cases have also been reported from the United States, Germany and Russia.

Much bacteriological work has been carried out on the subject and in the United States attempts have been made to lay down bacteriological standards for bathing waters. As might be expected from the number of twariables involved such standardsare not of practical use. In the present state of our knowledge the adoption of a standard directly related to health risk does not appear possible.

The basis for the coli test in the bacteriological examination of drinking waters rests on the records of large number of water-borne typhoid epidemics reported over the years. On the other hand with regard to bathing waters the known health risk amounts to little more than a small total of sporadic cases of typhoid fever ascribed to bathing during the last 50 years.

Informed opinion in Great Britain and the Urited States, with which I am in complete agreement, holds that rigid bacteriological standards for bathing waters are quite impractible is and unjustifiable. The final classification of bathing waters should be based on Sanitary Survey information, bacteriological analyses being used as a guide if considered necessary. With reference to information from Sanitary Surveys the entire front is under the continued observation of the Town Enginee, the Co. Health Inspector and myself. At no time has anything of an untoward nature been observed. I refer to oil or grease forming "slick" and particles of faeces and sewage debris. The Municipal Baths are over 700 yards from the harbius mouth and it is the beach between these and Bray Head that is frequented by bathers (apart from Bray Cove further south). Bathing north of the baths is uncommon, but it is only right to say that neither north nor south of the Baths have I observed any contamination. Detailed health statistics of the County have been kept for about 30 years and during that period (and during the previous era when such matters were recorded by the Department of Local Government and Public Health) there has been no record of any case of typhoid fever or any other infectious disease having been o caused by bathing on the Bray beach, and I regard the position as satisfactory and in my opinion there should be no risk from infectious disease in bathing from it. The harbour should not of course be used for bathing. As a final word I would urge that the Council be very cautious in accepting into their sewers any trade wastes which may have a deleterious effect on our beaches. Aw such wastes should only be accepted after due investigation and under proper safeguards.

May I in conclusion be permitted to congratulate the Council for their interest in this important matter and for their determination in making sure that Bray remains in the forefront of the resorts in these islands. For my part I and those associated with me will continue to pay continuous attention to this important matter, which is vital to the health and prosperity of Bray.
