The Commissioner performing the duties of Bray Urban District Council held a Special Meeting in the Town Hall, Bray, at 12 noon on Friday, 9th April 1929.

1784 Estimate and Demand from Wacklow County Council for year ending 31st March 1930.

Town Clerk's Estimate of Poor Rate for year ending 31st March 1930 which showed that a Poor Rate of 6/- in the pound would be required.

Estimate considered and the following resolution passed:"Whereas I, the person appointed to perform the duties of
"Bray Urban District Council, having considered the Estimate
"of Poor Rate for service of the year ending 31st March 1930,
"do hereby adopt same at Six Shillings in the pound, being
"2/2d in respect of Roads; 1/2d in respect of County Services;
"2/7½ in respect of Poor Relief; and ¾d in respect of Board
"of Health and Separate Charges, and I hereby order and
"direct that Notice of Intention to make said Rate at a Special
"Meeting to be held on 26th April 1929 be published as
"required by law."

1785 Town Clerk submitted Estimate of Town and Harbour Rate for year ending 31st March 1930 and pointed out in a statement that the amount required for the year for ordinary requirements, less probable receipts would be £17,170 and to this should be added £7230 in respect of excess Liabilities and irrecoverable Rates etc. on Council property etc. A pointage rate of 15/3 would be required to raise this amount of £24,400 which with Harbour Rate of 1/- would make a total rate of 16/3 as against 11/6d for previous year, and to meet payment of interest on Housing Overdraft, £2050, and credit balance on Electricity Undertaking, £1192, claimed by the Electricity Supply Board, a further rate of 2/- in the £ would be necessary.

He recommended that £17,642 be raised out of rates and that a sum of £10000 be funded repayable over a period of five years. This would mean a rate of 11/1d which with 1/- for Harbour would make a total rate of 12/1d in the pound.
