"A Bray Urban Rate of ten shillings and tenpence in the pound whereof two shillings and sixpence is for the general and sanitary expenses of the district under and pursuant to the Bray Township Acts 1866 to 1895; seven shillings and sevenpence is for Sanitary and other expenses under and pursuant to the Public Health (Ireland) Acts 1878 to 1907, the Public Parks Act 1869, the Open Spaces Acts 1877 to 1906, the Notification of Births Acts, and for charges in respect of Loans under the Housing of the Working Classes Acts and Acts amending or extending same. Fourpence halfpenny in the pound is for Technical Instruction pursuant to the Vocational Education Act 1930; twopence halfpenny in the pound is for expenses pursuant to the Public Libraries Acts; one penny in the pound is for expenses pursuant to the Bands of Music pursuant to the Public Health Acts Amendment Act 1907; and twopence is for advertising the district as a Tourist Resort under the Health resorts and Watering Places Act 1908.

"A Rate of sixpence in the pound is for the purpose of defraying expenses in connection with the water supply of the district to be called the Bray Urban Water Rate and of which threepence is for domestic and threepence is for public purposes.

"A Rate of sixpence in the pound to be called the Bray Urban Sinking Fund Special Rate for the purpose of providing charges in re money borrowed and interest thereon.

"A Bray Harbour Rate of eightpence in the pound for the purpose of paying interest etc. on money raised under the provisions of the Bray Township Acts 1890 to 1895 for the construction of Bray Harbour and purposes connected therewith.

"AND I HEREBY ORDER AND DIRECT that Notice of Intention to make said Rate at a Special Meeting to be held on 11th day of April 1933 be published as required by law."
