Sub Sanitary Officer's Report

3rd February, 1925

During the month I inspected 89 premises and served 3 notices under the Public Health Act for sanitary purposes, two of which have been complied with, and the other is being completed.

The usual flushing of the main drainage and disinfecting of the Gully traps and Urinals on the North and South Quays have been carried out weekly during the month. The urinal on the North Quay is continually getting choked, and requires a flushing tank as there is no means of flushing same.

Owing to complaints about manure being stored at several places on road side at Ballynerrin and the Public Lanes throughout the District some persons are constantly dumping this rubbish in the public lanes, and the Council's Carter has to remove it. I wish the Council's direction in this matter.

During the month the Council's men were engaged on all roads cleaning water-tables and out-lets that choked during the rain storm, and had all mud scraped off Main Street and North and South Quays and removed to depot.

About 50 tons of stones were spread on the different parts

of the roads where necessary owing to pot holes. I had fine gravel spread on footpaths at Market Square, New Street and Summer Hill.

In consequence of the bad state of several of the roads I require 60 tons of stones to fill holes along same as I have no stones in depot.

One of the Council's men was reported sick on the 17th January and came to work again on the 26th January 1925.

The planks over bridge in Quarry at Dunbur were taken off and thrown down the Glen Stream, I had them taken up by the Council's men and carted to Yard on South Quay.

Waterworks Overseer's Report

3rd February, 1925

During the month I repaired fountains at Ball Alley, Friars Hill, and High Street, also services at Friars Hill and Fitzwilliam Road. I took up water meter at Chemical Works to have same sent away for cleaning.

Messrs Glenfield and Kennedy, sent to me new parts for Railway meter to replace parts that got worn out in what I consider a short period. These parts were sent free of cost.

The mains were flushed as usual and I was obliged to pack sluice valve at the Chemical Works and Marine. The reservoir is overflowing.

Electrical Engineer's Report

3rd February, 1925

I beg to report for period ending January 31st, during this time public and private services have been maintained as usual and plant has been running every day. Two new Consumers have come on during the month. As our stock of material for services and meters is now running out it will be necessary to lay in a new supply in order to meet any applications that come forward. I would suggest that thirty meters be placed on order now as

I regret having to report that a considerable number of our street lamps are maliciously broken, this applies more particularly to the Rathnew Road and Church Hill sections.

Corporate Agent's Report

10th February 1925.

On visiting Cottages on Murrough, after the late storm I was told by the several Tenants of the inconvenience and damage caused by water beating through the South Wall and leakage from the joining between main roof and annex. The south end of each block in my opinion will have to be cemented.

Your tenant Mrs Dorcas Mitchell of High Street, has died. I shall be glad if you will give me directions as to the future tenancy.

I request you will decide what is to be done regarding Grazing Field of which I reported last month.

The applicant to whom you granted house on Murrough at last meeting has not taken possession, so it will be necessary to readvertise. I wish to make it known to Plot Holders that applications for renewal should be made at once on Forms to be obtained from me.

3rd March 1925.

During the month I inspected 50 premises and ^{served}~~served~~ 2 notices which were complied with. Disinfected one ward in the County Hospital.

The usual flushing of the main drainage and the disinfecting of Gully Traps on the North and South Quays have been done weekly during the month. Owing to the very wet weather several Gully Traps got chocked and the pipes had to be tapped to clear same.

The paling on Backelors Walk is in a bad state for want of repairs.

Owing to the removal of the sand off Foreshore between the North Groyne and Chemical Works, I had notices posted warning parties against the removal of the said material.

During the month the Council's men were engaged, side-dressing and trimming briars along the Green Hill Road, Dunbur Road, Rathnew Road and Brickfield Lane.

Over 60 tons of stones were carted to the Mill Yard from the Beach and about 40 tons of stones were broken to 1½ inches guage and spread on the Rathnew Road, Dunbur Road and Strand Street.

I require 3 new lengths of 2 inch hose for the Fire Car to replace old ones that are worn out.

SPECIAL COMMITTEE'S REPORT

12th March, 1925.

The Committee inspected Eve Gutters on Houses at Coastguards Station and recommend that the Eve Gutters be taken down, rejointed and about a dozen new ones be fixed to replace old ones, these Eve Gutters are laid on Granite Flint and screwed to fascia, to fix same it will mean taking off Eve Slates, in many places the back of Gutters are broken on the inside and the water is flowing inside the houses.

The tenants of the five centre houses awaited on Committee and pointed out that they had no Sanitary arrangements, to remedy same we recommend that the pantry inside the doors be made into W.C's there is a splendid sewer running parallel to the houses and it would only take about nine feet of pipe to connect same with houses.

At the present time there are concrete rain water tanks outside each door, they are nearly full with putrid water, and many no trap doors, and the stench out of same is bad. We suggest that the Council's men scrap same and have materials removed to yard for crushing for roads.

Those rain water tanks were erected to catch water for washing purposes before there was any water supply in the town and a pump at Station supplied water for household purposes. In Coastguards time they were cleaned out and cement washed inside every three months according to regulation, but it would be very hard to get civilians to do this.

Sub Sanitary Officer's Report.

7th April, 1925.

Inspected 70 premises and served two notices, under the Public Health Act, for Sanitary purposes, which were complied with.

The usual flushing of the main drainage and the disinfecting of the Gully-traps and ^{Animals on} ~~minerals~~ the North and South Quays has been carried out weekly during the month.

I wish the Council's permission to have the public seats painted, and to have them put along the Sea Murrrough, for the Summer season.

I also wish permission to remove heaps of sea weed that has been taken up off the Beach some weeks ago, by some persons and left in heaps at the Sea Front. There are also several heaps of stones along same which would require to be removed off, or put back on the Beach, I had notices posted up warning all persons against removing these stones.

During the month the Council's men were on the Green Hill Road, Ballynerrin Road, Rathnew Road, Church Hill, and Dunbur Road, cleaning up water-tables and side-dressing roads, and trimming all overhanging briars along same.

The tree on footpath at Abbey Street requires some bows taken off. If the water car is required this season there are some minor repairs required for same before it can be used. I inspected Coastguards Houses with the Committee as ordered by the Council.

Waterworks Overseer's Report.

7th April, 1925.

During the month I had two men employed cleaning Filtering Bed and washing sand.. On the 19th March, there was a new bed turned on to the town. I repaired Fountains on Murrrough and at South

Quay, also water meters at Gas Works and the Brickfield Lane.

The water Meter at Chemical Works is now back in its place.

Three of the smaller streams coming into the Reservoir have stopped ~~although altogether~~ ^{altogether}, and some more of the bank of new cutting has fall into the Reservoir.

During the month I made several night inspections, and served two notices for waste through leakage, both ~~were~~ ^{were} complied with.

There is 19 feet 9 inches water in the Reservoir.

Electrical Engineer's Report.

7th April, 1925.

I beg to report for month ending 31st March, during this period all Services have been maintained as usual and the plant has been running daily, I regret having to report that our wires have been pulled down again by the Crane in traveling down Strand Street.

As this may cause an accident to occur it would be advisable to take steps with a view to preventing this happening again.

Accounts for current quarter have been made out and are being furnished to consumers, same are showing a satisfactory increase.

Corporate Agent's Report.

7th April, 1925.

As the fields let for grazing are not in use, I would recommend that they be advertised for letting from 1st May, next. I have not been able to lodge full amount of Allotment Account as two holders have not paid, I request your direction in this matter.

Arrears are still due on Bond Street houses, as also on Main Rental, I would ask that these be examined at an early date, there is no rent due on any other houses.

Application has been made for vacant house in Strand Street, also for Angle Field lately held by Mr James Clarke. Owing to vacancy of No.5 Murrough Cottages, arrears amounting to the sum of £5 : 5 : 0, require to be struck off. Tenants holding on 11 months system I take it, may be granted a renewal.

Local Government Inspector's Report on New Cottages
The Murrough.

Three of these houses i.e. Nos. 1, 3 & 5 show unmistakable signs of leakage at the points in each house viz:- at the southwest corner at the wall plate level and also on the south gable under the gable windows. The former is probably due to soakage through the solid

concrete kneeler and if the surface of the kneeler and barge in cement plastered in fine stuff mixed with pudlo it will probably not recur.

The later leakage may be due to insufficient rebating and throating of window cill on end bedding of the frame on same.

The remainder of the walling is dry as it must be in cavity walling.
