SUB SANITARY OFFICER'S REPORT.

3rd January, 1928.

Inspected 15 premises and served two notices for sanitary purposes which were complied with.

By the Medical Officer of Health's instruction I disinfected premises at Kilmantin Hill and destroyed the bedding of same by fire, and submit list for payment to the owner of bedding destroyed.

The usual flushing of the main drainage and the disinfecting of the Urinals on the North and South Quays has been carried out weekly during the month.

During the Storm from the 18th to the 27th December, about 180 yards of the pitching along the Foreshore at Sea Front has been washed away by the sea, and the road in one part is only about 5 ft. from the Station Wall, I had a paling erected on the Town end of same to stop all traffic and a notice on same.

During Christmas week about 140 men were employed throughout the District, at Corporation Lands, Mill Yard, Kilpeel Quarry, Upper Strand St., Bachelor's Walk, Black Castle, The Mall, and had pipes laid for sewer at Fitzwilliam Road. I wish Committee

Committee to inspect this sewer at Fitzwilliam Road with a view to having two man-holes and Gully-trap laid on same.

On the 19th December, the stone crusher in the Mill Yard was broken, I had Richard Kavanagh in charge of plant and he reported same to me.

The Council's men are now engaged in Strand Street finishing up the concrete curbing laid along same.

WATERWORKS OVERSEER'S *Report.*

During the month Council's men finished cleaning of Filtering Beds and waterways.

The Reservoir is overflowing and all streams running full.

One man was employed at Waterworks during Christmas week.

ELECTRICAL ENGINEER'S REPORT.

During the month ended 31st December, public lighting and private Consumers services were maintained as usual, and the usual extra lighting for Christmas carried out.

The weather during the holidays was very severe and our overhead

lines suffered heavily. A Considerable number of street and Harbour lamps being broken, and a number of private services damaged.

I have made all this damage good. The load on the Station plant during Christmas week was very heavy, and plant was running 67 hours during the week.

During the month I run two new services and connected two new consumers to the Council's mains. I collected and lodged £59 : 18 : 9.

The usual flushing of the main drainage and the disinfecting of
the Urinals on the North & South Quays has been carried out during the
month. The sewerage of the Urinal on the North Quay is choked,
I had the sewer opened and could not clear same as the Urinal is
built on part of the pipe where the choking takes place.

I wish the Council's directions re Dairies, Cowsheds and Milk-
shops Order., to have all persons who are trading as Cowkeepers or
Purveyors of Milk without being registered be proceeded against to
comply with the Order.

During the month the Council's men had the curbing in Upper
Strand Street and part of Bath Street completed., and the inside of
Curb filled up with material to form Path.

I had the Stone Crusher repaired by Mr Roscoe, and had 130 Yds of
Stones broken with same and part of them spread on North Quay, Upper
and Lower Strand Street, Bond St, St Patrick's Road, Upper Monkton
Row and Green Hill Road, and will have all stones spread this week.

During the last wind several slates have been Blown off the Boat House which is used now as a Store. The Flag Pole on the Roof of the Town Hall requires to be made safe as it is dangerous.

Corporate Agent's Report

Sub Sanitary Officer's Report

5th March, 1928

Inspected 40 premises and served 4 notices which were complied with. By the M. O. H. instructions I disinfected premises at Upper Strand Street, Quarantine Hill and Ward in the County Hospital. The usual flushing of the main drainage and the disinfecting of the Urinals on the North & South Quays has been carried out weekly. By your directions I had the main outlet of the Urinal opened up and cleared. The Urinal is now in working order. During the month 80 yds stones were spread on different roads in the district and about 20 yds Chippings spread on Footpaths. The Council's men are at present at Fitzwilliam Road at Sewer which will be completed during this week.

There are a number of persons keeping Swine in Insanitary premises unsuitable for the keeping of same. I wish the Council's instructions to have Swine not kept less than 7 yds from living room or public road.

I beg to apply for my Uniform and Cap.
