



> Medical Officer of Health's Report 30th April, 1928

I hereby report that I visited the premises used by "r Darcy, on the South Quay as a Figgery I find these premises well ventilated, well roofed and have concrete floors which can be kept clean. The distance from nearest house is 21 feet which is the limit I believe fixed by Urban Council. There is no proper drainage system outside the sheds. There is no receptable or pit for keeping manure, and I recommend that a proper Grainage system connected to a gully trap be put in immediately. That not more than 20 pigs be kept there at any one time. That as there is no pit for manure that all manure be removed every second day. This is very necessary during hot weather as any accumulation would give rise to a nuisance.

If I may suggest it I think it would be very advisable if the Members of the Urban Council drafted some bye laws about keeping of animals in the Urban Area. 21 feet seems a very small distance from a dwelling house. In England and Scotland the distance is 100 feet
