I have this day suspended the work in above pending visit from Board of Works Engineer after the Bank Holiday.

I would suggest that the Railway Co, be asked to loan their Crane, which could be moved into a position at the rere of the Promenade Wall, to enable us to draw about 40 old concrete blocks in against the Toe of the Wall. These old blocks were put down some years ago, and have gone so far seaward that their usefulness is negligible.

Further to our conversation to-day, I beg to confirm that the protection wall extending inwards from the Northern end of the promenade Wall could be erected for the sum of £40. In my opinion, this will be the real danger point during the coming winter storms; if the sea washes in behind the Promenade Wall, the present works will suffer considerably.

I regret that, having been called away on urgent business, I am unable to attend your Meeting.

Finance Committee's Report

4th September, 1931

Your Finance Committee met this evening and went into the Poor Rate Collector's Accounts for year ended 31st March, 1931.

We recommend that the sum of £74 : 1 : 5 be struck off as Irrecoverable and that the sum of £146 : 10 : 1 arrears be carried forward to next collection.

The Collector informs us that he has obtained Decrees in all those cases except in two or three which were not paid owing to deaths in the families, and as soon as administration is taken out the amount will be paid. In the other cases the Warrants are in the hands of the Guards and the Council's Solicitors are receiving the amounts in weekly payments.

In the case of Lawrence Byrne, who owes £31 : 4 : 4 Poor Rates the Collector states that he obtained Decrees in this case and that the Warrants were returned marked "No Goods"

We have directed your Town Clerk to instruct your Solicitors to take immediate steps to collect all rents and rates due in this case and if necessary to proceed against the House and Premises for recovery of same.

Your Collector has now been handed his Books for current year and we have instructed him to collect in all rates forthwith.

A further Meeting of the Finance Committee will be held on Friday next 11th Sept, to go into the accounts of the Township Rate Collector.

Sub Sanitary Officer's Report

1st October, 1931

Inspected 80 premises and served 4 notices which have been complied with. The usual flushing of the Main Drainage and disinfecting of Gully Traps and Urinals have been carried out weekly. Had water tables cleaned on St Patrick's Road, Church Road, Dispensary Lane; Ball Alley; and South Quay.

During the last storm two of the Public Seats were washed off New Pier and broken up. The Paling at Leitrim Place was broken and about 44 yards taken away by some person or persons unknown. The Paling requires to be repaired.

The Urinal on the South Quay is partly under-cut by the tide and would recommend that a wall be erected to stop the tide from carrying-away Urinal and road.

Waterworks Overseer's Report

Flushed Mains and made several night tests. The Council Men finished on 29th Sept, washing Sand and preparing Filtering beds.

The Reservoir is down 3 ins from overflow, and there is a good supply of water coming into Pond.

Part of the joists of Bedroom Floor in Cottage have worn away with the result that the floor has sunk down.

I beg to report that Mr Jameson, has given up possession of Field at Monkton Row, which he has held on 11 months letting. Mrs Canavan has complained that the wire Fence

at her House No.6. Urban Cottages is defective and requires renewing in parts. I have seen the Fence and few Yards of Wire would remedy the matter. Mrs Smullen also requires some Palings renewed that have become decayed.

The proceedings in this case were grounded on a Notice of Forfeiture of Lease.

The Counterpart Lease which you handed us is dated the 7th March, 1870 and is for a term of 75 years from the 25th March, 1862.

When the Council's case was proved in Court Mr Ebril, Solicitor for Thomas O'Neill, who was defending the Ejectment on his behalf, produced an Original Lease dated the 6th June, 1870 in respect of the same premises as the premises demised by the Counterpart Lease on which the Council based their proceedings. The Lease produced by Mr Ebril was for a term of 75 years from the 25th March, 1863. He also produced the Original Assignment dated the 23rd October, 1901 from John Wynne to John Hanlon, which Assignment recited the Lease dated the 6th June, 1870, being the Lease he produced.

On production of these documents by Mr Ebril the Council's case failed, as the Notice of Forfeiture upon which the Council relied to sustain their case was in respect of a Lease dated the 7th March, 1870, whereas it appeared when Mr Ebril produced the Original Lease and the Assignment thereof the O'Hanlon Estate held under a Lease dated the 6th June, 1870, which had not been Forfeited, and accordingly the Circuit Judge had no option but to dismiss the proceedings.

Before dismissing the proceedings the Judge asked our Mr Brazil if the Council were prepared to accept the arrears of rent due and immediately our Mr Brazil consulted your Chairman, Mr John Kennedy, and Town Clerk and received instructions from both that having regard to what the Circuit Judge had said it would be better to agree to accept the arrears of rent. JK

When this information was conveyed to the Judge he asked Mr Ebril, Solicitor, to give him an undertaking that he would pay the arrears of rent due and the undertaking was given in open Court.

The Circuit Judge then dismissed the Ejectment proceedings and awarded Mr Ebril £4 : 4/- costs and Mr A Cullen, Solicitor, who appeared for the Defendants James Jameson and Joseph Brien £1 : 1/- costs, both sums to be paid by the Council.

Before writing to Mr Ebril for the arrears of rent we would like to have a statement from you of all the rates due in respect of the property as Mr Ebril informed our Mr Brazil in Court that he would also discharge the rates.

Please let us know if we are to obtain a copy of the original Lease of 6th June, 1870 which was produced by Mr Ebril Solicitor, in Court today.
