The Tenders recommended for Sugar, Milk and Beef were not the lowest tenders received for these articles; tenders for 3d - 1s/3d and 4<sup>1</sup>/<sub>2</sub>d respectively for these commodities were passed over. It was pointed out to the Committee that the Council would be bound to accept the lowest tenders except good and sufficient reasons to the contrary were shown. In respect of the Milk the reason the Committee recommended the high tender of Mr John Lalor at 1s/4d per gallon in preference to the lower tenders of 1s/3d per gallon of Mr Peter Lalor and Mr Henry Nalty was that Mr John Lalor undertook to supply and showed he was in a position to supply the milk from a Tuberculin-tested herd. The only reason given for the acceptance of the high tenders for Sugar and Meat was that the higher tenders were from parties who supplied last year and gave satisfaction.

It was suggested that oil cloth was required for the tables and that the cooking utensils which are the Council's property are worn out and require renewal.

The Town Clerk warned the Council that they were bound to

and sufficient reasons for not doing so and stated that if there were not good and sufficient reasons set out for doing so the members voting for acceptance of higher tenders (if same were accepted) would be liable to surcharge.
