As a matter of urgency an application from Lynton's Hippodrome to extend the period of letting to them of space on Murrough from four nights to one week at the same price was considered, and it was recommended that they be allowed to continue for the week for the £12. 0. 0.

It was also recommended as a matter of urgency that the Town Clerk write to the Great Southern Railways and ask them to arrange that the hour of departure from Wicklow, of the Wednesday cheap excursions be extended from 9 p.m., to 10 p.m., and that they be requested to run a further cheap excursion train to Wicklow on Sundays and have 10.30 a.m., as the hour of departure.

Report of proceedings of the Finance and General Purposes Committee at their Meeting held on the 27th July, 1935.

Present: Councillors J. Everett, T.D., (Presiding), D. H. Haskins, James Waldron, A. Dunne, T. J. Doran, R. B. Haskins and Wm O'Grady.

The Town Clerk stated that in view of the near approach of the Regatta and the condition of the Woodenbridge the Engineer and Mr O'Toole proposed to execute repairs to the Bridge, and also to strengthen with cement footing the railings around the plot in the Murrough near the Shelters and that three extra men would be taken on for this work.

The Committee recommended that the work proceed.

The Town Clerk also pointed out that advantage should be taken of the fine weather to carry out improvements by tar spraying and chippings to some Streets and roads, and that he had instructed the Town Surveyor to prepare a list of works not to exceed £100. The Engineer had suggested the following places for such attention:

Salt House Lane, New Street (Footpaths),
Sea Front (at Clarke's), Bridge Street,
Leitrim Place (footpaths), Bayview Road,

Church Street (footpaths), Bath Street (footpaths), Kilmantin Hill (footpaths), and Strand Street,

and stated that 7 tons of Tar and 70 tons of Chippings would be required and a Patching Tar Pot (costing £15) would be required.

It was recommended that the work proceed and preliminary arrangements be made including ordering of material etc.,

The Committee were informed of Railway Company's proposal for maintenance of Railway Road and same was left over for monthly meeting.

It was recommended that there be all-night lighting on the 4th and 5th August on the occasion of the Regatta.

Circular (H.126012/35) dated 8/8/35 from Department of Local Government and Public Health dealing with a change of period for repayment of Housing Loans from 37 years to 35 years and change of rate of repayment from £2. 18. 10 $\frac{1}{4}$ per half-year per £100 to £3. 0. 3 $\frac{1}{4}$.

Read.

Letter dated 26/7/35 from Chief Executive Officer of County Wicklow Vocational Education Committee transmitting Report of Joint Conference on the proposal to build one new building to provide accommodation for a Technical School for Wicklow, a Library and Town Hall, and also the Architect's plan and estimate of cost: the cost of the Council's accommodation was estimated at £1700.

Order: The Council is not prepared to expend more than £800 on the accommodation offered and reserve the right to approve of site.

Letter dated 25/7/35 from Chief Engineer of Great Southern Railways Company, dealing with the maintenance of Railway approach road in which the Company agreed to enter into a four-year contract with the Council for the repair for the sum of £100.

Order: Council agree to accept the Railways Company's offer subject to sanction of the Department of Local Government and Public Health, the road to get an immediate overhaul of Tar and Chippings as indicated by Town Surveyor.

In this connection it was reported that following on a recommendation from the Finance and General Purposes Committee a deputation from the Council waited on the Traffic Manager of the Great Southern Railways Company on the 12th August 1935

at Kingsbridge, Dublin. The deputation consisted of J. Everett, T.D., Chairman, Councillor D. H. Haskins, J. T. O'Byrne, B.E., Town Surveyor, and the Town Clerk, and discussed with Mr Floyd and Mr Murphy, Engineer, the question of the road and also of the Railway Company's contribution to a further extension of Foreshore Works. An agreement was reached on the road question subject to a definition of steam-rolling and to the Departmental sanction. The Railway Authorities agreed to further consider the question of contribution for Foreshore Works.

Further consideration of this matter was adjourned to next Committee Meeting.

Letter from E. J. H. Hopkins, Esq., Solicitor, on behalf of John Power dated 11/7/35 inquiring if his client is expected to fill in the existing sewer or to pipe same, and if the work is to be done to a specification prepared by Council's Engineer or to his satisfaction.

Order: Mr Hopkins to be informed that the trench or shore may be filled in and that the £50 offered without prejudice is to be spent on strengthening and making secure the building, the work to be carried out with the prior knowledge of the Town Surveyor and in a general way to his satisfaction.

Item 2. The following Report of the Finance and General Purposes Committee from their Meeting on the 20th August, 1935, was read:-

The Railway Company having declined by letter of 15/8/35, to

accede to the Council's request for late departure of Excursions train because of late arrival in Dublin, it was recommended that the Town Clerk should point out to them that the Arklow train does not arrive in Dublin until 10.15 p.m.

It was recommended that the rent to be charged on the proposed new Leases to Mr Stone and Mr Shaw be increased from £15. 2. 6 to £18. 18. 4, the parties to adjust the rents between them.

It was recommended that the Council accept surrender from Mrs McPhail of premises at South Quay in accordance with her Solicitor's (Mr Hopkins) letter of 24th June last, the Town Clerk to inquire meantime as to tenancies existing and terms.

On the question of the plot at Friar's Hill leased to Earl Fitzwilliam at £1. 2. 0 and the proposal in the letter of his Solicitor Mr Hopkins dated 24/6/35 it was recommended that the Town Clerk and Solicitor take the matter up in a friendly spirit with Earl Fitzwilliam's Solicitor with a view to an amicable settlement.

In connection with the Notice of Application for Dancing Licence by John J. October 1st, 1935, - Gentlemen, There has been no improvement in amount of water coming into Reservoir in spite of recent rains.

As I pointed out before owing to state of streams, it will take at least from 10 to 12 hours very heavy rain to make any impression. This, I know from past experience.

I am anxiously waiting for water to have Filtering Beds washed and cleaned.

At this time last Season we had heavy rain and Reservoir was starting to rise.

There are 7ft. 10ins. of water in Reservoir. Of course, Reservoir has been lower at this time of year on many occasions..

It will be absolutely to cut off water at night towards the end of this week or early next week in order to ensure proper supply to higher levels.

Should there be much more call on resources of Reservoir, it will be very hard to keep constant supply to town in dry seasons.

I am afraid additional Filtering plant will also have to be provided, as we have to depend on water from Reservoir to wash sand etc., and this does away with a very large amount of water.

If water was confined strictly to domestic use the position would improve, but, an amount of water must be used in connection with many businesses, in order to keep premises in a sanitary condition, but this is very often abused. John DeCourcy.
