

Minutes of Monthly (March) Meeting of the Wicklow Urban District Council held on Tuesday 3rd March 1936, pursuant to the following Notice sent to each Member on the 29th February 1936.

Dear Sir: The Monthly Meeting of the Finance and General Purposes Committee of the Wicklow Urban District Council, of which you are a member, will be held at the Town Hall on Tuesday the 3rd March 1936 at 7 p.m.,

Item 1. Minutes were taken as read and confirmed.

Item 2. The following report of proceedings of a Special Meeting of the Finance and General Purposes Committee summoned for 15/2/36 was submitted.

A Special Meeting of the Finance and General Purposes Committee was held at 12 o'clock Noon on Saturday 15/2/36 after Notice to each Member.

The following Councillors were in attendance :-

J. Everett, T.D., (Presiding), J. Waldron, J. Olohan, and J. Clarke

The Town Clerk's selection of 36 applicants for the 36 allotments in the Dunbur Road Allotment Field was approved and also the 20 applicants for Allotments at the new field at Ballynerrin - the Town Clerk to let as many as possible of the remaining allotments to persons not qualified for the

Free Scheme at 5s/- per plot per season.

The Proposal of Edward Dickenson to take the old Allotment field at Ballyguile in conacre at 10s/- was approved of.

It being reported that arising out of storm damages, it became necessary to expend money on repair and protection of the Foreshore Works, the Committee approved of the expenditure to date, viz. £24. 13. 4, but were unable to recommend further expenditure as required by the Town Surveyor, pending next meeting of the Council.

The Weekly Wages Book was examined and signed.

The Report was adopted. In connection with the Allotment Scheme the Town Clerk reported that under the Free Scheme 36 Allotments had been provided in the Dunbur field and 25 in the Ballynerrin field making in all 61, and that in addition 4 Allotments at 5s/- per annum had been provided for persons not qualified for the Free Scheme. Only two plots remained in the Ballynerrin field and these two were objected to because of the amount of loose fresh soil deposited on them from the excavating and levelling operations carried out in the Housing Site during last Scheme of Christmas work.

It being reported that Edward Dickenson required certain inprovements to the fencing on the old Allotment field prior to his taking it over under the conacre letting, it was decided that having regard to the cheap rate at which it had been let to him, not to incur any substantial expenditure on the improvement of the fence.

At the Meeting of the Finance and General Purposes Committee held at 7 p.m., on the 3/3/36 claims for exemption and refund of Rates from Messrs S. V. Delahunt, D. H. Haskins, Michael J. Dowling, the Hibernian Bank (in re house at Wentworth Place formerly occupied by Henry J. MacPhail), Thomas Campbell and Guards Marren and Murray were examined and ruled on and the recommendations of the Committee were adopted. In case of the claim of the Hibernian Bank, it was recommended that the rates on the house for 1933/34 amounting to £24. 2. 2 be refunded subject to sanction, on the grounds that the house was not occupied at the time the rates for 1933/34 were made. It being pointed out that the Council had on the 24/2/35 declined to refund any rates paid in respect of the house. Councillor A. Dunne handed in Notice of Motion to rescind that decision.

The recommendations of the Committee on other cases were adopted as were also their recommendations of payments of £401. 14. 5 on the General Account and £132. 12. 0 on the Housing No. 3 Account, also the Committee's recommendation that the Council take no action on the report of the Town Agent of his having instituted Ejectment proceedings against E. Gaffney and James Wynne and his wife in respect of No. 9, St. Dominick's Road.

Item 3. It was Proposed by Councillor D. H. Haskins, Seconded by Councillor J. Waldron and passed unanimously,

That the amount to credit on the Sewerage and Watermain Loan of 1935 be applied, with the Department's sanction, to the work.

Letter P.H. 30960/36 dated 18/2/36 from Department of Local

Government and Public Health in reference to the proposal to in crease contract price for coal supplied by Mr H. J. Hamilton for School Meals Scheme, pointing out reasons why increase should not be allowed and intimating that the Council should take steps to ensure that they will receive the benefit of the reduction on Coal following removal of duty of 5s/- per ton.

Mr Hamilton to be informed.

Letter G.1145/35 from Department of Agriculture dated 25/2/36 approving of acceptance of tender of Mr N. H. Haskins, Main Street, for supply of seeds, implements and manures under Allotment Scheme and returning all tenders submitted.

Noted.

Letter H.21598/1936 dated 7/2/36 from Department of Local Government and Public Health sanctioning additional overdraft accommodation of £1,500 for new Housing Schemes.

Noted.

Letter P.H.21352/36 dated 5/2/36 from Department of Local Government and Public Health pointing out that owing to benefits to be the Public Health of the Diphtheria Immunisation Scheme, no restrictions should be placed on classes to benefit by same.

Noted.

Circular H.190700/35 dated 29/2/36 from Department of Local Government and Public Health transmitting Acquisition of Land (Allotments) (Forms) Order 1936.

Read.

Circular No. 18/36 from Department of Local Government and Public Health on the subject of compulsory retirement of Officers.

Send copy to Officers concerned.

Letter H.208422 dated 2/3/36 from Department of Local Government and Public Health returning the lay-out plan and specification in connection with the proposed erection of the 98 houses - stating that the Minister is of opinion that the density should be increased so as to provide 15 houses to the acre, and questioning the advisability of building any one-storey houses, also other matters.

Also letter H.217242/35 dated 2/3/36 from same Department returning lay-out plan and specification for the 20 houses of better class advising that density be increased here also, and advising that this Scheme be deferred until tenders are received and accepted for other 98 houses.

Owing to the views held by the Council on the question of density and other matters a deputation consisting of the Chairman and Town Surveyor and any other Councillors available was appointed to wait on the Minister to strongly advocate approval of the existing Schemes - Council agreeable to the suggestion as to deferring the Housing Scheme of 20 ketter houses until tenders are accepted for others.

Letter H.21505/1936 dated 6/2/36 from Department of Local Government and Public Health enquiring what action the Council propose to take on reports from M.O.H., and Engineer on the Dispensary Lane houses?

The same deputation to await on Minister to permit of a

Compulsory Purchase Scheme for this area.

Letter dated 8/2/36 from M. Ward for Boys Guild, Glasgow, asking for use of the Murrough during coming Summer. The Town Clerk pointed out that he had already let Murrough space to boys from De La Salle Bros., School, Sheffield, at £1 per week and 5s/- for water.

Town Clerk to correspond and arrange with Boys Guild

Report dated 27/2/36 from Town Surveyor on wall at Bayview which Mr P. T. Healy complained had been damaged by water percolating through from footpath - Town Surveyor estimating cost at £14.

Adjourned.

Letter dated 26/2/36 from Solicitors for O'Hanlon Estate agreeing finally to terms in Council' Solicitor's Letter of 25th idem. and forwarding proposals for sale of two houses signed by their client. Town Clerk explained that one tenant Purchaser (Denis Noctor) had up to the present refused to sugn necessary release and that he had written him intimating that proceedings would be taken to compel him to sign.

The Chairman and Town Surveyor who were appointed at the Monthly (March) Meeting to wait on the Minister for Local Government in connection with the letters from his Department dated the 2nd March 1936 on the Council's Housing Schemes, and also in connection with the Council's proposals as to Dispensary Lane Clearance Area reported as follows:-

#### Ballynerrin Housing Scheme.

Dear Sir: We, the undersigned beg to report that we attended at the Housing Section of the Department of Local Government on Friday 13th inst., at 3 p.m., and interviewed representative Officials of that Department regarding the proposed alterations in the above Housing Scheme.

The question of increasing the density of the building on the land available was under discussion, and it was evident that the Department was most desirous to have such an increase. The proposition put forward by its representatives was that 15 houses to the acre was desirable. After hearing arguments from both sides it was finally decided that the Wicklow Urban Council should be advised by us to build 100 houses on the Ballynerrin Site, thus making the density approximately 12½ houses to the acre, and it was also pointed out to us that a greater number of four-roomed houses and a lesser number of three-roomed houses would be required.

It was also clear that the Department would not approve of the erection of one-storey houses on this site.

Item 1Minutes of Meetings of 3/3/36 and 16/3/36 were confirmed.

Committee was held as directed on the 14/3/36 to consider the Town Surveyor's proposals for the provision of an auxiliary Water Supply for the Town. There were present Councillors McMahon, Olohan and Clarke, the Town Surveyor and the Water-works Overseer. The Committee visited the suggested source of supply at the Glen, Dunbur, where the Town Surveyor demonstrated his proposals. The Committee were of opinion that the Scheme of supply from the Glen Stream was a good one, but considered it would be wise to get the report of an Engineer specialising in Waterworks before embarking on any expenditure. The Committee were of opinion that the provison of an auxiliary supply was urgent.

Proposed by Councillor M. McMahon, Seconded by Councillor D. H. Haskins,

That the report of the Finance and General Purposes Committee which met on the 14/3/36 to consider the provision of an auxiliary Water Supply be adjourned, and that in the meantime provision be made by way of loan or Overdraft for the amount as found by the Engineer to be necessary for the repair by grouting, of the wall of the existing Reservoir. and Cost of bringing the Main throughwarks when

That the Minute of 24/2/35 be rescinded so far as the rates on the house in Wentworth Place (formerly occupied by Henry J. MacPhail) for 1933/34 are concerned, and that the rates paid by the Hibernian Bank, Wicklow, in respect of that year amounting to £24. 2. 2 be refunded to the Bank, subject to sanction of the Department of Local Government and Public Health on the grounds that the house was not occupated at the time the rates for 1933/34 were made.

Item 4. The Town Clerk reported that completed plans and Estimate (as amended) for the 120 houses were handed in at the Department by him on Friday 3/4/36 and that he expected a letter with daily from the Department approving of same.

He submitted the amended Estimate of £42,642 for the 120 houses and pointed out that it meant a reduction on the cost of each house of £7 odd, and that he anticipated a rent of between 4s/- and 4s/9d including rates would have to be charged. It was decided to adjourn this matter to an adjourned meeting to be held at 7.30 p.m., on 15/4/36 when it was expected definite approval would have been received from the Department to permit the Council to advertise for Tenders.

I beg to report that I have audited the Accounts of the Wicklow Urban District as administered by the Commissioner, Mr Patrick J. Meghen, B.E., B.Sc., for the period from 1st April, 1933 to 5th July, 1934; and as administered by the Urban District Council from 6th July, 1934 to 31st March 1935. Certified Copies of the Abstracts are forwarded herewith.

The General Fund Showed balances in favour of £529. 13. 11 at 31/3/1933; £1,632.5.1 at 31/3/1934 and £1,110. 17. 4 at 31/3/1935; and the Poor Rate Account showed balances in favour of £1,040. 9. 4, £564. 16. 7 and £458. 8. 1 respectively at the corresponding dates.

In the year 1933/34, arising from their liability as Guarantors under the Harbour Confirmation (No. 3) Act 1907, Wicklow Harbour Order Article 41, the Council were obliged to pay to the Board of Works a sum of £2,279. 7. 9, being the accumulated arrears of Principal and Interest due from 1st November 1924 to 1st May 1933. In addition there was an accumulated liability of £653. 9. 2 in respect of penal interest, and by an agreement made this is being repaid by ten half-yearly instalments of £65. 6. 11. Moreover, since 1st November 1933, the Council have had to pay to the Board of Works the recurring half-yearly instalments of Principal and Interest in respect of the Harbour Loan in question. The Council should definitely ascertain, and keep themselves constantly informed, to what extent, if any, the Harbour Board is in a position to recoup this outlay.

Law Costs amounting to £693. 14. 5 paid in the year 1933/34 included an amount of £462. 5. 8 which had accumulated over a number of years. In this connection attention is drawn to Article 23 of the Public Bodies Order, 1935.

The Balance to credit of Loans Fund at 31/3/1935 as shown in the Abstract of Accounts is £4,051. 15. 6. The amount which should be at credit of the Fund at that date as shown in the Table of Sinking Fund accumulations is £3,948. 3. 0, so that in appearance there is a surplus in the Fund but this is only an apparent surplus as there is included in the amount of £4,051. 15. 6 a sum of £1,110 derived from the sale of Coastguard Houses, a portion of the Corporate Estate, to which I made reference in my last report.

A balance of £852. 12. 9 arrears of rents shown in the Rental of Corporate Estate appears to include a number of items which are now irrecoverable and the rental should be revised at an early date.

The balances shown on the Treasurer's Accounts do not correspond with the respective Refenue balances and to correct this the following Bank Transfers should be made:-

We represent that the effect of this order will be as disastrous to the farmers, as to the traders, on whose behalf we speeak."

Report of Town Clerk on School Meals for Season 1935/36.

The School Meals Scheme began on the 21st October 1935 and concluded on 3rd April 1936, During that time 9,341 meals were given on School going days at the centre on The Mall, to the girls from the Dominican Convent School and the De La Salle Brothers School at a total cost of £91. 7. 4. The cost works out at 2.4d per meal. Of the meals served 786 were in October, 1991 in November, 1345 were in December, 1389 in January, 1794 in February, 1795 in March and 241 in April. It was noticeable this Season that the attendances kept up well to the close of the Scheme, - due no doubt, to the inclemency of the weather. The average daily attendance was 90.

The attendance of girls appeared to be on average much

greater than of boys.

In the administration of the Scheme the services of the ladies Committee in charge, particularly those regularly attending and the Hon. Secretaries (Misses Kavanagh and Fitzsimons) were of the greatest assistance, and in fact provided the Council with their main assurance that matters were well managed at the distributing centre.

Proposals for payments were examined and authorised.

After consideration of the Town Clerk's Estimates for Rates for 1936/37 and his report thereon, it was recommended by a majority that a Town Rate of lls/2d and a Poor Rate of 6s/6d be adopted, - the minority being in favour of a Town

Rate of 11/1d and a Poor Rate of 6s/6d.

- The adjourned matter of the plot at Friar's Hill held under Lease by Earl Fitzwilliam from the Council and sold by him as fee-simple to Mrs Grimshaw and now by lapse of time so held by her, was again under consideration, as well as letter of 26/3/36 from Mr Hopkins, Solicitor, on the matter, and it was recommended that the Council offer to accept £30 for their rights in the matter.
- It was recommended that a complaint by Sergeant McBrinn as to the condition of Cooper's Lane be referred to the S.S.O., to have cleaned.
- The Town Surveyor having renewed his application for fees on the Monkton Row Houses inspected and reported on by him and subsequently condemned, it was recommended that the Council should ascertain in advance from the Department what is the proper amount payable for such work in connection with Scheme of 120 houses.
