Item 5.

Town Surveyor's Report.

In accordance with your instructions after the last Meeting of the Council, I have investigated the cost, and propose to

(a) Repair the Old Reservoir Embankment.

(b) Lay a new Main from the Old Reservoir down direct through or near the Marlton Glen, and continuance of same to new proposed service Tank on a high level above New Housing Scheme.

I have obtained data in connection with proposal (a) above, and the Estimates range from £900 to about £3,000.

I have examined the old embankment and I regret to report that it is in a very poor condition and leakages are evident throughout. At the moment I find that the loss is approaching 10,000 gallons per day. I do not propose to submit an estimate at this stage, because, I think it very advisable to make a more thorough examination in the Autumn when the water is low.

As regards proposal (b) above, this item can be proceeded with immediately, and I estimate the cost of laying a new 9 inch main direct through from the Old Reservoir to Ballynerrin (a distance of 2,050 yards) to cost £3,000. This figure to include the erection of a small 40,000 gallons service Reservoir. This would ensure adequate pressure to the higher parts, and pending the provision of an increased impounding Reservoir, now under investigation, would give satisfaction.

The Town Surveyor reported progress on the work of repair of the concrete promenade on the Sea-front for which a sum of £10 was earmarked and the quotations for the supply of cement for same were examined.

The first of such inspections shall be made in the month of July, 1936.

2. Preparatory to the inspection (after entry) of any house, premises or building in the District, pursuant to the inspections hereinbefore provided for, the Notice prescribed under Sec. 42 (c) of the Housing (Miscellaneous Provisions) Act, 1931, shall be given to the occupier and owner, if the owner is known, of the intention of the Inspecting Officer or Officers to enter such house, premises or building, for the purpose of survey and examination, which Notice the Inspecting Officer or Officers are hereby authorised to give for the purpose of the inspections hereinbefore provided for.

3. The Records referred to in paragraph 7 of the Regulations shall be prepared and kept by the Town Clerk at his Office, Town Hall, Wicklow.

4. The Council shall at least twice in every financial year at a regular Meeting of same, and after Notice on the Agenda sent to each Member, take into consideration the records prepared under the Regulations, and shall give all directions and take all such action within their powers, as may be necessary or desirable, in regard to any house or houses to which such records relate, PROVIDED ALWAYS that for their better guidance in relation to any house, premises or buildings, they may direct the Town Surveyor to inspect same and report to them, and he, as well as the Medical Officer of Health, shall, on receipt of such directions be an Inspecting Officer for the purpose of Rule 2 and the provisions thereof respecting Notices shall apply to him accordingly.

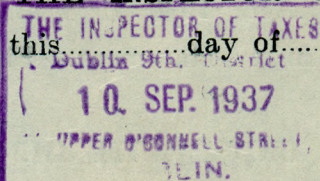

NOTE I. ALLOWANCES AND RELIEFS.

If your claim to the allowances has not been made, you should complete and forward the appropriate form immediately. If you have not a form, one will be sent by the Inspector on request. In the case of a claim for Life Assurance, you should produce the receipts for premiums paid during the past twelve months.

NOTE II. APPEALS AGAINST THE AMOUNT OF THE ASSESSMENT.

In addition to giving notice and stating the grounds of your appeal, you should furnish the Inspector of Taxes (unless you have already done so) with full and complete yearly accounts of your profits from Trade, Concern, Profession, or Vocation for the preceding year, ending on the date prior to 5th April, 1937, to which your accounts have usually been made up, or on 5th April, 1937. If you have commenced business within the preceding year, your accounts must show the profits for one year from the date of commencement. If, however, the assessment against which you desire to appeal is in respect of income from Interest, Annuities, or Discounts, not taxed by deduction, particulars should be given for the year ended 5th April, 1937, or ending on 5th April, 1938, if the income first arose subsequently to 6th April, 1936. If the assessment against which you desire to appeal is in respect of any other income, you will be notified as to the particulars required.

NOTE III. CIRCUMSTANCES IN WHICH SPECIAL APPLICATIONS FOR ADJUSTMENT MAY BE PREFERRED.

1. New Businesses.—In the case of a trade, concern, profession or vocation set up or commenced within the year ended 5th April, 1937—Finance Act, 1929, Sec. 9 (2).

2. Discontinued Businesses.—In the case of a trade, concern, profession or vocation permanently discontinued in year ending 5th April, 1938—Finance Act, 1929, Sec. 12 (1) (a).

3. Loss sustained.—

(a) In the event of a loss being sustained in any trade, etc., by any person during the year ending 5th April, 1938—Income Tax Act, 1918, Sec. 34.

(b) Where relief has not already been wholly given in respect of loss proved to have been sustained in the same trade, etc., in any of the six years preceding the year ending 5th April, 1938.—Finance Act, 1929, Sec. 14.

4. Partial Change in Proprietorship, etc.—If occurring in year ending 5th April, 1938.—Finance Act, 1929, Sec. 13 (1).

5. Interest, and Income from Securities, Stocks, Shares, Rents and any other Possessions not having suffered Saorstát Tax by deduction :—

(a) where the income first arose on 6th April, 1936, or on some day in year ended 5th April, 1936 other than the 6th April, 1935.—Finance Act, 1922, Sec. 17.

(b) where the source of income wholly ceases in the year ending 5th April, 1938.—Finance Act, 1929, Sec. 10 (3).

6. Double Taxation Relief.—A person resident in Great Britain or Northern Ireland and not resident in Saorstát Éireann, is entitled to claim exemption. A person resident both in Saorstát Éireann and in Great Britain or Northern Ireland, is entitled to Double Income Tax relief.—Finance Acts, 1926, 1928, and 1929.

7. Error or Mistake.—In taxpayer's return or statement.—Finance Act, 1924, Sec. 8.

NOTE IV. TIME LIMITS FOR APPLICATIONS UNDER NOTE III.

Under paragraphs 1, 3 (a), and 5 (a), within one year after the end of the year of assessment; under paragraph 4 within three months after change took place by a notice signed by all the persons concerned; under paragraphs 2, 5 (b), and 6 within six years after the end of the year of assessment; under paragraph 7 within three years after the end of the year of assessment; under paragraph 3 (b) within six years after the end of the year of assessment in which the loss was sustained.
