After deliberation on the Report for at least 1½ hours and considering what steps the Council should take on it, it was recommended

"That the report be adopted as far as items (c), (e), (f), (h), (i) and (j) are dealt with, i.e. 32 houses in all and that the Committee adjourn further consideration of the matter until Friday 18th December 1936 and meantime Doolittle property at Lower Monkton Row to be inspected and reported on by Dr Beckett and Mr J. T. O'Byrne."

The Committee also had under consideration a letter dated 8/12/36 (RU/203/32) from the Department of Local Government and Public Health offering a Road Grant of £1,025 subject to a local contribution of £375 and subject to the other conditions therein stated and the following recommendation was made:

"That we recommend that we adhere to the Scheme of Road Works as already submitted amounting to £600, and that the Council contribute £100 out of Revenue to that Scheme, and that the Department be requested to allocate to a further extension of the Coastal Defence Work a Grant of at least £1,025 part to be taken from the proposed Grant on condition that the Council raise the balance up to an expenditure thereon (Coastal Works) £1,550."

The Committee had under consideration a letter of 9/12/36 from Mr W. Sutton (building a house under the Small Dwellings Acquisition Acts Scheme) in which he asked for Council's assistance with regard to the Sewering of the house and reduction of costs of Lease and it was recommended

"That the Council agree to extend a nine inch Sewer to Mr Sutton's bounds, cost not to exceed £30 subject to sanction, - Mr Sutton's other obligations under the Lease to remain and the cost of the Lease as furnished to stand."

The examination of the Main Rental was adjourned.

The following Report of the Committee Meeting of the 11th December, 1936, was submitted:-

Report of Adjourned Monthly Meeting of the Finance and General Purposes Committee held on 11th December, 1936.

Present: Councillors W. O'Grady, (Presiding), J. Olohan and J. Clarke.

The Town Clerk reported that he had interviewed the Department Officials in connection with the Committee's recommendation on the Unemployment Grant offer and was informed that the Council could proceed with a small Scheme at first, but that the local contribution to a £400 Scheme would need to be £125.

It was recommended that a £400 Scheme be proceeded with at Christmas, that the local contribution of £125 be found from revenue and that consideration of a further Road Scheme be deferred pending a decision from the Department on the Coastal Defence Scheme under which an expenditure of £1,250 on a further extension is proposed if the Government give a Grant of £775.

The List of men as supplied by the Labour Exchange was gone into, and the most deserving were marked out for employment prior to Christmas and that as many as possible from the lists be employed for a full week about Christmas time.

Payment of £200 of the Advance to Mr W. Sutton was arranged for and the following recommendation made:

That we recommend that a new Account be opened with the Council's Treasurer to be known as the Small Dwellings Acquisition Acts Account to be operated for receiving Advances from the Board of Works and making Advances to parties building houses in pursuance of the Acts.

Seconded by Councillor W. O'Grady and passed unanimously,

That the Report be adopted.

The following Report of the Committee Meeting of the 18th December, 1936, was submitted:

Report of Meeting of the Finance and General Purposes Committee held on the 18th December, 1936, as adjourned from 9th December, 1936.

Present: Councillors W. O'Grady, (Presiding), J. O'Connor, J. Olohan and J. Waldron.

The steps taken to deal with insanitary houses in view of the 120 houses in course of construction were reviewed and Councillor W. O'Grady handed in Notice of Motion to regularise the steps taken in connection with the houses in Ball Alley etc., in October 1935.

Further consideration of the remaining houses in the list of 58 houses in the County Medical Officer of Health's report was adjourned to next Monthly Meeting of the Committee in view of the small attendance.

Progress was reported on the work under the £400 Relief Scheme.

Mr W. Sutton's further letter dealing with costs of his Lease was adjourned to Monthly Meeting.

Arrangements were made for payments under the Christmas (£400) Unemployment Scheme, and also for all-night lighting of lamps on Christmas Eve.

It was recommended that Mrs Ellen Dunne be allowed to continue to have use of the grazing of the field at Ballynerrin Lower from 1st November last at a weekly tenancy at the rate of 2s/6d per week, the tenancy to terminate definitely on the 31st March next or earlier on a week's notice if land required for Housing.

It was Proposed by Councillor J. Clarke,
Seconded by Councillor W. O'Grady and passed unanimously,

That the Report be adopted.

The following matters were dealt with in Committee prior to the Meeting this night:

On the application of James Jameson for tenancy of yard at South Quay recently surrendered by M. Turner at £3 clear of Rates,

It was recommended that he be given the yard on the same terms as Mr Turner, viz. at £5 per annum and Rates.

It was recommended that the Council's Solicitor be empowered to negotiate a settlement with Mr Brazil, Solicitor, of Mrs Gregory's Rates amounting to £65. 8. 6.

The Town Surveyor's letter of 15th December, 1936, and enclosures thereto dealing with the dangerous wall in Market Street was referred back to him for further consideration and report.

It was recommended that the De La Salle Brothers application for remission of rates because of vacancy of house on Chapel or St. Patrick's Road be granted and Mr William Clarke's ~~xxxx~~ similar application in respect of a yard at North Quay be granted subject to the sanction of the Department, in view of the doubt as to whether remission was permissible in respect of a yard.

Mr W. Sutton's further application for reduction of costs of Lease was considered. The Town Clerk pointed out that in regard to the recommendation to extend the Sewer for Mr Sutton at a cost of £30 no money was available unless the amount allocated for cost of fencing and regulating the Dumping Ground at Black Castle was applied.

It was recommended that the costs of the Lease as furnished should stand, and that the money earmarked for fencing the Dump be now allocated to the extension of the Sewer for Mr Sutton.

It was recommended that the Clerk's acceptance of the quotation from the County Printing Works for printing Allotment Forms at £1. 5. 0 as against the Monument Press's figure of £1. 7. 6 be approved.

The Bank Pass Books were examined and also proposals for payment and the following payments were recommended :-
