COUNCIL MEETING: - The Town Clerk read his Report on this Estimates for Town and Poor Rates as follows:-

To :-The Chairman & Members of the Wicklow Urban District Council
A Chairde,

I submit for your consideration and adoption (with or with-out amendment) my Estimates for Town and Poor Rates for the service of the year 1939/40.

TOWN/RATE.

Last year's net expenditure exceeded my estimate for same by £483 due mostly to over-expenditure on Public Lighting (£20), Town Hall (£100), Harbour Commissioners Loans (£26), Bank Interest (£9), School Meals (£13) Roads (£140) and under estimation on Loan for Waterworks (£116) and Sewer Extension Loan (£30).

Last year's Receipts exceeded the estimated receipts by £348 due principally to a larger amount received from Housing Subsidy than was anticipated. That left a deficit of £135 on my figures as submitted to you last year. The amount asked for last year was reduced by you by £95 and our resultant deficit should be £230 but after close examonation of the possible yield from Rates and Corporate Estate, I believe we can, with safety, carry forward the Deficit as shown in my Estimate viz £194 :3 :5. In carrying forward this deficit, I am still counting on receiving from a Housing Capital Account the sum of £240 at least which was spent on roads developing Housing Sites. If our Normal Housing Scheme should not proceed, this £240 will have to be found mutx from Revenue.

It will be noted from figures supplied you that this year provision is made for £823 under SALARIES etcagainst £754 last year. This
becomes necessary because of increase Poundage given to Town Agent and
Rent Collector by you last year and also because of increment in salary
due to Town Sergeant & Road Overseer as granted by you and sanctioned

Under the heading of General Expenditure, you will note increased provision of £136:13: - due principally to £60 additional provided for repairs to Artisans Dwellings, £40 for Fire Hose and £50 for Rents Rates Taxes and Insurances.

Under ROADS, I have reduced the local Contribution this year by £140 by reason of the spending of that amount in advance last year when same was not estimated or provided for. This will probably have the effect of reducing the Grants for Relief Works from £2,095 to £1,047 or thereabouts. The Town Surveyor gave me an Estimate of £766 for ordinary Road Maintenance: I consider that the most we can provide against this and keep within normal Road Expenditure is £260 i.e. £200 for wages and £60 for material. That makes the estimated expenditure on Roads this year £445 against £485 provided for last year.

The <u>BURIAL BOARD</u>'s Demand is up by £11 :13 :8.

For <u>WATERWORKS</u> I provide the same as last year viz £250 (last year's expenditure was £265).

In the <u>REPAYMENT OF LOANS</u> an increase of £814 :6 :3 must be prov-ided for , due principally to an increase (£640) on the Loan for the
120 Houses , £87 for Foreshore Loans and £140 for Waterworks.

Inxthexreps I have provided for £80 this year for Harbour Commiss -ioners' Loans against £150 last year. The gross expenditure this year taking the deficit of £194 and allowing the reductions on roads and Harbour Commissioners' Loans, is increased by £1116.

RECEIPTS.

While , this year, we lose the £124 from the E.S.B. I am counting on getting the full rents accruing on the Artisans' Dwellings for the year, an increase of £800 on Housing Subsidy, a small increase on Corporate Estate Rents and for those reasons I am estimating for an increase of Total Receipts by £10009: -: 7 over last year's Estimatedeor £678:18:3 over last year's receipts. Against a total Expenditure of £9407: 9:3 I calculate total receipts of £5436:10:8 leaving £4033:18:7 to be found by Rates. This amount has to be found on an effective valuation of £6203:L9:- i.e. £194:13:- less than last year and I have therefore to recommend a Town Rate of 13/- in the £ or 1/8 increase on last year.(ld in the £ now yields only £25:17:-)

Briefly the reasons for the increase in Rates are (1) insufficiency of last year's Rate (2) increased expenditure, particularily on Loans, (3) loss of the E.S.B. Receipt of £124 per annum and the reduction of the Effective Valuation. The reduction of Effective Valuation is due principally to the operations carried out under the Housing Acts.

I may add that the during the past twelve months the Council have had recourse to extensive overdraft accommodation from their Treasurer and paid the sum of £91 :1' :- as interest on same. I believe the reasons for this to be principally the prevailing error that Town Rates are not -t due until the end of the year for which they are made and also to the to the fact that the time fax we have been making the rates is too late in the year. Town Rates are due and payable when the Demand Notes are served. I have advanced my Estimate this year by one month on last year. The Minister for Local Government has warned the Council sufficient that unless/provision is made in this year's rates for liabilities no further overdraft accommodation will be authorised.

No specific provision is made for Grant to Tourist Developm--ent Association or to repair and improve the National Monument in the Market Square.

POOR RATE

The yield from the Rate of 7/8 last year was not equal to expectation. It was reckoned that it would yield £3047 :2 :- whereas it yielded only £2868 :4 :2. This deficiency of £178 :17 :10 coupled with the knowledge that the irrecoverable rates will be roughly maxe£100 more than the Estimate for same makes it necessary to bring forward a debit of £274 : 9 :8 this year against a debit of £83 :6 :11 last year. These deficiencies in yield are accounted for mainly by the operations of the Housing Acts and other vacancies. The deficit in excess over last year's deficit accounts for the necessity of an increase of 6d in the £ this **jear*.

In addition, the County Council Demand is up by £29 which requires roughly another ld in the £ over last year's Rate .Finally because of the drop in the total Effective Valuation by £38 and a consequential increase in Collector's Poundage, the total increase over last year's Rate is brought up to 8d in the £. It is therefore necessary, in my opinion, to provide for Poor Rate of 8/4 in the £ if the Council are to meet all the liabilities that fall to be discharged -d by Poor Rate for 1939/40. (The total Effective Valuation for Poor Rate Purposes at present is £7921 :7 :4--1d in the £ brings in £33).

Haskins handed in a Notice of Motion to rescind. On re-consideration of the proposals for new Works it was agreed to instruct the Town Surveyor to prepare Plans specification and Estimate for a new re-inforced concrete Rxix Foot Bridge to replace the old Wooden Bridge accross the Leitrim River and to instruct the Town Clerk to make application to the Department of Local Government & P. Health for the maximum grant available -- the Council's contribution from Rates to be raised by Loan.

The Town Surveyor's Report of the 8th May 1939 on the present position of the Beach and Foreshore at Wicklow and the further requirements to make it safe was read and it was agreed to undertake the repair and strengthening of the old Promenade at an estimated cost of £648 -- the necessary pland and requirements to be furnished to the Department of Local Government and they to be asked for the maximum grant in aid.

The Town Clerk submitted the following report on the working of the School Meals Scheme for 1938/39:-

Meals were distributed from the 31st of October 1938 and continued without interruption on every school-going day until the 31st March 1939 for a total of 95 days.

The number of meals distributed to Girls was 4208 and to boys 3933 or a total of 8141 meals. The total cost was £96:17:11 or about $2\frac{3}{4}$ d per meal.

The number admitted to the benefits of the Scheme was 120 (51 Boys and 69 Girls). The average attendance was 86 i.e 42 Boys and 44 Girls.

The number of ladies giving their services voluntarily to supervise the distribution of the Meals has so far reduced as to make the work of supervising for the few remaining both onerous and exacting: it would appear that in the event of the unavoidable absence of the few attending there would be no supervisors to attend and mark the rools etc.

For this reason all the greater credit and thanks of the Council are due to to the few voluntary workers left and in particular to Miss Fitzsimmons who acted as Hon. Secretary.
