The Town Clerk submitted the following memorandum in connection with the Ach.

Behome :-

" The following are Workers within the meaning of the Act :-(a) Town Clerk (b) Town Sergeant, S.S.O., Road Overseer & Shops Inspector i.e. B.O'Toole (c) Waterworks Overseer (d) Town Agent & Rent Collector (e) Roadmen & Scavengers

There may be some question about the original appointment of the Town Clerkwhose employment was described in 1932 as part-time but having regard to the amount of work since accrued and the time devoted by him to it and his subsequent employment as Solicitor there appears little doubt but the present holder of positions of Town Clerk & Solicitor come within the meaning of thes Act.

In this connection I would ask the Council for this and all other purposes to delare that by reason of the joint positions and the amount of work now involved, that I am engaged for at least the normal working hours (10 a.m. to 5 p.m.) on the Council's business and therefore whole--time ---- subject to Departmental sanction. This may be a matter of s importance in the near future by reason of the possibility of War Bonuse:

> ORDER :-Required declaration approved of unanimously and hereby made .

The Memorandum proceeds :- "There is an element od doubt re the M.O.Health and Town Surveyor and Veterinary Inspector and Rate Collector by reason of the difficulty of ascertaining the amount of their time engaged on the business of the Council and their <u>rate</u> of remuneration accordingly. The Act prescribes the minimum holifays that must be given and does not debar the Council from giving more nor does it interfere with the holdays an officer or Employee may be entitled to by reason of the terms of his appointment.

The Act may present some difficulty as to the employment of such officers as (1) Town Sergeant etc(B.O(Toole) and (2) Waterworks Oversee: -r on Public Holidays i.e. Xmas Day, St.Stephen's Day, St Patricks Day Whit Monday and 1st Monday in August . Emergencies may necessitate their working on those days or some other person in their places. If such emergencies arise on those holidays the requisite notice (14 days) cannot be given and therefore it would be necessary in such emergencies to employ substitutes for them on such days."

Order :- Abide the emergencies arising.

Item 3.

(a) The Town Clerk referred to the reports which he had and which were already before the Council in connection with the house occupied by the McCarthy family at Bath Street.and pointed out that some steps should be (baken in the matter with a view to transferring the Tenant or otherwise. A letter dated the 2nd of January 1940 was handed in by Mr Wm.O'Brien of Bray the Contractor provisionally accepted for the 34 & 10 houses propos--ed to be built in which he pointed out that he had ascertained that he could get now the greater substantial items of the materials required for the houses and indicated the increase in the price of such since the date of his tenders. The matter was discussed fully by the Council and Mr O'Br--ien was then called in and questioned and heard and he was again asked to retire.

Mr O'Brien was informed then of the terms of the resolution and stated he would not be able to give a reply until the following morning and undertook to telephone the Town Clerk at 11 a.m. on the following morning as to his decision.
