Present :- Councillors J. Everett T.D.(Presiding), W. O'Grady, J. Olohan, C. W. Hudson, J. Clarke, J.O'Connor, M. McMahon and E. Lalor. Also present --J. T. O'Byrne Esq., B.E. Town Surveyor. Payments were were recommended and authorised on General account as presented. Payments in connection with the 34 House Scheme were left over until the Town Surveyor was in attendance as it was doubted whether the amount proposed to the Contractors (£1,016) was excessive:on the Town Surveyor subsequently attending and stating he was satisfied with the amount of his certificate , the payments were authorised as presented.

#### Item. 2.

PROPOSED by Councillor J.Olohan , SECONDED by Councillor C. W. Hudson and passed :-

That we the Members of the Wicklow Urban District Council Grant a Lease for 31 years to Richard Kavanagh of the parcelx of Land at Cooper's Lane at a Rent of 12/6 per annum in addition to the Rent of 2/6 per annum which he pays for the Right of Way through the said Plot (Total 15/6) the plot being that as shown on the sketch as produced and containing  $14\frac{1}{2}$  perches he not to erect any structure on the plot without the written consent of the Council and to permit the Council or their successors to acquire at any time hereafter portion of the said plot for the purpose of **memiring** opening up or widening Cooper's Lane at a price not exceeding 1d per linear foot AND that a Lease for the same period and subject to the same terms be given to John Leonard of the plot adjoining at Copper's Lane at the annual rent 7/6.

### Item 3.

The Town Clerk reported that on the 11th of May 1940 a Committee consisting of Councillors J. Everett, J. Clarke and J.O'Connor inspected the plots proposed to be leased at item 2. and made payments to Road Workers. He also reported that on the 18th of May a Committee consisting of Councillors McMahon and Hudson attended at the Town Hall and agreed to let the house at 27 Glenview Road --previously given to Mrs O'Shea and not taken by her --to John Byrne of High Street who was living in an overcrowded house with his parents wife etc.

The reports were approved .

A letter dated the 1st of June 1940 (H.14498/2/40) was read from the Department of Local Government & P.Health in which it was stated that no recoupment could be made in respect of the cultivated plots it is proposed to surrender.

Order :- Mr Haughton to proceed on the understanding that he is to re-coup the Council for any loss and that he settles with the 2 Allotment Holders.

# Item. 5.

Letter of the 28th May 1940(G.4015/6/40) from the Department of Local Government in which it was stated that the Minister declined to sanction overdraft accomodation in view of the Reduction by the Council of the Estimates and directing the re-opening of the Estimates.was tead. The Town Clerk stated that he had asked the Chairman to intervene in the matter and the read his replying letter of the 29th of May 1940.

The Town Clerk also read letter of the 30th <sup>M</sup>ay 1940 (G.4015/8/40) from the Department of <sup>L</sup>ocal Government sanctioning pverdraft up to £2000 up to the 15th of June 1940.

The Town Clerk read a Scheme for collection of water rents which he had found approved of in the Council's Minutes of the 2nd of October 1928 setting out charges for various classes of non-domestic users .

After discussion it was agreed to adjourn this item to a Special meeting aft to be held on the 25th of June 1940.

# Item 8.

The Town Clerk read details of the contributions promised by local property owners concerned and stated that he believed that with the Railway Company's Contribution and Contributions from the Gas. Co and Manure Co. the contributions would reach Elmost £300.It was therefore agreed to proceed to apply for a Loan of £600 and a Grant of £900.to find the £1800 estimated cost of completing the works necessary for the repair and improvement of the Promenade.

# Item 9.

It was agreed to hold the annual Meeting on the 25th of <sup>J</sup>une 1940 and also to hold a Special Meeting on the same date to deal with a number of Matters of urgency and importance. A Requisition was signed accordingly.


