Arising out of the system of retailing the Fuel the County Manager stated that he did not think that the arrangements were satisfactory and he feared that the Rate Collector who was engaged on the Scheme might be neglecting his duties as Rate Collector in consequence : the County Manager referred to the figures of the collection and to the Council's overdraft,

The Town Clerk reported that there was available only about 20 tons of inferior Turf and 5 or 6 tons of blocks and that the bringing of that the blocks from the Forestry Departments Depot at Glendalough at £4:4: per cord (yielding about 3 tons 9 cwts) and paying £2:10:- per Cord for haulage was uneconomic.
