

Minutes of Adjourned Monthly (AUGUST) Meeting of the Wicklow Urban District Council held on Tuesday the 10th of August 1943 pursuant to Order and to Notice sent to each member on the 31st of July 1943.

Adjourned Item (1) - Minutes.

The Minutes of Meetings held on the 6th and 20th of July 1943 were confirmed.

Adjourned Item (2) -- Manager's Orders .

The Manager's Order Book was produced for inspection by the members

Adjourned Item (3) -- Fuel Schemes.

Reference was made to the decision of the Council at the meeting on the 20th of July 1943 to continue the Scheme and to the direction given to the Town Clerk to make inquiries as to any suitable accommodation that Miss Darcy might have on the South Quay for storage of Turf .

The Town Clerk read a letter dated the 27th July 1943 in which he conveyed to the Manager his views on the premises available by Miss Darcy following an inspection made by him and the Town Sergeant on the 26th of July 1943 from which it appeared that none of the premises were suitable .

PROPOSED by Councillor M. McMahon , SECONDED by Councillor Joseph O'Connor and passed :-

"That a Loan ~~max~~ of £400 be applied for to repair and reconstruct the Quarantine Hill premises so as to make them available for Fuel storage -- meantime 100 tons of Turf be stored in existing Fuel Yard at North Quay and monthly tenancy of same to be arranged " .

It was recommended that the Council get as a first instalment 50 tons of Turf from South Wicklow and that the County Surveyor be asked to have stacked in convenient depots on the bog at Sally Gap Turf which the Council will require up to an amount of approximately 400 tons.

It appeared from figures quoted by Mr O'Byrne Town Surveyor that the South Wicklow Turf would cost 56/- per ton delivered in Wicklow and that the Sally Gap Turf , when dry and available , would cost 49/6 per ton delivered in Wicklow . The Town Clerk pointed out that when the Council had previously bought Turf from the County Council at 48/6 per ton delivered in Wicklow , the Wicklow U.D.C. lost money on retailing same at the control price.

Adjourned Item 5. (Housing )

An application from William Hunter that he be declared tenant of the house of which his grandmother (Mary Mullins , now deceased) was tenant of and which is numbered 26 St Laurence's Road . It appeared that William Hunter always resided with Mary Mullins and went with her into the Council's house from the condemned house in Pond Street

It was unanimously recommended that William Hunter be declared the Tenant of the house.

A complaint from Mrs O'Reilly of No. 5 ~~St Laurence's~~ Road about the annoyance caused her by Mrs Kelly and her children of No. 6 of same Road was read . Councillors referred to verbal complaints that they had in confirmation of same and to the condition in which Mrs Kelly kept the house.

It was unanimously recommended that Mrs Kelly be given Notice to Quit and that she be given the option of the vacant house at Glenview Road provided that she cleared all rent against her in respect of existing house.

Letter G.131/11/43 of the 4th of August 1943 from the Department of Local Government in reply to the Town Clerk's letter of the 8th of July 1943 sanctioning overdraft up to a limit of £3,500 up to the 3rd of August 1943

The Town Clerk explained that the present overdraft accommodation was £2968 :17:4 and that there was an amount payable at the moment that would make the requirements up to the 15th of August 1943 (when income from the present rate might be counted on ) to be £3500.

PROPOSED by Councillor Ml. McMahon, SECONDED by Councillor J. Clarke and passed :-

That application be made for renewal of authority for overdraft on General Revenue Account up to a limit of £3500 up to the 15th of August and that thereafter the Town Clerk to arrange until the September monthly meeting such reduced overdraft as may be required.

The Town Surveyor wrote that by reason of having a bad leg he was unable to attend the meeting .

Item. 1.

Minutes of Meeting held on the 10/8/43 were read and confirmed.

Item. 2.

The Orders of the County Manager were produced for inspection.

Item. 3.

The Town Clerk gave particulars of Receipts and Expenditure on Turf for Fuel Scheme for those paying the controlled price which showed that since July 1941 to 30th June 1943 there was a loss of £56 ; 12 : 2 on sales without making any provision for remuneration to officers . He intimated that there would be , he expected , still a bigger loss on Timber ~~when~~ but that he was unable to reach final figures because he was waiting for Account from the Forestry Department . He stated that he had ~~arranged~~ requested the Co. Surveyor to make provision for Wicklow 's needs by stacking Turf in some convenient centres either on the bog or elsewhere.: that he had arranged to keep the yard on North Quay on a monthly tenancy at £2 : 10:- per month and had taken in there about 60 tons of Turf for the Free Fuel Scheme. He read the Town Surveyor's Estimate for putting yard at Quarantine Hill in a suitable condition for storing Turf --a total of £455.

It was recommended :-

- (a) That in accordance with the suggestions of the Town Clerk the County Council be asked to arrange to supply Turf this year at a price that would permit the Urban Council to sell without loss to rates and to recoup past losses.
- (b) That ~~Everett~~ Councillor Everett T.D. and Town Clerk interview the Department of Forestry concerning the account for Timber.
- (c) That the arrangement for storing turf be approved of pending further arrangements
- (d) that the estimate of the Town Surveyor be referred back to him with a request that it be re-examined with a view to reduction of same.

#### Item 4.

Questions were asked concerning the vacant house at Glenview Road which had been provisionally allotted to Mary Brien of Strand St and the Town Clerk read letters which he had written to the Department of L.G. & P. H. on the matter and which were still unanswered. He also read applications of Mrs Hodgkinson and William Corcoran looking for the house.

Inquiries were made concerning the improvement Scheme that the Council had ordered for the six brick houses on The Murrough and the Town Clerk read letter from the Department of the 17th of August last returning and approving of the specification.

~~Further~~ Inquiries were also made about the increase of rents to the tenants ~~because~~ because of the addition of rates.

Proposed by Councillor J. Everett, Seconded by Councillor Haughton

That the Council obtain a Loan of £700 to meet the costs of the Scheme of improvement of the Six Houses and that the work be advertised for contract.

Councillor J. Everett T. D. handed in the following Notice with regard to the Rents (The Manager and Town Clerk pointing out that the proposed course would have to be subject to sanction of the Department of Local Government & P. Health):-

I beg to give notice at next monthly meeting of the Wicklow Urban District Council I or some member on my behalf will move that owing to the increase of rates in the Cottages or Housing of the Working Classes that the Rents of these cottages be reduced to meet the increase costs in Rates.

#### Item 5.

The Town Clerk ~~invited~~ read letter dated the 13th of August 1943 from the Wicklow Co. Manager enclosing schedules of works arranged over the County including those arranged by the Wicklow U. D. C. to provide for conditions that might arise because of widespread unemployment and in which he

invited the Council to add thereto such further works as might be deemed useful and desirable.

It was decided to include the removal of the surface watercourse from Kilmantin Hill either by diverting same into a sewer or otherwise. Inquiries being made concerning the Scheme of works prepared for this year's unemployment Scheme and the Town Clerk stated that the Scheme was forwarded to the Department in June 1943 and that ~~£22~~ £100 had been provided as a local contribution (the scheme embracing the concreting of Wentworth Place and renewing the Watermain there and the finishing of the road to meet Coopers Lane and Summer Hill from the Black Castle) and that so far he had no acknowledgment or sanction.

The Town Clerk was directed to write to the Department to ascertain if the works were approved of so that the Council might make some preliminary arrangements.

Arising out of the necessity of works of improvement on roads an order was made that the Town Surveyor be asked to furnish a report ~~on the~~ ~~and~~ and estimate of the cost of (1) removing the flow of ~~surface~~ ~~water~~ ~~from~~ along the channel at Kilmantin Hill and (2) concreting the paths at New Street --those works to be then sent up as supplementary to the Scheme of works forwarded in June last to be included if possible under this year's Relief Scheme.

#### Item 6.

Reports were received from the Waterworks overseer, Town Sergeant, Rent Collector and Veterinary Inspector.

Arising out of the report of the Waterworks overseer ~~the~~ Town Clerk was directed to make inquiries as to when the water was turned off from the houses at Ballynerrin and the Town Surveyor was directed to make inquiries and report re the water flowing across South Quay from Darcy's yard. --making a ~~large~~ channel on South Quay dangerous to traffic.

It was reported that the Rate Collector had collected £ 268 : 18:5 of the Town Rate Warrant and £244:5:1 of the Poor Rate Warrant since the 16th of August 1943.

Arising out of discussions on the subjects it was ordered that the attention of the Gas Works Manager be called to the failure of the Company to repair the streets satisfactorily after excavating for Gas purposes and that he be asked if he would arrange to allow the Council to repair such at the Company's expense.

That his attention be also called to the reduction, without notice of the quality or pressure of Gas in the Town without any corresponding reduction in price .

Arising out of the Report of the S.S.O. & Town Sergeant it was recommended that the public lavatory on the South Quay receive more frequent attention in the matter of flushing and that the damaged concrete floor of same be repaired.

Item 4. (Adjourned) (Allotments --1944)

The Town Clerk read Circular letters from the Department dealing with the Scheme for 1944 and stating that the Field at Ballyguile should be discontinued and other accommodation sought. The Town Clerk stated that he recommended the other field at Ballyguile locally known as "The Sledge Field" and which was ploughed out of grass last year and cropped with oats in conacre letting. The matter was left over for further consideration.

Item 5 (Adjourned) (Fuel Schemes).

The Town Clerk reported progress under the Free or Cheap Fuel Scheme and in connection with the other he reported that he had not yet received License to sell Turf and that as a result no turf or fuel had been provided for the paying Scheme. Councillors expressed themselves as dissatisfied with the position and the following Order was made :-  
Request the Co. Manager to arrange for getting into the Council's yard at least 300 tons of Turf without further delay.

The Town Clerk reported that two inspectors from the Department of Supplies had seen the County Manager concerning the Council's application for License.

## Item 6 (Adjourned) (Notice of Motion re Rents).

The Town Clerk read particulars ~~fix~~ from minutes of how the rents on the 34 houses came to be fixed at 5/- per week and Rates and pointed out that on the figures then submitted the ratepayers were bearing part of the cost up to 1/6 per week per house. When Councillor Everett explained that he desired to confine his motion to the 34 houses (last scheme of Slum Clearance) the Town Clerk pointed out that the rent of 5/- per week had been sanctioned and incorporated in the Tenancy agreements and that no reduction ~~in the~~ ~~rents~~ or increase in those rents could be made without Departmental sanction and that in any event the question of interfering with such rents was not a function reserved to the Council under the County Management Act 1940. This notwithstanding and the Town Clerk having stated that he hoped he had made his position clear Councillor Everett T.D. decided to proceed with his motion stating that he relied on a letter in his possession from the Department of Local Government & Public Health and it was :-

PROPOSED by Councillor J. Everett T.D., SECONDED by Councillor ~~J. O'Connor~~ J.D. Haughton and passed unanimously :-

That we hereby resolve that the Rents on the 34 houses be so reduced as to make the Rent inclusive of Rates to be 5/- per week.

Grant was again referred to together with the Town Clerk's reply of the 12th of October 1943 giving the terms of the Council's Resolution of the 8th idem on the subject and he reported that he had had no further correspondence on the subject. As to the question of the Licence to sell Fuel, he reported that the Department of Supplies had also been supplied with a copy of the Resolution and that a Licence had now been received and would be discussed under item 7.

#### Item 4.

The Town Clerk reported that he had obtained the lists of Children from both the Convent and Brothers National School and that he had the usual School Meals Committee examine them on Friday the 22nd of September 1943 and that the total number of children provisionally admitted was 161 i.e. 75 from the Convent and 86 from the Brothers School. He now produced the lists for inspection and reported that the Scheme had begun on the 25th inst and that he had no complaints so far.

#### Item 5.

The Town Clerk reported negotiations that he had had with Thos. Carroll in connection with the 5 houses, his property at Castle Street and that he had ascertained that they were included in an old Lease of 1865 with Mr O'Carroll's own premises ~~and~~ not included in the Order : that the Lease had now run out and that he had agreed with Mr O'Carroll that he should apply for a new Lease of his ~~own~~ premises @ £2 -- the rent for all the property in the old Lease being £4 per annum. The proposal then before the meeting was to get from Mr O'Carroll a Release of all claims to the 5 houses in the Order and to grant him a new Lease of his own premises at £2. He was to get the sum of £40 for his ~~own~~ interest in the 5 houses which sum was to be applied by way of payment of his debts to the Council. The Housing Scheme would have to bear this £40 and his costs of title measured at £3.3 :-

PROPOSED by James Everett, SECONDED by Councillor Joseph O'Connor and passed Unanimously :-

That the Common Seal of the Wicklow Urban District Council be affixed to the Deed of Release of the Five houses in Castle Street from Thomas O'Carroll in consideration of a payment of £40 to him

PROPOSED by Councillor J. Everett, SECONDED by Councillor J.O'Connor and passed unanimously :-

That the request of Thomas Carroll for a new Lease of his premises at Summer Hill be granted at a Rent of £2 per annum.

Part of the titles to Miss Wall's ~~xxxxxxx~~ houses (5) at Castle Street was still outstanding and in the hands of Mr Cullen Solicitor.

The Town Clerk explained that in respect of the 5 houses at Castle Street the property of Miss Wall a question had arisen concerning a claim of R.F. Conway to have the gable of his house exposed by reason of the demolitions that had taken place and the Town Clerk outlined the negotiations he had for settlement of the matter : that a tender for £14 for concreting the gable had been accepted and an agreement in writing with Mr Conway had been reached which he now read.

Item 6

It was agreed that the two tenders received for the Scheme of Improvement works to the six houses on The Murrough be referred (unopened) to the Manager to deal with.

A request from one of the tenants of the said houses for a grate in lieu of the damaged range in her house was read and it was agreed that she should be provided with some immediate relief. A further request from Mr Hendley tenant of one of the Dunbur Road houses that he be allowed to replace the Grate in his house by a self-setting range that he had and that the Council bear the expense of erecting same was considered. It was recommended that a flue pipe at a cost of 16/- be supplied to Mr Hendley and that he be allowed to have the range replaced put in -- the grate so displaced to be utilised if possible for Mrs.avanagh.

Applications for houses were received from Mr James Keogh St Laurence's Road and from Mrs Hunter of Quarantine Hill were read and left over pending any house becoming vacant.

Item 7.

The Town Clerk reported on the Fuel Schemes as follows :-

FREE (or CHEAP) FUEL SCHEME:- Up to Friday the 29th October 1943 there had been taken into store on the North Quay 96 tons of Turf from the Co. Council and that, with the amount already there, he estimated that there was now in store and under cover there 120 tons of good dry turf for this scheme. About 30 or 40 tons more would be required later to keep that scheme going on until the new year's supply of Turf would be received. This extra turf need not necessarily be very dry but could be stacked in a suitable place in the yard at North Quay where he expected it would be dry before being required next Spring. He deemed it advisable to stop making <sup>further</sup> provision for the Free Fuel ~~xxxxxx~~ Scheme and requested the Co. Surveyor to continue drawing to another depot for the other Scheme.

GENERAL OR PAYING SCHEME:- He then looked around for a suitable depot for the Turf or Fuel required for this Scheme in view of the fact that a Licence had been sent to him on the 21st of October 1943. He agreed with Mr Stone -- subject to approval of the Council and Manager -- to take a monthly tenancy of part of his yard and sheds opening on High Street @ 28 eight Shillings per week from the 1st Nov. 1943. He then learned that the County Council had no further dry turf to offer but that an effort was being made to find some. He stated that to be able to sell without loss to the rates they would require the Turf (good dry Turf) in the yard at about 40/- per ton.

He read letter dated the 19th of October 1943 (D.31/115) from the Department of ~~xxxxxx~~ Supplies transmitting the Licence in his name and pointing out the obligations attaching to the operation of the Licence. He asked that remuneration be fixed in advance for him in respect of the undertaking and that he should be indemnified against all loss, fines, charges and costs that might be incurred by him in respect of the operation of the Scheme.

The arrangements made by the Town Clerk as well as the written proposal for tenancy received by him from Mr Stone were approved of and it was :-

PROPOSED by Councillor J. O'lohan, SECONDED by Councillor C. W. Hudson and passed unanimously :-

"That in consideration of John McGrath Town Clerk undertaking, as our nominee, the responsibility of the Fuel Merchant's Licence granted in his name we are agreeable that he should be indemnified by the Council against all loss, fines, charges and costs arising in connection with the operation of the Licence by him and that we recommend that he be paid as a remuneration for his work now being ~~xxxxxx~~ undertaken by him Five per cent on the gross receipts from Sales of Fuel".

He stated that there would have to be a person employed by him to issue Fuel Dockets and he proposed that the same person as he was authorised to employ for the Free Fuel Scheme i.e. Miss Olive Kennedy and that this 5% was to cover remuneration of her or any other person so employed by him.

It was agreed that when the scheme begins to be operated that sales be confined to registered customers in the URBAN AREA. He reported that he had arranged for issue of Fuel Dockets for Free Fuel each morning (except Saturday) between 10 and 11 a.m..

Item 8.

PROPOSED by Councillor J. Everett, SECONDED by Councillor C. W. Hudson and passed :-

That the Common Seal of the Wicklow Urban District Council be affixed to the Lease from the Department of Industry and Commerce of the portion of added land on the Foreshore between the Jacket Pier and the New Pier at Wicklow. The Lease was accordingly executed in triplicate by the Council and witnessed by the Manager.

The Council's Manager wrote that owing to prior engagements he would be unable to attend

Councillor C. W. Hudson wrote a letter apologising for his absence due to being confined to bed with a bad cold and set forth his views both on the Milk shortage and the Fuel shortage. He pointed out that due to the operation of the new Emergency Order prescribing increased tillage some of the large suppliers (such as Halpin's of Tinnakilly who supplied to Wicklow last year upwards of 16000 gallons) would have to reduce their herds and were unable to supply Milk on Free Vouchers from the Labour Exchange and he suggested that they should be given an exemption from the new Tillage Order. He also referred to the very inferior turf made available to the Council from County Council and stated that with regard to Milk and Fuel the Council should take immediate and forceable action to remedy matters.

After discussion it was PROPOSED by Councillor J. Everett T.D.

SECONDED by Councillor J. Haughton and passed :-

That we the members of the Wicklow Urban District Council hereby call the attention of the Departments of Agriculture and Industry and Commerce to the serious shortage of milk supplies in the Wicklow Urban Area and the fact that the people receiving Free Food Vouchers from the Labour Exchange have been unable to procure Milk in exchange for them from established Milk Suppliers or at all.

On the question of the Supply of FUEL for the town, the Town Clerk reported that both schemes (Free & otherwise) were now in operation that there was now available in store for the ordinary consumers

Forty Five tons of Turf obtained from the County Council and that Turf from that source was still coming into store. He had seen the first load that had come in and thought it was reasonably dry and that until receipt of Mr Hudson's letter that evening he had no information of the inferior quality or wet condition of the Turf. He explained his difficulties with the Turf Development Board, Fuel Importers Ltd and Department of Supplies in getting Turf from outside the County and had obtained a quotation from General Textiles Ltd of Athlone for 100 tons of good Turf delivered in waggons there at the rate of two per week at the price of 30/- per ton there: he could not get that into Wicklow without permit

It was recommended that supplies from the County Council should be stopped and Councillor Everett T. D. was requested to interview the Department of Supplies with regard to the 100 tons of Athlone Turf which it was recommended to procure

Councillor Haughton charged the officials administering the Turf Schemes in Wicklow with neglect in that there had not been made available for the people of Wicklow town an adequate amount of good turf from County Wicklow

He also questioned the source of supply of the Free Milk being distributed to necessitous children under the Free Milk Scheme and said he believed that milk other than produced on the Knockrobbin Farm was being distributed under the Scheme.

- (6) That the 3 acre field and the Sledge field be now ploughed by Mr C. xxxxx Heavener
- (7) That the Plots for the unemployed be retained as last year and that Mr Wynne be asked to give a an extension of a further year for his field.
- (8). That every effort be made to collect ~~the~~ all the sea weed and ~~xxxx~~ suitable Town Refuse for manure for the allotments.

#### Item 6.

Re County Council Application :-

PROPOSED by Councillor C.W. Hudson, SECONDED by Councillor J. Clarke and passed :-

That we the members of the Wicklow Urban District Council hereby agree to grant to the Wicklow Urban District Council a Lease of a plot of ground on the ground locally known as "Clarke's plot" fronting the Main Road from Leirim Place to the Goods Railways Station on The Murrough and containing an area of 20 pers S.M. or thereabouts reserving a rent of £4 for the purpose of erecting thereon a tool store (same to include the present Public Weighbridge) in accordance with Plan and specification to be approved of by the ~~the~~ this (Wicklow Urban) District Council.

Re : Application of Thomas Dickenson :-

The Town Clerk read a letter which he had received from Mrs Martha Heatley claiming ~~the~~ interest in the plot of ground applied for by Mr Dickenson : the letter was dated the 6th December 1943 and conveyed a warning to all concerned not to interfere with her rights.

It was ordered that the matter stand adjourned and the Town Clerk was requested to get the parties in conference in the meantime with a view to negotiating a settlement between the parties.

#### Item 7.

The Town Clerk referred to the previous correspondence and resolutions in the matter and in particular to a letter dated the 23rd ~~inst~~ <sup>Nov 1943</sup> from the

Department of Local Government & Public Health on the subject (which letter was not read) and to an order made by the County Manager on the matter on the 3rd December 1943. He pointed out that since receipt of the ~~letter~~ said letter of the 23rd November 1943 he had an opportunity of discussing the ~~matter~~ terms of same with the responsible officer in the Roads section of the Department of Local Government and that this officer had authorised him to state publicly and privately that there was no intention of suggesting that the Town Clerk was in any way to blame for the loss of the grant to the Urban Area or for the misunderstanding that appeared to exist in connection with the proposed Relief Grant.

After some discussion the following Resolution was ~~proposed~~

PROPOSED by Councillor C.W. Hudson, SECONDED by Councillor J.D. Haughton and passed unanimously :-

The Council were also supplied with particulars of the Rate Collection to date : the Town Clerk pointing out that the Town Rate Collection was very much in arrear and that same was reflected in the very large over-draft. The rate Collector informed him (Clerk) that he

had been indisposed for a week with a bad leg.

This matter too was left in the hands of the Manager to deal with. Notices to quit served on Patrick Kelly and Moses Kelly tenants of houses in Glenview Road and the request of Moses Kelly to be named as the Tenant of the house in his wife's name and his promise, if that were done, to clear the arrears were referred to The Manager for suitable action.
