While I will be ready to give at your meeting all details in connection with the subject, the following remarks may assist you to understand in advance the position:

TOWN RATE: The Town Rate raised in your Urban Area for the three years ended the 31st inst has been at the following rates in the £

At the close of this year I anticipate an estimated deficit on General Revenue Account amounting to £669. This , as I informed you last year, is due, as I believe, to under-estimating over a number of years. In accordance with your undertaking in the matter, and with the usual practice, this amount will have to be raised in this year's Rate. You will note from the figures of Receipts that after making full inquiries I am counting on receipt of £600 of deferred Housing Subsidy:before your meeting on the 28th inst I hope to have fuller confirmation of this. The determination of the eligibility of your tenants to qualify for full subsidy has not yet been made and hence, in this matter, I am making a problematical estimate and am giving to the ratepayers this year all the relief that I can with any hope of success count on being able to give.

POOR RATE:- The Poor Rate raised in your Urban Area over the three

In the matter of Poor Rate for 1944/45 you will note that a small increase in my Estimate. While the Rural Areas benefited, or will benefit, in the coming financial year by the application of deferred Agricultural Grant and thus had their rates reduced, as compared with 1943/44, your Urban Area does not get any benefit from Agricultural Grant, and the Demand from the County Council on you is something larger than for 1943/44-thereby increase of 4d in the £ on the Poor Rate.

Councillors called attention to the fact that it was arranged last year that the deficit then estimated should be extended over four years and therefore claimed that only £223 of the deficit of £669 should be raised this year.

A discussion took place on the deferred Housing Subsidy and the Town Clerk reported that as a result of correspondence and interviews with officials in the Department of Local Government he was now satisfied that only one case remained of doubtful eligibility for tenancy of all the Council 1 192 houses and that the £600 --at least--of deferred subsidy could be counted on as a receipt within the next financial year. His estimate for yearly subsidy--on the basis that all tenants qualified --was £ 2066 odd: that was agreed with the Dept and on that basis there was deferred subsidy of £956. The Council considered that in the circumstances a further sum of £200 could be counted on by way of Subsidy deferred.

The number of meals supplied was 8157 (13047 last season). The gross cost was £160:17:5 (£173:10:-) last season by reason of the tillage scheme promoted by the Council, the gross cost was reduced to £147:7:
-the gross cost per meal being 4\frac{3}{4}d and the net being 4\frac{1}{4}d. In those figures I have not taken into auccount a free donation of Fuel without which it would be well-nigh impossible to have cooking carried on as in other years—the value of this gift, if not invalauable, would be at least £10.

The number of boys admitted to the benefit of the Scheme was 06 and of girls was 75. The average daily attendance was 45 and 44 respectively or a total of 89 as compared with 129 during the previous season.

As heretofore the voluntary and generous services rendered by the lady supervisors contributed largely to the success of the scheme ."

Read and considered satisfactory -- many all the members paying a tribute to the lady supervisors for their work in connection with the scheme.

The Council expressed approval of the arrangement re increased water charges to the County Council in pespect of the icreased demand from the Courthouse -- viz £5 per annum --as contained in the County Manager's letter of the 13th of April 1944.

the Town Clerk stated that the whole position of collecting charges for ising water for non-domestic purposes was unsatisfactory. Some few people were paying and were willing to pay whereas others who were large consumers made no proposal as to payment and, he believed, were advising against payment. Furthermore any effort to get one of the existing staff to collect these charges had proved fruitless: he was collecting what came in but felt it unfair to keep on collecting from the few while others took no notice and continued to use the water as heretofore.

ORDER: - Recommended that peremptory demands be sent out to each consumer and water be cut off in the event of no payment being made: the method and officer for collecting to be referred to the Mangarer Manager.
