MINUTES OF MONTHLY MEETING HELD ON THE 2nd SEPTEMBER, 1969.

PRESENT: Mr. T. A. Delahunt, Chairman, Presiding, Councillors Mrs. P. McNamara, Messrs F. Conway, P. Doyle, T. Byrne, Ed. Kavanagh, J. Kane and L. Turner.

IN ATTENDANCE : Mr. C. O'Brien, Town Clerk, Mr. N. D. Farrell, Town Surveyor.

Apologies for inability to attend were received from Councillor Mrs. M. McEnroy, and Mr. M. Flannery, County Manager.

CONFIRMATION OF MINUTES:

The minutes of the ... monthly meeting held on the 6th August, 1969, copies of which had been circulated, were taken as read and signed by the Chairman.

APPLICATIONS UNDER LOCAL GOVERNMENT (PLANNING & DEVLLOPMENT) ACT. 1963.

PETER A. DUFFY:

The Council agreed that permission be granted to Mr. Peter A. Duffy, a Council tenant to build an extension to No. 4 St. Patrick's Avenue subject to the advice of the Council's Law Agent as to the protection of the Council's interest in the matter.

#### PETER BYRNE:

The Council agreed that permission be granted to Mr. Peter Byrne, who is purchasing his house by way of annuity to build an extension to No. 16, St. Laurence's Road provided the Council's Law Agent had no objections.

#### DE LA SALLE BROTHERS:

The Council agreed that outline permission be granted to the De La Salle Brothers, Wicklow, to extend the property known as "Ardnaluinn", St. Manntan's Road, and to provide an access from same to the proposed new school.

#### DOMINIC CRONIN:

The Council considered the application of Mr. Dominic Cronin for permission to erect a bungalow at Greenhill Road and noted that outline permission had been granted previously for two houses in the same field. The Town Surveyor advised that such ribbon development was undesirable at this distance from the town but agreed with a recommendation of the Council that the application be approved on the understanding that Mr. Keogh, the owner of the field, be notified that no further frontage development will be permitted unless a comprehensive scheme for developing the whole field is submitted.

#### HOUSE PURCHASE LOANS:

The Council considered Circular letter H.21/69 from the Department of Local Government. copies of which had been circulate ...

which outlined the proposal to allow only those Urban District Councils with a population of 10,000 or more to make House Purchase Loans from 1st April, 1970. Several members expressed reservations regarding the proposals and stated that the need for direct representation for Urban District Councils had again been highlighted. Councillor Conway said that some delay might result in processing applications but that the scheme would be of great benefit in view of envisaged availability of supplementary grants in Urban areas under the scheme. It was agreed to request the County Council to consider accepting the recommendations of the Urban Council with regard to local applications. During the general discussion on the matter the Clerk advised that the rate of interest on advances from the Local Loans Fund, had in a number of cases changed since the first instalment was issued to applicants for loans. The Council agreed that the interest rate in these cases should be half per cent in excess of the rate prevailing on loans from the Local Loans Fund at the time when each loan instalment was advanced.

# URBAN ROAD IMPROVEMENT GRANT 1969/70:

The meeting requested the Town Surveyor to prepare estimates of tarmacadaming various areas in the town for consideration at the next monthly meeting. These areas included Coate's Lane, Salt-House Lane, Cooper's Lane, Morton's Lane, Lower Strand Street/Bond Street, St. Manntan's Road, Kilmantin Hill and Castle Avenue.

# SHAMROCK FERTILIZERS LIMITED - PLOT OF GROUND AT BOND STREET:

The Clerk advised the meeting that Messrs Shamrock Fertilizers Ltd. held a plot of ground at Bond Street, Wicklow, under a lease granted in 1961 which contained a covenant to construct within twelve months railway sidings and a despatch store and that the firm had made application for the Council's consent for a waiver and discharge of this covenant. The Council agreed to adjourn consideration of the matter to the October Monthly Meeting.

## DRAFT RATE RELIEF SCHEME:

, A draft soheme for the waiver of rates in certain cases was considered by the members who expressed the view that the scope of the scheme was limited and that the clause stating that "applications for relief must in each case be made by the rated occupier, but such occupier must not be the owner of the dwelling or have any interest in it other than of tenant" should be redrafted to read "applications for relief must in each case be made by the rated occupier" The Clerk advised that such an amendment would prevent the Council from securing Judgement Mortgages in cases where the applicant for relief of rates was the owner of the dwelling. It was agreed to further consider the amended scheme at the October Monthly Meeting.

During the course of the discussion on the rate relief scheme the opportunity was taken of generally discussing the Council's Rate Collection. The meeting was advised that arrangements for the appointment of a Rate Collector, necessitated by the election of Mr. Liam Kavanagh to Dail Eireann, had not been finalised. The members recommended that the position be advertised.

# TENANT PURCHASE SCHEME - ST. PATRICK'S AVENUE:

.

The members considered the Tenant Purchase Scheme which had been prepared for the eight houses at St. Patrick's Avenue and noted that the scheme was based on the replacement value of the houses and that a reduction from the replacement value of 2% for each year after five of tenancy subject to a maximum of 30% had been provided for. The scheme, as presented, detailed a purchase price ranging from a minimum of £1,435 to a maximum of £2,050, depending on the period of tenancy.

The members expressed satisfaction with the information conveyed by the Secretary, Wicklow County Council, that the Minister for Finance had agreed to increase the State contribution towards the cost of the Coast Protection Scheme proposed for the Murrough from 50% to 60%.

A letter was read from Miss Irene Kilcoyne, Clerk/Typist, tendering her resignation from the staff with effect from the 4th October in view of her forthcoming marriage. The Chairman joined with the members in paying tribute to Miss Kilcoyne's courtesy and efficiency and wished her every happiness in her married life. The Clerk, on behalf of the staff, associated himself with the tributes and good wishes.

On the proposal of Councillor Kavanagh, seconded by Councillor Delahunt, Chairman, the Council passed a vote of sympathy with the De Courcy family, Kilmantin Hill, on the death of their mother.

Councillor J. Kane queried the position regarding the proposed 20 House Scheme at Ballynerrin and expressed concern about the delay in the progress of the scheme as did the other members of the Council, in view of the housing shortage in the town. The Clerk informed the meeting that the Department of Local Government had requested detailed information including "finalized sketch drawings for the entire local authority development" and that the Architect had been instructed to furnish same. The members considered the Department's request unreasonable. and instructed the Clerk to acquaint the Department of the Council's opinion. Councillor Kane undertook to make personal

representations in the matter immediately.

The Council appointed Councillor F. Conway to attend the All Ireland Road Safety Congress due to be held in Dublin on the 22nd and 1. G Delah 23rd October, 1969.

Councillor Kane considered that an average price per house might prove more acceptable. The Clerk advised that this proposal might not meet with the approval of the Department of Local Government as the 2% reduction was especially provided for in the Regulations and designed to relate to the period of tenancy in each case. It was agreed to prepare an average price per house for submission to the Department of Local Government for sanction and to circulate details to the tenants involved.

## TOWN SURVEYOR'S REPORT FOR AUGUST:

Arising out of the discussion on the Town Surveyor's report for August a number of complaints were noted for attention by the Town Surveyor. Following a discussion it was agreed that the question of the future of the building housing the Social Welfare Office and the Library at The Mall be discussed at the next meeting and that the opportunity would also be taken of generally reviewing the scavenging service, which had been the subject of a number of recent complaints.

Councillor Kane requested that the report on the provision of camping facilities on the Murrough be available for the next monthly meeting. On the suggestion of Councillor Turner it was agreed that Wicklow County Council be requested to provide a Yield-Right-Of-Way sign at Fitzwilliam Square in the interest of road safety.

MINUTES OF JOINT MEETING BETWEEN MEMBERS OF WICKLOW URBAN DISTRICT COUNCIL AND THE WICKLOW HARBOUR COMMISSIONERS HELD ON THE 24th SEPTEMBER, 1969.

PRESENT: Councillors T. A. Delahunt, F. Conway, J. Kane, E. Kavanagh, T. Byrne and Harbour Commissioners W. Byrne, L. Kavanagh, J. Quinn, P. J. Smith, and P. X. Clarke.

IN ATTENDANCE: Mr. William Kinsella, Harbour Master, Mr. N. D. Farrell, Town Surveyor, Mr. J. H. McCarroll, Law Agent and Mr. C. P. O'Brien, Town Clerk.

At the outset it was proposed by Councillor T. A. Delahunt, seconded by Councillor E. Kavanagh and unanimously agreed that Councillor F. Conway act as Chairman of the meeting.

The Chairman briefly reviewed the proposal of the Harbour Commissioners to acquire the interest of Shamrock Fertilizers Ltd. in the sheds at North Quay and requested Mr. J. H. McCarroll, Law Agent, to outline the up to date position. Mr. McCarroll then gave details of the negotiations and advised that Messrs Shamrock Fertilizers Limited were prepared to sell their interest in the three sheds for £11,500 and that Nitrigin Eireann Teoranta had agreed to purchase shed "E" from the Commissioners for £9,000 and to rent shed "C" for a period of 10 years at a rent of £600 per year.

Following a lengthy discussion on the matter the Law Agent was instructed to prepare the contract documents for the sale of shed "E" and the employment of Mr. N. D. Farrell for the preparation of the necessary lease maps was also authorised by the Commissioners.

The meeting noted that the application of Messrs Shamrock for permission to assign their interest in the sheds in question would be considered at the monthly meeting of Wicklow Urban District Council to be held on the 7th October, 1969.

PRESENT: Mr. T. A. Delahunt, Chairman, presiding, Councillors Mrs. P. McNamara, Messrs F. Conway, Ed. Kavanagh, J. Kane, L. Turner and T. Byrne.

Apologies for inability to attend were received from Councillors Mrs. M, McEnroy and Mr. P. Doyle.

#### VOTES OF SYMPATHY:

At the outset the Chariman extended the sympathy of the Council to to Councillor T. Byrne and the Byrne family on the death of his sister. Each member of the Council joined in the expression as did the County Manager on behalf of the staff. The Council members also extended their sympathy to Mrs. J. Clarke on the death of her father. Both votes of sympathy were respectfully passed, all present standing.

#### CONFIRMATION OF MINUTES:

The minutes of the September Monthly Meeting and of the Joint Meeting between members of Wicklow Urban District Council and the Wicklow Harbour Commissioners held on 24th September, 1969, copies of which had been circulated, were taken as read and signed by the Chairman.

APPLICATIONS UNDER LOCAL GOVERNMENT (PLANNING & DEVELOPMENT) ACT, 1963

### P. SULLIVAN:

The Council agreed that outline permission be granted to Mr. P. Sullivan for the conversion of Friar's Hill House into an hotel, subject to the condition recommended in the technical report on the application that details of the entrance and sight lines of the proposed new access road be submitted and approved by the Council.

#### EDWARD JAMESON:

The Council reviewed the application of Edward Jameson for permission to build an estension to his dwellinghouse at 16, Convent Road, Wicklow, and adjourned consideration of the matter to the November meeting on the advice of the Town Surveyor that the details submitted would not qualify the applicant for a State Reconstruction Grant. It was agreed that the Town Surveyor would advise of the modifications required and that Mr. Jameson would be requested to submit revised details

#### WILLIAM P. FORDE:

A number of Council members indicated that they had received complaints about the manner in which the housing development was being carried out by Messrs William P. Forde at Friar's Hill. The Town Surveyor undertook to examine the complaints and to prepare a report on the matter for consideration by the members.

The Council considered the quotations received from Messrs Roadstone Limited for tarmacadaming various areas in the town and agreed to expend the current year's grant allocation of £1,089 on Kilmantin Hill, Castle Avenue & Bath Street. Following a suggestion by Councillor Kavanagh the members requested that the Town Surveyor investigate the possibility of developing the area overlooking the sea at Castle Street under the current year's E.S.V. Scheme.

The meeting was informed that the estimated overdraft accommodation required in the quarter ending 31st December, 1969, amounted to £12,000 and it was then proposed by Councillor T. A. Delahunt, seconded by Councillor E. Kavanagh and resolved:

The meeting was advised that the inclusion of an average price per house in the proposed tenant purchase scheme was not acceptable to the Department of Local Government as the 2% reduction from the replacement value, subject to a maximum of 30%, was especially designed to relate to the period of tenancy in each case. The Scheme, as presented, detailing a purchase price ranging from a minimum of £1,435 to a maximum of £2,050, depending on the period of tenancy was approved by the members and the Clerk was directed to circulate details of same to the tenants concerned.

# OLD TECHNICAL SCHOOL AT THE MALL, WICKLOW:

The future of the building housing the Social Welfare Office and the Library was considered at length by the Council. Some of the members requested that the possibility of demolishing the existing building and erecting offices, which could be let at an economic rent, be explored. The Town Surveyor advised that the foundation of the existing building would have to be examined as well as the likelihood of traffic conjestion occurring if it were not found possible to provide car parking facilities in any proposal for the development of the area. The Council agreed that Messrs Meehan, Levins & Associates, Architects, Arklow, be requested to examine the site and submit recommendations on the possibility of developing same. It was also decided that the Architect should submit recommendations on the possible future development of the Orange Lodge, park overlooking harbour at Castle Street and corner adjoining St. Patrick's Road.

# RATE RELIEF SCHEME:

# ROAD IMPROVEMENT GRANT 1969/70:

## OVERDRAFT ACCOMMODATION FOR QUARTER ENDING 31st DECEMBER, 1969:

"That we hereby approve, subject to the sanction of the Minister for Local Government, of the provision of Temporary Overdraft Accommodation not exceeding £12,000 on General Revenue Account for the quarter ending 31st December, 1969."

#### ADJUDICATOR'S REPORT ON TIDY TOWNS COMPETITION 1969:

On the suggestion of Councillor T. A. Delahunt, Chairman, it was decided to circulate the adjudicator's report on the Tidy Towns Competition 1969 for consideration at the November Monthly Meeting.

### TENANT PURCHASE SCHEME - ST. PATRICK'S AVENUE:

An amended scheme for the waiver of rates in certain cases as suggested at the Council's September meeting was considered by the Council. After considering the matter in detail the members indicated that the existing arrangements for writing off rates in hardship cases at the end of each financial year was adequate and agreed that the adoption of draft Rate Relief Scheme be deferred in view of the fact that no State contribution is available towards meeting the cost of the scheme. The members were of the opinion that the estimated cost of implementing the scheme - 1/3d. in the pound - might prove an intolerable burden on the Wicklow ratepayers.

# WICKLOW HARBOUR COMMISSIONERS:

On the proposal of Councillor Conway, seconded by Councillor Turner the Council unanimously passed a resolution consenting to the assignment of the interest of Shamrock Fertilizers Limited in the undermentioned leases in respect of premises at North Quay, Wicklow, to the Wicklow Harbour Commissioners:-

(1) The premises comprised in and demised by Lease dated the 10th August, 1953, and made by the Wicklow U.D.C. to Wicklow Fertilisers Limited for the term of 75 years from the 29th September, 1950, at a rent of £20 per annum. Registered on the 1st September, 1953, Book 48 No. 231.

(2) The premises comprised in and demised by further Lease dated the 10th August, 1953, by the Wicklow U.D.C. to Wicklow Fertilizers Limited for the term of 75 years from the 29th September, 1951, at the rent of £2 per annum. Registered on the 1st September, 1953, Book 48 No. 232.

(3) Premises comprised in and demised by Lease dated the 26th June, 1956, by the Wicklow U.D.C. to Shamrock Fertilizers Limited for the term of 31 years from the 29th September, 1955, at the rent of £9. 12. 0. per annum. Registered on the 25th July, 1956, Book 46 No. 105.

(4) The premises demised by Lease dated the 10th August, 1953, made by the Wicklow U.D.C. to Wicklow Sawmills Limited for a term of 75 years from the 25th March, 1951, at the yearly rent of £30. Registered on 5th October, 1953, Book 56 No. 169.

(5) The premises demised by Lease dated the 7th July, 1959, by Wicklow U.D.C. to Shamrock Fertilizers Limited for the term of 75 years from the 25th March, 1959, at the yearly rent of £5. Registered on the 29th July, 1959, Book 40 No. 117.

(6) The premises demised by Lease dated the 6th September, 1960, Wicklow U.D.C. to Shamrock Fertilizers Limited for a term of 75 years from the 25th March, 1960, at the yearly rent of £2. 10. 0. Registered on the 9th September, 1960, Book 53 No. 90.

# SHAMROCK FERTILIZERS LIMITED:

Consideration of an application from Messrs Shamrock Fertilizers Limited for permission to revise the boundaries of the properties held under sub-lease from them by Messrs Neil Watson and Wen-Plast Limited was deferred to give the members an opportunity of visiting the area in question.

The Council approved of an application from Messrs Shamrock Fert. Limited for the Council's permission to a short-term sub-letting by Wen-Plast Limited of a portion of the premises leased to them at North Quay, Wicklow, on a short-term basis only not to continue beyond lst May, 1970, at the latest.

#### JOHN G. SUGRUE:

The Council approved of the assignment of the interest of John G. Sugrue in 25, Dunbur Park to the Trustees G. F. Robinson and indicated their agreement to the proposal of the Trustees to grant a sub-lease of the property in question to a member of the Robinson family following the general terms of the head lease save as to term and rent.

# TOWN SURVEYOR'S REPORT FOR SEPTEMBER:

Arising out of the discussion on the Town Surveyor's Report for September a number of matters were noted for attention by the Town Surveyor. These matters included a request to have the broken post on the steps at Castle Street repaired and the grass at Leitrim Place cut. cont/..... A letter signed by twenty four people requesting that the back entrance at the rear of Glenview Road and St. Laurence's Road be re-opened was discussed by the Council. The Town Surveyor advised that part of the entrance in question had been incorporated in the leases of various houses sold under the Tenant Purchase Scheme. The members indicated that if the people could come to some arrangement amongst themselves then the matter could be further considered by the Council.

# HOUSING DEVELOPMENT AT DUNBUR:

The Chairman informed the meeting of the discussions which had taken place with Crosspan Development Limited in connection with the proposed Housing Development at Dunbur. It was noted by the members that Messrs Crosspan have been requested to prepare an alternative lay-out plan for the site and that it is expected that these amendments could lead to a reduction in price.

The Council agreed that a fine of £100 and grount rent of £15 per annum would be charged per site.

#### SWIMMING CLUB:

A letter from the Wicklow Swimming Club requesting that the Council's property comprising of a store and ladies and gents toilets for conversion into dressingrooms and a social centre was read by the Clerk. The members indicated that it would be necessary for the Club to submit details of their proposals before the matter could be considered.

#### LINDSAY PROPERTY:

The meeting was advised that a satisfactory offer had been received for the derelict Lindsay property at Strand Street by William Fallon, Solicitor, Arklow, and that it was hoped to have the premises sold without delay.

# RESIGNATION OF RATE COLLECTOR:

A letter from Mr. L. Kavanagh submitting his resignation from the position of Rate Collector\_due to pressure of work arising out of his election to Dail Eireann was read by the Clerk. Mr. Kavanagh indicated that if difficulty were found in finding a temporary replacement he would be willing to continue to the 31st December, 1969.

Tributes were paid on the manner in which Mr. Kavanagh carried out his duties.while in the service of the Council and the County Manager and members joined in expressing good wishes to him in his role as a Dail Deputy.

## CAMPING FACILITIES AT MURROUGH:

A suggestion from Frank Fallon, Sea Front, Wicklow, that the Council provide caravan/camping accommodation between the Veha grounds and the railway was considered by the members. It was decided that the viewsof the industrialists in the vicinity of the Murrough be obtained and that the Town Surveyor would examine the matter.

#### SCAVENGING SERVICE:

The Town Surveyor advised the meeting that the trailer used for the refuse collection service had broken down during the month and would need to be replaced in a short time. Details were given of the cost of purchasing either a new refuse collection vehicle ( $\pounds 1,998$ ) or a new trailer ( $\pounds 635$ ). It was agreed that further details be obtained from manufacturers to ensure that the prices mentioned are competitive and also to contact Mallow Urban District Council and Bray Urban District Council for details of their scavenging vehicles.

The members voiced complaints about the litter problem in Main Street and decided that extra facilities for litter collection be provided.

The meeting was informed that the final drawings and specification in connection with the proposed 22 House Scheme at Ballynerrin had been submitted to the Department of Local Government for approval. The Clerk was requested to obtain approval to these documents at the earliest possible date and to arrange for the early invitation of tenders for the scheme.

The Town Surveyor reported that he had investigated the complaints made at the monthly meeting about the manner in which the housing development at Friar's Hill was being carried out and found that the only deviations from the plans approved by the Council were the relocation of the houses on the corner sites.

The members noted that a further application had been received on the day before the meeting from William P. Forde for permission to erect 11 bungalows on sites for which approval for another type house plan had been granted. Consideration of the matter was adjourned to enable the Town Surveyor to examine the proposals.

# PROVISION OF CAMPING SITE FOR ITINERANTS:
