MINUTES OF MONTHLY MEETING HELD ON 2ND JANUARY, 1973.

PRESENT: Councillor E. Kavanagh, Chairman, presiding, Councillors Mrs. M. McEnroy, Mrs. P. McNamara, Messrs T.A. Delahunt, J. Kane, F. Conway,

CONFIRMATION OF MINUTES:

The Minutes of the December Monthly Meeting, copies of which had been circulated, were taken as read and then signed by the Chairman.

APPLICATIONS UNDER LOCAL GOVERNMENT (PLANNING & DEVELOPMENT)

Application - East Coast Coaches: (1)

> The Town Clerk informed the meeting that the Town Surveyor had recommended that planning permission be granted to East Coast Coaches to change the use of their premises from a dance hall to a garage. The Council agreed to the application.

Application to Connect Twelve Houses to the Council's Watermain -(2)Mr. Joseph T. O'Byrne, B.E.

The County Manager pointed out that on the technical advice Eiven to him both by the Town Surveyor and the County Engineer he could not grant permission to connect the twelve houses to the Council's main. He stated that over the last five years Wicklow County Council only made seventy-six connections to the Croneroe Scheme while the Wicklow Urban District made almost 350. In view of the proportion of the cost being paid by the Wicklow County Council towards the Croneroe Scheme he stated that some water must be available for the County Council's own development and some private development in the Rural Areas.

Councillor J. Kane disagreed with this and requested that permission be granted in view of the fact that it was reasonable to expect that the improvements to the Croneroe Scheme would be completed within a period of twelve months.

Councillor T.A. Delahunt pointed out that steps were being taken to eliminate leaks in the town and this should mean a considerable saving in the water consumption.

Other Councillors felt that permission should be granted and a suggestion was made by Councillor F. Conway to invite both Mr. O'Byrne and the County Engineer to the next meeting of the Urban District Council.

The County Manager pointed out that the County Engineer was under no obligation to attend Urban Council meetings.

The Chairman expressed the opinion that water from the Abbey River could be used by the Veha Factory, and this also would be a considerable saving in the water consumption.

When Councillor Mrs. M. McEnroy suggested that the County Engineer be written to to reconsider his decision the Council agreed to defer the matter.

#### (3) Blainroe Housing Scheme:

The County Manager pointed out that an application had been received by the Wicklow County Council from Mr. J.G. Cooney Limited on behalf of Blainroe Estate Limited for a comprehensive residential recreational and social development at Blainroe. The proposed development would be sited about three miles from Wicklow on the coast road to Arklow, and covers an area of approximately 550 acres. The application proposed the building of 667 houses on a total site area of approximately 124 acres. It was also pointed out by the County Manager that the proposal included provision for a hotel, a restaurant, a golf course, a club house, schools, shops, a church and land has been reserved for industry. It was further pointed out by the County Manager that the members of the Wicklow County Council had requested the views of the Wicklow Urban District Council, particularly in relation to access roads and the way it would affect the Wicklow town generally.

The Council agreed to inform the Wicklow County Council that they are favourably disposed towards the development with some reservations in relation to access roads. It was also suggested that a meeting take place between all interested parties including the Urban District Council and the applicants architect.

### Application - Messrs. S.V. Delahunt & Company Limited:

The Town Clerk informed the meeting that it was proposed to grant planning permission to Messrs. S.V. Delahunt & Company Limited to alter their premises and carry out reconstruction work at Main Street, Wicklow. The Council agreed that permission be granted.

Application - Mr. P.T. Hickey & Associates to Connect 125 Houses at Friars Hill, Wicklow to the Urban Council's Sewer:

The Council considered the above application for a connection to the Council's Sewer and agreed that permission bo granted subject to the following conditions:-

- (a) A sewerage plant of an approved type must be provided and maintained by the applicant for the planning permission.
- (b) A capital charge of £15,000 must be paid to the Urban District Council before any development commences on the land covered by the application.

.

- (c) A sewer rent of £8 per annum must be made in respect of each house connected to the sewage disposal plant which will then be connected to the Council's Sewer. The rent is subject to a quinquennial review.
- (d) That only foul sewage, i.e., toilets, sinks and bath waste, is to enter the sewerage disposal plant which will be connected to the Urban Sewer, and under no circumstances whatso-ever can any surface water from: - roads, drains, paths, roofs, etc., be allowed into the system.
- (e) The proposals for disposing of such surface water to be outlined in detail to the Urban District Council.

## OVERDRAFT ACCOMMODATION FOR QUARTER ENDING 31ST MARCH, 1973:

On the proposition of Councillor E. Kavanagh, seconded by Councillor T.A. Delahunt it was resolved :-

"that we hereby approve, subject to the sanction of the Minister for Local Government, of the provision of temporary overdraft accommodation not exceeding £16,000 on General Revenue Account for the quarter ending 31st March, 1973".

### PENSION INCREASE - FORMER TOWN SURVEYOR:

On the proposition of Councillor Mrs. M. McEnroy, seconded by Councillor E. Kavanagh the Council resolved:-

"that an increase in pension be granted to the Former Town Surveyor in accordance with the provisions of circular E.L.25/72 of 12th September, 1972, and the excess expenditure be and is hereby provided".

#### AMENITY GRANTS SCHEME:

The Council agreed that the following applications be submitted to the Department of Local Government as our work programme on the Amenity Grants Scheme for 1973/174:-

- (a) Car Park at Castle Street, Wicklow The Council agreed to contribute £250 from rates towards this Scheme, and agreed to apply for another £250 of a Grant from the Department of Local Government.
- (b) G.A.A. Playing Field and Amenities Generally -The Council agreed to seek a Grant of £1,000 and agreed to contribute £1,000 from their Capital Reserves towards the project, subject to the sanction of the Minister for Local Government.
- (c) Childrens Playground at Ballynerrin, Wicklow -It was agreed to seek a Grant of £375 towards this Scheme and to contribute, subject to the sanction of the Minister for Local Government, £375 out of the Capital Reserves towards the development.

#### TOWN SURVEYOR'S REPORT:

The contents of the Town Surveyor's Report for the month of December, 1972 were noted by the Council.

The Town Surveyor requested that the Council authorise the employment of a Caretaker at the dump for a further period of one month.

It was proposed by Councillor T.A. Delahunt, seconded by Councillor E. Kavanagh and resolved:-

"that we hereby authorise over-expenditure in the sum of £110 to cover employment of Caretaker at the dump for a further period of one month".

#### Oil Pollution:

#### Parking:

LEASE OF PREMISES OF THE FORMER WICKLOW MINERAL WATER COMPANY AT MONKTON ROW, WICKLOW:

The Council agreed to an Assignment of the lease of the premises of the former Wicklow Mineral Water Company from Mr. Roy Bradshaw to Messrs Oliver and Norbert O'Reilly, Rocky Road, Wicklow. Permission to sub-lease portion of the property to Mr. James Connolly for the purpose of a Shellfish Processing Plant was refused as advised by the Council's Solicitors because planning permission was being refused.

The Council also agreed to transfer the lease of House No. 23, Dunbur Park, Wicklow from Mr. Thomas Fitzpatrick to Mr. Thomas Murphy, Laragh, Bray, Co. Wicklow.

PUBLIC LIGHTING:

The Town Clerk informed the meeting that a request had been received from the Dominican Convent to have a public light erected at the entrance to the Holy Rosary School. The Electricity Supply Board had estimated the cost at £100. The Council agreed to provide the light, but requested the Town Clerk to ask the Electricity Supply Board if it would be possible to erect the light over the entrance gate itself.

#### CONFIRMATION OF MINUTES:

The Minutes of the February Monthly Meeting and of the Special Meeting held on 14th February, 1973, copies of which had be circulated, were taken as read and then signed by the Chain

### DEPUTATION FROM WICKLOW RESIDENTS' ASSOCIATION:

A deputation consisting of:- Mr. Richard Giblin, Mr. James O'Brien and Mrs. Richard Kavanagh, all members of the Wicklow Residents' Association, addressed the Meeting of the Council regarding the Shellfish Processing Plant which has opened in the premises of the former Wicklow Mineral Water Company. The deputation pointed out that the shellfish being processed was causing a smell in the area and that the location of this type of factory in a residential area was not in the interest of the amenity of the area and would de-value their property.

The County Manager pointed out that permission to use the premises as a Shellfish Processing Plant had been refused and that this Council could now proceed under Section 24 of the Local Government (Planning & Development) Act, 1963.

All members of the Council were strongly opposed to the location of a Shellfish Processing Plant in this area and unanimously

resolved that the County Manager instruct the Council's Law Agents to take immediate proceedings under Section 24 of the Local Government (Planning & Development) Act, 1963.

The Manager informed the meeting that this would be done.

# CHAUGE FOR CONNECTION TO WATER AND SEWERAGE MAINS:

The County Manager pointed out that taking into account the future development which will take place in this town a new Sewerage Scheme will eventually have to be installed. He felt that at this stage contributions for houses now being connected to the Council's Water and Sewerage Mains should be made, and felt that a reasonable figure would be £200. He added that this would help to meet the heavy outlay and loan charges for new and extended Sewerage Schemes.

Some members of the Council were completely opposed to the charge while others felt that it was excessive and it was agreed to defer the matter to the April meeting of the Council.

The County Manager pointed out that it will be necessary to arrange a meeting with Crosspan Developments Limited to determine the price per house. It was agreed to request Crosspan Developments Limited to submit prices based on a Site Fine of £150.

The Council decided to reduce this heading by £607. They agreed that the purchase of two pressure reducing valves, which was included under this heading, be regarded as capital outlay and charged to our capital reserves.

The County Manager was requested to seek the sanction of the Department of Local Government.

## GENERAL PURPOSES :-

#### Election Expenses:

The Council agreed to delete the sum of £100 under this heading in view of the Minister's recent decision not to hold Local Elections in 1973.

#### Town Hall Improvements:

Councillor Mrs. M. McEnroy requested the Town Surveyor to investigate the possibility of carrying out a major improvement job to the Town Hall; the cost of same to be borne from the capital reserves.

#### County Council Demand - Health:

Councillor Mrs. M. McEnroy expressed disappointment at the decision of the Eastern Health Board to erect a Clinic in Greystones, Co. Wicklow contrary to the advice of the Wicklow Health Advisory Committee.

The Council agreed to express their protest at the decision.

#### County Demand - Malicious Injuries:

The Council noted that were it not for the huge amount of vandalism in the County, for which the ratepayers had to pay, the Wicklow Rate would be reduced by 15 pence.

At the conclusion of the meeting, Councillor J. Kane proposed that, in view of the decision to charge the cost of the pressure reducing valves to capital reserves and to the deletion of the item for Elections, the rate in the pound be reduced to £5.06, but was subsequently withdrawn when Councillor T.A. Delahunt, seconded by the Chairman, Councillor E. Kavanagh, proposed

For - Councillors T. Byrne, L. Turner, F. Conway and J. Kane.

Against - Councillors E. Kavanagh, T.A. Delahunt, Mrs. P. McNamara and Mrs. M. McEnroy.

The amendment was defeated on the casting vote of the Chairman.

The original motion was then put to a vote and the voting was as follows:-

For - Councillors E. Kavanagh, T.A. Delahunt, Mrs. P. McNamara and Mrs. M. McEnrov.

Against - Councillors T. Byrne, L. Turner, F. Conway and J. Kane.

The Chairman then gave his casting vote in favour of the motion which was carried.

### ANY OTHER MATTER:

The Council agreed to an outline planning application by Mr. Edward M. Kane, Fitzwilliam Road, Wicklow, for the erection of five dwellinghouses at Ballynerrin Lower, Wicklow.

### Vote of Sympathy:

The Council passed a vote of sympathy to the relatives and present Archbishop of Dublin on the death of the former Archbishop Doctor John Charles McQuade, C.S.S.P.

## Site at St. Patrick's Avenue:

The Council agreed to an application by Mr. John Finlay for the transfer of a site from Site No. 20 to Site No. 32.
