APPLICATION BY VEHA LIMITED FOR LEASE OF THAT REDE OF ROADWAY BETWEEN THEIR GATE ON THE NORTH SIDE OF THEIR FACTORY AND THE NEW ROAD WHICH LEADS TO TERRAPIN'S FACTORY:

On the suggestion of Councillor J. Kane, this matter was deferred until such time as the Council had decided on the possibility of providing an alternative road leading to The Murrough, Wicklow. Councillor J. Kane pointed out that the heavy traffic for the Docks and the Industrial Estate on The Murrough, Wicklow should be diverted and a road built joining perhaps the Coras Iompair Eireann road and the railway bridge and linking up with The Murrough between Veba Limited and Terrapin (Ireland) Limited.

The Council agreed to employ a Consulting Engineer to investigate this possibility.

MINUTES OF MONTHLY MEETING OF WICKLOW URBAN DISTRICT  
COUNCIL HELD IN THE TOWN HALL, WICKLOW ON TUESDAY,  
2ND OCTOBER, 1973 AT 7.30 P.M.

PRESENT: Councillor Mrs. P. McNamara, Chairman, presiding, Messrs T.A. Delahunt, J. Kane, E. Kavanagh, T. Byrne, L. Turner and F. Conway, and Councillor Mrs. M. McEnroy.

An apology for inability to attend was received from Councillor P. Doyle.

At the outset the Chairman, Members and Town Clerk welcomed Mr. Francis J. O'Brien to Wicklow as County Manager. They congratulated him on his appointment and assured him of their co-operation.

Mr. O'Brien, County Manager, suitably replied.

The Chairman read a letter from the out going Manager, Mr. Michael Flannery, thanking the Chairman, Members, Officials and Staff for all their help and co-operation over the years. He conveyed his deep gratitude for the presentation made on the occasion of his retirement.

CONFIRMATION OF MINUTES:

The Minutes of the September Monthly Meeting, copies of which had been circulated, were taken as read and then signed by the Chairman.

Arising out of the Minutes Councillor J. Kane asked if any progress had been made on the provision of an alternative route to The Murrough, Wicklow.

The Town Clerk informed the meeting that the matter was under consideration.

APPLICATIONS UNDER LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) ACT, 1963:

The Council was informed that permission was being granted to the following:-

- (a) Mr. George Canterbury, Summerhill, Wicklow for the erection of a bungalow at St. Manntan's Road, Wicklow.

- (c) Miss Sarah Darcy, 3, Upper New Street, Wicklow for the erection of an extension to her dwellinghouse.
- (d) Mr. John Flynn, 10, Dungalow, St. Laurence's Road, Wicklow for the erection of an extension to his dwellinghouse.
- (e) Messrs. Durkan Brothers (Dublin) Limited, 3, Sandford Road, Ranelagh, Dublin, 6 for the erection of 25 dwellinghouses at New Park Road, Wicklow.

Powers Supermarket Limited:

The County Manager informed the meeting that he proposed to grant outline permission to Messrs. Powers Supermarket Limited for the erection of a shopping centre on the Rectory Grounds, Wicklow, subject to his obtaining permission from the Minister for Local Government to deviate from the Council's Development Plan. He further pointed out that the land in question is zoned for residential purposes in this Council's Development Plan and that this development would materially contravene the said Plan. Accordingly, it would be necessary to apply to the Minister for Local Government for permission to deviate from the said Plan.

The Council noted a letter which had been received from the staff of the Wicklow Vocational School making observations on this particular application.

In reply to a question by Councillor F. Conway the County Manager pointed out the legal position in relation to decisions on planning applications.

Crossspan Developments Limited:

In reply to a question by Councillor Mrs. M. McEnroy, the Town Clerk informed the meeting that provision has been made for a childrens' playground on both layouts which was agreed to for housing development by Crossspan Developments Limited at Dunbur Road, Wicklow.

Concern was expressed at the fact that the cost of the houses would be increased because of the reduction in the number of houses.

CRONEROE IMPROVEMENTS - APPORTIONMENT OF COSTS:

The Town Clerk read a letter from the Wicklow County Council which stated that they had received a tender for Phase 1 of the Improvements at Croneroe and that it was estimated that this phase would cost £53,000 approximately. The letter pointed out that the Wicklow County Council approved of the improvements on condition that the Wicklow Urban District Council would pay 60% of the capital cost and would pay the maintenance costs as and from 1st April, 1972 in proportion to the quantity of water from this Scheme consumed by the Wicklow Urban District.

It was pointed out to the meeting that the Wicklow Urban District Council was at present consuming over 60% of the water being produced at Croneroe.

The Members felt that it was unreasonable for the County Council to insist on the Urban Council paying 60% of the capital cost. The Members agreed to pay 50% of the capital cost and to pay £1,000 per annum towards maintenance costs, the latter figure to be subject to a quinquennial review.

TIDY TOWNS COMPETITION:

The meeting noted the Adjudicator's Report on Wicklow's entry in the 1973 Tidy Towns Competition. The meeting noted that special mention was given to Mr. Phil Healy's premises at Fitzwilliam Square and the "Bridge Tavern", Bridge Street, Wicklow for being nicely painted.

It was requested that the Town Clerk write to the owners of these premises thanking them for the effort they have made.

A vote of congratulations was passed to Kiltegan on winning the Competition.

RENEWAL OF LEASES:

The Council agreed to grant a new 75 year Lease to Mrs. Harrett Doyle, Market Square, Wicklow, subject to the following conditions:-

- (a) A Leasehold rent of £20 per annum.
- (b) The rent to be reviewed every 15 years having regard to changes in money value relationships.
- (c) All legal costs including this Council's costs to be paid by the lessee.

Councillor Mrs. M. McEnroy stated that she noted from a recent report by An Foras Forbartha that there were no fatal accidents in Wicklow town during the year covered by the report. This she attributed to the Monument in the Market Square, Wicklow, which she stated slows down the traffic.

#### Public Lighting:

Councillor E. Kavanagh requested that the Town Clerk contact the Electricity Supply Board regarding the provision of a public light at Monkton Row, Wicklow.

#### Appearance of Courthouse:

The meeting requested the Town Clerk write to the Wicklow County Council requesting that something be done to improve the appearance of the Wicklow Courthouse.

#### Private Housing Development:

Councillor F. Conway informed the meeting that a person living on Friars Hill, Wicklow had informed him that his house was in a bad condition and he asked if the Council could help him in any way.

The County Manager pointed out that the Council could not help. He stated that it was a case of buyer beware as far as private houses were concerned.

#### Right-of-Way at Outer Murrough:

In reply to a question by Councillor F. Conway the Town Clerk read a letter from the Wicklow County Council regarding the opening up of the right-of-way at the Outer Murrough, Wicklow.

The Council agreed that the Wicklow County Council be requested to acquire this right-of-way.

#### Planning Application:

MINUTES OF SPECIAL MEETING OF WICKLOW URBAN DISTRICT COUNCIL HELD ON TUESDAY, 16TH OCTOBER, 1973 IN THE TOWN HALL, WICKLOW.

PRESENT: Councillor Mrs. P. McNamara, Chairman, presiding, Councillors Mrs. M. McEnroy, Messrs E. Kavanagh, J. Kane, F. Conway and T. Byrne.

IN ATTENDANCE: Mr. D. Lane, B.E., Town Surveyor, and  
Mr. P. Hughes, Town Clerk.

Apologies for inability to attend were received from:-  
Councillors T.A. Delahunt, L. Turner and P. Doyle.

The Town Clerk informed the meeting that the Wicklow County Council, at their meeting held on 8th October, 1973, considered the authorising of a loan to defray its share of the cost of the improvement works to the Wicklow Regional Water Supply Scheme. The Wicklow County Council noted the Wicklow Urban District Council's request that the capital cost of the improvement works be apportioned on a fifty-fifty basis and our offer to increase the contribution towards maintenance costs from £400 to £1,000.

The Wicklow County Council has noted the fact that the Wicklow Urban District was consuming 60% of the total production of water and resolved that the capital cost be met as to 60% by the Wicklow Urban District Council and 40% by the Wicklow County Council and that the maintenance costs of the Scheme be defrayed in the same proportion.

The Members of the Wicklow Urban District Council pointed out that they appreciated the fact that they are now consuming 60% of the water produced at Croneroe and will continue to do so for perhaps another ten years.

At that stage, however, they pointed out that it was reasonable to expect that there will be no further land for development within the Urban District and that all development will then be taking place outside the Urban Boundary. They further noted the fact that the County Council has already given permission for development outside the Urban Area which will be serviced by the Urban Council's Sewerage System. Provision of an Industrial Estate in Rathnew, Co. Wicklow, should, they feel, mean that considerable development will take place in Rathnew. They felt it reasonable to assume, therefore, that after approximately ten years the County Council could be consuming 60% of the water produced and the Urban Council only 40%.

The Members also noted that of the 60% being consumed by the Wicklow Urban District almost 15% is used for industrial purposes. These industries, the Members pointed out, facilitate both the Rural population as well as the Urban.

Following a discussion the Members decided to discuss the matter with Members of the Wicklow County Council for the Wicklow Electoral Area.

Following a lengthy discussion on the matter it was decided that the Town Clerk would write to the Wicklow County Council and inform them that the Wicklow Urban District Council is now prepared to pay 60% of the capital cost of the Phase 1 improvements and is further prepared to pay £1,000 per annum towards maintenance costs. This latter figure is subject to a review every four years.

The Members of the Wicklow Urban District Council pointed out to the Members of the Wicklow County Council that it is absolutely essential to the ratepayers of the Urban District that a fixed figure for maintenance be agreed upon.

MINUTES OF SPECIAL MEETING OF WICKLOW URBAN DISTRICT COUNCIL  
HELD IN THE TOWN HALL, WICKLOW, ON MONDAY, 18TH FEBRUARY,  
1974, AT 7.30 P.M.

Following a lengthy discussion on "The Discussion  
Document on Local Government Re-organisation"  
the Town Clerk was instructed to write to the  
Minister setting out the Council's views, together  
with their reasons for the views expressed.  
The views are summarised hereunder:-

- (1) Agreement that the County Councils should be the principal Local Authorities.
- (2) Agreement that the existing Urban District Councils and Board of Town Commissioners be retained.
- (3) Agreement with the Minister's proposal to introduce legislation providing for a simplified and comprehensive system of boundary adjustment. It was felt that the Urban boundary should be extended for the following reasons:-
  - (a) Rapid expansion of the population, together with the consequential result of limiting the amount of land available for housing development within the Urban boundary.
  - (b) The amount of development which is taking place in the natural hinterland of the town which is being served by the Urban Council's sewerage system.
  - (c) The expanded Urban could take in the development proposed at Blainroe, together with, perhaps, the village of Rathnew.
- (4) Planning and Development should remain the function of the Urban Council. The Urban Council should, however, have the expert advice of the County Council staff available to them. It was felt that these functions were at present being carried out both efficiently and effectively.
- (5) Sanitary Services functions to be retained by the Urban Council. The members, however, felt that co-operation should take place between the Urban Council and the County Council with a view to the introduction of joint schemes where possible.
