- (6) Agreement that no change take place under the heading of Roads and Road Traffic.
- (7) Complete opposition to the proposal to transfer the housing functions to the County Council. It was felt that this service was very efficiently carried out by the Urban in the past and if the County Council took over this function the service was not be as good.
- (8) Existing staffing situation is considered both adequate and economic.
- (9) The Urban Council should continue to levy the rates in the Urban area.
- (10) Agreement with the proposal of the Minister to devolve more powers to the Local Authorities but feel that it is inconsistent with his proposal to take powers away from Urban Councils.
- (11) Welcome for the Minister's statement that the public representative elected by statutory elections occupies a key role in Local Government.

It was agreed to discuss this document with the members of the County Council and other Urbans on Friday the 22nd February, 1974, at 2.30 p.m.

(e) Mr. Leslie T. Bradshaw, The Mall, Wicklow:

It was proposed by Councillor F. Conway, seconded by Councillor P.T.K. Liston, and resolved:

"That we hereby authorise the raising of a lean of £430,000 from the Local Leans Fund repayable over 35 years to defray the cost of constructing 82 houses at Ballynerrin, Wicklow.

The Council expressed their appreciation of the work of the County Manager and the former Council in arranging to have this Scheme of 82 houses constructed.

On the proposal of Councillor M. 38 Murphy, seconded by Councillor D. Teevan, it was decided to adopt the provisions of circular letter EL 25/74 of 2nd June, 1974 regarding pension increases.

The Council expressed concern at 30 7 7 the standard of the Refuse Collection Service expecially since an expensive Refuse Collection Vehicle had been purchased to improve the Service. Following a discussion of the subject it was resolved, on the proposal of Councillor F. Conway, seconded by Councillor D. Teevan:

"That the Town Surveyor examine the Refuse Collection Service and submit a Report to the next meeting of the Council".

The Report of the Clerk of Works 30 7 74 was noted together with the letter of 24th July, 1974 from the Contractors, Messrs. McIlvenna Brose Ltd. explaining the delay in completing the Housing Scheme. The Council expressed their dissatisfaction with the explanation given.

The Town Surveyor's Report was noted and it was requested that the Town Surveyor should examine and report on the maintenance of the Public Open Spaces in the town.
