Sub Sanitary Officer's Report

1st March, 1927

Inspected 65 premises and served three notices which were complied with. By instructions of the Medical Officer of Health destroyed the bedding from the premises of Mr H. Naulty, New Street, and submit list for payment of the Bedding destroyed.

The usual flushing of the main drainage and the disinfecting of the Urinals at the North & South Quays were carried out weekly during the month.

I had sample of Water taken and sent for analysis. Examined main drainage in Strand Street and found gravel in the pipes which will require to be cleared.

The Council's men have been engaged cleaning up water tables and side dressing on the Dunbur Rd, Green Hill Rd, Marlton Rd, Rocky Rd. Had 35 Cubic Yds stones broken and spread at High St Stone Bridge and Monkton Row. Sixty Yds of more Stones are required next month. Owing to the condition of the North &

South Quays I wish the Council's Instructions to have them cleaned.

On the 28th ultimo two of the Council's Men were reported sick and have not resumed work yet

WATERWORKS OVERSEER'S REPORT

1st March, 1927

Since last Meeting the Water in the Reservoir has come up 3 feet, there is now 9ft 6 ins of Water in the Reservoir and a very large amount coming in.

During the month I repaired a Main at Wentworth Place, and made a number of night tests. Served 6 notices for waste of water through leakage, and turned the water off in ⁴ houses for failing to have leakages looked after. There is a leak in the service to the Pound House, I want your instructions in this matter.

Part of the coping of the Wall Boundary has been knocked off and would require repairing.

The Roof of the Cottage is leaking and one of the door posts has come away from its socket.

Electrical Engineer's Report

1st March, 1927

During the month ending February 28th our public lighting and private services have been carried out as usual, and any faults occurring in Overhead System from the severe weather attended to and made good. Plant has been running daily and is in good condition.

The scraping and painting of Electric Standards which I recommended to be carried out last year is now considerably over-due and it is essential that provision be made for carrying out this work early in the coming Summer. I would also advise that the offer of the Chloride Electrical Storage Co, to carry out periodical inspections of the Battery be accepted, their expert to carry out two inspections per year and furnish report.

During the month I collected and lodged to credit of Council £70 : 10 : 3.

That Messrs John Clarke & John Conroy be written to for an explanation for their non attendance at the Council Meetings within the statutory period failing a satisfactory answer the vacancies be filled at next Monthly Meeting.

Mr P. H. McCarthy's Report
on Waterworks.

I beg to report that on the 11th February, I inspected the Reservoir with Mr Lalor, the Chairman; Mr Turner; the Town Clerk; and the Water Inspector. The level of the Water in the Reservoir was exactly the same namely: $-6\frac{1}{2}$ feet as on the occasion of my previous inspection. The gauge pipe I put up for testing the leakage of the Reservoir was in place and all the waste was flowing through it.

After examining the old filters and chambers in the Embankment and seeing the leakage into the chambers we ~~decided to close~~ decided to close down the outlet valve of the Chambers and having done so the leakage practically stopped, in other words the inflow to the chambers was being stored in the chambers. This would indicate that there is not much leakage under the Embankment, at least at the present water level, though the floor of the chambers is 18ft below the present water level.

We explored the district for some miles round the Reservoir to see if any streams could be intercepted but we could not find any at the proper elevation where the flow was such as to justify a large outlay.

We found however a fair flow in a stream between the Townlands of Hawkstown Upper and Hawkstown Lower, and at a reasonable outlay this could be intercepted and conveyed in a 6 inch stoneware pipe to one of the small streams at present supplying the Reservoir. The stream to be intercepted is in Mr Delahunt's land and if the Council could obtain his consent to divert the water the work could be carried out without any difficulty. The stoneware pipe would be laid through Mr Symes land and with a cover of 2ft over top of pipe which is ample for all purposes. I have shown this pipe on Map which I send herewith. It

is marked with the letters A. B. C. The length is about 610 yards. In our explorations we also discovered a considerable flow of water passing by Mr Symes house and though it is in the catchment area it is running down through the fields and discharging into the main stream below the Reservoir and is lost to the Council. I did not go up to the source of this flow of water but it is shown on the Map as starting at one of the streams which supplies the Reservoir and obviously an artificial cut was made to bring a supply of water by Mr Symes house, and it is obvious that much more water is being diverted by Mr Symes than is necessary, and if the whole of this water was discharging into the Reservoir all the Winter it would be probably filled to overflow level by this. Mr Syme's supply is obviously an old one but arrangements should be made to take it into the Reservoir. This can be done without in any way depriving Mr Symes of sufficient water for all his requirements. The water can be intercepted at the point "C".

and taken into the pipe from Mr Delahunt's Stream, but a small tank should be built at the place and a 1½" pipe could be run from this tank to troughs in the Farm Yard and to the two fields lower down which are at present being supplied by the diverted water. I have shown these troughs on Plan. The troughs could be fitted with Ball cocks or a continuous flow could be passed through the troughs and from the lower trough the pipe could be continued into the Reservoir. The whole arrangement is very simple and the great increase in the supply would more than justify the expenditure.

The work can be carried out in such a way that neither Mr Delahunt or Mr Symes would suffer in the least.

If the work were put in hands at once you would have some chance of filling the Reservoir, otherwise I fear you will be in a very bad way for the Summer.
