Monthly Meeting Monday September 6th 1909

The usual Monthly Meeting of The Arklow Town Commissioners was held in their Office, Court House, Arklow, on Monday the 6th. September 1909 at 7 o'clock p.m. when the following Members were present:-

The Minutes of the last Monthly Adjourned Meeting and of the Special Meeting of the 19th August 1909 were read and agreed to and duly signed by the Chairman.

Arising out of the Minutes of the Special Meeting of the 19th August 1909 Mr. P. Kavanagh strongly objected to public money being squandered by not accepting the lowest tender for Oil. There was a short discussion on the matter and the incident closed.

The Local Government Board wrote under date the 26th. August 1909 in answer to an inquiry stating that the loan of £3,500 under the Arklow Harbour Act 1882 would not affect the borrowing powers of the Commissioners.

The L.G.B. also sent a copy of a letter received from P. Boland, Arklow, in reference to the Oil Contract, and their answer thereto. And by letter dated the 2nd. Sept. 1909 the same Board notified the Commissioners that a sealed Copy of the Arklow Urban District Order 1909 had been forwarded to the Irish Office, London, with a view to its being confirmed by Parliament.

Mr Muldoon M.P. offered his services to the Board in connection with the Housing Question, whenever they (the Board) required his help. All the foregoing letters were marked "Read".

Messrs Shand, Mason & Co., London submitted their illustrated catalogue of Fire Engines. No notice was taken of the matter.

The Clerk read again Mr. C. Toole's Notice of Motion re the extension of the Gas along the Harbour Road. Mr. Toole placed the matter once more before the Board for consideration.

Mr. H. Byrne supported Mr. Toole, but took exception to the latter's statement that the lamps down Harbour Road were not kept burning during the fishing season.

Mr Byrne said the lamps were lighting all night during the months of November, December & January for the last ten years except last year. He (Mr Byrne) suggested the Clerk should take measurements along the Harbour Road and find the price per lineal foot of piping $\frac{1}{4}$ " size. The Clerk was directed to do this.

Lamplighter Thos. Copeland signed his Agreement at this meeting. As Lamplighter Lar. Kavanagh was not present directions were given that he should sign at the General Purposes Committee.

The arranging of the evenings for the Housing Committee meeting was held over pending the adoption of Mr Kavanagh's Notice of Motion.

The gas-man sent in a Report that there was 1 ton 14 cwt. of Carbide in stock and that some oil & gas burners were required for reserve. A small quantity of each was ordered to be obtained.

There was a discussion on the price of Carbide. The Clerk said we were giving at present £12 a ton to Messrs. Chas. Tennant, Belfast, with the advantage of any reductions in price. As we had so far not benefited by the latter stipulation, the Clerk was requested to write to other Carbide Merchants for quotations and compare prices, and if favourable, to submit them to Tennant & Co. for consideration.

The Minutes of the last Monthly Meeting were read, agreed to, and duly signed by the Chairman

Correspondence

A letter was received from the Law Union and Crown Insurance Company offering Insurance proposals for the Gas Works. The letter was marked "Read".

Messrs Chas. Tennant & Co wrote expressing regret that the last ton of Carbide sent was of too small a mesh, and asking the Commissioners, if possible, to retain it. As it could be used up with the larger size Carbide it was decided to keep it.

Mr. J. J. Kavanagh submitted to quote for lamp burners, globes, wicks etc. The Clerk was directed to consider Mr. Kavanagh when getting his next supplies.

The above was seconded by Mr. L. O'Ffoole and passed unanimously.

Attention was drawn by Mr. P. Kavanagh to the exorbitant valuation of the Gas Works and Mains. No definite line of action was, however, taken in the matter.

The usual Monthly Meeting of the Arklow Town Commissioners was held in their Office, Court House, Arklow, on Monday the 1st. November 1909 at 7 o'clock p.m.

In the absence of the regular Chairman it was proposed by Mr C. Toole, seconded by Mr. P. Tracey & passed unanimously that Mr. J. Mc Gradden take the chair, which he accordingly did.

The Minutes of the last Monthly Meeting were read, agreed to, and duly signed by the Chairman.

Mr. P. Tracey said the Clerk only went over the Minutes of the year 1907 in order to find out where mention of the election of the Harbour Board Representatives was made, and protested against the Clerk's writing to the Harbour Secretary for the information which should be found in his own Minutes. Mr. P. Kavanagh said the Town Clerk could not be held responsible for the omission of others. The matter dropped when the Clerk was ordered to go back over the Records till he found the required information, & report at the next Monthly Meeting.

Lamplighters Thomas Copeland & Laurence Kavanagh applied for an increase of wages. Mr. P. Tracey proposed they should get an increase of 2/- per week, & in addition that they be paid weekly. To be in order, however, Mr Tracey handed in the following Notice of Motion:-

Take notice that I or someone for me will move at the next Monthly Meeting of the Board that our Lamplighters get two shillings per week of a rise, and that they be paid weekly, and that the Standing Agreement be rescinded.

A communication was received from the Town Tenants' League, Dublin, asking the Board to send Delegates. It was proposed by Mr W. Merrigan, seconded by Mr. C. Toole and passed unanimously that the Chairman (Mr M. Waldron), Messrs J. McCrudden, P. Kavanagh, & P. Tracey be appointed to represent the Commissioners.

The L.G.B. sent a letter stating that they would hold over their decision re the surcharges until after the settlement of Urbanisation. The letter was marked "Read".

The Arklow Development Association wrote asking if the Carbide used by the Commissioners was of Irish manufacture & whether they (Commissioners) insured under an Irish Company. The answer in both cases was in the negative & the Clerk was directed to reply that the Comms. always used Irish made Goods whenever possible. The Clerk also said he would see Mr Kelly, Sec. of the Body, personally.

A Special Meeting of the Arklow Town Commissioners, at which all persons interested were invited to attend, was held in their office Court House, Arklow, on Monday 22nd November 1909 at One O'clock p.m. to adopt Part III of the Housing of the Working Classes Act 1890.

The Requisition having been read, which was contained in a Public Poster, the Chairman announced the purpose for which they were assembled. There was no opposition to the project by outside bodies, so the Chairman after a short discussion proposed the following Resolution:-

The Minutes of the last Monthly Meeting and of the Special Meeting of the 22nd November 1909 were read.

Mr P. Tracey objects to Minutes being signed with reference to Harbour Board representatives. Minutes signed in original form after some discussion.

Mr P. Tracey objected to the signing of the Minutes of the Monthly Meeting Minutes as not being a true Record with regard to the insertion of the directions given in reference to the Harbour Board Representatives. The Chairman read again the Clerk's Record of the proceedings in question, and said although he was not present at the last Meeting he would consider the Minute a correct one. After a lengthy discussion the matter was allowed to drop and both Minutes were signed in their original form.

Correspondence: A letter of thanks was received from the Arklow Development Association, and asking

from the Arklow Industrial Developmen Assocⁿ the Commissioners to insure with the Hibernian Company at the expiration of the present policy with the Rly. Passengers Assurance Co. as the former would take on at the same rate as the latter. It was unanimously agreed to accede to the Association's request.

Resolution on House Grabbing by Rathdrum R. D.C. (Re Earl Fitzwilliam Estate)

The Rathdrum Rural District Council sent a copy of a Resolution, to be laid before the Board, condemning the action of the house grabbers who bought over the heads of the tenants at the recent sale of the Fitzwilliam Estate in Wicklow and Rathdrum. It was proposed by Mr. W. Merrigan, seconded by Mr. Wm Kavanagh and carried unanimously that the resolution be adopted.

Gas extension postponed.

The Local Govt. Board sent a letter advising the postponement of the gas extension pending the decision as to the Urbanisation Order at present in Parliament. It was decided to abide by the the L.G.B.'s decision.

Tennant & Co. offer £10-10-0 per ton Carbide.

Tennant & Co. Belfast wrote refusing to give rebate asked for but offered to invoice all Carbide ordered from now till the end of the contract at £10 - 10 - 0. There were several quotations from other firms and the Clerk said Tennant's compared favourably with all of them except the Sun Gas. Co. who offered £10-0-0 a ton free on rail at Dublin. The Clerk was asked to point this out to Tennant

A communication was received from the Local Government Board asking what action the had been taken by the Town Commissioners in regard to the matters referred to in the Auditor's Report for year ended 31st March 1909. The Clerk said he answered this letter pointing out that the Reports for year 1908 & 1909 were not read owing to the Audits not yet being completed, on account of the surcharges. The L.G.B. then sent a letter asking whether the Rate Collector had yet furnished a Bond according to statute, and whether the sum of £16-10-0 due by the late Town Clerk had been settled up. With regard to the first portion of the letter the Clerk was directed to write saying the Collector has already personal securities & having had these so long to ask if this form of Bond could be retained by Mr. Evans. In reference to the £16 - 10 - 0 the father of the late Town Clerk paid £45 on account & the above money was subsequently found to be outstanding. The Clerk was requested to write to the Local Government Board to this effect and also that it was the opinion of the Town Commissioners that Mr. Gerald Kavanagh would pay the amount due if he returned to Arklow.

A letter was received from the manager of the Wexford Gas Consumers Co. saying something about the enlargement of the gasometer, but as the letter was so difficult to understand no notice was taken of it.

The Clerk brought before the notice of the
Board that the gas-Man had no oil-coat to
keep him dry in wet weather. Permission was
given to get him one.

The next business on the Agenda was the
Report of the Town Clerk upon the result of
his searching the Minutes for the last election
of the Harbour Representatives on the Board.
The Clerk said he had gone back over the
Minutes as directed, but found no reference
to any election of Harbour Commissioners till
the year 1903 and in August of that year
Messrs Hugh Byrne, Gold and Richard Kearon
were elected Representatives on the Harbour Board.

Mr P. Tracey said what were they going

The Clerk read the Requisition, which was contained in the Minutes of the Monthly Meeting of the 6th Dec. 1909, authorising him to call the meeting.

In the absence of Mr. P. Tracey, who was sick, Mr W. Merrigan proposed that the lamplighters get 2/- per week extra and that they be paid weekly. This was seconded by Mr Wm Kavanagh. Mr P. Kavanagh said he would not propose an amendment, but he disapproved of the increase because there was plenty of expense at present and all the funds available were wanted for the proposed Workman's Dwellings which he (Mr Kavanagh) considered was a more urgent matter than anything else.

Special Meeting Wednesday 22nd December 1909 Contd.

Mr M. Waldron (Chairman) said it was an inopportune time to levy extra expense as their funds were already low, and supported Mr Kavanagh's view of the Housing Question.

Mr C. Toole supported the Motion and said the men were employed only half of the year, and he considered they would not go beyond the mark if they gave the lamplighters double the money. Mr Toole mentioned about an amendment by Mr P. Kavanagh, when the latter gentleman refuted Mr Toole's statement, and said he did not propose an amendment but only expressed himself not in favour of the Motion, for the reasons he had stated.

Mr J. Mc. Cradden also supported the Motion, as, he said, the lamplighters were doing their work very satisfactorily. Every Member then having spoken the Chairman asked was there any amendment, and there being none the Motion was declared carried unanimously. The Town Clerk was directed to start the increase and pay weekly from Monday the 27th inst. This finished the first portion of the business.

The Clerk then read two letters on the Housing, one being from the Local Govt Board of Act proofs required and the other from the Town Clerk, Enniscorthy. The L.G.B. required formal proofs of the adoption of the Act which was to be sent along with a Form to be filled in, with

reference to the loan. A Form was enclosed for this purpose. Amongst the questions contained in it were some relating to Engineer plans and estimates, so that the Commissioners would have to employ technical knowledge. Various suggestions were put forward as to how this could be done with the least expense for the present, and after several proposals, it was decided, on the initiative of the Chairman, to advertise for an engineer to advertise in the Dublin Independent and in the two local papers. It was agreed also to leave the matter open till the 10th Jan. 1910 when the Clerk could call a Special Meeting, on a day suitable for the above purpose, to consider applications.

The Enniscorthy letter gave particulars as to the class of houses built, the number, 46 in all, and the average cost of each. Thirty five houses at £115 each and 1/9 per week rent meant a loss to the rates of $\frac{1}{4}$ in £, and at 2/3 per week rent, a loss of $\frac{1}{3}$ in £. Eleven houses were erected at the cost of £165 each and let at 3/- per week which also meant a loss to the Rates of $\frac{1}{2}$ in £. This letter stated we would have to employ an Engineer to prepare plans, specifications to forward to the Local Govt. Board when applying for a loan.

A couple of other matters in regard to new lights, and graveling of the Back-Lanes, were brought up by Messrs W. Kavanagh & P. Kavanagh, which were not on the Agenda.

The Board requested that the matters referred to in their letter should be dealt with at this meeting.

~~Report of Deputation appointed to wait on R.D.C. Rathdrum as to sanitary funds~~

Mr Mc. Gowan handed in a Report dated the 13th Decr. 1910, which was read, of the result of his attendance upon the Rathdrum Rural District Council on behalf of the other Members of a Deputation who were unable owing to the elections to attend at Rathdrum and who were appointed to confer with the District Council with regard to funds necessary for the cleansing and scavenging of the Town.

Mr Mc. Gowan in pointing out the difficulties in which the Council were placed through want of money was courteously received by the Rathdrum Board who expressed their sympathy in the matter and therewith signed a cheque for £15/- for the time being to meet the requirements of the Urban District Council.

Mr Mc. Gowan pointed out that the above facts disproved any derogatory reports which were made about the Rural District Council.

Dr. MacCormack advised the Board as directed by L.G.B.^d to finance and steps to be taken re fever outbreak. Present L.S.O.'s services availed of. Dr. MacCormack then addressed the Board as to the best arrangements which could be made under the present circumstances, and with regard to the necessary finance that the Treasurer might accommodate us until such time as we could meet our demands. The Medical Inspector advised the Board to carry out the directions of the L.G.B.^d letter with reference to the Sanitary officers, and he himself further advised the appointing of an Assistant Sanit. Sub. Officer and with Dr. Hamilton also suggested the employing of two additional scavangers and another horse & car, all of which suggestions were embodied in a Resolution afterwards adopted.

Dr MacCormack said all the Premises should be disinfected and the clothes of the patients burned. To substantiate his reason for suggesting the last drastic remedy he quoted extracts from a letter of Professor MacWeeney's as to body lice which infected people's clothes being the chief if not the sole means of conveying the infection. He (Dr MacCormack) further advised the Board to make no more applications to the L.G.B.^d re expenditure, that the infected area should be daily visited and that enforced compliance of the measures and precautions to be adopted should be taken if necessary.

Dr. P. J. Hamilton, M. O. H. under date of January 14th reported:-

I beg to report for the information of the Council, that during the past four weeks there has been only one case of typhus fever in town, so that we may reasonably hope to be free of the disease. I would recommend the Council to make an order, as sanitary authority, forbidding the exposure and sale of second-hand clothing on the streets of Arklow, as this is a common cause of the spread of infectious diseases and may possibly have been the cause of the recent typhus outbreak. The scavengers have been doing their work well, and I think, considering the extent and population of the township, it would be necessary to have two horses and carts constantly employed to do the work."

After some discussion relative to the necessity of a new set of bye-laws to enforce and carry out the Doctor's recommendation, the Chairman suggested that the Clerk should write to Bray and Wicklow Urban Councils for copies of their bye-laws for the guidance of

the Council. Mr Walsh said that the Council should make an order prohibiting the sale of and exposure of second-hand clothes, and that the Clerk should be instructed to take steps to禁 the sale of second-hand clothing presented. Dr Hamilton requested that if the Council acted on Mr Walsh's suggestion they would be doing the right thing, and thought that the police if asked would take steps to stop the practice of selling in the streets, though he thought they could not prevent persons from selling second hand clothes in the shops.

The following order was then made and unanimously agreed to:-

"That in accordance with the directions of the Medical Officer, the sale of second-hand clothes be prohibited in the street". Mr Kavanagh suggested that an order should be made for the sub-sanitary officer to have the Council's order carried out at once.

This suggestion was unanimously adopted.

Proposed by Mr Walsh that the Board should congratulate their Medical Officer, sub-sanitary officer, assistant sub-sanitary officer and all those who had taken part in the stamping out of the fever outbreak in Arklow for the successful manner in which each of them had performed

his duty."

This vote of congratulation was seconded by Mr Kavanagh and passed unanimously.

A letter was read from the County Surveyor notifying the Urban Council that the contracts for the maintenance of three roads inside the Arklow Urban bounds would expire next March.

Mr Henderson said the letter should have been read before the Council dealt with the surveyor's appointment, as they could not now under the circumstances postpone the appointment for six months. They would have to rescind that resolution because these roads would have to be looked after by the town surveyor after the contracts expired in March. After some discussion it was eventually agreed that the Clerk put the consideration of the Surveyor's appointment on the agenda for the next monthly meeting.

The Drs also reported that the outbreak seemed to be at an end as there were no fresh cases in the last three weeks.

Report unanimously adopted and L.G.B. inspector's recommendation ordered to be carried out.

The Chairman mentioned, that the conference of sub-committees to adjust the finances between Arklow U.D.C and Rathdrum R.D.C. was to be held on the 31st ^{inst} at Wicklow.

The following communication embodying the report of the Conference on Financial Relations, was received from C. N. Wynne, Secretary to the County Council:-

The Joint Committee consisting of representatives from the Wicklow County Council, the Rathdrum Rural District Council and the Arklow U.D.C.

appointed to confer together on the financial adjustment rendered necessary by reason of the Arklow Urban Order 1909, met in the Council Chamber Courthouse Wicklow, on the 31st January 1911.

Present - Councillors D. J. Cogan in the chair, Patrick Flaherty, J. J. Reilly, & Joseph Mc Carroll, representing the County Council; Messrs P. J. Carney Mr. Byrne J.P. Joseph Clarke, & J. H. Mc Carroll solicitors, representing the Rathdrum R. D.C.; Messrs E. C. Walsh, Lord Wicklow; Michael Walwyn, and the Acting Clerk T. J. P. Kavanagh representing the Arklow U.D.C.

Having carefully considered the several matters involved, the following agreements were come to and signed by the several representatives -

① The representatives appointed by the U.D.C. of Arklow to confer with the reps. of the County Council and of the R.D.C. of Rathdrum relative to the financial adjustments requisite in consequence of the urbanisation of Arklow, promise and agree that the U.D.C. of Arklow will pass a resolution authorising the County Council to continue the collection of the current Poor Rates within the Arklow Urban District up to and including March 31st 1911; and further authorising and requesting the County Council to continue to discharge the payments due on existing contracts up to the 31st March 1911; and the County Surveyor - with the consent of the County Council - be authorised and requested to enter into

short contracts on behalf of the U.D.C. of Arklow for the upkeep of the road within the Urban District of Arklow until the 30th of September 1911.

- (2) The representatives of the Rathdown R.D.C. and of the Arklow U.D.C. at this financial adjustment conference hereby agree that the Rathdown R.D.C. do pay the Arklow U.D.C. a sum equal to the Rural District Council expenditure on the area now included in the Urban District during the half year ended 30th of September 1910 after deducting therefrom the amount already expended on said area during the current half year; at the close of the current half year when the books are closed on the 31st March 1911 the actual balance, ^{as between the two Councils} to be struck and paid over by the Council liable thereto.

- (3) The representatives of the Arklow and Rathdown Councils hereby mutually agree that the costs of the Sanitary Officers Dr. O'Keefe, and Dr. Hamilton be borne by each council in the following proportion that is to say: Rathdown R.D.C. to pay £17..10 and Arklow U.D.C. £10..10

The Chairman in commending it on the above report remarked that "there will be coming to the Urban Council the sum of £619..1..3 to start with."

The report was unanimously adopted and in conformity with its terms the following resolution proposed by Mr. Condron was also unanimously agreed to.

"That the Report of the sub-committee be adopted and that we hereby request the County Council to continue the collection of the current poor rate within the Arklow Urban District up to and including the 31st March 1911; that the County Surveyor with the consent of the County Council be authorised and requested to enter into short contracts on behalf of the Urban District Council of Arklow for the upkeep of the roads within the Urban District until 30th September 1911; that we further authorise and request the County Council to discharge the payments due on existing contracts up to 31st March 1911; and that we agree that the Rathdown R.D.C. pay over any balance or funds to the credit of the Urban Council, at the end of the financial year as agreed upon by the Conference.

The County Surveyor, present, read out a list of payments amounting to £100 .. 3.. 3 due by the Arklow U.D.C. on existing contracts before paying which the County Council would need the sanction and authority of the Urban D.C. It was pointed out that the foregoing resolution authorised the County Council to make these payments.

The County Surveyor read out a list of expiring contracts which it would be necessary for the Council to advertise for tenders after their first Quarterly Meeting. His estimate for the cost of the maintenance of the various roads to be contracted for to September 30th 1911 was £105.

On the motion of Mr Conder it was unanimously agreed to that, the first Quarterly meeting at which the County Surveyor's recommendation would be considered and advertised, would be held on Monday February 13th 1911.

A communication was read from Mr G. L. Moore b.c. detailing for the information of the Board the various steps he had taken for the supplying of plans, specifications, and documents for the forwarding of the Housing Scheme, and stating that, as he had supplied all the documents required by the Board from him for the completion of the Scheme, Mr Mc Carroll the Board's solicitor would be able to give any further information necessary.

Mr Mc Carroll, present, stated that the petition of the Scheme had been filed with the L.G.B. and the next step is the issuing by the L.G.B. of a Provisional Order, copies of which will be served on the owners and

occupiers concerned. After that it would be necessary for the Council to apply for the Loan on the Scheme.

A discussion arose on the price offered by the Board for land to be purchased in the carrying out of the scheme, and both the matter of price, and Mr Moore's letter were referred to the Housing Committee.

A letter of acknowledgement of note of sympathy received from Mr P. Karangl was also read.

Mr J H Mc Carroll wrote re Housing Scheme, as personally explained above, and also drew the Council's attention to the necessity and advisability of getting the services of an expert familiar with the details of striking a rate for the purpose of starting the new set of Books necessary under the Public Bodies Order, and for the estimating and striking of a rate up to March 31st 1911.

Proposed by Mr Conder, seconded by Mr Keaton and passed unanimously "That Mr J. J. Doyle be asked to name a fee for starting the Atlow H.D.C. business on a proper basis, making an estimate of the rates, and start the hearing for the different books required by the Council, and other business that requires to be done".

One trader only being received for Sime and his same were ordered to be re-advertised.

A report was read from the Assist S. S. O. and the consideration of same, and also the consideration of the retention of the Assist S. S. O's services was left over for the consideration of the adjourned monthly meeting.

On the motion of Mr Waldron seconded by Mr T. Lynell Mr J. N. Barrett was given three months leave of absence applied for, and that Mr Kavanagh be appointed to act in his place for 3 months at £5 per month.

Mr J. Byrne who acted as substitute for Mr Barrett from Jan 15th to Jan 28th inclusive wrote drawing the Council's attention to the fact, and the Acting Clerk was instructed to refer him to Mr Barrett.

Messrs T. Lynell & P. Leacy suggest that the Council make an order to change the hour of holding the fowl market, and the consideration of the matter was left over until the adoption of a set of Bye-laws.

A communication from G. F. Fleming requesting that the Council deal with his Bill of costs was referred to, Mr J. Mc Carroll, who was at the same time instructed to procure all necessary papers, and correspondence in connection with the matter.

It was agreed further that Keaveny get £9 and Sarah Redmond £8 and the Clerk was directed to get in each case a receipt acknowledging full settlement. A sum of £4 was ordered to be paid to the children of Owen Kavanagh and £4 to Stafford in both cases as compensation for clothing and bedding destroyed.

The following report was read from Dr Hamilton M.O.H.:-

The town and district of Athlone is at present free from all forms of infectious disease. Owing to our intercourse with Dublin where a good deal of contagious sickness is now raging, I think it would be wise, that the temporarily increased scavenging staff be kept on at work for at least another month. The Council might also consider the question of undertaking domestic scavenging in accordance with Section 52 of the Public Health Act. particularly in the poorer parts of the Town."

A communication was received from Mr McCarroll Solicitor enclosing copy of extract from the minutes of the evidence taken at the Sworn Inquiry on the Urbanisation of the Township.

The Pay Roll for the ensuing month was sanctioned and signed.

"Owing to ill health and advancing years I find it increasingly difficult to perform my duties as town collector. For this reason I have been thinking of giving up my appointment and would be prepared to resign if the Urban Council would kindly consider the question of allowing me the usual compensation or retiring allowance based on my period of service and average emoluments for the past three years. If the Council would graciously deal with this question

and measure the amount of the proposed compensation or superannuation on the above basis at the meeting on the 27th inst or 3rd next, I could hand in my formal resignation. This course would I believe save time and inconvenience in the appointment of my successor. I am 32^{1/2} years now Rate collector being the first and only rate collector under the Atklow Town Commissioners. My percentage as rate collector on the amount of my warrant amounted to on an average of £20¹⁰ per annum for the past three years. I am nearly 75 yrs of age and I would feel greatly obliged if your Council would generously consider this application for compensation or retiring allowance taking into consideration my service age and ill health.

Mr Byrne Poor Rate Collector was not in attendance, and as no communication was received from him it was agreed to defer the consideration of Mr Evans' letter until Mr Byrne should be present also. It was proposed by Mr. G. Pearson, seconded by Mr. F. Henderson, and carried unanimously that "A poundage of sixpence in the pound be fixed as the poundage for the collection of all Rates".

The following communication was read from the Local Government Board

"With reference to your letter of the 27th ult. I am directed by the Local Govt. Board for Ireland to state, for the information of the Arklow Urban District Council that they have sanctioned the proposal of the Council to appoint a Sanitary Sub. Officer in the Urban District at a salary of £40 a year, and the Clerk of the Council as Executive Sanitary Officer.

Having regard to the salary offered for the post of Sanitary Sub. Officer and in view of the sanitary circumstances of the District the Board consider it highly desirable that the Council should endeavour to secure the services of a person holding a certificate from a recognised Sanitary or Public Health

Institute

I am to enclose a copy of Sanitary Order No 2, and to draw the Council's attention to Article 4 as to mode of procedure in regard to such appointments.

Mr J. T. Evans submitted his list of irrecoverable Rates and received instructions from the Council to prosecute for recovery fourteen persons, all others on his list being struck off and being deemed to be irrecoverable. Mr Evans was further instructed to notify the Council's solicitor when he intended taking the cases to court in order that he might have the advantage of the Solicitor appearing on his behalf.

Special Meeting Tuesday April 18th 1911

A special meeting of the Arklow Urban Council was held at their office courthouse Arklow on the above date to consider the Solicitor's additional report on the compensation of Rate Collectors, and if necessary to make arrangements for the appointment of the new Rate Collectors.

The following communication was read from Mr Mc Carroll. Solicitor.

Referring to your letter of the 11th inst we beg to say that upon the 12th inst we forwarded case to Mr Moloney R.C. for his opinion with reference to a couple of very difficult questions connected with the compensation of the collectors and also with reference to the status of the sub-sanitary officers. Upon yesterday the 18th inst we received a reply from Mr Moloney that he would have the case written

on by the end of this week. We enclose you copy of his reply and would suggest getting the meeting of the Council adjourned for a week."

The following letter was enclosed by Mr Mc Carroll 17/4/11 (Re Arklow U.D.C)

Dear Mr Mc Carroll.

I thought I would be able to send you this case to night but I find it raises some questions of great importance which cannot be hurriedly disposed of. I can however, promise you to send the case written or by the end of this week. You might in the meantime send me a complete copy of the Provisional Order and also of the letters from the L.G.B. in regard to super-annuation which your clerk showed me last week.

The position of Sanitary sub officer is the most difficult to determine and so far has never been discussed.

The Chairman asked the Clerk to explain on whose authority Mr Mc Carroll had consulted Counsel's opinion, and why he had referred to the Sanitary Sub Officer.

The Clerk in reply to the Chairman stated that he had not

authorised Mr Mc Carroll to consult Counsel's opinion and that he had not referred to the Sanitary Sub Officer beyond enclosing a communication from the Local Government Board, for Mr Mc Carroll's consideration, as he was directed to do by the Council.

The Clerk then read his letter to Mr Mc Carroll dated April 11th 1911 as follows -

I received your communication re compensation of Rate Collectors per 5:25 train last evening and duly submitted same to this Council. After due consideration they decided (the town rate collector being meanwhile present) that the information given was insufficient to cover the case and they have therefore deferred final consideration of the matter to Tuesday night next.

I am therefore instructed to write to you to ask you the amount of such compensation.

The average emoluments and years of service as stated in Mr Evans communication which I sent you, are correct. The correct amount of Mr James Byrnes emoluments for the Arklow Urban District can be ascertained directly by you from the Secretary of the County Council. If you cannot let me have the information on or before Tuesday the 18th inst

Kindly wire me to-morrow Wednesday so that I may postpone the meeting until I receive this information.

I am enclosing as directed by the Council a communication from the Local Government Board which they request you shall consider with a view to taking action."

The Clerk stated that his letter to Mr McCarroll carried out the exact instructions given by the Board.

The Chairman stated that he did not remember the Council authorising the Clerk to send any such enclosure to Mr McCarroll, and that he would like an explanation of Mr Moloney's reference to "a letter from the Local Government Board with regard to superannuation, which your clerk showed me last week."

In explanation the Acting Clerk pointed out that that communication was from Mr Moloney to Mr McCarroll, and that the Clerk referred to was Mr McCarroll's clerk inasmuch as he the Acting Town Clerk had never to his knowledge met or spoken to Mr Moloney in his life.

Mr D'Conrau stated that it would make matters clear, when he informed them that there had been a discussion at a recent meeting of the Rathdrum Rural District

Council about the Sanitary Sub-officer, and that Mr McCarroll may have been instructed by that Board to get counsel's opinion on the matter and that it was apparently that question which was referred to in the respective letters of Mr McCarroll and Mr Moloney.

The Board considered Mr D'Conrau's explanation to have left the matter clear.

M'Conrau also stated that as Solicitors must of necessity obtain counsel's opinion from time to time, he had probably found it necessary to do so on his occasion for his own information.

Messrs Frank Lyndall & P. Henderson having expressed the opinion that the Solicitor ought to have personally been present, it was unanimously agreed on the suggestion of Lord Wicklow to direct the Clerk to inform Mr McCarroll that the Council regretted that he found it necessary to consult counsel on his occasion, and that in future he should receive authority from the Board before consulting counsel on the business of the Board.

It was proposed by Mr McBreddin, seconded by Mr M. O'Brien that the Acting Town Clerk be appointed Returning Officer for the forthcoming election of Poor Law Guardians. This resolution
