SPECIAL MEETING HELD ON FRIDAY, 25th MAY, 1945.

A Special Meeting of the Council was held on above date at 6.30 p.m. for the purpose of considering a letter from Dept. of Local Government and Public Health re Estimates 1945/6, enquiring as to the arrangements which were being made to cover the expenses of the Local Elections.

The Clerk informed the Meeting that he had been asked by the Manager to point out that, in accordance with the requirements of the County Management Act, it would be necessary to obtain the Council's consent by Resolution to expenditure on the Local Election, provision for which had been disallowed by the Urban Council at their Annual Estimates Meeting.

Read Department's letter G.7596/45 - 10th May, 1945, in regard to the matter.

It was proposed by Councillor McElheron, seconded by Councillor Weadick, and passed unanimously:-

RESOLVED - "That, in accordance with the requirements of Section 25 (1) of the County Management Act, 1940, we hereby consent to the expenditure by the County Manager of an amount not exceeding £100 in connection with the holding of the Local Election 14th June, 1945, the said expenditure to be provided for in the Estimate of Expenses 1946/7."

Read copy letter 1st May, 1945, sent County Registrar informing him of staff which operated successfully under Town Clerk as Returning Officer at last Local Election.

Read letter 14th May, 1945, from local Branch, I.N.T.O., enquiring if Council would be prepared to receive a Deputation at their next Meeting.

It was unanimously decided to receive Deputation, Clerk to ascertain matter to be discussed for inclusion on the Agenda.

Read letter 18th May, 1945, from I.T.A. stating tourist literature had been forwarded Mrs. Brennan at the "Cigar Box" and that it was regretted the suggestion re Arklow Folder could not be implemented as the publication was at present in the hands of the printers.

Order - Clerk to express Council's disappointment that "Proof" will not be submitted for their approval, as the publication would not have been made possible were it not for the assistance given Mr. D'Arcy, I.T.A., by Council's Tourist Committee, in securing advertisements.

The Monthly Meeting of the Council's Tourist Development Committee was held on the above date at 8 p.m.

Mr. T. E. Earl wrote regretting inability to be present.

Afising out of Minutes Meeting 2nd May, 1945, re request to County Manager to take over control and maintenance of public right-of-way connecting 'Bus Stop with St. Mary's Road, the Secretary informed the Meeting that the County Manager was not at present disposed, having regard to the fact that no money was available for repair or maintenance, to consider the matter. He had, however, directed that inquiry be made as to the ownership of the right-of-way so that a notice for abatement of nuisance might be served.

The County Manager was recommended to take measures to have old tree stumps and posts removed from Seaview Avenue, and also iron guards removed from trees on Ferrybank.

At the request of the Meeting, County Manager's Order No. 1563 was read re G.A.A.'s. application for site as playing pitch at Ferrybank - Manager prepared to consider granting of application on Club undertaking to have site properly fenced and rendered suitable as a playing pitch within a period of two years - rent to be £10 per annum.

Mr. Hickey informed the Meeting that he had interviewed the Manager on behalf of the G.A.A. Club in the matter, and a Deputation from the Club proposed to wait on Co. Manager on 8th prox.

The Town Surveyor was asked to report to the Urban Council on the danger of gully traps to pedestrian traffic in Main Street, the traps being below the level of the roadway.

Read letters 7th and 18th May, 1945, from I.T.A. in regard to new Arklow Tourist Folder at present in course of preparation.

Read letter 12th May, 1945, from I.T.B. in regard to the Committee's complaint re increases in hotel tafiffs, setting forth the attitude of the Board in the matter.

Order - Copy of letter to be supplied to Councillor McElheron for the information of persons who referred the matter to him.

Read letter 14th May, 1945, from E.S.B. re public lighting at new housing scheme, stating that the Board had now the necessary material for the network extension, but had not got lamp fittings, and they suggested transferring existing lamp fittings from other points in the town.

Recommendation - Committee does not approve of suggestion - E.S.B. to be again written in the matter.

Read letter 8th May, 1945, from Independent Newspapers, Ltd., giving, as requested by the Committee, details of their Garden Competition, and setting forth the features of merit upon which each competitor was judged, viz. cultivation, variety, colour harmony, neatness, general effectiveness.

It was unanimously decided that the Competition this season be confined to Urban Council houses, there to be three prizes, viz. First - £2, Second - £1, and Third - 10/-. Mrs. Brennan and Messrs. McElheron and Callanan offered to contribute to the prize fund. No entry fee for competition to be charged.

The Monthly Meeting of the Council was held in the Boardroom, Courthouse, Arklow, on the above date at 7 p.m.

Minutes of Meetings 7th and 25th May, 1945, and Report of Tourist Committee 30th May, 1945, were unanimously adopted.

It was unanimously decided to approve of the County Manager overdrawing during the month of June on the Council's Revenue Account for the purpose of meeting current expenses to an amount not exceeding £2800.

Read letter 14th May, 1945, from Electricity Supply Board re public lighting at new housing scheme, stating that the Board had now the necessary material for the network extension but had not got lamp fittings, and they suggested transferring existing lamp fittings from other points in the town out to the housing scheme.

Order - E.S.B.'s. suggestion unacceptable; Clerk to make further representations in the matter and to explain Council's point of view re suggested interference with existing lighting system for the purpose of meeting present difficulty.

Read Circular 22nd May, 1945, from E.S.B. notifying increase of 30% in cost of public lighting as from month of June, 1945.

It was proposed by Councillor Birthistle, seconded by Councillor Weadick, and passed unanimously:- RESOLVED:

"That we record our protest at the decision of the E.S.B. increasing the present high rate of charge for current used in public lighting."

Following discussion of suggested alteration in public lighting system in the town, the Town Clerk informed the Meeting that the County Manager had before him the recommendation to have lamp at Beresford Terrace transferred to pole convenient to public fountain, and had expressed his reluctance to have the lamp moved in view of its having been located at its present point for over 15 years. There was no money available for a new lamp.

It was proposed by Cllr. McDonagh, seconded by Cllr. McCarthy, and passed unanimously:- RESOLVED - "That this Council considers it its duty to bring to the notice of the Minister for Supplies the fact that potatoes are at present being retailed in Arklow at 3/- per stone, while the controlled price in Dublin is 2/4d. per stone."

It was proposed by Councillor McDonagh, seconded by Councillor Weadick, and passed unanimously:- RESOLVED - "That this Council congratulates An Táiniseach, Mr. DeValera, on the very able manner in which he dealt with Mr. Churchill's speech attacking Irish neutrality."

A Deputation from the local Branch, I.N.T.O., consisting of Messrs. G. English, F. O'Kennedy, J. Byrne, and M. O'Connor, came before the Meeting in connection with their Organisation's agitation for a living wage.

It was proposed by Cllr. McCarthy, seconded by Cllr. Birthistle, and passed unanimously:- RESOLVED - "That the Council supports the claims of the Irish National Teachers to a living wage."

The following decisions were made on Home Assistance Case Papers submitted:- Letitia Loughlin - 3/- per week; Mary Colvin - 8/- plus 3/- voucher; Lizzie White - 6/- plus 1/- voucher; Marcella Wolahan - 15/- and 3/- voucher; Sarah Stuart - 4/-. Re case of Timmins family, 79 Rory O'Connor Place (Case Paper not submitted) it was recommended that they be given an allowance of 7/6d. per week temporarily.

The Town Clerk reported that the foregoing newly-elected Councillors had each signed their Declaration accepting Office.

The Town Clerk submitted Declaration of Result of Poll at Election held 14th June, 1945.

Read Section 43 (1) of Local Government Act, 1941, re procedure at election of Chairman.

It was proposed by J. W. Sheehan, and seconded by Councillor J. Fitzgerald, "That Councillor W. Cleary be elected Chairman of the Council for the ensuing year."

It was proposed by Cllr. McCarthy, and seconded by Cllr. McElheron: "That Councillor T. J. Birthistle be elected Chairman of the Council for the ensuing year."

Councillor Birthistle, with the permission of his Proposer and Seconder, withdrew his name as a candidate for the Chair, and, there being only one candidate remaining, Councillor Cleary was declared elected.

It was proposed by Cllr. Fitzgerald, and seconded by Cllr. Sheehan: "That Councillor James Tyrrell be elected Vice-Chairman of the Council for the ensuing year."

It was proposed by Cllr. McElheron, and seconded by Cllr. McCarthy: "That Councillor T. J. Birthistle be elected Vice-Chairman of the Council for the ensuing year."

A Poll was then taken, resulting as follows:-

It was unanimously decided that the entire Council constitute the Committee to advise the County Manager on matters relating to Home Assistance in the Urban District.

It was unanimously decided that the Town Clerk telegraph the Minister for Defence and the Minister for Industry and Commerce deplored the decision of the Government to disband the Marine and Coast-Watching Service, the following Resolution unanimously adopted, on the proposition of Cllr. McElheron, seconded by Cllr. Cleary, to be communicated subsequently:-

RESOLVED: "That we, the Arklow Urban District Council, deplore the decision of the Government to disband the Marine and Coast Watching Service, which Service is, from our local knowledge and experience, essential to the safety of our shipping in Peace time as well as in time of War, and we, the representatives of one of the principal Sea-faring towns in the country, respectfully ask the Government to re-consider their decision in this matter."

Read letter 22nd June, 1945, from the Minister for Local Government and Public Health addressed to the Chairman in regard to some of the most important problems to be dealt with during the present Councillors' term of office.

It was proposed by Cllr. O'Cleirigh, seconded by Cllr. McCarthy, and passed unanimously:-

Resolved:- "That we hereby authorise the County Manager to Overdraw, subject to the Minister's sanction, on our Revenue Account during the month of July to an amount not exceeding £3,000, for the purpose of meeting current expenditure, pending collection of Rates."

Read letter 12th June, 1945, from Secretary, Irish Tourist Board, in regard to proposed leasing of 4½ acres of land at Council's North Beach property to local G.A.A. Club for use as a playing pitch, stating that they were not lodging a formal objection, but submitted certain comments for the consideration of the County Manager before he gave his decision in the matter.

Read County Manager's Order 1599 - 22nd June, 1945, in which he directed that the Town Planning Consultant be asked to favour him with his observations on the I.T.B.'s letter.

Read Manager's Order 1563 - 18th May, 1945, re G.A.A. Club's application, and recommendation of Town Planning Consultant that lease be granted, in which he directed that the Club be informed that he was prepared to consider granting the application on their undertaking to have the site properly fenced and rendered suitable as a playing pitch within a period of two years, the rent to be £10 per annum.

It was proposed by Cllr. Birthistle, seconded by Cllr. O'Neill, and passed unanimously:-

Resolved - "That in view of the urgent necessity for a local football pitch, and the fact that the I.T.B. in their letter had advanced no sound reason as to why the site should not be given to the G.A.A. Club for that purpose, we hereby recommend the County Manager to grant the lease in conformity with the terms and conditions set forth in the Town Planning Consultant's Report dated 19th April, 1945."

It was proposed by Cllr. Sheehan, seconded by Cllr. McCarthy, and passed unanimously:-

RESOLVED - "That in view of the dangerous condition of roadway over Navvy Bridge, we hereby authorise the County Manager to exceed by £300 the estimate for Road Repairs, 1945/6, to enable the necessary repairs to be carried out thereto."

Prior to the putting of the Resolution, the Clerk informed the Meeting that the Council, at their Annual Estimates Meeting, disallowed provision made by the County Manager, for the expenditure of £280 on the work referred to.

It was proposed by Cllr. O' Cleirigh, seconded by Cllr. McCarthy, and passed unanimously:-

RESOLVED - "The County Manager, having sought our considered opinion in regard to the advisability or otherwise of his undertaking costly legal procedure towards vesting the property in the right-of-way known as "The Ditch" in the Urban Council, we hereby recommend to him the urgent necessity of discontinuing the right-of-way over "The Ditch" in order to allow of cottage gardens being extended, and, as the acquisition of the property is a necessary preliminary, we consider the expenditure referred to both necessary and desirable."

It was proposed by Cllr. O' Cleirigh, seconded by Sheehan, and passed unanimously:- RESOLVED - "That the C.I.E. Company be informed of the inadequate travel facilities to and from Arklow, and, as a solution, it be suggested that the Company consider having the Wicklow-Dublin service extended to Arklow."

It was proposed by Cllr. Sheehan, seconded by Cllr. Tyrrell, and passed unanimously:- RESOLVED - "That correspondence started some time back between Dept. Posts and Telegraphs and the U.D.C. in regard to inadequate telephonic facilities and Post Office accommodation, be again taken up."

It was proposed by Cllr. McElheron, seconded by Cllr. Tyrrell, and passed unanimously:-

RESOLVED - "That copies of the Resolution re Marine and Coast Watching Service adopted at Meeting 25th June, 1945, be circulated to the local authority of all sea-port towns in Eire, with a view to securing their co-operation in the move to prevent the disbandment of the Marine and Coast-Watching Service." The Co. Manager was requested to provide a public lamp convenient to Kilbride Church, Ferrybank, and to expedite Dept's. sanction to increase in Carters' wages.

Read letter 17th July, 1945, from Coras Iompair Eireann regretting that it was not possible for the Company to extend the Dublin-Wicklow Bus Service to Arklow, as suggested by the Committee.

It was unanimously decided that the Secretary ask the Company to accede to the Committee's request as soon as position improves in regard to the supply of fuel, spare parts, tyres, etc. Also to ask that suitable shelter be provided for bus passengers at Dublin end.

The Secretary informed the Committee regarding difficulty in inaugurating Garden Competition, in view of lateness of Season, and asked that date for entry to next year's competition be now fixed.

It was unanimously decided that Entry Forms be made available to prospective competitors as from 1st March, 1946.

Read letter 20th July, 1945, from Irish Tourist Board, acknowledging receipt of Council's Resolutions passed at their July Monthly Meeting, and stating that, having considered the contents of the published Report of the Council's discussion on the Board's letter of 12th June, 1945, they were reluctantly forced to the conclusion that no useful purpose would be served by arranging for a representative to attend a Meeting of the Council, and adding that it was regretted members of the Council did not appear to appreciate the Board's difficulty in placing before a meeting proposals for a development scheme before such proposals had been submitted to and approved by the Government . . . . .

It was unanimously decided to refer the matter to the Urban Council.

Councillor McElheron complained re offal from slaughterhouses lying in river and causing a nuisance at low tide.

It was unanimously decided that Mr. J. Fogarty be requested to prevent dumping of his land adjoining South Quay.

On the proposition of Councillor McElheron, seconded by Mr. Callanan, and passed unanimously, it was resolved:-  
"That the County Manager be requested to proceed with the erection of an Abattoir."

It was unanimously decided to recommend the County Manager to take measures to have the Public Conveniences at Main Street cleaned more carefully during the Tourist Season.

The August Monthly Meeting of the Council was held on above date at 7.30 p.m.

Councillor Birthistle objected to the signing of the Minutes of July Monthly Meeting, on the grounds that, while he did not dispute their accuracy, the adoption of a Resolution authorising the County Manager to exceed the Annual Estimate 1945/6 by £300 for the purpose of repairing Navvy Bridge was irregular, on account of its not having appeared on the Agenda of that meeting, and he (Councillor Birthistle) had left the meeting, with the permission of the presiding Chairman, prior to the putting of the Resolution.

Following explanation from the Town Clerk on the point raised in regard to the signing of the Minutes, the Chairman ruled, and it was unanimously agreed that the Minutes were in order for adoption without amendment. The Minutes of the July Monthly Meeting were accordingly signed.

Councillor McCarthy handed in the following Notice of Motion, which was directed to be inserted in the Minutes:-

"That I or someone for me will move at next Meeting of the Urban Council that the Resolution appearing in the Minutes of July, 1945, Monthly Meeting, authorising the County Manager to exceed the Annual Estimate 1945/6 by £300 for the purpose of repairing Navvy Bridge, be rescinded, and that we, the Arklow Urban District Council, decide to raise a loan from our Treasurer, the Munster and Leinster Bank, Ltd., Arklow, for this amount, repayable over a period of three years, for the purpose of meeting the expenditure referred to."

On the request of Cllr. McCarthy, it was unanimously agreed that it be recorded in the Minutes that the Council are concerned in regard to the present dangerous condition of the Navvy Bridge.

The Town Clerk also asked permission to have it recorded that the County Manager had made provision in the Annual Estimates 1945/6 for the carrying out of repair work on the bridge, but that the item had been disallowed by the Urban Council, and in consequence no money was available to the County Manager for the purpose.

It was proposed by Councillor Birthistle, seconded by Councillor McElheron, and passed unanimously:-

RESOLVED - "That we record our profound regret at the retirement of the County Manager, Mr. P. T. Healy, who has during his term of office as Manager of the Urban Council, rendered valuable service to the Town and District, and we wish him from this Meeting happiness and continued health in his well-earned retirement."

The Town Clerk, on behalf of the officials and employees of the Council, begged to be associated with the Council's expression of regret at the Manager's retirement, and expressed both his and the officials' indebtedness to Mr. Healy for the guidance and able assistance given by him in conducting the business of the Council.

Read extract from Minutes of Meeting 1st October, 1945, setting out particulars of reply letter to be sent I.T.B. re their communication 24th September, 1945, in connection with North Beach property.

Read letter 5th October, 1945, from Secretary, Irish Tourist Board, noting with pleasure arrangements made for attendance of Town Planning Consultant at a Special Meeting to discuss planning of North Beach area, and expressing surprise at Council's request for an estimate of the rateable value of buildings proposed to be erected in the area before a decision was reached on the question of providing public health services there.

Following discussion by the members in regard to the purposes for which the property had been purchased, it was unanimously agreed that one of these purposes had been to make available portion of it convenient to the riverside for industrial purposes, there being little space for further industrial expansion on South side of river.

Mr. R. Hogan, A.M.T.P.I., (representing Council's Town Planning Consultant, Mr. N. O'Dwyer) gave particulars to the Meeting of his contemplated development of the area, with which the erection of industrial plants there would conflict. He agreed that the town was mainly industrial, having in addition a substantial tourist trade, and, in planning the area, he would have to have regard to these features, while at the same time having in mind the advantage in industrial development, since the tourist industry was only seasonal. U.D.C.'s North Beach property was relatively more valuable to tourist trade, and industries should be grouped in a separate area. From the correspondence with I.T.B. it would appear they were to select the choice portions of North Beach property, leaving the remaining portions to U.D.C. This had also been Messrs. McNicholls' intention. The property for tourist development needed public conveniences, shelters, sewerage and water, but the layout of these services, contrary to the opinions of the I.T.B., were contingent on the Board's proposals. He disapproved entirely of the U.D.C.'s. proposal to lease derelict buildings of the property for reconstruction as a factory.

Following further discussion on the desirability, having regard to the services afforded by the adjoining river, of industrial development on the North Beach property, it was unanimously agreed that provision be made in the sketch development

plan for an industrial zone 100 yards in depth on property parallel with North Quay. To this Mr. Hogan agreed.

It was unanimously decided that Messrs. McNicholl be informed that their application could not be entertained on Town Planning grounds, but that a site would be available in the industrial zone at North Quay.

The County Manager summarised as follows the unanimity reached by the Council in their discussion of matters arising out of Tourist Board's letter 5th Oct. 1945:-

1. Council are aware of their powers, functions, and duties as sanitary authority as regards provision of public health facilities in district, and North Beach area would receive consideration with due regard to the needs of other portions of the Urban District, and the relative urgency of various pending works:

2. The extent of such facilities to be provided to meet the needs of visitors to the Nort. Beach would bear no relation to the degree of sanitary accommodation which would be necessary in the event of the I.T.B. being granted an interest in the property for the purpose of erecting large-scale buildings thereon. If such a proposal were to be agreed to by the Council and put into effect by the I.T.B. the extent of the water supply and of the sewage disposal plant and outfall works would have to be planned accordingly:

3. In view of the fact that the I.T.B. were not prepared to take the Council into their confidence as to their intentions, the Council would be unable to give any undertaking as to the facilities, if any, which would be provided by them in the undefined circumstances referred to:

4. The Council are not prepared to accept the conclusion implied in the second page of the I.T.B.'s. letter that a local Council should not have prior knowledge of the operations which the I.T.B. would undertake, particularly in the case of Arklow, where the land in question was the corporate property of the Urban District, and in respect of which the Council was the statutory Planning Authority.

The Clerk was directed to forward a copy to Department of L.G. and P.H. of reply to I.T.B's letter, and to point out the considerations which weighed with Town Planning Consultant in ruling out Messrs. McNicholls' proposal, and also permitting industrial zone abutting North Quay; also to suggest to that Department to consult with Dept. of Industry and Commerce in location of industries in Arklow.

Read letter 6/1/46 from Mrs. E. Pearson, 19 Back Street, complaining of flooding at front of her house.

The Town Surveyor stated that the laying of the proposed new sewer at Abbey Street may improve conditions in this case.

Read letter 7/1/46 from Miss J. Furlong stating that part of a boundary wall at St. Columba's Terrace had been broken down, with the result that her property adjoining was open to trespass.

Councillor McCarthy stated that boundary wall at end of Parnell Terrace was in danger of collapse.

Both the above matters were referred to the Town Surveyor for attention.

The Chairman referred to Demolition Orders made in respect of Mr. R. Kearon's houses 23-26 Back Street, and enquired if the County Manager could allow the houses to be left standing for renovation and use as Stores.

Read letters 21st May, 1946, and 3rd June, 1946, from Secretary, "Transport Socials", Dublin, setting out particulars of Arklow Publicity Scheme which it was intended to implement if the Tourist Committee were interested and would co-operate. The Scheme provided for Transport Socials holding in Dublin "Arklow Holiday Dances", awarding Spot Prizes, viz. Free Holidays in Arklow (cost to be borne by local businessmen), Free Rail Tickets, Souvenir Programmes, etc.

The communications were marked "Read."

Following a discussion on a proposition by Cllr. McElheron to inaugurate a "Window Display" Competition, it was decided that a decision be deferred to next Meeting to enable the idea and its practicability to be set out by him in Scheme form.

It was unanimously decided to write to the Hon. Secretary of the Irish Vocational Education Association re possibility of that Association holding their Annual Conference at Arklow in 1947 or 1948. Messrs. McCrea, G. Flood, and H.J. Painting, Wicklow Representatives of the Association, to be asked for their assistance in the matter. Other such Organisations to be similarly approached.

The following Scheme for a Photographic Competition, as suggested by Mr. L. Sweeney, was adopted:-

Competition to be divided into photographs dealing with (1) Sporting; (2) Scenic and General. Prizes in each category to be - 1st £1; 2nd 10/-; and 3rd - two consolation prizes of 5/- each. Judging to be by the President of the Photographic Society of Ireland.

Mr. Callanan promised to get in touch with the Camera Film Companies to secure their financial assistance and co-operation. Terms of competition to be that winners surrender rights in negative. Entry forms to be available at Hotels, Chemists' Shops, and Cigar Box.

The following Schools Essay Competition Scheme was approved:-

1. Subject of Essay to be "How I Would Beautify my Town" (In Irish or English language);
2. Adjudicators of Competition to be Mr. D.L. Kelleher, I.T.A.; Mr. M. O'h-Ioseadhá, and Mr. F. McNamara. Mr. Kelleher to decide after receipt of reports on Essays from the other two Adjudicators.
3. Closing date to be 30th June, 1946.
4. Prizes to be awarded as follows:-

First, 2nd and 3rd Prizes of 10/-, 5/-, and 2/6d. respectively, for best Essays in Irish: 1st, 2nd and 3rd prizes of 10/-, 5/-, and 2/6d. respectively for best Essays in English.

Prizes to be presented by Chairman of Urban Council and cost to be borne by Tourist Fund at Munster and Leinster Bank.

5. Competition to be open to all pupils under the age of 14 years of the following Schools:- (a) Boys' National School, Coolgreaney Road; (b) Girls' do. do. (Convent); (c) Carysfort National School; (d) Ferrybank National School; (e) Templerainey N.S.

It was unanimously decided that the Sergeant of Garda be written to drawing attention to unauthorised burning by unknown persons of gorse bushes at North Beach property.

The Secretary drew attention to the fact that the Competitions suggested were outside the scope of the intended functions of the Committee, and suggested it might be better if a separate Organisation were formed to sponsor same. - The Committee unanimously agreed that as the Funds of the Urban Cl. would not in any way be affected, the matter was in order.

We accordingly ask that the Grant be restored to the Urban Council, so as to enable the Council to carry out the very urgent and necessary work of reconstructing Arklow Dock Road, and at the same time relieve the unemployed in the District."

Resolutions from Urban Councils for Adoption:

It was proposed by Councillor Wm. Cleary, Chairman, seconded by Councillor Wm. O'Neill and passed unanimously all members standing.

RESOLVED:- "That we, the members of the Arklow Urban Council, desire to extend our very sincere sympathy to our colleague, Councillor P. McCarthy, and the members of his family, in their recent sad bereavement"

TOWN PLANNING:- The County Manager summarised the various points referred to in the Consultant's Report, copies of which had already been circulated to the members.

The Chairman suggested that items contained in the Report be considered in the following order:-

- (1) Roads,
- (2) Zoning for Housing purposes,
- (3) Industrial reservations,
- (4) Open spaces,
- (5) Car parks.

The Council, following examination of the Sketch Development Plan, approved of the following recommendations affecting roads:-

(a) New Road to be constructed from South Quay across "Green" to Togher, and a new road through Chapel Ground to Back Street.

(b) New Road from Froby's Row along high ground to Golf Pavilion.

(c) New Road South of Pottery to South Beach.

(d) New Roads on site of proposed housing scheme at Sheephouse connecting Wexford Road to Coolgreeney Road.

(e) Widening of Bridge by the addition of a footpath at Eastern side.

(f) Outlet for 124 houses at Collins Street via Hall's Lane to Back Street.

The Council adjourned to the next meeting consideration of the question of constructing new roads connecting 124 House Scheme at Collins Street with Back Street, Lr. Main Street and Bridge St.

The Council were of opinion that the new road to connect Abbey Street with Harbour would be better sited by running direct from East end of Abbey Street to the junctions of Tinahask St., Tinahask Lr., and Harbour Road.

In connection with the proposal for the widening of Wexford Road the Council consider that this road is sufficiently wide in its present state to provide easy access for traffic to the Town.

Of the four alternative routes suggested in the Report for a new Main Road the Council consider the proposal to construct a new road from the Wicklow Road through the Marsh to join the V-Le Road at a point opposite St. Saviour's Church, to be the most satisfactory.

Further consideration of the Report was adjourned to the monthly meeting to be held on the 14th March, 1947.
