

COUNCIL MINUTE BOOK



Council Meeting.

The Statutory Meeting of the Bray Urban District Council was held in the Town Hall Bray, on Tuesday 1/3/1938.

Present Councillors G. Byrne (in chair) E. Byrne, Dunne, Heatley, Kinsella, Hipwell, Frame, Cooney, puffy and Martin.

Minutes of Meeting of Council on 1/2/1938. Read and signed. Votes of condolence with the relatives of the late Mr. J. Fisher. Mr. Denis Ledwidge, Mrs. Mary Moore and Mrs. Gormley.

Passed in silence the Council standing. 1686 Councillor Hipwell proposed, and Councillor Cooney seconded the adoption of the report of the General Purposes Committee on Passed unanimously.

1687 Councillor Duffy proposed and Councillor Dunne seconded the adoption of the report of the Public Health Committee of the Passed unanimously.

Councillor G. Byrne proposed, and Councillor E. Byrne seconded the adoption of the report of the Harbour and Esplanade Committee of the 15-2-1938. Passed unanimously.

Councillor G. Byrne proposed and Councillor Dunne seconded the adoption of the report of the Finance Committee of the 22-2-1938, and a special meeting of the Finance Committee on 18-2-1938. Treasurer's Advice Note and Financial Statement signed and led.

Passed unanimously, 1690 On the question of lettings on Esplanade and Bray Head for the coming season, reports from Surveyor of works necessary to be done on Esplanade and Bray Head, letter from Very Rev. Canon Bowden applying for use for fete on the Esplanade, and letter from Irish Amusements Ltd. applying for site for pavilion.

The Chairman refused to allow any discussion on this matter until the case of the Council V Dawson was finally settled. 1691 Letter from Minister for Local Government dated 19-2-1938 re application of the Council towards grant for cost of works for damages at sea wall, stating that it would not appear necessary for a deputation to discuss this matter. Read. Letter from Mr. Seamus Moore promising his help and letter from Mr. James Everett enclosing copy of letter from the Parliamentry Secretary, Ministery for Finance re coast erosion and suggesting that if the parties whose interest is effected would:-

(a) Bear a reasonable proportion of the cost.

(b) Maintain the works completed

Maintain the works completed. (c) Submit a scheme on that basis.

The proposal will be examined with any others that might be received. Read. It was decided to reiterate the request to the Minister for Finance pointing out the dangerous aspect of the present state of the Sea Wall and the inability of the rates to meet these recurring annual expenses with the prospect of a further and greater calamity.

Surveyor to supply all the necessary data and these to be supplied to the Minister for Finance.

1692 Letter from Minister re storm overflow and re laying of Strand sewer asking for report from the Surveyor in connection with with the improvement, and asking the extent of the area to be served and the intensity of the rain fall in this area.

Copy of report of Surveyor dated 17-2-1938 giving particulars asked for, and stating that it would be impossible to carry out the work during the Winter months and the earliest time it could be done would be the end of April of the beginning of May. Read, and noted. Copy of Surveyor's report to be sent to

the Minister.

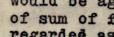
