Councillor H. J. Byrne apologised for the absence of Clr. McKeown and Councillor Sayers owing to illness.

Officials present:- County Manager, Town Surveyor and Town Clerk and Accountant.

90 Submitted Report of the Co. Manager upon the Estimate of Expenses for the financial year ending 31st March, 1949.

In a general review of the Estimates the Chairman stated that the burden of Rates had become well nigh intolerable and pointed out that when the Rates were less than 10/- in the £ it was felt that they were then excessive. However the position he said must be faced that Rates have been increasing steadily for many years and the Council must accept the increase as one of inevitability in view of the additional social services, amenities, etc. provided.

Councillor J. Temple explained that the Estimates as submitted made provision for an increase to Council's employees of 7/6d per week. The employees refused to entertain the acceptance of the increase and were demanding the maximum of 11/- per week which had been granted elsewhere.

Councillor P. Ledwidge stated that although he was not opposed to the grant of the demand he felt that the general conditions of service of the Council's employees were superior to those prevailing in the case of employees of similar occupations in the Township.

Following a discussion it was agreed to adjourn the matter to the next Statutory Meeting of the Council to consider the Report of the Special Committee which had been appointed to consider the demand of the employees Trade Union.

With the exception of the undermentioned amendments the various items having been examined seriatim were adopted.

Urban Roads - Ordinary Road Works - Tar Spraying & Repairs (£200 page 1)

It was agreed to devote the sum provided in the Estimates viz. £200 on repairs to paths and roads on Back Street, Greenpark Road, Pearse Square and O'Byrne Road.

Urban Roads - Loan Charges

Florence Road Reconstruction (£272 - page 1)

The County Manager explained that the Tender proposed to be accepted for the resurfacing of Florence Road was lower than had been provided for in arriving at the Loan Charges as indicated. Accordingly a sum of £25 could be deducted from the figure of £272 provided in the Estimates, leaving £247 as the amount required.

Order - agreed.

The effect of this amendment was to reduce the amount provided for Urban Roads from £2,954 to £2,929 equal to a saving of £25.

Sanitary Services - Sewers.

Little Bray Outfall (£150)

The Surveyor intimated that it would be possible to carry out the work for a sum of £100 and accordingly it was agreed to reduce the amount provided from £150 to £100.

Sanitary Services - Drainage

Cockbrook Outfall £150

The Surveyor intimated that it would not be essential to have this work carried out during the coming year and agreed to the deletion of the provision of £150 in the Estimate. Councillor French opposed the deletion which had been agreed to.

Sanitary Services

Municipal Baths Maintenance (£75)

It was proposed by Clr. P. Ledwidge and seconded by Clr. E. Byrne "That a sum of £75 be included in the Estimates for the maintenance of the Municipal Baths"

The following amendment was moved by Clr. H. J. Byrne and seconded by Clr. E. J. Little "That a sum of £50 be included in the Estimates for the maintenance of the Municipal Baths"

The amendment was put and a division taken when there voted

The amendment having been declared carried it was put as a substantive motion and carried. The sum of £75 was accordingly reduced to £50.

Sanitary Services.

Bray Cove Swimming Pools Repairs

Clr. E. J. Little proposed and Clr. G. H. G. Stuart seconded "That the sum of £100 provided in the Estimates for the repairs to the Bray Cove Swimming Pools be deleted."

The following amendment was moved by Clr. J. French and seconded by Clr. E. E. Byrne "That a sum of £50 be provided in the Estimates for repairs to the Bray Cove Swimming Club."

The following voted for the amendment:-

The amendment having been declared lost the motion was put and carried with the same division.

The sum of £100 was accordingly deleted from the Estimates.

The effect of the amendments reduced the amount provided for Sanitary Services from £11,839 to £11,514 equal to a saving of £325 in the Estimates.

Sanitary Services

Public Lighting £1,350

It was agreed to refer the matter of Public Lighting of the Township to the next Statutory Meeting of the Council.

The provision of £1,350 would allow for 60 additional lamps during the coming year.

HOUSING

Maintenance and Repairs (£1,000)

Clr. J. Temple proposed that the sum of £1,000 provided in the Estimates for maintenance and repair of Council houses be reduced from £1,000 to £750 and that the sum of £200 provided for repairs to footpaths at Wolfe Tone Square be increased to £450.

Order - Agreed.

The County Manager promised to investigate the possibility of obtaining sanction to loan for repairs to footpaths, etc..

The amount provided in the Estimates for Housing Services, viz. £21,722 was adopted without amendment.

GENERAL URBAN PURPOSES

Town Hall Repairs and alterations (£250)

It was agreed to reduce the sum of £250 provided in the Estimates for repairs to the Town Hall to £50 which sum would be expended in the provision of sanitary accommodation on the premises.

GENERAL URBAN PURPOSES

Public Parks, Sea Wall, etc. Painting and Repairs (£1,480)

It was agreed to delete the following amounts from the sum of £1,480 provided in the Estimates for the painting and repairs, etc. to Public Parks, Esplanade, etc..

roadway Bray Head £120
Painting Kiosks : : £ 90
Painting Railings : : £360
Repairs to Paths - Esplanade £220

and to reduce the amount for Sea Wall decking from £250 to £200

Thus, the total amount of reduction effected is £840 leaving a sum of £640 to be provided in the Estimates for painting and repairs to Public Parks, Esplanade, etc.

Rate Collector's Commission

Following discussion it was agreed that the scale of salary to be provided for the present Rate Collector should be amended as follows:- £300 by £20 to £400 per annum plus commission of a maximum of £200.

Thus a sum of £500 is required during the coming year and a reduction of £100 from £600 to £500 should be effected.

Refunded and Irrecoverable Rates (£700)

It was agreed to reduce the sum of £700 provided in the Estimates from £700 to £500 thus effecting a saving of £200.

The foregoing amendments in the provision for Urban Purposes will result in the provision of £47,111 compared with £48,451 as estimated, i.e. a saving of £1,340, under this heading.

R E C E I P T

General Urban Purposes - Kiosks

It was agreed that the amount provided in the Estimates under this heading, viz. £250 should be increased to £665 in consequence of the additional income to be derived therefrom during the coming season. Thus an increase of £415 is accruable and the Estimates should be amended accordingly. The effect of this amendment results in an increase of receipts from Urban Purposes from £6,471 to £6,886.

The County Manager gave a review of events leading up to the position which now prevailed. He stated that an application for permission to erect a Greyhound Racing Track had been received by the Council on the 5th November, 1947, on behalf of the Greyhound Racing Association. This application had been refused unanimously by the Council at its Meeting on 16th November, 1947.

Notification to the foregoing effect was forwarded on the 1st December to the Solicitor acting on behalf of the Greyhound Racing Association in the course of which it was pointed out that the establishment of a racing track on the proposed site at Sublin Road would be open to serious objection and that permission could not be given for the proposal which, although it could not be regarded as a formal application under the Town Planning Acts, the Council nevertheless felt it desirable to convey such indication to the Promoters before expense had been incurred by them.

The County Manager made an Order on December 16th, 1948, refusing permission for the construction of the Track which the promoters had formally requested on the 5th idem. and a copy of that Order was duly served on them.

Notwithstanding that Order the Promoters of the project continued to carry out work and on the 10th February, 1948, a Prohibition Order was issued and again on the 20th February, 1948, a further Order was made by the Manager declaring any contravention of the prohibition to be unlawful.

After service of the latter Order the Promoters appealed to the Minister for Local Government in pursuance of the provisions of the Town and Regional Planning Acts and the County Manager stated that legal Opinion of Counsel had been obtained by them. Consequently it was decided that the Council should seek the Opinion of Counsel which Opinion had since been received. The County Manager then read the Opinion which broadly indicated

- (1) That the proposed Greyhound Track is a "structure" within the meaning of the Town Planning Acts, and that the laying down of such Track is, in effect, the "execution of work" within the meaning of the Acts.
- (2) The Planning Authority is entitled to require an applicant to submit Plans and Specifications for structures for approval.
- (3) The Council had power to make the Order of 10th February, 1948, prohibiting absolutely the further proceeding with the construction, etc. of the proposed Greyhound Racing Track.
- (4) The Council had power to make the Order of the 20th February, 1948, declaring any contravention of the prohibition before the coming into operation of a Planning Scheme should be unlawful.

The County Manager read a letter forwarded to the Department of Local Government in reply to the appeal of the Promoters to the Minister, and also a letter from the following viz. Country Air Association; Very Rev. A. Canon Moriarity, P.P.; Very Rev. E. H. F. Canon Campbell, objecting to the erection of the proposed Track.

Clr. J. Temple intimated that originally he had opposed the erection of a Track because he had been given to understand, erroneously, he added, that the Clergy were opposed, but he had since learned to the contrary. He felt that there was a definite need in Bray for such an undertaking and was strongly in favour of it.

Councillors French and McLoughlin suggested that the Council should await the decision of the Minister for Local Government. Clr. H. J. Byrne said he was morally bound to support the view of the Clergy.

Clr. E. J. Little proposed and Clr. G. H. G. Stuart seconded:-

"Whereas the Special Meeting called for March 31st to consider the Council's legal position in relation to the proposed Greyhound Racing Track at Dublin Road stood adjourned to this date to enable the Manager to seek the Opinion of Senior Counsel thereon, and whereas the Opinion of Counsel as so obtained supports the action taken by the Council and by the County Manager respectively, the Council in discharge of its consultative and advisory powers and of all and every power thereunto enabling hereby approves the action taken by the County Manager as and for and on behalf of the Council in relation thereto; and we order and direct the Town Clerk to forward copies of this Resolution to the Solicitor for the Promoters and to the Minister for Local Government respectively urging the Minister to an early decision on the appeal lodged by the Promoters with him in relation thereto."

150 Speed Limit in Urban Area

It was proposed by Councillor J. French
seconded by Councillor P. Ledwidge

"That having regards to the very marked increase in motor traffic which has occurred in recent years and to the degree of congestion which is evident at times on thoroughfares in the Urban District, and to the speed at which motor vehicles, especially high powered vehicles are frequently driven, this Council strongly urges that there should be a speed limit of 20 miles per hour for all motor vehicles within the Urban District of Bray, and views with greatest concern the danger to the public, especially to young children, which is liable to arise in the absence of a restriction requiring drivers to observe a speed which will ensure the safety of the public within the confines of the Urban District. That accordingly the Minister for Justice, The Minister for Local Govt. and the Commissioners of the Garda Siochana be and are hereby requested to arrange immediately for the imposition of such a speed limit."

Councillor French in moving the motion referred to the grave danger to children, etc. particularly on the Meath Road as a result of fast driving of vehicles on that road and stressed that, in his opinion, a speed limit in the urban area generally was essential. Other members expressed similar views. After discussion the motion was carried with the addition of the following words at the conclusion of the motion:- "within the Urban District of Bray."

It was agreed that copies of the Resolution be forwarded to the Minister for Local Government, the Minister for Justice and the Commissioners of the Garda Siochana.

151 Parking on Quinsboro' Road

The Chairman submitted a petition from business firms on the Quinsboro' Road in connection with the limitations in time of parking which it was alleged adversely affected the business of the firms concerned.

Regarding the request to have the Esplanade closed for the holding of Pony Jumping Competitions it was agreed that permission be deferred pending a report from the Esplanade Caretaker as to possible damage which might arise as a result of such usage.

163 Travelling Facilities for Civilian Bands

The following Notice of Motion handed in by Councillor J. Temple was passed unanimously:-

"That we the Bray U.D.C. request the C.I.E. to consider the possibility of providing special travelling facilities for Civilian Bands booked by the Council for performances during the Summer season. We suggest that the Company provide either a special 'bus or that a voucher be issued to the Bands and accommodation on trains should be reserved."

164 Alternative Accommodation for residents of houses at Vevay Road Housing Site.

The County Manager explained that the Housing Contractor would shortly commence work on the Vevay Road Housing Site. At the present time there were two houses which prevent the commencement of the work. These houses were part of the Bray Clearance Order, 1935, but the houses had not been demolished. Accordingly it would be necessary to provide immediately alternative accommodation for the two families residing in the houses. It was decided to leave the matter to the discretion of the County Manager.

165 Repairs to Bandstand (Central)

The Town Surveyor reported that he had obtained two Estimates for repairs to the floor of the Central Bandstand both of which tenders were over £100. 168 Local Loans Fund Account, 1935, - Interest Rate

Submitted Circular Letter H. 31/48 from Department of
Local Government intimating that the Minister for Finance had made
an Order under the Local Loans Fund Account, 1935, fixing the Interest
Rate on advances out of the Local Loans Fund at 3½% per annuus from
5th May, 1948. A general discussion took place at which members
stated that an increased Interest Rate would seriously affect the
finances of the Council's Housing Schemes at present in progress.

The following resolution was passed unanimously:-

"That this Council views with concern the increase
in the Interest Rate for Loans from the Local Loans
Fund to 3½% and considers that any such increase in
the Interest Rate, if unavoidable in present
circumstances, should be offset by a compensating
measure of assistance from State Funds, especially
in the matter of financing Housing Schemes of local
Authorities, or the making of Loans under the Small
Dwellings (Acquisition) Acts. The effect of such
an increase in Interest would result in an increase
of 2/8d per week in the Rentals for the houses at

131. Acquisition of Sites for Housing:

The County Manager read a report regarding various sites
which it was proposed to develop for the provision of additional
houses. He intimated that the Town Planning Committee had
inspected a number of sites and decided that two fields at Boghall,
the property of the Earl of Meath, shown on Map submitted, should
be acquired.

In deference to the views expressed by the Minister for
Local Government upon the occasion of his recent visit to Bray
the Town Planning Committee had inspected a number of Derelict
Sites, which could be used for the erection of houses and had
decided that the particular sites shown on Map submitted would
be suitable. These sites, nine in number, would permit of the
erection of 21 houses.

Councillor Temple expressed the view that the present
site at Hudson Terrace should be reserved for the erection of
maisonettes for small families or aged childless couples.

In view, however, of the delay which would be occasioned
by a departure at this stage from the Plans etc. and existing
Housing Contract it was agreed that the 21 houses proposed to be
erected on the Derelict Sites referred to should be of a smaller
type than the houses now in course of erection and could if
necessary be reserved for the classes mentioned by Councillor
Temple.

Councillor Ledwidge expressed the opinion that the use of
the two sites at Boghall would centralise the population at the
south of the Town to the detriment of the business community and
suggested that it would be desirable to acquire a Site at the
Northern end instead of one of the Boghall Sites.
