Answer:—The Licence under the Cinematograph Act, 1909, provides that children shall not be allowed to enter or be on the licensed premises after 6 p.m. on any week day on which the National Schools are open for the attendance of juveniles. Since the schools would not be open during the Summer Holidays, there does not seem to be any reason why proprietors of the cinemas should refuse to admit children to the cinemas after 6 p.m. If the Council wish, the attention of the proprietors can be drawn to the provisions of the Licence in relation to the admission of children to the cinemas.

Conce ning, the raising of questions it was proposed by Clr. P. Ledwidge, seconded by Clr. H. J. Byrne:—

The railing at present being erected will only come to the entrance gate of each house, but if the Council wishes the railing can be extended to include the entire frontage of each house."

The Council decided not to erect additional railings as requested by the tenant.

Clr. J. French:— Has the Town Surveyor received a Report on illegal tree cutting on Bray Head during the Christmas season? If so, could be state roughly how many trees were cut?

The following Report from the Town Engineer answering the question, was read and noted:

"This matter was reported to me after the Christmas by the Overseer. I subsequently inspected Bray Head and would say that approximately 20 Fir trees were removed immediately prior to the Christmas. In some cases large fir trees were damaged by the removal of branches apparently for use as Christmas trees.

It would appear also that over the past few years a number of larch and beach trees have been removed from time to time (probably one or two every few months) for use as fewered.

It is extremely difficult to detect the offenders in the latter case, but in future I would suggest that a watchman should be small as

in future I would suggest that a watchman should be employed on Bray Head for the Christmas period to prevent the cutting of Christmas Trees."

Submitted letter from Bray Amusements Committee regarding provision of strip lighting on the Esplanade during the Summer Season; the lighting of lamp on the steps and the removal of the drinking fountain.

SHOP FRONT, MAIN STREET FOR MR. LEDWIDGE. 84. The Council approved of a Plan submitted by Mr. Ledwidge for new shop front at Main Street.

ALTERATIONS TO ROOF OF 24 DUBLIN ROAD.

85. The Council approved of a proposal of Mr. Lyons to amend the Specification of the roof of premises, 24 Dublin Road, Plans for which had already been approved.

GARAGE AT BELMONT, STRAND ROAD.

86. The Council approved of Plan submitted by Mr. Reid for garage and store room at Belmont, Strand Road, subject to the structnot being used for human habitation.

EXTENSIONS TO ST. COLUMBA'S, PUTLAND ROAD. 87. The Council approved of Plan submitted by Mr. O'Brien, Architect, for extension to kitchen at St. Columba's Putland Road, subject to structure not being used for human habitation.

ERECTION OF NEW ROOF ON LATTICE COTTAGE. 88. Submitted letter from Mrs. Mary Murphy, Lattice Cottage, requesting permission to construct a new roof on Lattice Cottage. Proposed by Clr. Hipwell and seconded by Clr. Martin,

"That permission be granted for the construction of a new roof on Lattice Cottage, subject to the condition that natural slates or suitable tiles be used and subject to compliance with any other requirements of the Town Engineer."

The Motion was put and a division taken when there voted for the Motion—5, viz: Clrs. E. E. Byrne, H. B. Hipwell, Mrs. McCallion P. Martin and D. Sayers.

There voted against—5, viz.: Clrs. H. J. Byrne, Dr. Donnelly, J. French, J. Kinsella and G. H. G. Stuart. The Chairman, Clr. Stuart, gave his casting vote against the Motion, which was accordingly declared lost.

EXTENSIONS TO STRAND HOTEL.

89. The Council approved of Plan submitted by Sean G. O'Kelly, Architect, for extensions to the Strand Hotel for the Misses Donaldson.

BOUNDARY EXTENSION AT BOGHALL.

90. Submitted letter from the Department of Local Government forwarding co py of Order, viz., "Bray Urban District (Alteration of Boundary) Order 1952 (S.I. No. 42 of 1952), whereby part of lands at Boghall have been added to the Urban District. The land concerned measures approx. 1.8 acres and is described as follows:—

"The lands of Kilruddery Demesne East enclosed between the existing boundary of the Urban District and a line drawn from the junction of the said boundary with the western boundary of the Townland of Kilruddery Demesne East in an easterly and northwesterly direction along the outer face of the fence of the field shown as comprising 4.460 acres and 1.834 acres on the 25.344 inches to the mile Plan 1 of Ordnance Survey Sheet 8 of County Wicklow to the next junction of the outer face of the said fence with the existing boundary of the Urban District."

The Order came into operation on the 23rd February, 1952. Order:—Noted.

REVISION OF REMUNERATION OF FIRE BRIGADE PERSONNEL.

91. The Council adjourned consideration of a letter from the Department of Local Government regarding revision of remuneration of the personnel of the Fire Brigade for the submission of a report by the Town Clerk in the matter.

DAYLIGHT CINEMA SHOWS AT CENTRAL

BANDSTAND.

92. Consideration of the proposal of Hardiman Enterprizes Ltd.. Dublin, to provide Daylight Cinema Shows at the Central Bandstand. was adjourned, pending a reply from the Company regarding an offer for the use of the Bandstand for the purpose.

ILLUMINATED WINDMILL.

93. Submitted letter from Messrs. Breen Electrical Co. Ltd., stating that it would not be possible to instal a Windmill on Bray Head as E.S.B. Services were not available and suggesting that it be erected on the Esplanade.

It was agreed to intimate to the Company that E.S.B. Services were in fact available and that Bray I-lead would be frequented to a greater extent in the coming season owing to the proposed Amusement Site, and that the erection of a Kiosk and Windmill should prove remunerative.

TEMPORARY DAMS.

94. Submitted letter from County Wicklow Anglers Association asking permission for the installation of temporary dams in the Dargle River. The Council raised no objection in principle, to the proposal, but that no liability whatever could be accepted in the event of any damage or injury being caused as a result of installation of the dams.

PROTEST BY CLR. J. TEMPLE.

95. At this stage, Clr J. Temple was in attendance. Having protested against the holding of the Meeting during the Retreat Week at the Church of the Queen of Peace, he left the Meeting.

FUEL SCHEME.

96. Submitted letter from the Secretary, Wicklow County Council stating that the Council could supply turf in connection with the Urban Council's Cheap Fuel Scheme. The Council raised no objection to the arrangement providing the Department of Social Welfare recoup the cost and subject to arrangements being made for delivery of the fuel to the homes of the recipients under the Scheme.

Tenders for Amusement Site at Bray Head.

The only Tender received for Licence to use a site at Bray Head for Amusement purposes during the Seasons 1952 and 1953 was that of Mr. Richard Williams, in the sum of £750 plus 50% of all receipts from the Amusement devices on the Site during one week in June and one week in September. It was agreed to adjourn consideration of the Tende to enable inquiries to be made as to whether the sum of £750 was an annual amount or if it were intended to cover the entire period of the letting.

100. Estimate of Expenses 1952/53

Submitted report of the County Manager dated 21st March, 1952, upon the Estimate of expenses of the Council for the year to end 31st March, 1953 as follows:-

In the attached Tables full details are given of Estimated costs of the Council Services for the financial year commencing 1st April, 1952. Expenditure and Receipts are shown under the four main headings of Roads; Sanitary Services; Housing; and General Urban Purposes. The Demand from the County Council is included under the latter heading.

SUMMARY OF EXPENDITURE AND RECEIPTS

The total to be met from the Rate levy in the coming year therefore would be £74,718. The total valuation effective for rating purposes in the coming year is £46,802 and the Municipal Rate which would be required to produce £74,718 is 31s 11d in the £1. This would be an increase of 3s 5d in the £1 compared with the rate for the present year, which is 28s 6d. The total expenditure allowed by the Council for the year 1951/52 was £64,833.

The Estimates now submitted for your consideration would entail expenditure of £9,885 in excess of the sum allowed for the current year. This excess derives in the main from an increased Demand from the County Council and the large scale provision made for new works such as the improvement and repair of Urban Roads, relaying of watermains and improvements at Esplanade.

In the following list a summary is given of the major increases which would require an addition to the existing rate levy:-

Whilst there are other minor variations in costs, the foregoing items, which amount in all to £10,326 mainly account for the increase in expenditure in the coming year. It is offset in the Estimates to the extent of £600 by a receipt from the proposed letting of an Amusements Site at Bray Head. Many of the new items of expenditure for which provision has been made have been under consideration by the Council in the present year and consequently, it has been decided to make provision for them. The Council, when they are determining the Rates, may however, having regard to the costs involved, decide that some of the items might be omitted or the scale of expenditure be reduced. The County Council Demand however, being a statutory item, cannot be pruned, and its increase (£2,806) represents a rate increase of 1s 3d. It will be found that for Road Improvements the additional outlay provided is £2,444, and for repairs, improvements and the provision of new amenities at the seafront, provision is made for an outlay of £2,731.

The gross expenditure is estimated at £6,475, and after deducting receipts of £125 the net levy is £6,350 as compared with £3,521 in the present year. It should be mentioned that apart from the provision made for new works, wages show an increase of £364, but this is practically altogether due to the transfer of chargeability of the remuneration of an employee from the Harbour Account to Roads Account. In former years a State Grant was received towards the cost of Harbour but since the liquidation of the loan charges, consequent on the Redemption of the 1893 32% Stock Issue, this Grant is no longer receivable.

The Estimates now presented would permit of the carrying out of a major scheme of roads resurfacing and reconstruction. Last year it was decided to defer such works but in recent months the Council asked that the Town Engineer would submit recommendations for improvements which might be undertaken as capital works and the costs be defrayed by loan over a period of ten years. The Engineer's Report on this subject is attached. He recommends that the following roads be resurfaced:-

It is considered by the Engineer that if new surfaces to a suitable depth in special tarmacadam were laid on these roads they should last for at least fifteen years, i.e. five years beyond the period of loan repryments. It is found that if the roads were relaid in concrete the cost would be about twice as high as for tarmacadam. Cement has increased considerably in price since the Meath, Sidmonton and Florence Roads were reconstructed some years ago, and furthermore, it is doubtful if sanction to borrowing for a large scale roads scheme in concrete would nowadays be forthcoming, as cement has still to be imported for other works such as Housing. Since the original surface in Westfield Park was concrete (which surface however, it transpired, was not of a durable character) it is suggested that the road be restored in concrete. The total capital cost would be £9,690 and the yearly loan charge, with repayment over a period of ten years, would be £1,356. For the coming year only part (£625) of this loan charge is included in the Estimates but in the following years the full charges would be payable.

In addition to reconstructing the foregoing roads the Town Engineer has recommended that £1,000 be allowed for tarspraying the following thoroughfares:Herbert Road (from King Edward Road to Crowbank), Convent Avenue, Sidmonton Ave.,
Victoria Avenue, Strand Road (North and South ends), Seymour Road, Galtrim Road,
Wyndham Park and Eglinton Road.

Last year the Council allowed only £400 for normal repairs such as pot-hole filling, etc.. For the coming year the Engineer considers that £750 would be essential for this type of maintenance and accordingly this sum has been included in the Estimates. For Repairs to Footpaths £200 is included, and for New Name Plates, Traffic Signs (including painting of existing signs) and Litter Baskets, £80 is provided.

SANITARY SERVICES

The net outlay is estimated at £14,532; the amount allowed last year was £12,339 - the increase is £2,193.

Under the heading of <u>Sewers</u> wages show an increase of £79 due to a special allowance to workmen employed on sewers. Materials are increased by £80 and £50 is provided for Carting of supplies. For the Cleaning of Cockbrook £70 is provided (£50 in 1951/52).

In the Waterworks salaries are increased by £154 as it was necessary to revise remuneration of Water Inspectors in 1951 and to allow for overtime payments For the payments to Dublin Corporation for Bulk Water Supply, a like amount to that allowed last year, viz., £3,300 is provided. This is based on a price of 2.88d per 1,000 gallons but it again must be mentioned that Dublin Corporation are still pressing for an increase in this price. As mentioned when submitting the Estimates last year, the Corporation have sought a revised price of 8d per 1,000 gallons, which if granted, would, on the basis of present consumption, involve an additional yearly payment of £6,500. To meet such an additional payment, the rates would have to be increased by 2s 10d in the £1. At present there is a Petition from the Corporation, before the Minister for Local Government which seeks a revision on the foregoing lines in the bulk supply charges and it may happen that a special Inquiry will be held. A lengthy and detailed investigation of the history and accounts of the Dublin Corporation Waterworks has already been undertaken in order that the Council's Case may be adequately presented in the event of such an Inquiry being held in the near future.

For the past four years the Council has been carrying out a programme of relaying watermains which, owing to their age (most of them had been in use for up to seventy years) had become defective. Thus far, new mains have been laid in the following thoroughfares: Meath Road, Herbert Road, Sidmonton Road, Vevay Road, Church Road, part of Main Street, Seapoint Road, Novara Avenue, Brighton Terrace, Connolly Square, St. Kevin's Square. The greater part of this work has been done by Direct Labour by the Council's own staff. In the coming year it is intended to continue this work in the following districts: Upper Dargle Road, Sunnybank to Bray Bridge, Killarney Lane to Town Hall, Quinsboro' Road, Kilmantin Park, Strand Road (southern end), Putland Road. The additional loan charges arisin; from next year's programme would be £558,

but a State Grant of £186 is expected. Moreover, the Council has procured a State Grant towards the cost of the scheme which includes Church Road, etc., so that the net increase in loan charges in the coming year will be £168. These improvements in the Water Distribution System have enabled supplies to be afforded at adequate pressure; in former years continuous complaints were being received from many parts of the town regarding the insufficiency of the supply. Again the relaying of mains, together with the installation of meters, have resulted in a substantial decrease in consumption per head of population in the past three or four years, so that any increased costs arising from these capital works has been more than counterbalanced by savings in Bulk Supply Costs. It is doubtful if many members of the community realise the very extensive programme of water supply improvements which have been carried out in recent years, at a time when many other Capital Works, such as Housing Schemes, etc., were also being undertaken.

It was represented to the Council sometime ago that a water supply to the Kiosks at the Esplanade was essential and approval was given with a direction that provision for the cost be included in the Annual Estimates. A sum of £336 is included to meet the cost of this item.

Scavenging:

Wages for Domestic Refuse Collection show an increase of £73 as it was decided in 1951, to provide a daily Collection service during the Summer for Hotels and houses on the seafront, and this entails the working of certain periods of overtime. In former years, under the Contract system, it was never possible to provide a daily collection for the entire seafront and in fact it has only become practicable since the Council purchased their own Refuse Collection Vehicle. Again, under the Contract System, refuse from some parts of the town was only collected once per week; there is now a daily collection from premises in the Main Street and Quinsboro' Road throughout the entire year, from Strand Road there is a daily collection from 1st June to 30th September, and in all parts of the town there is at least a twice weekly collection. There is an increase of £139 in the wages for Street Cleaning, which arises from the allowance of an extra week's leave (two weeks in all) to workmen and the granting of sick leave with pay, under certain conditions. For some time past the Council has been negotiating for the acquisition of an alternative site for a Refuse Dump as it has often been represented that the use of the existing site near the Harbour, is open to objection. The costs of acquisition of the alternative site, the making of a length of roadway to it and fencing, are estimated at £275.

Municipal Baths:

It will be noted that provision is made in the Estimates for expenditure of £750 on Repairs and painting to the Municipal Baths at the Esplanade. The Baths were last painted in 1949. Owing to their exposed position paint deteriorates rapidly. For a new store at the Cove Swimming Pools, a sum of £150 is included.

Public Lighting for the coming year is estimated to cost £1,900, which is £140 more than in the present year, as in August, 1951, the E.S.B. charges for lighting were increased. Last year the Council decided to arrange for about sixty additional lights. The cost for the coming year will be £550 higher than in 1950/51 when it was £1,350. This increase is due to the provision of additional lights and the revision of E.S.B.charges.

Public Lavatories: The Council has had under consideration certain improvements to the Lavatories at the Boat House and the Town Engineer estimates the cost at £120. He also recommended the provision of a new public lavatory near the Town Hall to replace the existing one. Since however, the Council in the present year, is providing, in conjunction with the County Council, a new Public lavatory at the Courthouse, Main Street, it was not thought necessary to provide, at this stage, for a new structure near the Town Hall.

HOUSING

For Housing Repairs the Town Engineer submitted an estimate of £2,000 made up of £1,500 for general repairs, and £500 for painting. The amount included in the attached Estimates is £1,200, which is £200 more than the sum allowed for the present year. It is to be noted, however that £1,200 was allowed in 1950/51.

The Rates on Council Houses show an increase of £548, due to the Valuation of new houses, but this is offset by a similar increase in Rent Receipts.

£100 has been included for the cleaning and improvement of a number of Derelict Sites at Upper Dargle Road.

Since 1947, the Council has erected 160 Houses - 91 by Contract and 69 by Direct Labour. The erection of 22 Houses at Boghall, which are being let on a Tenant Purchase basis, is now being completed. It is hoped to start the building of houses at Old Connaught at an early date; it is regrettable that much delay, owing to the many difficulties to be solved, has been experienced by the Council in commencing this Scheme.

Small Dwellings Acquisition Acts Loans.

Thus far, loans amounting to £137,000 have been approved. This special facility has enabled 110 persons to erect their own houses in the past four years. The loan charges incurred by the Council are recouped by the repayments made by borrowers. It is evident therefore, that the Council, in making such loans available, has given very material assistance towards solving the housing problem, quite apart from the schemes for the building of working-class houses. In all, the Council by its own building of working-class houses, and by the financial facilities given to persons building their own houses, has enabled 270 new houses to be provided in the past four or five years - a number sufficient to cater for the needs of about 1,350 persons

GENERAL URBAN PURPOSES

The expenditure under this heading includes the Demand from the County Council, the special levy of 9d in the £1 under the Unemployment Assistance Acts, the Vocational Education Demand, the maintenance of the Esplanade, Public Library, School Meals Scheme, Fuel Scheme, and many other items.

The total expenditure is estimated at £54,734 as compared with £48,312 in 1951/52; and receipts are estimated at £4,891 - the corresponding figure in 1951/52 being £3,737. The net outlay therefore, is £49,843, as compared with £44,575 in the present year. The greater part of the increase is due to the County Council Demand, new works at the Esplanade, the Public Library and School Meals.

Town Hall Expenses.

A sum of £100 is included to cover the cost of painting Entrance Hall and Caretaker's apartments.

Tourist Development

Last year the contribution to the Tourist Association was increased from £100 to £200 and the latter sum is again included.

Public Library

The total provision allowed for the Public Library last year was £1,660 and after deducting receipts of £200, the net outlay was £1,460. The Estimate for the coming year is £2,355; receipts are estimated at £300, leaving the net expenditure of £2,055 - an increase of £595 over 1951/52. This increase is mainly due to an additional provision of £450 for Book Stocks and £100 for a Juvenile Library. The number of Borrowers from the Library is still increasing and it is evident that the service is much appreciated by the public

Vocational Education:

The Demand for the coming year is £1,657, an increase of £116. The Demand now represents a rate of 82d in the £ on the effective Valuation.

Esplanade:

The total outlay on the maintenance of, and improvements to the Esplanade and Public Park at Bray Bray Head, including loan charges and wages, is estimated at £4,315. Provision is included for the following new works:-

The total cost of the foregoing works would be £1,945. Members have drawn attention during the year, to the necessity for painting of the Railings adjoining Strand Road. The provision of a new Storage Hut has often been mentioned as desirable, but last year the expenditure was deferred. The Amusements Committee asked some time ago, that Tree Planting should be carried out at Bray Head and the matter was deferred to the consideration of the Annual Estimates. The Town Engineer has pointed out that new Shutters are required for Kiosks. Last year a sum was included in the Estimates for repairing the Boundary Wall to Bray Head Park and Plantation Fences, but the works were deferred. The Town Engineer considers that further Repairs to Sea (Promenade) Wall at an estimated cost of £120 are urgently required. He also has recommended Repairs to Seats, Boat Slip and the provision of new Notice Boards. The Council have had under consideration, the provision of a new Kiosk at Bray Head Park (near Fiddler's Bridge) from which a revenue could be derived by lettings in the coming years. In the present year the Council, subsequent to the adoption of the Estimates, agreed to spend £226 on Strip Lighting. The sum of £465 now included in the Estimates would cover the purchase of Poles, bulbs, cable, cost of current and erection and maintenance of Strip Lighting in the coming year for the period June to September. Last year the Strip Lighting which cost £226 was only provided in month of August. If special Flags for poles in lieu of bunting, be provided, the cost is estimated at £150.

The cutting of the grass at People's Park has been carried out in recent years without special provision being made therefor in the Estimates. The cost is about £40.

A Loan Charge of £360 is included to meet the capital cost of the Scheme of improvements to be carried out at Northern End of Esplanade. The full year's loan charge is expected to be £720. It should be mentioned that £360 was also provided last year but sanction to borrowing and to the details of the Scheme had to be awaited before the work could be started. The Scheme contemplates the lay-out of a new lawn and the achieving of suitable colour and interest by the planting of special shrubs, mainly of the flowering type. In addition, shelters, and a number of fountains, and a Children's play space will be provided.

In the present year a section of the Railings at Esplanade was painted, some of the seats were repaired, paths were relaid in concrete and a section of the Promenade Wall, which had suffered damage from the sea is now being repaired.
