216. Changes of names of tenancies.

The Council agreed to appoint Mr. Columba Dunne as tenant of 7 Wolfe Tone Sq. West in succession to his mother, Mrs. Dunne, decd. The Council also appointed the daughter of Mr. Frank Leggett as tenant of 4 Wolfe Tone Sq. South.

217. Amusement Site at Bray Head.

The Council agreed to amend the Agreement in respect of the letting of Bray Head Park whereby the Council would receive 50% of the gross proceeds from the Amusement Devices for one week commencing the 6th July instead of one week in June and one week in September, as previously agreed.

218. Boghall Housing Scheme.

The Town Clerk reported that the all in cost of the Housing Scheme at Boghall Road (subject to possible minor amendments later) was £39,795 3s 10d. The cost of land acquired for 44 houses (22 of which were built by the Council) was £2,313 11s 6d. The development of the site for the 44 houses cost £5,084 3s 6d and the actual cost of the erection of the 22 houses by the Council was £32,397 9s 10d. Half of the cost of land and development are of course chargeable against the Members of the two Public Utility Societies to whom the Council leased 22 sites for erection of houses by them. A sum of £181 2s 4d being half the cost of the erection of a division fence is also chargeable against the Utility Societies, as follows:-

218.(contd.) On the basis of the foregoing figures a Ground rent of £8 13s 4d per house per annum will be charged in respect of each house, i.e 3s 4d per week. Taking into consideration a Grant of £275 per house and the deposit of £25 made by tenant purchasers, the net Principal sum to be repaid will be £1,165 approx. With interest at 3 $\frac{3}{4}$ % over a period of 35 years the Annuity will be £60 0s 3d, i.e. £1 3s 1d per week. Thus the annuity and Ground Rent will amount to £1 6s 5d. In addition of course, Rates will be payable for the current year amounting to 8s 9d. The foregoing details of Annuity, etc., will be subject to the approval of the Department of Local Government.

FOOTPATH AT PEOPLE'S PARK.

267. Clr. Ledwidge asked permission to refer to the work of the construction of a footpath at People's Park. He stressed the desirability and necessity of laying the footpaths nearer the river on the site of an old footpath which was now covered by soil. The Acting Town Engineer intimated that if the footpaths were laid nearer the river wall it would entail removal of a large quantity of earth and that the roots of the trees might cause damage to the footpath.

Following lengthy discussion, it was proposed by Clr. Ledwidge, seconded by Clr. Martin,

"That a direction be issued to the Acting Town Engineer to proceed immediately with the laying of the footpath at the People's Park on the site of the old footpath, in accordance with the wishes and direction of the Council in the matter."

The following amendment was moved by Clr. Hipwell and seconded by Clr. H. J. Byrne:

"That the footpath be laid on the site of the old footpath and that the laying of the footpath be deferred pending the return of the Town Engineer from Annual Leave."

The amendment was put and a division taken, when there voted for the amendment, 5 viz.: Clrs. H. J. Byrne, Dr. Donnelly, H. B. Hipwell, J. Kinsella and G. H. C. Stuart. There voted against, 5 viz.: Clrs. J. French, P. Ledwidge, P. Martin, D. Sayers and J. Temple. The Chairman gave his casting vote in favour of the Amendment which was put as a substantive motion and was carried.

TENANCIES OF COUNCIL HOUSES.

268. Submitted applications for interchange of tenancies from Miss J. Flanagan, 34 St. Kevin's Square, Mrs. B. Morris, 14 St. Cronan's Road and Mrs. Nora Gallagher, 6 O'Byrne Villas, Bray.

The Town Clerk intimated that the house occupied by Mrs. Gallagher had two bedrooms and that the house to which she proposed to transfer had one bedroom only.
