

VOTES OF SYMPATHY.

326. The Chairman, on behalf of the Council extended votes of sympathy to the relatives of the late Miss Isobel O'Reilly, 30 Castle Street, Mrs. Byrne, 30 Duncairn Avenue, Mr. Murphy, Ords Terrace Senator A. Clarkin, Dublin and Dr. Nealon, Bray.

PURCHASE OF TIPPER LORRY.

327. Proposed by Clr. T. Byrne, seconded by Clr. J. O'Toole.

"That we hereby affix the Seal of the Council to Mortgage with the Hibernian Bank Ltd., in the sum of £1,040, repayable over a period of five years, to defray cost of purchase of new Tipper Lorry."

REPAIRS TO SEA WALL AND RAILINGS.

328. Submitted letter from Commissioners of Public Works indicating that repairs to Sea Wall will commence in March, 1956. It was pointed out that delay in commencing this work was not due to the Council or to officials.

The Council authorised the necessary excess expenditure of £810 and £152 for repairs to railings to be defrayed from Revenue for the purpose of carrying out repairs to Esplanade railings.

PALERMO TENANTS ASSOCIATION

329. Deputation was received from Palermo Tenants' Association consisting of Messrs Kelly, McNaughton and Martin. Several proposals were put by the Association to the Council for the improvement of the housing site at Old Connaught. The Chairman informed the Deputation that all suggestions put forward would be carefully considered and the representations made by the Deputation would be examined by the Council and a further communication would be sent to them at an early date.

RAVENSWELL ROW

330. The following Notice of Motion standing in the name of Clr. D. Sayers was adopted unanimously, viz.,

"That in view of the scarcity of sites within the Urban area suitable for the erection of houses under the Housing of the Working Classes Act, it is hereby resolved by the Council that the site now vacant at Ravenswell Row, Greenpark Road be utilized for this purpose."

It was decided to obtain the views of Council's Architects on this proposal and to ascertain from Wicklow County Council particulars of any proposed road widening at this point.

REVISION OF SALARIES OF OFFICIALS

331. This application, in which the Union sought an increase of 12½ per cent on present gross salaries with effect from 1st September, 1955, was examined by a Special Committee of the Council and the County Manager who met representatives of the Union on 7th December, 1955.

The Committee, having carefully considered the application, recommended that an increase of 10 per cent on existing gross salaries i.e. salaries inclusive of any present temporary allowance) might be granted to the salaried staff of the Council, with effect from 1st September, 1955, subject to a minimum increase of £40 per annum and a maximum of £60 in the case of any Officer.

After a discussion on the subject it was unanimously resolved that the recommendation of the Committee be approved and that the expenditure arising in the present financial year from such revision of salaries also be approved.

SMALL DWELLINGS (ACQ.) ACTS.

332. The Council affixed its Seal to Assignment of 56 Cuala Rd., from Mr. A. McCormack Courtguard Station, Bray, to Peter Doyle Sweet Shop, Quinboro Road, Bray.

REVISION OF PUBLIC LIGHTING.

333. The Council agreed to defer report of Engineer on revision of public lighting system to Estimate Meeting. The Council adopted recommendation of the Town Engineer to install lights under Railway Bridge (four), and authorised the necessary expenditure.

 Clr. P. Dempsey dissented.

ANNUAL AUDIT.

399. The Council noted a letter from the Department of Local Government stating that in future the accounts of the Council would be audited annually.

KILLARNEY WOOD, BRAY

400. The Council considered an offer from the Co-Operative Holiday Association to lease 12-35 acres of Park at Killamey Wood, Bray, to the Council at £5 a year. They further considered a report from the Town Engineer which pointed out certain problems connected with the undertaking. It was finally decided not to accept the offer of the Association.

BRAY AMUSEMENTS COMMITTEE—**USE OF CENTRAL AND SOUTH BANDSTANDS**

401. On the proposition of the Chairman, seconded by Clr. E. Byrne, the above Committee were granted the use of the Central and South Bandstand when not required for Bands hired by the Council or by individuals who might tender for their use during the Summer season.

AN TOSTAL COMMITTEE—**USE OF CENTRAL BANDSTAND**

35 O'BYRNE ROAD

403. The Council considered report from Rent Collector, Mr. Hughes, to the effect that John McKenna had not yet taken up occupation in above house. No action was taken.

The Council indicated that they had no objection provided the sponsors of the Race received permission from the Garda Authorities.

CORAS IOMPAIR EIREANN—TRAINS ON SUNDAYS

460. On the proposition of Clr. Dr. Donnelly seconded by Clr. D. Sayers, it was resolved that Coras Iompair Eireann be asked to inaugurate a train service to Bray commencing on the first Sunday in May and ending on the first Sunday in October—the trains to be run at a cheap rate.

PIGEONS.

461. After a lengthy discussion on the question of Pigeon Lofts in O'd Conna Housing Scheme, it was decided that if the Pigeon Racing Association submitted a detailed Plan and Specification, with indication of location, same would be considered by the Town Engineer.

NOVELTY CRAFT.

462. One Tender only was received in response to public advertisement for above, i.e., that of Messrs. R. J. Merlihan and A. G. Scott, of Gledside, Clonskeagh, Co. Dublin, who offered a sum of £3 3s. 0d. per Craft per year or £5 per Craft per year on condition that they received a four year Licence. On the proposition of Clr. P. Savage, seconded by Clr. T. Byrne, the acceptance of the Tender in the sum of £3 3s. 0d. per craft for one year was recommended, Clrs. D. Sayers, Dr. Donnelly and M. O'Toole, dissenting.

In making the recommendation the Council directed the Town Clerk to urge that adults be employed by the Tenderers.

WEIGHING MACHINES—QUOTATIONS

463. Only one quotation was received for a Permit to place Weighing Machines on sites at the Esplanade—that of British Automatic Co. Ltd., in the sum of £40. It was recommended that the quotation be accepted.

BRAY SWIMMING CLUB

464. The Council considered a letter from the Bray Swimming Club asking that they be allowed to operate the Municipal Baths and Sanitary Conveniences during the coming year and offering to restrict and confine their activities where necessary. It was decided to consider granting these facilities to the Club when the Engineer thought that it would be feasible, having regard to the progress which would be made by the Commissioners of Public Works in carrying out repairs to the Sea Wall. It was further decided that the Council would operate the Sanitary Conveniences directly.

BAND PERFORMANCES

465. The Town Clerk informed the Council that he had provisionally booked six Bands for the People's Park and Wolfe Tone Square. It was decided, Clr. Savage dissenting, to allocate four of the Bands to the People's Park and two to Wolfe Tone Square.

HOUSING PROGRAMME

466. The Council considered and approved of Report of Dr. Dunlevy, Asst. Co. Medical Officer of Health on the Housing needs of the town and noted that it appeared necessary to build 35 houses at present. They recommended that the Consultant Engineer would again consider the site at Ravenswell Row to ascertain if it would be possible to build a number of duplex houses thereon. The Council also recommended that the Manager would examine the possibility of building houses for newly weds.

27 WOLFE TONE SQUARE NORTH

467. The Council were informed by the County Manager that it was intended to recover possession of above house from the tenant, on the grounds that he was in arrears of rent; that he did not occupy the house, and that certain amount of wilful damage was done to the house.

17 FR. COLAHAN TERRACE

468. The Council recommended an application from Miss Ellen Whelan to be appointed tenant of 17 Fr. Colahan Tce., in place of her late father, be granted.

TOWN PLANNING ACTS— 34 DARGAN STREET

469. Submitted plan from Mr. Thos. Foley, 34 Dargan Street, for permission to erect a kitchenette at his premises.
Order: Recommend approval be granted.

SMALL DWELLINGS (ACQ.) ACTS APPLICATION

470. The Council approved of application from Sergt. J. McBrinn, for loan of £1,600 under the above Acts for a house at Cuala Road, the approval being conditional on the Council being able to provide the money.

LICENCE FOR HIRE OF PONIES ON THE BEACH

471. Permission was refused to Mr. William Moorehouse, 6 St. Laurence's Tce., to hire ponies on the seafront.

ESTIMATE OF EXPENSES 1956/57

454. Submitted report of County Manager dated 19th March, 1956.

SUMMARY OF EXPENDITURE AND RECEIPTS

The Expenditure and Receipts and Net Costs to be met from Rates are estimated at:

The total to be met from the Rate levy in the coming year would be £92,230 but the application of Credits of £670 which are available from the present year, reduces the net requirements to £91,560. The total valuation effective for rating purposes in the coming year is £50,422 and the Municipal Rate required to produce £91,560 is 36s. 4d. in the £1. This would be an increase of 1s. 0d. in the £ over the rate for the present year, which is 35s. 4d. The rates productivity shows an increase in the coming year but the rise in the valuation is due to new Council houses, and in this instance, the additional valuation is offset by new Loan Charges on the houses to be borne by the Council.

The total expenditure (after deducting Receipts) allowed by the Council for the current year was £87,980, and the estimates now submitted for your consideration would entail an additional expenditure of £3,580. Briefly, some of the increases in expenditure which would require an additional rate are:

Whilst there are other variations in costs and reductions under some headings, the foregoing items, which amount in all to £4,463 are mainly responsible for the increase in the Estimates.

Some time ago applications were received from the Workmen's Unions seeking increases in Wages and after lengthy consideration the Council approved of an increase corresponding to that which had already been allowed in other employments. Later a similar application was received from the Union representing the Council's salaried staff and after a careful examination of the matter it was agreed to allow increases similar to those which had been given in the Civil Service some months ago.

Almost all the remaining increases, apart from the County Council Demand, are ascribable to new works, and further details of them are given later under appropriate headings.

The Town Engineer again has prepared a special Report on the Municipal Services under his charge and on works which are contemplated or were recently carried out. A copy of this Report is attached.

ROADS

Under this heading the gross expenditure is estimated at £7,133 and after deducting miscellaneous receipts of £125, the net levy is £7,008. The amount allowed in the present year was £7,116.

The outlay on maintenance and repairs shows a reduction; this is due to the gradual improvement of road surfaces in recent years. The Council has been spending very large sums on the construction of new streets and roads. Many of these thoroughfares have been constructed in concrete. Whilst the capital costs of the works have involved the Council in new loan charges, there has been a marked improvement in the surfaces of most of the streets and roads throughout the town. It is also now possible to reduce the outlay on repairs—the filling of numerous potholes on badly worn thoroughfares can be costly—and the beneficial effects of the policy pursued by the Council can now be seen. In the past many years the Council has resurfaced approx. five miles of Urban Roads and of this two miles have been done in concrete.

The Council last year approved of a loan of £3,700 for the purpose of reconstructing Eglinton Road, part of Strand Road, Duncairn Avenue and part of Quinsboro' Road (eastern end). The works were completed recently and Eglinton Road has been reconstructed in concrete which should obviate any maintenance on this thoroughfare for many years to come. Only part of the annual Loan Charge for these works were included last year, but in the coming year the full loan charge, which involves an increase of £272, must be met.

Last year the Council also approved of a Scheme for the reconstruction of Sevmour Road, St. Kevin's Square, Galtrim Road Wyndham Park and Connolly Square at a cost of £3,500 and in the coming year there will be a loan charge of £300 for this Scheme. The loan charge for a full year, however, would be £520.

For the coming year the Town Engineer has recommended that the Council might undertake the reconstruction of the following roads as Capital works:—

Herbert Road (part from King Edward Road to Urban boundary)—surface in tarmacadam	£1,350
St. Laurence's Tce.—New concrete road	1,050
Dock Terrace—Surface part of width in tarmacadam	400

The total cost of these works would be £2,800 and the annual Loan Charges would be £400. If the Schemes were approved by the Council the Loan Charge to met in the coming year would be £200.

In recent years (including the programme for 1955/56) the Council has raised loans amounting to £28,130 for the Reconstruction

of Roads, but they were mainly for short terms and the first of them will be liquidated in 1957/58. It is expected that most of the roads, especially those constructed in concrete, will be in good condition for many years after the loans have been repaid. Apart from the work done through loans the Council reconstructed many other roads and made new footpaths, with moneys provided from Revenue or with the aid of Employment Scheme Grants. In the present year, in this way, a new concrete road was made at Maitland Street and new concrete footpaths at Seymour Road and Rathmore Terrace.

SANITARY SERVICES

The gross outlay on Sanitary Services is estimated at £19,261; the amount allowed by the Council last year was £17,381. The increase of £1,880 is attributable mainly to new works and wages increases.

Sewers: The usual provision, £50, is being made for cleaning the stream known as "The Cockbrook." This is work which has been carried out annually for the past seven or eight years.

It is considered that a new Storm Overflow is necessary at Castle Street and Emmet Road. During heavy rains flooding has now and again occurred in this area and the Town Engineer has reported that this could be remedied by the construction of a special Storm Overflow to the Dorele River, which would cost £400. It is recommended that this work should be charged to Revenue and the amount accordingly is included in the Estimates.

Waterworks: The payments for the bulk supply of water to Dublin Corporation are estimated at the same sum as was allowed in the present year (£3,300). There is, however, as in last year's estimates, an additional sum of £245 payable for water supplied to the new Council houses at Old Conna, which are in County Dublin.

Last year the Council allowed a special sum in the estimates for the purchase of new watermains and with the aid of this, new mains were laid at Maitland Street, Seymour Road, Duncairn Avenue. In addition, the Council agreed to loan charges to meet the cost of laying a new 6" main from Killarney Road to Vevay Road. Tenders for the pipes have already been received and the work of laying them should start at an early date. The cost of the Scheme is £2,500. For the coming year only part of the annual Loan Charge will have to be met, viz., £120. The normal Annual Charge will be about £250.

It is recommended by the Town Engineer that in the coming year the Council might approve of the laying of a new 6" main at Putland Road, which is estimated to cost £2,500. It is proposed that this main would be laid along Putland Road between Sidmonton Road and Vevay Road corners. The Council may, however, consider that with the improved supply to the Vevay Road, etc., areas, which can be expected when the new 6" main from Killarney Road is completed, it might not be necessary immediately to provide a new main at Putland Road. The Council, admittedly, has in the past seven or eight years, spent very large Capital sums on the relaying of watermains, but it can be held that this has been a prudent policy, for notwithstanding rise in the population and a large accretion to the number of dwellings in the Urban District it has been possible to keep the consumption of water at a constant level. The replacement of mains and services which were old and defective has cut down waste, whilst at the same time, given a better supply. It is fitting, however, that mention should also be made of the very capable manner in which the Water Inspector and his Assistant have discharged their duties. The work done by these Officers has also helped very much towards reducing consumption and the payments to be made for Bulk Supply of water.

SCAVENGING

There is a rise in the cost of this service, apart from wages increases. It is due to the demands made on the service by the expansion of the Town and the many new dwellings which have been erected, both by the Council and otherwise, in recent years. This demand has been met, however, by the transfer of two men from road and other works to which they had been previously assigned. As mentioned earlier, the construction of new roads has reduced the necessity for repairs and maintenance and it has in consequence, been possible to assign to other services, workmen who previously had almost been wholtime engaged on road repairs. Whereas, formerly repairs to roads were continuously being required, it was also more difficult to keep them in a clean condition.

For some months now the new Refuse Dump at Woodbrook has been in use and the arrangement whereby material was dumped near the Harbour, giving rise to many complaints, has been discontinued. Notwithstanding the increase in population and in number of dwellings, the Council has continued to provide a domestic Refuse Collection service which compares more than favourably with that available in other Towns and Cities. Throughout the entire year a twice weekly collection is available for every part of the Town and during the summer there is a daily collection from the Main thoroughfares on which hotels and Guest Houses are sited.

A second motor vehicle, which is mainly used in scavenging, was purchased by the Council last year. Its cost (£250) is almost completely offset by the reduction in the charges paid for vehicles which were hired in former years.

COVE SWIMMING POOLS

The Council recently agreed to a Scheme for some improvements to the Swimming Pools at Bray Cove, the cost of which would be met to the extent of 75 per cent, by a special Grant from the Irish Tourist Board. The total cost is estimated at £3,000 and the Loan Charge for the Council's proportion of the cost in the coming year would be £80 (charge for half year).

For a number of years past the Council has been paying a contribution towards the cost of cleaning the Pools—a work which is carried out by the Swimming Club to which the Pools are let. For the coming year £75 has been included for this purpose.

MUNICIPAL BATHS.

These Baths normally involve the Council in substantial expenditure on repairs and maintenance each year. In 1955/56 about £200 was spent on them and in previous years the outlay ranged from £200 to £500.

It has now been found that it will not be possible to use the Baths during the coming summer as this part of the Promenade will have to be closed for urgent repairs, which are being carried out to the Sea Wall. It is regrettable that the Sea Front will be lacking this amenity but it will, it is felt, be accepted that the maintenance of the Sea Wall, on which not only the Baths, but the entire Sea Front are dependent, must be given priority.

It was proposed that the Platform and Divine Stage at Municipal Baths should be reconstructed in a more permanent form (i.e. by the use of reinforced concrete and piles) and the Tourist Board had been asked to give a Special Grant towards the cost of the work. This proposal will now, however, have to be postponed owing to the works which are being done on the adjoining Sea Wall.

PUBLIC LIGHTING

The estimate for the coming year is £2,332. The increase of £32 is due to the provision of a small amount of additional lights at Old Conna Housing Scheme. For some years past the Council has been progressively improving the public lighting in addition to providing new lights in new residential areas. There are now 443 public lights as compared with 273 in 1949. There has been a corresponding rise in the cost of this service, which is now £1,200 higher than in 1949. Some months ago it was suggested by the Electricity Supply Board that the Council might consider further improvements in the lighting service. It was found that they would entail an additional cost of £565 per annum. Provision for this improved service has not been included in the Estimate as the Council, thus far, has not taken a decision in the matter.

SEA FRONT IMPROVEMENT SCHEMES

It has been decided to arrange for the erection on Bray Head, of a structure which would contain a Shelter, Public Sanitary Convenience andiosk. The cost is estimated at £5,300 and the Tourist Board has indicated that they would give a Grant of £2,138. The Loan Charge in the coming year to meet the Council's proportion of the cost would be £160. In the full year, however, it would be £320.

NEW SANITARY CONVENIENCES

It has been decided that new Public Sanitary Convenience be provided at the Town Hall; the People's Park (Lr. Dargle Road) and that the Convenience at the Boathouse would be enlarged. The cost of this Scheme is estimated at £1,500 and a Loan Charge of £150 is included in the Estimates.

SEA WALL REPAIRS

The cost of the urgent and very essential repairs which are now being carried out to the Sea Wall is estimated at £20,000. The Council succeeded in procuring a Government Grant of 75 per cent. of the cost and to meet the balance (£5,000), a Loan Charge of £551 is included. This Loan already has been raised from the Council's Treasurer and the Charge now shown is that for the full year.

REPAIRS TO PROMENADE.

Apart from the urgent repairs to the Sea Wall, which are being carried out by the Commissioners of Public Works on behalf of the Council, the Town Engineer has recommended that the Council should replace sections of the concrete slab on the Promenade, which are defective. The cost is estimated at £2,500 and provision is made for a loan Charge of £142.

HOUSING.

The total expenditure is estimated at £59,846; Receipts are £54,375 and the net cost is £5,471. There is an increase in the net cost of £382, compared with last year.

In the present year £1,200 was allowed by the Council for repairs. The original estimate was £1,400 but this was found to be inadequate and the Council has had to vote an extra £500. There was a substantial number of transfers from older houses to new houses, at Old Conna in the past eighteen months, and these involve the Council in additional expenditure on repairs. But aside from the latter type of cost it is considered that the provision made last year for repairs must be regarded as adequate. Consequently, £1,500 has been included for the coming year, which is an increase of £300 over that allowed for 1955/56.

There are increases in Loan Charges but these are offset to a certain extent by receipts from State Subsidies and Rents. New Schemes recently completed have involved the Council in an increased Charge for Housing of about £300. The Scheme of 36 houses at Old Conna was completed in December and this brings the total number of houses erected by the Council since 1947 to 338.

Rates are still payable to Dublin County Council on the houses at Old Conna which are outside the Urban Boundary and this will continue until a decision is given on the application of Bray Urban Council and Wicklow County Council for an alteration of the existing County Boundary. As pointed out when submitting the Estimates last year, Dublin County Council are liable for the provision of certain services to the Occupiers of these houses, such as Health and Assistance, but the Urban Council has to provide Scavenging (Street and Domestic), Public Lighting and pay for water supply to Dublin Corporation.

PROVISION OF CHILDREN'S PLAYGROUND

Last year the Council agreed to provide a new Playground at Boghall which would serve the children in that area. Paths have already been laid and some other works carried out. A Loan Charge of £100 is included to meet that part of the cost which is being defrayed by way of loan.

There was a proposal that special works be carried out at the Playground and Open Spaces at the Old Conna Housing Scheme and to meet Capital costs which might be incurred, Loan Charge of £40 has been included.

SMALL DWELLINGS (ACQ.) ACTS

The Loan Charges (£11,146) are the same as last year but a number of new loans have recently been approved, which thus far have not involved the Council in new Loan Charges. The Charges to the Council are met in full by the repayments from the borrowers and this Scheme does not involve any cost to the Rates. The number of loans advanced since 1948 is 148 and the total amount which has been lent is almost £200,000.

GENERAL URBAN PURPOSES

The expenditure under this heading includes the Demand from the County Council, the special levy of 9d. in the £1 under the Unemployment Assistance Acts, the Vocational Education Demand, the Maintenance of the Esplanade and Parks, the Public Library, School Meals Scheme, Fuel Scheme and many other items.

The total expenditure is estimated at £67,373 as compared with £65,948 for 1955/56. The Receipts are estimated at £4,906, the corresponding figure for 1955/56 being £4,856. The net expenditure for the coming year, therefore, is £62,467, as compared with £61,092 in the present year—an increase of £1,375. The principal increases in the General Purposes part of the Estimate are in respect of County Council Demand revision of salaries and Vocational Education Demand.

TOWN HALL REPAIRS

A sum of £100 has been included to defray the cost of some essential repairs to the Town Hall. Some of the repairs, such as roof valleys are of an urgent character. It should here be mentioned that the Town Hall will be used in September next for the Annual Conference of Municipal Authorities.

TOURIST DEVELOPMENT

Under this heading the same amount as provided last year, viz., £250 has again been provided.

VOCATIONAL EDUCATION DEMAND

For the coming year the Demand is £2,380, being an increase of £228 over that for 1955/56. The rate for this service is now about 11d. in the £1 and has increased by 4d. in the last five years.

PUBLIC LIBRARY

The expenditure on this service shows an increase of £164. It is proposed to purchase additional books for the Juvenile section of the Library, which section continues to show a remarkable increase in membership and book issues. The total number of borrowers at present registered is 3,000, of which number 1,197 are children.

It is evident that this is a Council service which is very much appreciated by the public; the number of registered borrowers and the number of book issues during the year provide ample evidence of this. Another notable feature of the library is that the non-fiction issues nowadays are in excess of this issues of fiction. As mentioned last year, the Council and the Library Committee can feel that they have contributed very materially to cultural activities in the Town and to the enjoyment of leisure by bringing this service to its present very satisfactory level.

ESPLANADE

The total outlay from Revenue on the Esplanade and Public Parks, including Loan Charges and Wages is estimated at £3,136 for the coming year. Reference has been made earlier to the expenditure on the provision of new amenities (Shelter and Public Sanitary Conveniences, etc.) and to the outlay on Sea Wall Repairs and repairs to the Promenade.

For decorative lighting along the Sea Front during the summer months, a sum of £200 is again included. £100 is being included for new Life Lines which would be kept at the Sea Front for use in any emergency. The question of employing Life Guards was discussed by the Council some months ago but if this were to be arranged, an additional £200 (not included in the Estimates) would be required. The Town Engineer has indicated that repairs would be required to the Boat Slip at a cost of £150. This is an increase of £125 over the sum allowed last year.

The cost of a new Concrete Mixer, £150, is shown under the heading of Esplanade, but whilst it would be used in connection with the repairs to Decking of Promenade, etc., it also would be used in the coming and future years for many other Council services. The Council at present has two concrete mixers but both are now worn out and useless.

AN TOSTAL

For flood lighting, provision of flower baskets and other decorations which the Council might provide during An Tostal in May, 1956, the sum of £150 is included. Last year, however, the Council did not make any special provision for An Tostal.

BAND PERFORMANCES

The Council last year allowed £400 for Band Performances. It was intended that this sum would cover not only Band Performances at the Sea Front, but also a limited number in the People's Park, Lr. Dargle Road.

SCHOOL MEALS AND FUEL SCHEME

The Expenditure and receipts for these services are approximately the same as in the present year. The number of householders availing of the present Fuel Scheme is approximately the same as in the present year. The number of householders availing of the present Fuel Scheme is approximately 300 and the average number of children being supplied with School Meals is about 600.

COUNTY COUNCIL DEMAND

This Demand shows an increase of £562 which is equivalent to a rate of 2½d. in the £1. The following figures give a comparison of the Demand with that of the present year, viz.,

The Demand by the County Council from Bray Urban Council for services which are charged over the entire County has been apportioned on a new basis for the coming year. Provision was made in the Local Government Act, 1955, for the apportionment of the cost of such services in the ratio of the actual product of a rate of 1d. in the £1 in each of the Urban Districts and in the County Health District. Originally the cost in question had been apportioned on the basis of the respective gross valuations of the various districts. It had been used for many years by Urban Authorities that account should be taken of the many properties in their area which were non-productive owing to being in a derelict condition or which were only assessed to rates on part of the Valuation (such as new dwellings, etc.). The new method of apportionment makes due allowance for Valuations on which rates would not be payable. It has afforded a considerable measure of relief to the Urban Council in the coming year and if it had not been for this new basis the County Council Demand would be up by 1s. 2d. instead of 2½d.

The cost of the County Council services which are chargeable to Urban Districts still continue to show an increase, mainly owing to the continued rise in the cost of the Health Services—a rising cost which, according to present indications, can certainly be expected to continue in the immediate future.

UNEMPLOYMENT ASSISTANCE ACTS LEVY

The amount to be raised is £1,875 and represents the product of a special rate of 9d. in the £1 which the Council is obliged to levy under Unemployment Assistance Acts, 1933-40. The money so raised is paid by the Council to the Department of Social Welfare.

COMPARISON OF RATES

As mentioned at the outset, the Estimates now submitted for your consideration would require a rate of 36s. 4d. in the £1, which would be an increase of 1s. 0d. in the £1 over that for the present year. It has been shown that in brief the increase is due almost completely to (1) Increases in wages and salaries; (2) the County Council and Vocational Committee Demands; and (3) the provision made for new works. What has become known as "the fifth round" of wages increases had already been allowed in other employments before it was applied to the Council's employees. On this occasion also, the salaried staff of the Council also sought increases—in their case the last increase had been granted four years ago—and it was eventually agreed to allow them the same as had been given to the Civil Service some months earlier. Regarding revisions of rates of remuneration, it is evident that these in any year, will be determined by what has happened in other employments. If employees in industry or commercial undertakings, on the grounds of cost-of-living increases, or for other reasons, obtain rises in remuneration, then local authorities will be obliged to follow suit.

It is not unlikely that once again local authorities will be subject to much censure by critics, who throughout the year seek new and improved services but give the impression in March of each year that the cost of them can be confined from some mysterious source when members try to determine the rate levy. Once more it will be implied, or even charged in strident terms of abuse, that local authorities are lacking in a sense of responsibility to the rate-payers or the electorate. As has often been indicated by them, local authorities are only too glad to receive, and indeed will welcome any practical suggestions which would help in reducing their expenditure and the costs to be met from rates. It is noted, however, that those who refer to existing extravagant and reckless spending never give any indication whatever, as to the items on which it is being incurred. One may, it is hoped, be pardoned for pointing out that any discussion of the level and incidence of local rates, which ignores such issues as the scope and impact of the housing and health programmes, is aimless. Local Authorities could reduce their outlay by building no more houses or hospitals or inadequately maintaining those which they already have. The abandonment of Health Services such as those for the treatment of Tuberculosis or for mothers and children, and a refusal to provide new amenities such as water supplies, sewerage and public lighting would also help to reduce the scale of expenditure. But nobody has suggested such drastic measures.

If such conditions as a stable level of prices and an acceptance of existing living standards obtained, then stability in rates could also be achieved. But local authorities, especially in the conditions which obtain today, cannot completely ignore public needs or the claims for new Services and their difficult role is to try to strike some reasonable balance between the claims they have to meet and the resources which are available. They are not only aware, but frequently stress that the insistent demands for services can only be met either by the levying of additional rates or much greater subsidies from State Funds. It sometimes, however, appears to local authorities that in certain respects local rates are being asked to meet an undue part of the cost of new social welfare arrangements which they are obliged to administer and in large measure to finance, but the nature and ambit of which they have had no part in determining. There still is an impression that local rates are paid in return for Services to be rendered by the local authority such as provision of roads or water, the disposal of sewage or the putting out of fires. Whereas the truth is that a local rate today is in great part, a tax based on the occupation of property which is being increasingly used in endeavouring to apply living (or dying) conditions to the community.

That the foregoing is the case shown by a comparison of the rates for the present year (1955/56) with the years 1938 or 1939. In the present year the rate to meet the cost of Municipal Services (i.e. those administered directly by the Council, such as the construc-
