

The total expenditure is estimated at £68,076, as compared with £67,103 for 1956-'57. The Receipts are estimated at £5,724, the corresponding figure for 1956-'57 being £4,906. The net expenditure for the coming year, therefore, is £62,352, as compared with £62,197 in the present year.

TOURIST DEVELOPMENT

Last year it was agreed that the Council's contribution to the Irish Tourist Association for publicity should be increased from £250 to £300 and the latter sum is included in the attached Estimates.

TOWN HALL REPAIRS

Last year £100 was allowed by the Council for urgent repairs and for the coming year £150 is included. It is intended that this sum should be mainly used for electrical re-wiring as a recent report showed that there were many defects in the present wiring system which could involve a fire risk.

Consequent on the finding of dry rot in the timbers of the Town Hall it was necessary to have the structure examined carefully. The removal and replacement of affected timbers will, unfortunately, be a rather costly undertaking. It is expected that it will be necessary to arrange for a Loan of about £3,000 and £200 has been provided in the Estimates to meet the required Loan Charges.

AN TOSTAL

To meet the cost of flood-lighting, provision of flower baskets and other decorations which the Council might wish to provide during An Tostal in May, 1957, £150 is included. It should be mentioned however, that last year the Council did not make any special provision for this purpose as they felt that outlay on amenities to attract tourists would give a better return later in the year, such as between July and September.

VOCATIONAL EDUCATION DEMAND

The increase in the Demand for the coming year is of a limited character, being £58; in previous years it had been necessary, each year, to meet substantial increases under this heading.

PUBLIC LIBRARY

The outlay on the Public Library shows an increase of £181. In reporting on the Library service to the Library Advisory Committee, the Librarian stated that during the year 1956 a total of over 134,250 books had been issued and of these almost 25% were issued to children. Books of non-fiction represented over 41% of the total issues so that it is evident that the Library can be regarded as a very helpful medium of public instruction. Already over 1,100 children are resorting to the Library and the choice of books by these children shows a surprisingly high standard. The Librarian com-

ments on the care which children take of the books issued to them and gives an impression of their discipline and response in mentioning that it is not unusual to issue between 400 and 500 books in the comparatively limited quarter assigned to Juvenile section. Members will be aware of the remarkable skill shown by the children in the competitions in painting and handicrafts which were arranged at Christmas. Everybody who is acquainted with the wide range and standard of service being provided by the Council's Library will, it is felt, agree with the Librarian when he states that "as an educator and a source of ideas the Public Library has proved its use." A copy of the Librarian's report is also attached to these Estimates.

ESPLANADE

In the coming year provision is being made for new works at the Esplanade estimated to cost £850.

It is proposed to provide new Litter Baskets at a cost of £50; Repairs to footpaths will, according to the Town Engineer, cost £100. In the interests of public safety it is necessary that sections of railings which have been damaged by the sea should be replaced and this will cost £200. It is urged by the Town Engineer that railings and seats along the Promenade should be painted and this work is estimated to cost £500. These were last painted in 1954.

Last year the Boat Slip was repaired at a cost of £150. For the coming year the Town Engineer considers that a similar sum should be allowed and be applied towards the cost of repairing seats.

To meet the cost of Strip Lighting a sum of £210 has again been included.

The total outlay from Revenue on the Esplanade and Public Parks, including Loan Charges and Wages, is estimated for the coming year at £3,383. This does not include cost of the Municipal Baths and Band Performances.

BAND PERFORMANCES

The sum similar to that allowed last year, £400, is included in respect of Band Performances.

FUEL SCHEME

The cost of providing fuel to households which are unable to meet the cost, either in whole or in part, from their own resources, shows an increase of £602. This increase in cost has resulted, it seems, from the automatic issue of fuel docketts at the Post Offices to all recipients of Old Age, Widows' and Blind Pensions. Formerly these persons used to have to call to the Town Hall for the docketts and the new method of issue must have resulted in practically all Old Age Pensioners availing of the Scheme. In 1955-'56 the number of householders resorting to this Scheme, on an average, was 320 but in the present year it has risen to 430. The additional costs are recouped in full from State Funds.

SCHOOL MEALS

The cost of providing School Meals is expected to be the same as in the present year. The average number of children supplied with meals at present is about 600.

COUNTY COUNCIL DEMAND

It is unusual to record that there has been a reduction in the Demand from the County Council. For the coming year it will be less by £1,154, which represents a rate of about 5½d. in the £1. The following figures give a comparison of the Demand with that for the present year:

COUNTY COUNCIL DEMAND

It was mentioned last year that the revised methods of apportioning the cost of services which are charged over the entire County had provided much relief to Bray Urban Council. Where formerly the cost had been apportioned on the basis of the respective gross valuations of the Urban Districts the new method of apportionment makes allowance for Valuations (such as new dwellings, derelict properties, etc.), on which rates would not be payable in full or might have to be declared irrecoverable. It could be taken that this new method of apportionment has reduced the amount of the Demand in the past two years by about 1s. 0d. in the £1. But apart from the result of the new system of apportionment, there has been a reduction in the cost of the services provided by the County Council which are chargeable to Bray Urban Council especially under the headings of Public Assistance, Mental Hospitals and Health Services.

UNEMPLOYMENT ASSISTANCE ACTS LEVY

The amount to be raised is £1,897 and represents the production of a special rate of 9d. in the £1 which the Council is obliged to levy under the Unemployment Assistance Acts, 1933-40. The money raised is paid by the Council to the Department of Social Welfare.

THE LEVEL OF RATES

In submitting the Estimates each year it has been the practice to give figures showing current rates for Municipal Services, i.e., those provided and controlled directly by the Council, and the rates which were levied in 1938-'39—the year from which money values and the Social pattern began to take on a profound change. Once more it is felt that it might be of interest—at least to some—to give such a comparison. The Municipal Services administered directly by the Council include the construction and maintenance of roads, the water supply, sewerage, public lighting, housing (under which also comes the rather complex administration of the Small Dwellings Act Loans Scheme), Street Scavenging, collection and disposal of domestic refuse, vocational education, public library, School meals, baths, public sanitary conveniences, tourist development and Seafront amenities. The estimate for these services in the present year is equivalent to a rate of 17s. 9d.; in the year 1938-'39 and those immediately prior to it the levy for this purpose was on an average 14s. 0d. The increase in this part of the rate, therefore has been about 26%.

The balance of the rate to be raised by the Council is for the County Council Demand and the special levy imposed under the Unemployment Assistance Acts. The County Council Demand for the coming year is £42,690 and of this over £30,000, that is almost three-fourths, is for Social Services, namely, Health, Mental Hospitals and Public Assistance (even though the latter item is now comparatively small). The expansion of the Social Services was a matter determined by legislation which was presumably sought by the Electorate. One hears much criticism of the level of rates, but nothing of the causes, the main one, apart from rising prices and scales of remuneration which affects the running costs of all organisations, being social legislation. As often mentioned in previous Reports on the Estimates, any criticism of the level and incidence of local rates which ignores such fundamental issues as the scope and impact of the health and housing programmes seems fruitless. Local authorities readily could curtail outlay by building no more houses, hospitals or by inadequately maintaining those in their charge. The assumption by the State, as in Britain and Northern Ireland, of practically the entire cost of the Health Services would also ease the burden of local rates. It is notable, too, that throughout nine months of the year, from April to December, local authorities are being urged to provide more services such as better roads, housing, water supplies, sewerage and further public lighting, but in February and March there is strident criticism of costs. It is not infrequent for local authorities to find people who think that public services—whether they be in hospital or home—should be withheld until they themselves seek them. To-day courthouses and Town Halls are being crowded by people who clamour for stability in rates. But may one politely suggest that such deputations might perhaps have

achieved more if sent elsewhere when social legislation, such as the Health Acts, was being passed. It also seems to be overlooked that local authorities are bound to be affected by items such as rising prices and scales of remuneration. In this County in the present year it has been possible to submit Estimates which show little change from those of last year but this is mainly due to a certain stability in price and wage levels and to a halt in the continuous expansion of the Health Services. It is felt necessary to dwell once again on these matters as there is a very grave danger that uninformed criticism, which ignores so many basic considerations may seriously impair the prestige of local administration which after all has had no mean record in the past thirty years. It might moreover, happen that men of proved capacity and integrity may be discouraged from taking an active part in local affairs—there have been such results in other countries—and this would be a deplorable outcome. Might one even suggest that local authorities may have progressed too rapidly in improving the services for which they are responsible, and that too much of the capital wealth of the nation has been entrusted to them for capital works of a Social Character—capital works which so frequently are looked on primarily as immediate sources of employment, but which do not contain the potentialities of future and continuous employment. Houses built to a standard pattern intended to accommodate a standard family are nowadays, especially in rural areas, probably beyond accommodation requirements in many instances; they are, it seems, of an appreciably higher standard than in many other European countries apart from Britain. Again roads, which so often carry rather limited traffic, are maintained to a higher standard than obtains elsewhere. To-day in some respects we may have almost gone too far in the building of hospitals. Some of this possibly excessive diversion of capital resources to the activities of local authorities is probably due to viewing them almost completely in the light of the quantum of employment which they will immediately afford. The examination of these matters might, it is humbly suggested, lead to more fruitful results than vague censures of public representatives who give much time and consideration (an unpaid service) to the Sisyphean task of meeting increasing demands from restricted resources.

To the Chairman and Members of the Council I desire once again to express my sincere appreciation of the guidance and assistance always available in endeavouring to solve so many municipal problems and this affords me the opportunity of expressing the sincere hope that the Chairman, Mr. E. E. Byrne, may soon be restored to health.

All members of the Council staff, both indoor and outdoor, gave diligent service during the past year. For the preparation of these Estimates valuable help has been given by the Town Clerk (Mr. McCarthy) and Town Engineer (Mr. Healy). But it is only fitting

that special mention be made of the Accountant (Mr. McDonnell) who keeps the accounting records with great care, and devotes so much thought and zeal to the state of the Council's finances.

The net requirements to be met from rate Levy as above are £92,146. Credits of £624 are available, which can be applied to reduce the amount to be raised by Rate Levy in the year 1957-'58 to £91,522.

Municipal Rate of 1d. in £1 produces £212 7s. 0d.

Rate in the £1 to meet the net expenditure of £91,522 is 35s. 11d.

URBAN ROADS

The estimate, as presented, was passed — a proposition by Clr. Dempsey that a sum of £50 for roadside tree planting be deleted having been defeated by seven votes to five. A proposition by Clr. Dempsey that no new road works be carried out this year was defeated by nine votes to three.

SANITARY SERVICES

The estimate for Sanitary Services was amended as follows:

Repairs to Cove Swimming Pools—£25—deleted

It was decided to ask the Irish Tourist Association Officials to a Conference with the Council to discuss the erection of a kiosk for Tourist information.

A proposition by Clr. Stuart that the Tourist Association contribution of £300 be reduced to £200 was defeated by eight votes to four.

HOUSING

The estimate presented under this heading was adopted. The Manager, however, was asked by the Council to examine (1) the question of raising rents when new tenancies were being granted, and (2) effecting a sale of the houses to the tenants.

GENERAL URBAN PURPOSES

The estimate under this heading was adopted with the following amendments, viz., a sum of £150 for An Tostal was deleted and it was decided to reduce the Engineer's estimate for painting from £500 to £250. It was agreed that £250 should be again expended in the next financial year under this heading. During discussion of this heading, tributes were paid to Miss O'Byrne and the Library Committee for their excellent management of the Library. The Town Clerk however, was asked to go into the question of the feasibility of increasing the charge for membership of the Library.

Clr. M. O'Toole suggested that strip lighting might be placed on the kiosks. It was agreed that the Engineer examine this matter and bring it before the Council at a future date.

837. On the proposition of Clr. Mrs. Ledwidge, seconded by Clr. T. Byrne, it was decided to seek the sanction of the Minister for Local Government to the raising by the Council of overdraft accommodation from Council's Treasurer in a sum not to exceed £20,000 for the period ending 31st July, 1957.

RESURFACING OF ROADS—LOAN £2,500.

838. On the proposition of Clr. D. Sayers, seconded by Clr. Dr. Donnelly, it was decided to seek sanction to the raising by the Council of a Loan of £2,500 for the resurfacing of roads—Dock Terrace, St. Laurence's Tce., and Herbert Road.

On the proposition of Clr. Dr. Donnelly, seconded by Clr. D. Sayers, it was decided to seek a Grant from the Department for the carrying out of further work on footpaths and roads and to inform them of the rather large capital sums which had been spent by the Council in recent years on works of this nature.

PEDALO WATERCRAFT.

839. The Chairman recommended it was best not to read a letter from Mr. R. J. Merlihan re Pedalo Watercraft.

AMUSEMENTS SITE AT ESPLANADE.

A letter was read from Mr. T. J. Moloney, Ashdale Gardens, Terenure, offering £50 for Amusement site at Esplanade. The Engineer recommended that the offer not be accepted and the Council concurred with the recommendation.

SHRUBS ON ESPLANADE.

841. A letter was read from Marlfield Nurseries stating that they would be glad to supply about one dozen shrubs set in tubs for the Esplanade for a limited period this year. The Council expressed their gratitude for the public-spirited manner in which this firm had met their request.

HUTS AT HARBOUR.

842. The Town Clerk read a letter from Mr. J. Nolan and seven others protesting against the letting of these huts and claiming that they should be placed at the disposal of the writers. After a discussion it was decided to open the five tenders received, which were as follows:

865.—The Council directed the Town Clerk to extend their heartiest congratulations to (1) Ladies' Section, Knights of Malta, on their recent triumph in Limerick, and the firm of Mr. H. J. Byrne, Auctioneer and Valuer, on completing one hundred years as Auctioneer and Valuer in the town of Bray.

Newry Band.

866. The Council concurred with the decision of the Chairman and Town Clerk in granting permission to Newry Amateur Silver and Reed Band to give a Recital on the Bandstand, Esplanade, between the hours of 3 and 5 p.m. on 30th June.

Sale of Flags.

867. The following applications were received for permission to sell flags on the Esplanade:

1. Sisters of Charity, Ravenswell Convent.
2. National Council for the Blind.
3. St. John's Ambulance Brigade.
4. Irish Red Cross Society.

It was decided to grant them permission to sell flags at the various entrances to the Esplanade but not on the Esplanade proper.

Seating at Esplanade.

870. After a discussion on a suggestion from the Bray Amusements Committee that seating facing the town and sun be erected on the Esplanade, the matter was adjourned, with recommendation that next season the question of such seating be discussed with whoever received the Licence for Deck Chairs on the Esplanade.

Pedalo Watercraft.

871. An Application from Mr. P. Murray, 5 St. Patrick's Square, for licence to operate three Pedalo Watercraft was recommended on the same conditions as those entered into with Mr. R. J. Merlihan.

Café and Shelter at Bray Head.

872. The Council considered a letter of 22nd May, 1957, from Coras Iompair Eireann stating that they would not waive the condition of the letting on Bray Head that of 40% of receipts be paid to them; but, however, that they would be prepared to pay 40% of the Loan Charges, with the stipulation that where the revenue from letting was less than the percentage of loan charge, such amount only be contributed. The Council, after lengthy discussion, decided that Coras Iompair Eireann be asked to make a definite Lease of Bray Head Park to the Council.

Civil Defence.

873. The Council agreed, in principle, to hold a Public Meeting to stimulate recruiting for Civil Defence and left details in the hands of the Officials.

Public Transport Development Association—Future of Coras Iompair Eireann.

874. The Council considered a letter from above Association seeking Council aid in endeavour to oppose any curtailment of Coras

lompair Eireann service. The Council, while viewing the efforts of the Association with sympathy, decided that any action by them at this stage would be inopportune and injudicious.

Working Hours—Council Employees.

875. The Town Clerk informed the Council that a letter had been received from the Irish Municipal Employees Trade Union seeking a reduction of working hours for the Council's employees. The Council felt that they could not recommend any such reduction.

Smaller Type Houses.

876. Letter from the Department of Local Government on the question of erecting smaller type houses was adjourned to the next Meeting.

Proposal to Purchase House at rear of St. Anne's, Strand Road.

877. The Town Clerk informed the Council that Mr. Bateman was prepared to sell the house at the rear of St. Anne's, Strand Road, for the sum of £500. This also would entail rehousing a family named Buckley who were tenants therein.

The Council decided that the price was much too high and suggested that no action be taken in respect of either that house or "St. Anne's."

Election of Chairman.

886. Proposed by Clr. T. Byrne, seconded by Clr. G. H. G. Stuart, that Clr. H. B. Hipwell be elected Chairman for the year 1957-'58.

Proposed by Clr. P. Savage, seconded by Clr. D. Savers, that Clr. Dr. Donnelly be elected Chairman for the year 1957-'58.

On a vote being taken the following voted for Clr. Dr. Donnelly, viz., 7:—Clrs. E. Byrne, P. Dempsey, Dr. Donnelly, C. Doyle, M. O'Toole, P. Savage, and D. Savers.

There voted for Clr. Hipwell, viz., 3:—Clrs. T. Byrne, H. B. Hipwell, and G. H. G. Stuart. Clrs. Mrs. Ledwidge did not vote.

Clr. Dr. Donnelly was accordingly elected Chairman and took the chair.

Outgoing Chairman.

887. On the proposition of Clr. D. Savers, seconded by Clr. Mrs. Ledwidge, the Members voted thanks and tribute to Clr. E. E. Byrne for the manner in which he had conducted the affairs of the Council as Chairman during the past year. All the members present associated themselves with the vote and Clr. E. Byrne returned thanks to the members and officials for their co-operation with him during the year.

Élection of Vice-Chairman.

888. Proposed by Clr. E. Byrne, seconded by Clr. Mrs. Ledwidge, that Clr. P. Savage be elected Vice-Chairman for the year 1957-'58. There being no other proposition, Clr. P. Savage was declared elected.

Appointment of Delegates to attend Conference of Municipal Authorities.

889. The following proposals were made for the election of two delegates to attend the Annual Conference of Municipal Authorities, to be held in September next, in Buncrana, viz.:

Clr. D. Savers—Proposed by Clr. M. O'Toole, seconded by Clr. Dr. Donnelly.

Clr. P. Savage—Proposed by Clr. E. Byrne, seconded by Clr. Mrs. Ledwidge.

Clr. H. B. Hipwell—Proposed by Clr. T. Byrne, seconded by Clr. Stuart.

Clr. Mrs. Ledwidge—Proposed by Clr. C. Doyle, seconded by Clr. P. Savage.

On a vote being taken Clr. D. Savers received nine votes; Clr. P. Savage received five votes; Clr. Hipwell received five votes, and Clr. Mrs. Ledwidge received three votes. Clr. Mrs. Ledwidge was eliminated and a second poll resulted as follows, viz.:

Clr. D. Savers—11 votes.

Clr. H. B. Hipwell—6 votes.

Clr. P. Savage—5 votes.

Clrs. D. Savers and H. B. Hipwell were accordingly declared elected as delegates to attend the Conference with the Town-Clerk.

Pedalo Watercraft.

890. A letter from L. Kearon, Solicitor, sought Council's permission for Mr. R. J. Merlihan to put three further craft in operation as from 7th July, 1957.

Clr. H. B. Hipwell proposed, and Clr. G. H. G. Stuart seconded, "that permission be granted as sought."

Clr. M. O'Toole proposed that no permission be given until a local man, to whom the Council recently had given permission to operate three craft, had in fact put these craft into operation.

After lengthy discussion the Council agreed with the suggestion of the County Manager that they get legal advice on the terms of the Licence.

Lighthouse, Life Buoys, etc.

891. The Town Engineer reported that the light at the Lighthouse in the Harbour was out of commission but that Irish Lights had been asked to supply a new lamp which the Council would light. He further reported continual thefts of ropes from life

buoys and an extraordinary number of broken bottles being left on the seafront. The following suggestions were made as remedies for the matters complained of, viz.:-

Life Buoys—Clr. T. Byrne suggested that the life buoys might be enclosed in somewhat the same manner as fire extinguishers in public places. Clr. P. Dempsey suggested that the St. John's Ambulance might be asked to use their loud-speaker to make occasional appeals to the public to observe a sense of propriety in the matter of broken bottles. Clr. D. Sayers suggested that all public organisations in the town should help in this matter and strive for a better public spirit. Clr. M. O'Toole suggested that appeal be made also to fishermen for their co-operation.

Insignas of Office—Council Chairman and President of Association of Municipal Authorities.

892. The Town Clerk gave particulars of quotations received in this regard. It was suggested that he get in touch with a third firm, whose agent was Mr. H. James 2 Maretimo Villas, Bray. It was then decided, on a proposal of Clr. E. Byrne, that the Town Clerk be authorised to make the purchase as soon as possible.

Civil Defence Circular—Issue of Badges.

893. The Town Clerk read a lengthy Circular dealing with issue of Badges on payment to members of the Civil Defence. The Council, on the proposition of Clr. P. Dempsey, decided to refer the Circular back to the Department of Defence and express the view that Badges of this nature should be issued free of charge to a Volunteer Force.

Overdraft Accommodation.

894. On the proposition of Clr. Mrs. Ledwidge, seconded by Clr. M. O'Toole, the Council resolved to seek an extension of Overdraft Accommodation on the Capital Account in a sum not exceeding £4,500 to 30th September, 1957.

Band Performances.

895. Clr. E. Byrne complained that on two recent occasions the Bands engaged at the Esplanade did not seem to be giving full value for money inasmuch as there were only a relatively small number of performers. The Town Clerk informed the Meeting that he had taken the matter up with one of the Bands concerned and would write to the second one also. The Council decided to engage a Band for the Esplanade on the evening of Saturday, 13th July, to coincide with the opening of Civic Week, if the local Amusements Committee were unable to procure one themselves.

Sign at Quinsboro' Road.

896. The Town Clerk informed the Meeting that a sign had recently been erected on Quinsboro' Road between Messrs. Drennan and Burkes shop, indicating "Tourist Bureau," and that Mr. Drennan had protested at the location of the sign. The Council decided to take no action in the matter.

Esplanade Miscellaneous.

(1) Application by Messrs. E. W. Hosey & Sons, 4 Belton Tce., for a site on the Esplanade to sell Candy Floss was refused.

(2) Permission was granted to the Kilbride and Boghall Nursing Association to hold a Produce Sale on the Esplanade on 17th July.

Bray Head Park—Sale of Minerals.

898. Clr. P. Savage stated he had heard that some person had been selling minerals on Bray Head on recent Sundays and it was rumoured that a kiosk was to be erected in the area. It was decided to have the matter investigated.

Kiosk—Fontenoy Terrace.

899. It was decided to ask the Health Officer to investigate this kiosk to ascertain if it complied with the Food Hygiene Regulations.

Vote of Sympathy.

900. On the proposition of Clr. E. E. Byrne, the Council extended their sincere sympathy to Mrs. Nolan on the tragic death of her son in a recent motor race.

People's Park—Little Bray Civic Association Festival.

901. On the proposal of Clr. C. Doyle, the Council granted permission to above Body to hold their Festival in the People's Park from 21st July, 1957, to 5th August, 1958.

Grant for Roads.

902. Letter from Department of Local Government (R241/1) stated that the Minister had no funds at his disposal with which to make a Grant for improvement of Urban Roads and Footpaths in Bray. It was decided to re-apply for the Grant and to seek the good offices of Clr. J. O'Toole, T.D., in the matter.

Vacant House—26 Wolfe Tone Square South.

The Council concurred in the recommendation to transfer Mr. Prender, but decided to defer consideration of the second recommendation to the next Meeting, and asked that at that Meeting particulars of applicants whose names were on the A and B lists in 1955 be circulated for their consideration.

11 O'Byrne Road.

904. The Town Clerk read a letter from Mrs. A. Forde, 21 St. Peter's Road, stating that her husband was leaving for Canada on 29th June, and it was her intention, if permitted, to give up possession of 21 St. Peter's Road and go to live with her mother-in-law in 11 O'Byrne Road. The Town Clerk reminded the Meeting that the Council had received a Court Order for possession of 77 O'Byrne Road, and suggested that the Forde family might remain in 21 St. Peter's Road, while 11 O'Byrne Road could be used to re-house an applicant on the waiting list. Several members expressed the opinion that the Forde family be allowed to occupy 77 O'Byrne Road, and it was finally decided to discuss the matter fully at the next Meeting, in conjunction with the vacancy at 12 Wolfe Tone Square West.

907.
