The County Manager and the Town Engineer indicated that the Scheme was a most commendable one and would provide increased accommodation for shelters on the Seafront. 799.—TOWN CLERK

The Chairman and members welcomed Mr. McCarthy, Town Clerk, on his return to duty after illness. Mr. McCarthy thanked the members for their welcome and their kindness during his illness.

800.—CONFIRMATION OF THE MINUTES.

The Minutes of the Monthly Meeting of the 14th November were confirmed, it having been first decided to record the fact that Councillor McAuliffe had, at that Meeting, dissented from Council's approval to plans for reconstruction of Municipal Baths (Minute No. 788).

801.—COUNTY MANAGER'S ORDERS.

County Manager's Orders Nos. 8500 to 8506 were noted. Arising out of Order No. 8500—Clarke, 5 Sutton Villas, some of the members felt that the family should be provided with a house while the repairs were being carried out. During the course of the discussion the Chairman gave, as his opinion, that all documents, records, etc., in connection with Manager's Orders current, should be available at the Council's Meeting.

802.—AMUSEMENTS COMMITTEE—BAND STANDS.

The Council granted permission to the above body to use the Central and Southern band-stands in the 1962 season, when not otherwise required.

803.—PURCHASE OF LAND AT OLD CONNA.

The Town Clerk informed the Meeting that the representatives of the owners of this land had written to the effect that they would not be prepared to sell the whole field, i.e., $8\frac{1}{2}$ acres. After discussion it was decided to offer a sum of £2.000 for the $3\frac{1}{2}$ acres originally sought and the owners be responsible for erecting a boundary-wall or fence.

804.—HOUSING—NOTICE OF MOTION, COUNCILLOR McAULIFFE.

At the request of the Chairman, Councillor McAuliffe agreed to adjourn his Notice of Motion re, housing, and was granted leave to bring it forward at any time.

805.—CIVIL DEFENCE.

The County Manager gave the members a short report on the present position of Civil Defence in Bray, informing them that there were at present one hundred (100) active members, but pointed out that the Warden and Welfare sections were under-strength. It was decided to ask Mr. Brophy, Civil Defence Officer, and some of his officers to attend the next meeting of the Council to discuss Civil Defence generally.

806.—ALBERT WALK.

After a lengthy discussion on the question of the necessity for carrying out improvements in the Albert Walk it was decided to ask that Mr. Yates, C.I.E. Engineer, and Mr. Healy, Town Engineer, would have further discussion on the matter.

807.—LEASE OF HAY AND STRAW MARKET.

The Town Clerk informed the members that the Pembroke Estate had offered the Fee Simple Interest of the above property to the Council for £210. He, however, stated that at present the Council, by the terms of the Agreement with the Estate, incur no loss, but were bound to obtain the permission of the Estate before erecting any structures, etc., on the ground in question. It was decided to recommend that £25 be offered the Pembroke Estate for the Fee Simple Interest in the property.

808.—OUTDOOR STAFF—APPLICATION FOR INCREASE IN WAGES

It was decided, as per custom, to refer the above application to the sub-committee recently appointed to deal with wages,

809.—PUBLIC LIGHTING—ROYAL MARINE PARK.

The above matter was adjourned, pending reply from the residents as to what contribution they would make to the erection of Public Lighting in their area.

810.—ROAD IMPROVEMENT GRANT.

The Engineer submitted a report stating the works carried out with the grant and that, due to the necessity for a surface-dressing at Car Park, on the northern end of the Esplanade, there was an excess expenditure on the works programme of £177. On the proposition of Councillor Sayers, seconded by Councillor Mrs. Ledwidge, the excess expenditure was approved. Arising out of this item, a rather lengthy discussion took place on the laying off of men on the current relief works, and their subsequent re-employment at temporary demolition work. The Town Engineer explained to the meeting that the men were left off because of the fact that the Relief Scheme finances would not allow thm to be kept in employment. It was further pointed out that when they were re-employed they were taken on at the standard rate paid to the regular employees of the Council.

832.—CONFIRMATION OF MINUTES.

The Minutes of the Monthly Meeting of January 9th, 1962, which had been circulated, were confirmed.

833.—COUNTY MANAGER'S ORDERS.

County Manager's Orders Nos. 8515 to 8522 were noted.

834.—11, O'BYRNE ROAD.

On it being intimated that recommendation had been received that a tradesman be appointed tenant of 11, O'Byrne Road, it was decided, on the proposition of Councillor E. Byrne, seconded by Councillor M. O'Toole, that the basic rent on this house would be increased by 50 per cent. and that the Town Clerk would prepare a report on rents to be discussed at the next meeting of the Council.

835.—BRAY SEA ANGLERS—HARBOUR.

A Deputation of three members of the Bray Sea Anglers was received by the Council. Their spokesman, Mr. Messitt, said they desired three things:

- (a) Removal of obstruction at the mouth of Harbour.
- (b) Repair of the slipway at the Harbour.
- (c) They wish to lease a site of 30 square feet at Dock Terrace to build thereon a boathouse and clubroom

The Chairman informed the Deputation that he had been discussing this matter with Bord Failte; who were now prepared to facilitate erection of boathouses and pavilions in Dock Terrace for the Sea Anglers and the Bray Sailing Club and he felt that grants in aid of the project would be forthcoming to the Council from Bord Failte. He suggested that the Deputation prepare an inexpensive plan of their proposal and discuss it with the Town Engineer. The Deputation then withdrew.

836.—GROUND RENTS COMMISSION.

A request from the Ground Rents Commission sking for the Council's views on Ground Rents gave rise to a discussion during which the following points were made:-

- (1) That the Council approved of nominal ground rents—say £1 per year which gave Local Authorities certain control over groups of houses.
- (2) That they were of opinion that ground rents should be reduced to a nominal figure after the original capital gutlay had been recouped to the owner of the lands.
- (3) That they were strongly opposed to a ground Landlord increasing the rents when renewing the lease.

The Council's delegates to the Municipal Authorities Association were instructed to kring forward these points.

837.—SPEED LIMIT.

On the proposition of Councillor E. Byrne, seconded by Councillor D. Sayers, with Clr. McAuliffe dissenting, the Council adopted a report of a joint meeting of Garda Officers and Council Engineers, recommending that the 30 miles per hour speed limit replace that of 25 miles per hour in the Bray area.

838.—ANNUAL ESTIMATES MEETING.

Thursday, March 29th, was fixed as the date for the annual Estimates

839.—REVISION OF SALARY—TOWN ENGINEER.

On the proposition of Councillor Sayers, seconded by Councillor Hunt, the Council unanimously recommended that the Town Engineer's scale of salary be fixed at £1,350 by 57 to £1,635 per annum, Mr. Healy to enter the scale at the maximum with effect from the 1st August, 1960. The necessary excess expenditure to implement the reccommendation was also voted.

840.—GAMING AND LOTTERIES ACT—DAWSON.

The Council ha,ving heard reports from the Fire Officer and Health Officer, made no objection to the above application.

841.—CAR PARKS.

The Council, having considered the Town Engineer's report on parking, authorised the Town Clerk to enquire what the owners of Galtrim House and Novara Field would be prepared to sell their properties for.

842.—OFFICE FIELD.

The Town Clerk read the report of a meeting between the Chairman and officials of the Council and the Earl of Meath regarding the above. It was decided to renew the eleven months letting of the field and to prepare a plan for a pavilion to be sited on the rear access road

843.—DERELICT SITES—UPPER DARGLE ROAD.

On the proposition of Councillor Mrs. Ledwidge, seconded by Councillor Sayers, it was unanimously agreed in principle to lease a small plot of ground acquired some years ago by the Council under the Derelict Sites Act to a Mr. Ravely, owner of "Kimberley'. for £5 per annum

844.—BORD FAILTE—AMENITY SCHEMES.

A letter was read from Mr. Gordon Clarke of Bord Failte, stating that the Board's Architect, Mr. Fox, had the contract documents for the erection of 'bus shelter and toilet accommodation and shops at the boathouse ready for approval. The estimated cost was £6,500. Mr. Clarke's letter then went on to suggest that this work and the re-development of the Municipal Baths (Estimated cost, £10,000) be taken together from a financial viewpoint and that the Council meet 50 per cent, of the cost. He further stated that the Board would require the Council to guarantee that any profit derived from the projects be applied to:

(a) Upkeep and maintenance.
(b) Further development of Tourist Amenities and facilities for

The County Manager pointed out to the Meeting that the Council's share of the costs was estimated at £8,125 and that, depending on the Loan facilities available, the annual expenditure would be between £700 and £800. Councillor Stuart and other members expressed surprise at the Council being asked to contribute 50 per cent. as they had understood from previous discussions and correspondence that the Council's contribution to Amenity Schemes would only be about 20 per cent. The County Manager explained to the Council that the Council's contribution would be 20 per cent. of the comprehensive scheme and after further discussion the Council, on the proposition of Clr. and after further discussion the Council, on the proposition of Clr. E. Byrnes, seconded by Clr. Hunt, with Clr. McAuliffe dissenting, resolved that the provisions set forth in Mr. Clarke's letter of 8th February be agreed to, on the clear understanding that the costs now being met by the Council would be reckoned in collecting the total contribution of 20 per cent. of the comprehensive scheme, and in addition to the monies already spent by the Council in erecting shelters, clearing and demolishing properties, etc. The members authorised the efficials to make arrangements either with the Commission of Works er the Hibernian for a loan under the best possible terms.

845.—WAGES APPLICATION—OUTDOOR STAFF.

The Council considered a letter from the Transport Workers' Union stating that their members employed by the Bray Urban District Council would not accept the recent offer of 12s. 6d. per week. Members generally expressed their surprise and disappointment at the attitude of the Union in this matter and on the proposition of Clr. Hopwell, seconded by Cir. E. Byrne, it was recommended that the Manager and the Union should have further consultations, it being pointed out that if this were not successful the Union could approach

846.—ESPLANADE LEASE.

The Town Clerk informed the meeting that the Draft Lease submitted by the Solicitors of the Meath Estate was not satisfactory in as much as the Meath Estate had stipulated in it that the Council should have to seek permission for any addition, erection or alteration to any structure, etc., on the seafront. It was decided that the officials of the Council and their Legal Adviser hold a consultation with the Meath Estate and their Legal Advisers on the matter. The Chairman of the Council to attend if possible.

847.—ACQUISITION OF LAND AT OLD CONNA—GORHAM'S ESTATE

The Town Clerk informed the meeting that the Gorham Estate would not accept their offer of £2 000 for 34 acres of land, the estate to be responsible for building the wall. After some discussion it was decided to offer the Estate £500 per acre and to hold discussion with them regarding the building by the Council of a wall which would not cost the £1,200 estimated to be the cost of the type of wall now sought

848.—S.D.A. LOANS—APPLICATION.

The Council recommended that the Loan of £1,480 be made to Dermot P. Maloney, 1 Brabazon Cottages, in respect of a house proposed to be erected by him on Vevay Road, subject to his complying with the customary conditions and in accordance with the Council's Scheme under the S.D.A. Acts.

549.—TOWN PLANNING PROPOSALS.

(a) Bray Enterprises, Ltd.—Development of Barry's Field.

The Council approved in principle the Development of Barry's Field as per plan submitted under cover of letter date 11th December, by Mr. Maguire, Architect, on condition that the proposal outlined therein to erect a sectional timber concert hall not being proceeded with as the Council was not prepared to give permission for this.

(b) Application by Casino Amusements Theatre, Ltd., for permission to erect a large neon sign on the forecourt of their premises at 110-111 Strand Road, Bray. Recommendation from Town Engineer that permission be refused on the grounds that the sign would be in front of the building line, that it would constitute a sky sign and that that it would be injurious to the amenities of the area.

The Council agreed with the Town Engineer's recommendation but suggested that he have a discussion with the applicants in the matter.

(c) Application from Patrick J. Forde for permission to erect a bungalow at Raheen Park, Bray.

The Town Engineer expressed himself as not entirely satisfied with the plan submitted. It was recommended that the matter be dealt with by the officials.

850.—PALERMO HOUSING SCHEME.

874.—Rent Increase.

The meeting considered at length proposals for an upward revision of rents. The Town Clerk gave figures showing that in the last financial year monies expended on repair of houses had exceeded the estimate of £1,500 by £1,300 and that in the current financial year the sum of £2,000 would be expended on repairs. A scale of suggested increases ranging from 2/6d. per week on the lower rental houses to 1/- per week on houses whose rents ranged between 10/6d. and 12/- was placed before the members. The implementation of this would, it was estimated, increase the revenue of the Council by some £2,600 per year. The members, however, favoured an increase based on the number of rooms per house.

On the proposal of Clr. Hipwell, seconded by Clr. M. O'Toole, it was re-olved that no all-round increases would be made in the group 3 schemes (i.e., those built by Messrs. Dodd & Sons, rented at 16/- and 17/- per week).

After further discussion it was proposed by Clr. Hunt and seconded by Clr. J. Byrne, that an increase of 4d. per room be imposed on all schemes except the above-mentioned. Clr. E. Byrne proposed and Clr. D. Sayers seconded, that the increase be 3d. per room. On a vote being taken the proposal of Clr. E. Byrne was carried by seven votes—Clrs. E. Byrne, C. Doyle, Mrs. Ledwidge, H. L. McAuliffe, M. O'Toole, D. Sayers and J. Temple, to three votes—Clrs. J. Byrne, H. B. Hipwell and F. G. Hunt. On the proposal of Clr. E. Byrne, seconded by Clr. D. Sayers, the Town Clerk's report of the 27/2/1962, regarding increases on relettings, etc., was unanimously adopted. It was further agreed that increases imposed under both heads come into effect on the first gale day in the month of May, i.e., May 5th, 1962. The allround increase of 3d. per week not to be applied where increases have been made on re-lettings to date.

875.—Land for Houses—reps. Gorham.

The Council, having heard from the Town Clerk that the agents for the Reps. Gorham would not consider an offer of £500 per acre for 3½ acres of land at Palermo with the Council to be responsible for erecting a suitable wire mesh fence, decided, on the proposal of the Chairman, seconded by Clr. 878—Improvements at Seafront:

(a) Extension at Boathouse.

The following tenders for the proposed shelter and extension of public toilets at Esplanade were considered by the Council: Mr. E. Finucane, Quinsboro Road, Bray-18,280.

Wm. Clarke & Co., Abbey Street, Wicklow-£9,994 18s.

J. J. Smith & Co., St. Theresa's Rd., Crumlin, Dublin-£11,242 13s. 6d.

Having examined the tenders, Mr. K. Fox, Bord Failte, and the Town Engineer, recommended acceptance of the lowest tender. It was indicated by Bord Failte that they would contribute one half of the cost of the above works.

It was proposed by Clr. J. Byrne and seconded by Clr. D. Sayers, that the tender of Mr. E. Finucane, in the sum of £8,280, being the lowest, be accepted.

On the proposition of Clr. Hunt, seconded by Clr. Hipwell, it was agreed to raise a loan of £4,300 for a 15 year period from Council's Treasurer, for the purpose of defraying costs of the above work. Clr. McAuliffe dissented

(b) Acquisition of property at "Island," Strand Road.

Consequently, there would have to be resort to Compulsory Acquisition.

The Council noted position and agreed that in the circumstances Compulsory Acquisition of the property was to be sought.

879-Wages Application-Outdoor Staff.

On the proposition of Clr. McAuliffe, seconded by Clr. Hunt, the Council unanimously accepted the recommendation of the sub-committee who met the Union representatives to discuss the wage claim of outdoor staff. The recommendation was that an increase of 12s. 6d. already offered be increased to 17s. 6d. per week with effect from 1st January, 1962, and that the Unions concerned be notified of Council's decision.

It was indicated by the members that this would bring the total increase in wages to the outdoor staff, from April 1st, 1960, to 25/- per week. The Council also authorised the necessary excess expenditure resulting from the above revision of wages.

880—Bray Chamber of Commerce.

The Council decided that the committee appointed to the I.D.A. would arrange a meeting at Town Hall, Bray, on 17th April, 1962, at 8 p.m.

881-Small Dwelling (Acq.) Acts-Application.

Application from Mr. A. Byrne of Villa Maria, Dargle Road, to transfer his interest to Mr. T. J. Cranny, 2 Carlton Tce., Novara Road, Bray, was adjourned to next meeting as application, which was received late, had not been fully investigated.

882—Small Dwelling (Acq.) Acts—Application.

Application from Mr. Joseph Flood, 61 Wolfe Tone Square, West, for loan in respect of house proposed to be erected at Boghall Road, Bray, was deferred.

883-Town Planning Applications.

Application from Mr. E. Finucane, for permission to erect 13 houses near junction of King Edward Road and Killarney Road, Bray.

The Town Engineer recommended that general approval should be granted for a maximum of 12 houses subject to compliance with the following conditions:—

- (1) The houses at King Edward Road should be sited 100 ft. from centre of road and in line with the adjoining buildings.
- (2) That a revised layout should be submitted before any work commences.
- (3) No division walls should be erected between front gardens. The divisions, where required, should be low hedges or flower beds.
- (4) A low parapet wall should be built beside the footpath surmounted by railings if necessary.

After long discussion, the Council recommended approval of plan in principle and that Contractor discuss details of proposed house plans with Chairman, Clr. Hunt and Town Engineer.

884.—Extension at Edenvale, Brennan's Tce., Bray.

Application from Mr. J. Padden, to erect extension in front of premises. Report from Town Surveyor that work had commenced on this project without the Council's approval and it was necessary to serve a Prohibition Order on the applicant. The Town Engineer stated that the extension projects from the main wall of the Terrace in front of the building line and consequently is most undesirable. He also indicated that as this contravenes the Council's Draft Planning Scheme and is injurious to the amenities of the area, he recommended that the application is refused. The Council recommended that the Town Engineer and County Manager re-examine this application.

The amount to be met from the Rate levy in the coming year as shown above, would be £109,458, but the application of available Credits of £880 which derive from savings in the present year would reduce

The increase in the rate is due to the extent of 1s. 5d. to the Demand from the County Council and the balance of 1s. is ascribable to the Council's own services. In the case of the County Council Demand the rise was expected and comes mainly under the heading of the Health Services. The greater part of the rise in Cost of the Health Services is due to hospital treatment, as pay increases, together with a rise in the costs of medicines have led to further outlay. As to the Council's own services there is a rise in costs equal to a rate of 1s. 3½d., but this is offset to the extent of 3½d. by some savings, such as reductions in loan charges and some maintenance costs, so that the net increase remains at 1s. The decisions recently taken by the Council in relation to improvements at the seafront involve the Council in new outlay equal to a rate of 3d. in the £ whilst the Town Surveyor has reported that urgent works at the Harbour (slipway and jetty) will require 2½d. The Vocational Education Committee's Demand requires 1d. in the £ extra next year and the purchase of a new cleansing vehicle is responsible for another 1d. Some time ago, however, the Workmen's Union sought a further increase of 30s. per week. After rather prolonged negotiations, an increase of 12s. 6d. per week which would be a total rise of £1 in the year 1961/'62, apart from the reduction in working hours, was approved.

The cost of the new wages increase of 12s. 6d. would come to £750. and that granted at the beginning of the financial year (7s. 6d.) cost $\pounds 450$, or a total between the two items of $\pounds 1,200$ for the year. The Union, it should be mentioned, has indicated that they are not prepared to accept the last offer.

The Town Engineer has prepared a special report on the services which are in his charge. A copy of this is being circulated to the Members of the Council. A report of the Librarian on the Library Services is also being issued.

The total outlay on roads in the coming year is estimated at £10,039 and after taking into account receipts from various sources, but mainly from Government Grants of £4,010, the net outlay is £6,029.

The first time the Council received a Grant from the Road Fund was in 1960/61. The Council has to maintain about 14 miles of Urban Roads and for many years it had been the view of urban authorities that assistance from the Road Fund, which is maintained with the receipts from motor taxation, should be allowed to them. In the present year the grant received from this source was £1,600 and it was used in surface dressing part of the Strand Road and also Caltrim was used in surface dressing part of the Strand Road and also Galtrim Park, Kevin and Connolly Squares, Wyndham Park, Galtrim Road

It should be once again mentioned that long before any assistance was forthcoming from the Road Fund Grant the Council had embarked on an extensive programme of road improvements and reconstruction. From 1946 onwards this work was undertaken as a capital programme. The total cost of the programme came to over £35 000 and loan charges

arising out of it still have to be met by the Council. This capital programme has reduced considerably the cost of annual maintenance as much of the reconstruction was done in concrete. Furthermore, the work was done at a time when costs were at a level of about one half of those which would obtain at present.

The urban ratepayers, through the County Council Demand, contribute in the same measure to the cost of the upkeep of Main Roads as rural ratepayers. In the present year the levy for Main Roads was as fural ratepayers. In the present year the levy for Main Roads was the same in Bray as in the rest of the County, being 3s. 5d. in the £. It will be found, however, that in 1961/62 the total rate for Roads in rural parts of the County (the County Health District) was 9s. 104d. which is considerably higher than the levy in Bray Urban District where the total rate for Roads came to 5s, 6d, in the £. The reason for this difference is that, whilst the County Council had to spend the equivalent of a rate of 6s. 51d. on the maintenance of Rural Roads, the Bray Urban Council's outlay on the 14 miles of Urban Roads which they have to maintain, came to a much relatively lighter outlay, being 2s. 1d. in the £.

In the coming year, the Road Fund Grant will, according to a letter recently received from the Local Government Department, be increased by one-tenth to £1,760. The Department also indicated that the Estate Duty Grant, which for the past 60 or 70 years has been paid to Local Authorities, is being abolished. The amount from this source received by the Council was usually £125, but the Department say that Urban Councils will be compensated for the loss of this receipt. It should here be remarked that it is only to be expected that the money available for road works from the Road Fund should show an increase, seeing that returns of the numbers of motor vehicles taxed show a rise of about ten per cent. each year. It should follow that there would be a somewhat corresponding increase in the revenue of the Road Fund from Motor Taxation. Mention has been made in the newspapers recently of the necessity for the Central Authority to make special Grants towards the cost of providing roads suitable for new traffic in areas in which railways have been closed. If this has had to be done, it could not, however, be regarded as being part of a normal roads programme of reconstruction and maintenance.

Employment Schemes Granf.

Each year the Council receives a grant for Employment Schemes and these works are carried out in mid-Winter. The 1961/62 Grant received was £1,850 and as in every other year the Council had to make a special contribution. The contribution required in the coming year is estimated at £285, which corresponds to the amount levied this year. The last Grant and the Council's contribution has been used in the reconstruction in concrete of part of Ravenswell Road.

Footpath Repairs.

The estimate for this purpose for the coming year is £150, as compared with £100 in 1961/62. It is intended by the Town Engineer that this would be used in repairs to a number of sections of footpath throughout the Town which have got into a rather unsatisfactory condition. In the present year the County Council carried out a largescale scheme of reconstructing footpaths in the centre of the Town and it is expected that they will continue with it in the coming year.

New Access Road to Seafront.

The reconstruction of Ravenswell Road, which has been mentioned earlier, is part of a programme for providing alternative access to the seafront. This new access would serve, eventually, to relieve congestion and ease very much the traffic conditions on the existing route to the seafront, via Quinsboro Road, which is becoming somewhat more difficult each year during the height of the tourist season, especially

at week-ends. The sum, which has again been included in the estimates towards the cost of this scheme, is, however, only a token sum as no indication so far has been received of the extent to which the costs might be met by a special grant from the Road Fund. The scheme not only would require the improvement of Ravenswell Road but would also entail the improvement of the exit under the religious and the also entail the improvement of the exit under the railway and the provision of a new deck slab for the Harbour Road Bridge. It would be part of the comprehensive scheme of improvements which the Council have in mind for the seafront.

The total outlay on Sanitary Services is estimated at £21,530 and this compares with £19,838 allowed by the Council for the present year. The receipts under this heading are estimated at £2,561 which leaves the net outlay at £18,969. The corresponding expenditure for 1961/62 was £17,277.

The items responsible for a rise in the expenditure under this heading are the loan charges on improvements at the seafront and pay

Street and Household Scavenging.

The total cost of the services for the coming year will be £6,616, and will require a rate of 2s. 5d. in the £. Last year the rate was 2s. The services provided remain of a high standard compared with other urban areas. There is a daily collection of household refuse from all premises in the main thoroughfares in the town during the Summer and a twice weekly collection from all other parts of the town. The cost of 2s. 5d, as a rate in £, or a charge of about 10s. per head can under present circumstances be regarded as quite reasonable. During the year it was necessary to purchase a new refuse collection vehicle and this entails a new loan charge of £200 per year.

At times there have been complaints about litter on the streets and it is regrettable that they are often well founded. It may be said, however, that the presence of this litter is not due to any lack of service on the part of the Council, but it attributable to the habits of the public. From time to time, the Council has made appeals for more care in the disposing of litter and asked that it should not be deposited on public thoroughfares, but the result of these appeals has been rather disappointing. The practice of selling so many items in paper wrapping, which is to be commended seeing that it leads to higher hygienic standards, has, however, resulted in a spread of litter by people of careless habits. It can only be hoped that public appeal and the provision of litter boxes in increasing numbers will help to overcome

Waterworks.

The expenditure shows some increase due to the revision of remuneration but the consumption has been somewhat reduced in recent times. The Town Engineer and the Waterworks Inspector (Mr. P. Doyle) and his assistant have, as usual, been giving unremitting attention to the conservation of the supply and the prevention of waste.

The laying of new water mains in recent years in many parts of the town, especially on Meath and Sidmonton Roads, Herbert and Vevay Roads, Church Road, Quinsboro Road, Putland Road, etc., has involved the Council in heavy capital costs with resultant loan charges but has served to stabilise and even to reduce consumption, even though the building of so many new Council houses and private dwellings could be expected to lead to a greater use of water. If it had not been for these improvements and the attention given to the system at all times by the Council's officials the cost of the bulk supply of water would have become much greater.

The Provision of Litter Boxes.

The sum allowed for this is £75; last year the expenditure was £50 and in the previous year it was £100. Apart from the necessity to provide some new litter boxes, many were wantonly damaged during the course of the year and consequently have to be replaced.

Public Lighting.

The expenditure on Public Lighting at £2,693 shows practically no change.

From time to time it has been mentioned that better or additional lighting should be provided in some places, but the Council must view such proposals with care as, apart from the annual charges, all new lights also involve considerable capital costs. At present the Council has 430 lamps which are lighting up to midnight and 38 pilot lights at main road intersections, etc., which are kept lighting all night. Some time ago a comparison was made with other towns in the country and it was found that the standard of lighting in Bray compares very favourably with them. The present cost works out at about 1s. in £ or about 5s. per head of population.

Derelict Sites

For some time past the Council has been devoting much attention to improving derelict sites, which quite apart from their adverse effect on the appearance on parts of Bray should, it is felt, be applied to some useful purpose. The former unkempt site at Vevay Road has recently been used for new buildings and the appearance of this area in consequence has been much enhanced. Continuous negotiations have been in progress for the acquisition of derelict properties in Castle Street. The County Council, as Main Road Authority has helped in this matter. About six premises have been acquired and the sites cleared. Owing to the number of interests involved, the process of acquisition has been found slow and tedious. Eventually it is intended to provide a large parking area and a small green at this place. The main approach to Bray will also be much improved by these works. The area known as the "Island" on Strand Road has almost been completely cleared; there is still one property to be acquired before the Council's proposals can be completed. A number of derelict sites on the Upper Dargle Road, which the Council had acquired some years ago, and on which, owing to vandalism, improvements by the Council had not been successful, were recently leased to a person who has arranged with the Council to lay them out attractively.

Improvements at the Seafront.

The scheme recently agreed with An Bord Failte for the reconstruction of the Municipal Baths will involve loan charges in the coming year. The estimates for loan charges is £200 but this only represents the charge for one half-year. The cost is estimated at about £10,000 and the provisional arrangement being made is that one half of the cost will be met by the Council and the balance by a Grant from An Bord Failte. This arrangement must be described as provisional as the long-term agreement with An Bord provides that the Council's contribution towards the cost of all the schemes at the seafront will be 20 per cent. Even already the Council has completed new works such as the new Shelters at Bray Head and on Cliff Walk, etc., which cost over £5,000. Mention has been made already of the clearance being done at the "Island," Strand Road, and so far the entire cost of property acquisition and works has been borne by the Council. The capital expenditure on it will involve loan charges of £200 in the coming year; this, however, is only the charge for a half-year.

The provision of a new shelter and the expenditure on the public sanitary conveniences at the southern end of the Esplanade is estimated

to cost £8,000 and once more it has been provisionally arranged that one half of the cost will be met by the Council—the cost of these improvements also forms part of the comprehensive seafront Scheme towards which, ultimately, the Council is expected to meet 20 per cent. of the total outlay. For the coming year the work will entail a loan charge of £238; the following year it will be almost £500 provided that the contract price is more or less in line with the estimate.

Housing

On housing the gross expenditure is estimated at £63,808. The receipts are taken to reach £58,017 and consequently the net charge on rates will be £5,791. The outlay shows a reduction of £499 on last year and this, in the main, is due to a reduction in some of the loan charges.

Repairs.

In the present year the Council allowed £2,000 for repairs and this sum will be fully expended. In addition, if the Council were to carry out all the repairs which are sought, the outlay could be much higher. It will be found that the Town Engineer, in his report, refers to the considerable cost which had to be met in repairing a number of houses in Wolfe Tone Square due to costly replastering being repaired.

It is quite clear that if repairs on the scale which are sought from time to time were to be put in hand by the Council each year, the outlay would be very much greater than it is at present. Moreover, the expenditure on repairs must be viewed in the light of the rental income. The level of rents in some cases is so low that if there is any considerable expenditure on repairs for a house with a low rent it would take years before the rent received would be equivalent to the cost of the repairs.

Last year reference was made in the report on the Estimates to the low level of some of the existing rents; some houses, and the number is fairly considerable, are still being let at rents of 2s, 5d, and 3s, 2d, per week. It is quite clear that such rents bear no due relationship to present income levels and money values. In fact the number of houses let at these low rents comes to almost 300. It is clear that unless repair costs are to impose further burdens on the rates, there should be some revision of these rents. From time to time the Council has been urged by the Department of Local Government to introduce for new lettings differential renting under which the rents would be related to household incomes, but it has been felt by the members that this system might introduce too many complexities, and lead to difficulties in assessment and collection. In the absence of differential renting it seems, however, only reasonable that the Council might review the rents of all houses, so that they may bear some relationship to incomes and living standards. A rent of 2s, 5d, assessed about thirty years ago would, having regard to the change in money values in the meantime, be represented by about 7s, 6d., nowadays, whilst 3s, 2d, per week would correspond to about 10s.

Again wages and many other types of income have increased by three or four times the level which operated twenty or thirty years ago. It should also be mentioned that whereas in some other Urban areas low rent houses have not got bathrooms, most of the Council houses built in Bray in the past thirty years have this facility. In the past eight years the cost of repairs has gone up from £1,200 to £2,000, but there has been no compensating increase in rental income. It is suggested that the stage has been reached when the relationship of rent to outlay on maintenance and the cost for housing would require review.

Small Dwelling (Acq.) Acts Loans.

During the past year a fair number of new applications for loans to persons building their own houses was received. Consequently, the

Council had to arrange for a new loan from the Commissioners of Public Works of £20,000. This loan will entail new loan charges of over £500 in the coming year but involves no cost to the rates as the entire claim will be met by the repayments from berrowers. There is no doubt but that the existence of these Loans is a great facility to young persons seeking to build their own houses and the present trend shows that it is likely in the coming year that more new dwellings will be provided in this way.

New Housing Schemes.

A contract for the erection of six new houses at Chapel Lane has recently been arranged and it is hoped that work will start at an early date. The loan charge included in respect of this scheme is offset completely by an estimated receipt in rents.

For some time past the Council has been endeavouring to acquire a fairly large area of land in the Palermo district for new houses. Thus far, however, the offers made by the Council have not been accepted. Further progress with the building of new Council houses cannot be made until suitable land has been acquired.

Playground at Boghall Road.

A few years ago the Council procured a site, free of charge, from the Meath Estate for a playground at Boghall which was intended to serve the needs of the children in the nearby residential area. The site was developed by the Council but it is disappointing to find that little use is being made of it whilst it has suffered much from vandalism. Possibly the playground suffers from the drawback of not being sited in a place where it would attract young children and would be under the observation of parents. It must be admitted that the venture, even though a worthwhile one, has been disappointing in the result.

General Urban Purposes.

The expenditure under this heading includes the demand from the County Council; the special levy of 9d. in the £ under the Unemployment Assistance Acts; the Vocational Education Demand; the maintenance of the Esplanade, Seafront and Public Parks, the Public Library; Schools Meals Scheme; Band Performances; Fuel Scheme and

The main item is the County Council Demand which, including the cost of the Fire Brigade, for the coming year is £55,552. The total expenditure under General Urban Purposes is estimated at £84 037 and after allowing for Receipts of £5,368, the net requirement would be £78,669, which involves an increase of £6,117 over the present year.

It has already been pointed out that the County Council Demand shows a steep rise compared with last year. The actual amount of the increase is £4,439, and represents a rate of 1s. 5d.

The revision of salaries which took place in 1961 also appears under this heading and will require an additional rate of over 3d. in the £.

Provision has been included under this heading for the various works essential for the maintenance of the Esplanade. This includes the purchase of litter baskets, sodding, seeds, flags, pennants and lifebuoys and repairs to seats. Provision is made again for £350 for strip lighting, together with £400 for painting of railings and band

It is necessary to provide a new boatslip at the harbour and this involves an outlay of £300. The timber decking projecting from the northern harbour wall is now in a dangerous condition and the Town Engineer has recommended that it should be removed, seeing that

there is no possibility of vessels using the harbour which would require it. The cost of its removal is estimated at £250.

The total outlay on the Esplanade, Public Parks and Swimming Pools in the coming year, including loan charges, will come to about £6,000 and this represents a rate of 2s. 3d. in £. This might be regarded as the annual investment by the Council in the Amenity Schemes which serve to maintain the position of Bray as a seaside resort. The outlay, it might also be said, helps to provide a secondary source of income for a great number of householders in the town.

In the present year the Council allowed £400 for this purpose and a similar amount is again included. Having regard to the rise in the charge for band performances and transport charges, it may be necessary to increase this allocation after the coming year.

The demand from the Vocational Education Committee at £2,808 is up by £244 or about 1d. in £.

The charges are the same in the present year except that there is a slight increase in the cost of wages of attendants. One-half of the cost of School Meals is met by State Grant but the State Grant does not cover the cost of the attendants.

Public Library.

A special report on the Library has been prepared by the Librarian as mentioned earlier and is being circulated to the members of the Council, During the past year Mr. D. Breathnach took up duty as Librarian and already it is evident that he can be expected to maintain the high standard of service which has been afforded for many year's past. At present the total number of borrowers of the Public Library is 2,777, of whom 1,698 are adult readers and 1,079 junior

The Scheme for extensions to the Library building which are to provide for a reference library, a study room for children, a lecture room and an Art Gallery has been under consideration for some time past and it was indicated by the Library Council that a State Grant of one-half of the cost might be expected. The details of the scheme yet remain to be settled. The Council feel, however, that if the library service is to be extended then a State subsidy should be available towards ordinary running costs as well as towards new capital outlay.

Fuel Scheme.

The cost of providing fuel to households occupied by persons who would not be in a position to find it from their own resources is estimated at £1,820. This is a reduction of about £300 on previous years and is due to a falling off in the number of recipients. reduction in the number of recipients could be taken as reflecting generally improved living conditions.

Provision of New Public Parks.

The Scheme for improved Tourist amenities for the town include the acquisition of further lands for public parks in the Bray Head area. During the year negotiations for the acquisition of this land proceeded, but it is regretted that so far it has not been possible to conclude them. It is expected, however, that one part of the area which the Council proposes to acquire will be secured by the Council at a fairly early date. The loan charge included in respect of this item, however, is only a token sum, as having regard to the time

necessary to conclude negotiations it is not likely that any actual loan charges would have to be met in the coming year.

As mentioned when this project was first outlined, it is intended on the land near Bray Head to lay out a public park, do some land-scaping, and provide amusements such as a miniature golf course.

County Council Demand.

The Demand, as indicated earlier, shows a rise of £4,439. The increase is almost altogether due to the Health Services and was to be expected seeing that the cost of maintenance in institutions has been rising over the past year.

Unemployment Assistance Acts Levy.

The amount that is to be raised for this purpose will be £1,956 and is the product of a special rate of 9d. in the £ which the Council must levy and pay to the Department of Social Welfare under the Unemployment Assistance Acts, 1933/40. It will be found that the amount usually is almost equal to that which is received each year by way of a State Grant for the provision of employment in mid-Winter.

The Trend of Rates

At a time when all other costs are rising it scarcely can be expected that local rates, no matter what efforts are made with a view to achieving economy and lower costs, can be stabilised. In the past year those employed in every branch of industry and in business sought pay increases, and it is to be noted that the last of these claims came within a few months after awards of higher pay already had been made. It was frankly admitted that the claims were not based on a rise in living costs, and instead, it was advanced by the Unions that they were seeking higher living standards for their members.

A feature of the recent series of claims is that it is often difficult to segregate the stage they have reached, as a settlement may from the employer's standpoint mean a merger of two so-called rounds of increases, but may not be accepted as such by the employees. Again, claims for salary revisions are always settled very much later than those of wage earners, as they always follow the latter—and this means that there may be a degree of retrospection which involves heavy expenditure in excess of the provision made in Annual Estimates by Local Authorities. It is, for instance, because of the prolonged character of negotiations and the consequent element of retrospective application involved, that the pay increases for Hospital Staffs have resulted in a substantial rise in the cost of the Health Services as shown by the County Council Demand. Aside from the effect of wages and salaries adjustments, the costs of the hospitals have been affected by the increasing outlay on medicines—nowadays there is ever greater resort to new and costly medicines in the course of treatment—drugs which whilst costly undoubtedly have been proved to be efficacious.

Here it should be remarked that when people claim that value is not being got for the outlay on Health Services, they do not realise that the greater part of it is for hospital treatment. In Co. Wicklow about 70 per cent. of the cost of the total expenditure on Health is for hospital treatment, and it probably would be found that much the same is true of other counties. Yet the hospital costs in this country are quite low when compared with those in nearby countries—as a general rule, much less than half. The costs of the Health Services in County Wicklow were recently analysed, and were found to be incurred in the following proportions—Hospital Treatment (General Hospitals 45 per cent.; Mental Hospitals 25 per cent.-70 per cent.; General Medical Services (those provided through the Local Dispensaries including the cost of medicines) 10 per cent.; Maternity Services

6 per.cent.; Disabled Persons Allowances 3 per cent.; Tuberculosis and Infectious Diseases (excluding cost of Hospital Treatment) 3 per cent.; Specialist and Dental Services 2 per cent; Ambulance 2 per cent.; Administration 2 per cent.; Miscellaneous 2 per cent. Any expansion of the existing Health Services could only be financed through heavier imposition by way of either National or Local Taxation, as happened in Britain where the cost of the Health Services in part are met by heavy purchase taxes and much higher rates of Social Welfare Insurances payable both by employee and employer.

The rate for the present year is 36s. 5d., and of this, the Council's own services require 17s. 3d., the balance of 19s. 2d. being for the County Council Demand and the Unemployment Assistance Acts Levy.

As pointed out on previous occasions, the rate for Municipal Services for which the Urban Council is responsible, such as Housing, Urban Roads, Water Supply, Sewerage, Public Lighting, Cleansing, Vocational Education, Public Library, School Meals and Seafront Amenities has not shown a steep rise in the past twenty years or so; it is not much over 30 per cent., seeing that from 1937 to 1940 the rate for Municipal Services was on average about 14s.

As Bray is a Holiday Resort it is essential that Public Services, especially those which provide amenities and attractions for visitors, be maintained to a high standard. Consequently Roads, Public Lighting and Cleansing should be, if possible, maintained at a standard somewhat different from, say, inland towns. It is felt that this is being achieved in some measure by the Council. The provision of amenities at the Seafront is a matter which has been receiving much attention from the Council, and after detailed surveys of possible Improvements, a comprehensive scheme was agreed with An Bord Failte, which body also will contribute towards the cost of them. For the coming year, the various services and amenities at the Seafront will require a rate of 2s. 3d. in the £, but as the new projects, such as shelters and the swimming pool materialise, the rate levy in respect of them must be expected to rise. These new works, however, are necessities if Bray is to maintain its position as a leading holiday resort. Moreover, there must be very few in the town who do not benefit in some way from tourism. The significance of outlay on amenities and attractions, is evident in the case of hotels, registered guest houses, amusement caterers, and most business firms, but a substantial income from tourism is also derived by a great number of householders in the town, including, it should be said, the Council's own Tenants.

All the Members of the Council's Staff, both outdoor and indoor, continued to carry out their duties in a diligent manner during the year. To the Town Clerk, Town Surveyor and Accountant a tribute is due for the manner in which they have kept records and submitted details so that these Estimates would be informative.

To the Chairman and Members of the Council it is my duty to express appreciation of the assistance and guidance given by them at all times. They have been giving unselfishly of their time, their capabilities, and their experience to the many problems which required attention, some of them problems of quite a complex character, such as those for future long-term development. Evidence of the demand nowadays made on the time of Public Representatives may be seen in the number of meetings which they have to attend and the number of inquiries addressed to them by members of the public.

Any further information which may be required in connection with these Estimates will be forthcoming at the Estimates Meeting on Thursday, 29th March, 1962.

The net requirements to be met from Rate Levy as above, are £109,458. Credits of £880 are available which can be applied to reduce the amount to be raised by Rate Levy in the year 1962/63 to £108,578.

The Council considered the Estimates in detail and made the following amendments.

Sanitary Services.

A sum of £200 for part loan charge acquisition of land at the "Island," Strand Road, was reduced to £50.

Under the heading, Cove Swimming Pool Cleansing, it was proposed by Clr. McAuliffe and seconded by Clr. Doyle that the amount be reduced from £150 to £75. On a vote being taken only the proposer and seconder voted in favour.

A sum of £100—clearing undergrowth at Bray Head—was reduced to £50 and a sum of £250 Legal Expenses was reduced to £200. - (a) The Council concurred with recommendation of Town Engineer that permission be granted to S. O'Connor, 4 Vevay Road, to erect a screen wall and side door on his premises.
- (b) Erection of houses on the King Edward Road by Mr. Eric Finucane. The Town Clerk reported that a meeting had been held in the Town Hall on 5th inst. between the Council officials, Mr. Finucane and Mr. Hunt and Captain Nelson, who represented the residents of the area, and that Mr. Temple had pre-

sided at same. As a result of this meeting it was recommended that, subject to the recommendation made to the April meeting by the Town Engineer, Mr. Finucane get permission to erect nine of the houses and that he, at a later date, submit plans for three sites at the Northern end of his proposed scheme for larger houses, if that were possible larger houses, if that were possible.

(c) Application from Mr. V. Cassoni, Vevay Road, for permission to erect a Filling Station on the Vevay Road. Report from Town

Engineer recommending refusal for the following reasons:

- 1. The site is in a densely built up residential and business area and a filling station would be undesirable in the area.
- 2. The frontage of 68 ft, is not adequate to permit a proper run-in
- 3. The site is within 60 yards of the junction with Putland Road and parking of traffic in the vicinity of the filling station would constitute a danger to passing traffic.
- 4. There is already great difficulty in parking of traffic on this roadway and in the vicinity of the R.C. Church. This would be aggravated by traffic in the vicinity of the filling station.
- 5. A similar application by Mr. Cassoni has been refused on about six occasions.

The Council unanimously recommended that permission be granted.

In the course of a discussion on this matter Mr. Healy pointed out that he felt he could not change his views in the matter and in fact, these views had been upheld by the Department of Local Government.

898. Train Services.

The Town Clerk was directed to write to C.I.E. and urge that the Sunday train services to Bray commence on the first Sunday in June.

967. Confirmation of Minutes.

The minutes of meetings of 8th and 15th May, 1962, which had been circulated, were confirmed.

968. Manager's Orders.

Manager's Orders Nos. 8553 to 8570 were noted. 909. Arising out of the Manger's Orders, Clr. Temple voiced his disapproval of a recent tenancy appointment in Wolfe Tone Square.

909. Association of Municipal Authorities.

- 1. On the proposition of Clr. Hipwell, seconded by Clr. E. Byrne, it was decided to increase the annual subscription to the above Association from three guiness to five guineas.
- 2. (a) Resolutions for Congress:

Proposed by Clr. E. Byrne and seconded by Clr. H. B. Hipwell—That this Council considers the present system, whereby rates are assessed on Urban areas on the basis of valuation is unjust and inequitable. The Council feels that the County Council Demand should be based on Services rendered rather than on valuation.

2. (b) Proposed by Clr. McAuliffe and seconded by Clr. C. Doyle and resolved—That the upper income limit in respect to the issue of loans under the S.D.A. Acts be increased from £1,040 to £1,300.

910. Bray Sailing Club.

Application from Bray Sailing Club to---

- 1. Be allowed to increase the area of their Dinghy Park by 10 ft. This was acceded to, the Town Engineer having recommended same.
- 2. The Club were also given permission to place boats on Dock Terrace, on the clear understanding that they would remove them immediately on being requested to do so by the Urban District Council.

911. Bray Esplanade Bye-Laws—Bye-Law No. 12.

An application from Mr. R. W. Boles for permission to hold three open-air Services in Bray during the month of July was refused. The Town Clerk informed the Meeting that a Bye-law prohibited the holding of Services on the Esplanade unless with the explicit permission of the Urban District Council. Clr. E. Byrne proposed that permission as sought be granted. Clr. M. O'Toole seconded. Clr. McAuliffe proposed that permission be refused and Clr. Mrs Ledwidge seconded. A vote was taken on Clr. McAuliffe's proposal and five members of the Council, viz., Clrs. C. Doyle, Mrs. M. Ledwidge, H. McAuliffe, G. H. G. Stuart and J. Temple, Chairman, voted for.

The following Councillors voted against the motion: Clr. E. Byrne, J. Byrne, H. B. Hipwell, F. G. Hunt and M. O'Toole.—Five.

The Chairman then gave his casting vote in favour of Mr. Mc-Auliffe's proposal that permission be refused. It was so decided.

912. 36/36a Castle Street—Purchase of.

The Town Clerk informed the meeting that agreement had been reached with the various interests involved in the purchase of the above property and that the total sums agreed to be paid came to £190 17s. 0d., plus legal costs. On the proposal of Clr. McAauliffe, seconded by Clr. M. O'Toole, it was agreed to purchase the property at the figure mentioned and the necessary excess expenditure was voted. The Council let it be understood that the County Council would recoup the monies when they were made available for the Road Fund, as in the case of premises purchased from Mr. Ogle.

913. Derelict Site—52 Main Street.

A letter was read from Mrs. K. Kelly, 51 Main Street, complaining of the unsightly condition of 52 Main Street and of its being a danger to children in its present ruinous state. The Town Clerk informed the meeting that he had brought its condition to the notice of the owner on a few occasions recently. On the proposition of Clr. McAuliffe, seconded by Clr. M. O'Toole, it was decided to write to the owner and inform him that the Council would acquire the site under the Derelict Site Act, unless within 14 days he remedied its present position.

914. C.I.E.—Incoming Excursions.

The Town Clerk was directed to write to the Station Master and complain of the lack of staff available to take tickets up from incoming excursionists to Bray over the week-end.

915. Salaries of Rent Collectors.

The above matter was adjourned to the next meeting.

919. Gaming and Lotteries Act.

- (a) Application from Mr. John Cooke, in respect of 10 c.d. Albert Walk. Report from County Fire Officer stating that he had no objection in this case. Report from Health Inspector stating that he had no objection if Mr. Cooke re-installed a fan which had been removed from the premises. Council agreed with the recommendations of the above officers.
- (b) Application from Albert Tipple in respect of premises known as "Prom Amusements," Esplanade. Report from Health Inspector to the effect that the premises were unsuitable from the public health aspect, as—
