On 14th January 1924 Messrs P.W. Tunney & Co., at the request of the Council, made a valuation of the Sinking Fund and showed that there was a depreciation of £3235.8.0. As a result of recommendations placed before them the Council decided to sell out their holdings in Bank of Ireland' Stock and other Securities, and reinvest, principally in Dublin Corporation Stock. Purchases of this Stock were made at prices from 64 to 68% and the idea then was that the Council would obtain the full nominal value (i.e. £100 for what cost from 64 to 68%) of Jublin Corporation Stock in 1944, or 7 years before the Council's Stock would be redeemable in 1951. Various transactions took place, the principal being a gain on the sale of Bank of Ireland Stock of £4370. By a purchase of £15,490 of the Council's own Stoci, at prices ranging from  $62\frac{1}{2}$ to 65% the outstanding stock liability was reduced from £129,040 to £113,550. Instead of proceeding with the proposed Stock Conversion it was decided to first dispose of the Sinking Fund.

## Disposal of Sinking Fund

At the 31st March 1926 the cost of the amount in the Sinking Fund, after taking credit for gains on pu up to that time, was £37,548, but the nominal value of the securities represented by this at

It was thought that to do this was impracticable, but it has been accomplished, thus reducing £113,550 outstanding at 31st March last to £55,786, the total stock liability at present. It will be noted that the amount obtained by the sale and exchange of securities, viz., £57,764, is £20,216 of a gain on the amount standing to credit in Sinking Fund, viz., £37,548.

The yearly interest on £113,550 at  $3\frac{3}{4}\%$  was £4258.2.6, and the interest on £55786 will be £2091.19.6, or a saving in yearly interest of £2166.3.0, equivalent to about 1/4d in the £, and if this is multiplied by 25 (thenumber of years it would have been payable) the amount saved in yearly interest is £54,150.

## Conversion of Stock

You have had before you reports from me showing that the Council could, in two ways, offer to the Stockholders new 5% Stock instead of their holding in  $3\frac{5}{4}\%$  Stock at present :-

> 1. By giving them 75% of 5% Stock in lieu of their 34% Stock, and guaranteeing payment of balance of 25% in 1951; then creating a Sinking Fund to produce this amount in the period mentioned.

2. By offering them 85% of 5% Stock and by this amount increase their income by 10/-% per annum, which would accumulate at 5% in 25 years to more than the difference between £85 and £100.

I have since come to the conclusion that it is better for the Council, having reduced their outstanding Stock liability from £129040 to £55786, to retain the  $3\frac{3}{4}$  Stock and start a new Sinking Fund to repay this amount in 1951, which would be more favourable to the Council than converting into 5% Stock.

The Council can obtain a Consent Order from the Minister for Local Government, and raise new 5% Stock for any new works that are authorised by the Government, viz., Housing, Watermains or Sewers, or the like, and I would recommend that steps be taken to obtain a Consent Order from the Minister for Local Government for such purposes when the total amount required would be ascertained.

I may say that at the Conference of Municipal Authorities, held in Kilkenny on 2nd September, a resolution was passed unanimously, asking that the Local Loans Fund be opened for Housing Purposes at a low rate of interest and on a 60 years repayment basis. If this were done it might not be necessary to raise your own Stock and it might be advisable to postpone any action in this direction till it is ascertained what the Government will do in the matter.


