Ltd. to inform the Towns Commissioners that having secured a supply of Gas Coals on favorable terms (having regard to the present crisis in the Coal trade) they are glad to be in a position to be able to propose to light the Public Lamps of the Town on the same terms and conditions as last year viz for eight months from the 1st of Sept 1893 to 1st May 1894 exclusive of seven moon light nights in each month at the rate of 33/- per lamp, the lighting to commence at half an hour after sunset and the extinguishing to begin at 11 o'clock each night

of nuisance. — On different occasions at night and in
different portions of the Town I found twelve of the Public
lamps not lighted during the month. — On the 27th ultimo
Dr. Flynn Local Government Board Inspector visited your
Town he examined the fever hospital and almost all the lanes and
by ways of the Town and some premises. He directed me to draw
your Board's attention to the scavenging of the streets he suggests
that your Board provide a horse and large dray ^{or} float with
two men; by this means the whole Town could be cleaned
in the day, he also directs attention to the necessity of
having the sewer that runs through the pound flagged and
covered and some other matters that your Secretary will

I respectfully beg to report to your Board that during the past month there has been a few cases of Scarlet Fever in your Town; however the general health of the district but for those few cases appears to be in a fairly satisfactory condition. By directions of your Chairman I have been preparing the public pumps of the Town for the accommodation of the people with water. I also tried to make arrangements as to the conveyance of a drain from the premises built by Captain Darraugh, but failing to do so it now remains with your Board to settle the matter. — The public lighting of the Town during the month was very much neglected; on different occasions and different parts of the Town I found seventy lamps not lighted, besides this number Bay View Road, High Street and Rilmantin Hill were five nights without any gas being lighted.

I made usual inspections during the month visiting sixty houses and premises and served four notices under the Public Health Act for

abatement of nuisance. All the sanitary orders made by your Board up to last month has been complied with.

Dear Sir,

I duly received yours of the 9th Instant asking me what the words "existing circumstances" in Counsel's opinion meant, as I could not find that these words occurred in the case. I wired you to forward copy case marking the words referred to, I received the case and I find the words quoted do not occur in the opinion, but, the words as marked are "existing Harbour Commissioners. —

My view of the situation is this, the only persons really concerned in the matter method of the election of the eight Commissioners are the Towns Commissioners themselves, and as they have been parties to, and responsible for the irregularity for

many years, no one of them can well complain of the past, though he is entitled to have matters set right for the future. In the same way none of the eight Commissioners annually elected in 1891 or 1892, can assert any claim or right to sit for 1893, in preference to the eight elected in 1893, as to the elections in 1891 & 1892 were just as irregular as that for 1893. — Unless therefore the Commissioners like reasonable men agree amongst themselves to the rough and ready course suggested by Council of allowing the eight who have been selected for 1893 to remain in office for one year and during that time to arrange by ballot or otherwise a system of rotation by which three will retire in 1894, three in 1895, and two in 1896, there is no other remedy in my opinion except the costly one of a new Act of Parliament. The course suggested injures no one and defeats no right. The eight elected in 1892 were only elected for one year and having enjoyed that year cannot complain and certainly would not be listened to in any Court claiming a right to sit for three years from 1892. As to query No 4 Council did not mean that they could only ballot for a list of three particular names, but that each voter might, if it was thought advisable, mark on the one paper the names of three persons to fill the three vacancies instead of having a separate ballot for each of the three vacancies.
