

Gentlemen,

In compliance with your request our School Attendance Committee met on Tuesday 5th January 1897 and appointed their Chairman, Rev Michael O'Shea P.P. Vice chairman, Rev Canon Roche, and Secretary Mr Francis Wm MacPhail, the latter at a Salary of Twenty pounds per annum to be paid quarterly.

We directed our Secretary to advertise for a School attendance Officer at Twenty five pounds per annum and on Tuesday January 12th 1897 we appointed by ballot Mr Andrew Kirwan, School attendance Officer at the above named salary, to be paid in like manner as our Secretary, subject to the confirmation of the Local Authority —

We also directed our Secretary to procure "A Guide to the Irish Education Act 1892 as amended by the Irish Education Act 1893 containing full instructions to Local Authorities, School Attendance Committees and their officers for the working of the Act, also Census Register and other minor matters required by our officers for the discharge of their duties :

We must say that since the act was put into operation the attendance at our Schools has largely increased, thereby showing the great necessity for enforcing the Act in Wicklow.

We have determined to hold our meetings on the last Monday of every month.

The Local Authority by their resolution of the 4th January 1897 authorise the School Attendance Committee to make the necessary expenditure, we now ask for your confirmation of the same.

Gentlemen,

I respectfully beg to report that during the past month the Scavenger was attentive to his duties, but, Gentlemen I have again to draw attention to the street-scrapings and sweepings, as during the early portion of the past month the streets of the Town were kept in a filthy state owing to the Road Contractors not giving sufficient attention to them, in some instances where the streets were scraped it was left in heaps by the side of the water channels for several days before it was removed and some of the streets or roads were not swept or scraped at all -

The public lighting of the Town was fairly well attended to, however on different occasions during the month I found seven lamps not lighted this I attribute to them being either turned off by some mischievous persons or blown out by the wind. I think some notice should be taken of the illuminating power as it was very dull. The attention of the Gas Co. was drawn to the dirty state of the lamps which I am glad to say has been remedied - I have also to draw attention to a breach of the Laws relative to the removal of gravel from the Murrough Beach and ask for directions with regard to same. - I made usual inspections during the month visiting fifty premises and served three notices under the Public Health Act for abatement of nuisance - The Medical Officer's attention I have directed to some Sanitary matters - I had one patient conveyed to Hospital in the Ambulance car.

Wicklow Town Commissioners v. Foot-ball players
Dear Sirs,

We beg to report to your Board that the cases have terminated successfully -

His Honor Judge Kane gave Decrees for the nominal damages of one shilling in two of the cases - In the third case, he gave the offender the benefit of a doubt, as to whether he was actually playing at foot ball or (as alleged) only casually kicked at a ball which came near him and struck out the case.

The effect of His Honors Decision, under his "Title Jurisdiction" is to establish for ever the right of the Commissioners to prevent any games on the Murrough of Wicklow, unless by the express permission of your Board. - In point of fact we are of opinion that no one has any right to use the Murrough except for the purpose of promenading, and perhaps for showing horses on fair days -

In case of any future trespasses you may safely resort to the Petty Sessions Court as the production of the Decrees will be conclusive evidence of your Title, and prevent an ouster of jurisdiction by pleading that Title is in dispute - We deem it our duty in order to prevent a recurrence of the recent state of things to advise your Board, to have printed books of permits, which could be issued by the chairman for the time being or the Town Clerk to authorise persons to use the Murrough for such purposes as the Board should sanction, and to make a rule of summoning (before the Justices) every person using the Murrough for any purpose other than walking or riding over it -

Rathdrum Union. Re Cemetery

We are in receipt of yours of the 25th instant, with a copy of the
minute of the Guardians.

We do not think we misunderstood the intention of the Guardians
but we are of opinion that the Agreement as drafted by us is the best we
can do to accomplish the Guardians object. - Both the Guardians and
the Commissioners are the Burial Board for their respective districts
and any joint Committee is only feasible by the formation of an united
district and an united burial board for any of the purposes of the
Public Health Act 1878. - The purpose for which such united Board could
be formed would be the purpose of purchasing a Burial Ground and
we are not aware of any other purpose in this particular case in which
an united board could be formed - The Guardians have power under
section 175 of the Act to purchase lands for the purpose of forming a burial
ground but the guardians have no power to sell the lands so purchased.

There is a power given under Sec. 178 of the Act to sell the exclusive right

of burial either in perpetuity or for a limited period in any parts of any burial ground, provided that such exclusive right shall not extend in all to a space of one half of such burial ground and under sec 195 power is given with the sanction of the Local Government Board to let the lands purchased by them which have not been consecrated; but this apparently is only a letting for temporary purposes as the section goes on to say that the guardians must reserve power to themselves to resume possession on giving six months notice — These are the powers of the guardians to purchase and sell and the Wicklow Town Commissioners as Sanitary Authority and Burial Board for their district have similar powers.

Several difficulties therefore arise namely: —

- (1) An united board or committee cannot be formed after the lands have been purchased as the purpose for which such a Board could have been formed would have been already accomplished.
- (2) The guardians having purchased the land cannot sell the land itself but only a right of burial therein.
- (3) The guardians cannot even sell the right of burial in one half as section 178 provided that the right of burial to be sold shall not extend to one half.
- (4) Assuming that the guardians had a right to sell one half of the exclusive right of burial. The Wicklow Town Commissioners in our opinion have no power as a Burial Board to purchase a right of burial, their powers being as before stated similar to those of the guardians namely to purchase lands not a mere right of burial.

We return the draft Agreement and shall be glad to hear from the guardians with any further instructions they may wish to give us
