Sub Sanitary Officer's Report

4th November, 1924

Inspected over 50 premises and served one notice which was complied with.

The Main Drainage & Urinals were disinfected and flushed weekly during the month

Had about 60 tons of Stones broken with the crusher at Mill Yard and spread at Bridge Street, Marlton Road and Main Street. By the Council's instructions I had the Public Seats removed to Stores. I require half dozen lime brushes for lime washing.

Waterworks Overseer's Report

During the month repaired Fountains on Murreugh, Fitzwilliam Road, High Street and South Quay. All mains were flushed as usual.

I would be obliged if the Council could see their way to get seven extension bars or keys for Splice Valves in Valve Chamber, and at New Filtering Beds as these Valves are always covered with water and therefore very hard to fit Valve Key on. Reservoir is overflowing

Sub Sanitary Officer's Report

2nd December, 1924

Inspected 70 premises and served 2 notices which were complied with. Disinfected ~~one~~ premises. The usual flushing of the main drainage and the disinfecting of Gully Traps and Urinals on the North and South Quays has been done weekly during the month. I require a new set of Sewer Rods for sewerage work as the old Rods are worn out. During the month the Council's men were working on the Rathnew Road, Station Road Marlton Road and Church Road cleaning up water drains and side edging same and had Main St and North and South Quays scraped and material removed off to Depot.

Had 60 tons of Stones broken with the Crusher to 1½" and spread on roads at Abbey Street, Fitzwilliam Square and Summer Hill. Owing to pot holes on the Council Roads a large amount of stones is required this season. During the month four Stone Shores fell in I had to cover these Shores with timber as there is no Flags in stock now. We would require a couple of dozen of Flags for this work in stock.

I inspected Mr Healy's premises owing to complaint that water was coming through the wall off road in a basement room which is 10ft under level of the road. I wish a Committee's instructions before doing anything regarding same.

There is a new Fire Place required for Board Room as the present one is dangerous and not safe at present.

Order:- That Messrs Haskins, Kennedy & Conroy, be appointed a Committee to inspect Mr Healy's premises and Technical Schools and ascertain what is the cause of complaint.

Waterworks Overseer's Report

During the month all mains were flushed and Meters cleaned and oiled. Repaired Fountains at New Street, Bath Street and South Quay. The heads were forced off of Fountains at New St and Bath St and inside fittings strained.

Recommend that the Council get one or two New Fountains so that old Fountains could be taken down and properly repaired.

The Equilibrium Valve in Valve Chamber jammed on 10th inst, had same made right and Chamber cleaned out.

The Reservoir is Overflowing.

Electrical Engineer's Report

2nd December, 1924

I beg to submit report for month ending November 30th, during this time public and private Services have been maintained as usual. On Sunday night November 23rd owing to a Fault on overhead Mains at 11-15 p.m. I found it necessary to cut off the Supply from Lower end of the Town until 10 a.m. On Monday morning when fault was located and repaired. This was the only interruption of service for the month.

Since my last report 5 New Consumers have come on and 4 new services have been run and meters installed. Many of our Consumers have extended their lighting and our load is increasing every week. After 12 months working plant is in excellent condition and running an average of 7 hours daily including Sundays. I would wish to bring to the notice of Council that I have one account now over-due and would be glad to have instructions on the matter.

With reference to your letter of 10th ultimo, and your meeting with the Chief Valuer on 4th instant in the above matter we have to state that subject to the approval of the Ministry of Finance and of the Oireachtas, as provided by the State Lands Act 1924, we should be prepared to grant to the Council a sublease from 25th June last until 28th Sept 1961 of the Coast Guard Station at a rent of £45 per annum, the Council having put the premises into repair to be liable to maintain and deliver them up in such repair as is required by the conditions of the lease to us, and to discharge all rates and outgoings We shall also, subject as above, be prepared to grant a sub-lease from the same date until 30th October 1945 of the Boathouse at a nominal rent of 1/- per annum.

Sub Sanitary Officer's Report

6th January, 1925

During the month inspected 30 premises and served one notice for defective drainage which was complied with. Had one premises disinfected and bedding destroyed and bedding destroyed in two cases by the Medcial Officer of Health's instructions.

The flushing of the Main Drainage and disinfecting of the Gully Traps and Urinals on the North & South Quays have been carried out weekly during the month.

From a complaint I received re drainage through the premises in Church Street I had same opened up in both premises and after two days work had it cleared. This is an old type of sewerage not sealed as there are no joints only a saddle fitted on each pipe and I recommend a new sewer to replace same which would be about 80 yards

During the month the Council's men were engaged on all the various Roads repairing same and also the Water Tables which were damaged by rain storm. There were 160 men named for work

Christmas week of these 134 have worked in Mill Yard and around the Township cleaning up same. I had about 260 tons of stones broken and the greater part of them spread on the North and South Quays and Rathnew Road. There is about 80 tons that requires rebreaking to a smaller size for Main Streets. Had gravel raised and spread on Footpaths along Station Road and Fern Hill.

WATERWORKS OVERSEER'S REPORT

6th January, 1925

During the month flushed Mains, Oiled Meters and repaired Fountains at Ball Alley, Lower Monkton Row and Upper Strand St.

On the 8th instant there was a clean Filtering Bed turned on the dirty bed will now want to be cleaned.

There was four men employed at Waterworks during Xmas week trimming hedges and cleaning up Road way.

It will be necessary to renew some of the old Wooden Paling between Symes Land at Waterworks bounds as the old Paling which has been there for a number of years is rotten.

The Service into Power House is all corroded. I believe it is the Oil or some other matter that has caused this as some of the pipe was not 12 months in. This service wants renewing.

I beg to report that I find great difficulty in Collecting the Poor Rates, however the First Moiety of my Collection will be closed on to-morrow. I also wish to let you know that I have been unable to collect practically any of the arrears brought forward during the past three years, some of this Rate I am afraid I will not get as the persons have no visible means

The greater portion of this Rate arrears is due on unoccupied houses. I have served notices on the Owners of those Premises and will immediately issue Summonses for recovery of amount due which I expect to have settled before the end of the financial year. I also beg to report that I have had several prosecutions for Rates and Decrees granted but up to the present I have not been informed by the Civic Guard as to whether they have collected the amount of the Warrants.

The Town Clerk from time to time has been pressing me to close my collection but as you are aware there is such a lot of unemployment in the Town it is very difficult to collect the Rate, however as I must close my account before March 31st I now propose to issue summonses against any one who does not pay their Rates immediately.
