Adjourned until Thursday the 7th February 1935, Councillors Haskins and McMahon to interview in the meantime the Dominican Nuns to ascertain if they would be agreeable to exchange the field at Dunbur Road (6 acres) which they hold on a yearly tenancy from the Council for like tenancy in the field which the late John Keogh held and which his executors are anxious to surrender.

Item 4. Proposed by Councillor O'Grady, Seconded by Councillor Waldron and passed unanimously. That Tenders be invited by advertisement in "The Wicklow People" for execution of the works, provided that if no tender be received within the Engineer's Estimate, we ask the Department of Local Government and Public Health to allow the Council to carry out the works by direct labour under the supervision of the Council's Engineer.

It was also Proposed by Councillor Haskins, Seconded by Councillor McMahon and passed unanimously, That applications be invited for a Clerk of Works through advertisement in "The Wicklow People", the salary to be £4. 4. 0 per week, same to cover any overtime during which the Clerk of Works may be, in accordance with the Contract, required to attend on the job.
